

SANJU KILIMANOOR SASIDHARAN NAIR v. UBUSHINJACYAHA

[Rwanda URUKIKO RW'UBUJURIRE – RADA 00011/2018/CA – (Karimunda, P.J.) 22 Ukwakira 2018]

Kohererezanya ukurikiranyweho icyaha (extradition) – Ubusabe bwi gihugu n'ubwa Polisi Mpuzamahanga (INTERPOL) ko umuntu ushakishwa afatwa – Ubusabe bwi gihugu n'ubwa Polisi Mpuzamahanga (INTERPOL) ko umuntu ushakishwa afatwa (International Arrest Warrant), ubwabyo ntabwo ari ubusabe bwo kumwohereza mu gihugu yakoreyemo ibyaha (extradition).

Uububasha bw'inkiko – Urukiko rufite ububasha bwo gufata icyemezo ku ifunga n'ifungurwa by'agateganyo by'umuntu usabirwa kwoherezwa – Umunyamahanga usabirwa kwoherezwa aho yakoreye icyaha ashobora gufatwa byihutirwa, agafungwa by'agateganyo kugirango adatoroka icyo gihe iryo funga ry'agateganyo ndetse n'uburyo bwo kurijuririra biba bigengwa n'amategeko agenga imiburanishyirize y'imanza z'inshinjabyaha n'ububasha bw'inkiko by'igihugu arimo, – Urukiko rw'Ibanze ari rwo rufite ububasha bwo gusuzuma ishingiro ry'ifunga n'ifungurwa by'agateganyo.

Amategeko agenga imiburanishyirize y'imanza z'ubutegetsi – Ikirego cyihutirwa – Ikirego cyihutirwa kigomba kuba gishamikiye ku kirego cy'iremezo, kuba ababuranyi ari bamwe ubwabyo bitihagije kugira ngo cyakirwe.

Incamake y'ikibazo: Ku busabe bwa Polisi Mpuzamahanga (INTERPOL) kandi hashingiwe no kuri International Arrest Warrant yatanze na United Arab Emirates, SANJU Kilimanoor Sasidharan Nair yafatiwe ku kibuga cy'indege ikanombe, maze ashyikirizwa Polisi y'u Rwanda nayo imushikiriza Ubushinjacyaha nabwo bumuregera Urukiko rw'Ibanze rwa Nyarugenge busaba ko afungwa by'agateganyo mu gihe hagitegerejwe ko imihango yo kumuhererekanya irangira kugirango yoherezwe muri United Arab Emirates kurangiza ibihano yakatiwe ku byaha byo gutanga sheki itazigamiye ya 8.818.000 AED (amafaranga akoreshwa muri icyo gihugu) no kunyereza umutungo wa sosiyete yayaboraga nka Managing Director. Urwo rukiko rwasanze ashakishwa na United Arab Emirates, bityo rwanzura ko kumufunga by'agateganyo ariyo nzira yoroshye yatuma aboneka igihe cyo kumwohereza kurangiza igihano yakatiwe kigeze.

Nyuma y'icyo cyemezo cyaje no kwemezwa n'Urukiko Rwisumbuye rwa Nyarugenge mu bujurire, SANJU Kilimanoor Sasidharan Nair yatanze ikirego cyihariye mu Rukiko Rukuru, Urugereko ruburanisha imanza z'ubutegetsi, asaba urwo Rukiko kutemera ubusabe bwo kumwohereza mu mahanga (extradition). Ikirego cye kimaze kwakirwa yahise atanga ikirego cyihutirwa, avuga ko gishamikiye kuri icyo cy'iremezo, asaba ko ibyakozwe byose mu rubanza N° RDP 00125/2018/TB/NYGE rwaciye n'Urukiko rw'Ibanze rwa Nyarugenge ndetse bigashimangirwa n'Urukiko Rwisumbuye rwa Nyarugenge ku bijyanye n'ifunga ry'agateganyo bitesha agaciro kuko yafunzwe n'Urukiko rutabifitiye ububasha. Urwo Rukiko rwasanze urega atagaragaza isano iri hagati y'ikirego cy'iremezo n'ikirego cyihutirwa ndetse atanasobanura aho ashingira ubwihutirwe bwacyo, maze rwanzura ko ikirego cyihutirwa kitakiriwe kuko kidafite kamere y'ikirego cyihutirwa iteganywa n'itegeko.

Urega yajuririye icyo cyemezo mu Rukiko rw'Ubujujire, avuga ko ibirego byose birebana no kohererezanya abakurikiranyweho ibyaha harimo n'ifunga ryabo ry'agateganyo biregerwa mu Rukiko Rukuru nk'uko biteganywa n'ingingo ya 27 y'Itegeko N° 69/2013 ryo ku wa 02/09/2013 ryerekeye kohererezanya ukurikiranyweho icyaha, bisobanuye ko yafunzwe n'Urukiko rw'Ibanze mu buryo bunyuranyije n'amategeko kuko rutari rubifitiye ububasha.

Akavuga ko isano iri hagati y'ibirego byombi ari uko yashakaga ko Urukiko Rukuru rudaha ishingiro ubusabe bwo kumwohereza muri United Arab Emirates kandi ubwo busabe aribwo bwashingiweho afatirwa icyemezo cyo gufungwa by'agateganyo.

Ubushinjacyaha buvuga ko ingingo ya 26 y'Itegeko N° 30/2018 ryo ku wa 02/06/2018 rigena ububasha bw'Inkiko iteganya ko Urukiko rw'Ibanze ari rwo rufite ububasha bwo gufata icyemezo ku ifunga n'ifungurwa by'agateganyo, ko Urukiko Rukuru nta bubasha rufite ku bijyanye n'ifunga n'ifungurwa by'agateganyo, kuko igikorwa n'Urukiko Rukuru ari ukwemeza ko ukurikirananyeho icyaha yoherezwa mu mahanga aho kuba gufunga by'agateganyo.

Kubirebana ni sano hagati y'ikirego cy'iremezo n'ikirego cyihutirwa buvuga ko nta kirego cy'iremezo Ubushinjacyaha bwatanze mu Rukiko Rukuru, ariko urega akaba yarasabye ko icyo kirego kiburizwamo kitaratangwa, bityo mu gihe kitaratangwa, bivuze ko nta rubanza ruhari, ibyo bikaba bisobanuye ko nta n'isano cyangwa ubwihutirwe buhari hagati y'icyo abarega bita ikirego cy'iremezo n'ikirego cyihutirwa.

Incamake y'icyemezo: 1. [2] SANJU Kilimanoor Sasidharan Nair yashikirijwe Ubushinjacyaha nabwo bumuregera Urukiko rw'Ibanze rwa Nyarugenge busaba ko afungwa by'agateganyo mu gihe hagitegerejwe ko imihango yo kumuhererekanya irangira.

II. IBIBAZO BIGIZE URUBANZA N'ISESENGURA RYABYO

A. Kumenya Urukiko rufite ububasha bwo gufata icyemezo ku ifunga n'ifungurwa by'agateganyo by'umuntu usabirwa kwoherezwa

[8] Me RWAGATARE Janvier, Me NIYOMUGABO Christophe na Me RUGAZA David bavuga ko SANJU Kilimanoor Sasidharan Nair yafunzwe mu buryo bunyuranyije n'amategeko bitewe n'uko

Urukiko Rukuru ari rwo rufite ububasha bwo gufunga by'agateganyo umuntu ugomba kwoherezwa kurangiza igihano yakatiwe mu mahanga. Basobanura ko Ubushinjacyaha bwamufashe nk'uwakoreye icyaha mu Rwanda bushingiye ku Itegeko ryerekeye imiburanishirize y'ianza z'inshinjabyaha rikoresha gusa ku byaha byakorewe mu Rwanda, nyamara kuri we atari uko bimeze, bakaba basanga ku banyamahanga bakoreye ibyaha mu mahanga hagomba gukoreshwa Itegeko ryerekeye kohererezanya ukurikiranweho icyaha kuko ari itegeko rihariye (lex specialis). Bakaba basanga kurishingiraho ntacyo byica ku Itegeko rigenga ububasha bw'Inkiko rivuga ko ibijyanye n'ifunga ry'agateganyo biri mu bubasha bw'Urukiko rw'Ibanze kuko ari ibisanzwe ko amategeko yihariye ashiraho irengayobora ku mategeko rusange.

[9] Uharariye Ubushinjacyaha avuga ko ingingo ya 26 y'Itegeko N° 30/2018 ryo ku wa 02/06/2018 rigenga ububasha bw'Inkiko iteganya ko Urukiko rw'Ibanze ari rwo rufite ububasha bwo gufata icyemezo ku ifunga n'ifungurwa by'agateganyo, ko Urukiko Rukuru nta bubasha rufite ku bijyanye n'ifunga n'ifungurwa by'agateganyo, kandi ko nta cyitwa "détention administrative" kibaho. Asobanura ko igikorwa n'Urukiko Rukuru ari ukwemeza ko ukurikiranyweho icyaha yoherezwa mu mahanga aho kuba gufunga by'agateganyo, ariyo mpamvu asanga nta makosa yakozwe n'Urukiko rw'Ibanze rwa Nyarugenge ndetse n'Urukiko Rwisumbuye rwa Nyarugenge. Avuga ko iby'uko Itegeko ryerekeye imiburanishirize y'ianza z'inshinjabyaha rikoresha gusa ku byaha byakorewe mu Rwanda ataribyho kuko rishobora gukoreshwa no mu irangiza ry'ianza zaciwe n'inkiko zo mu mahanga kandi ko ari uko bimeze kuri SANJU Kilimanoor Sasidharan Nair.

[10] Ingingo ya 13, igika cya mbere, y'Itegeko N° 69/2013 ryo ku wa 02/09/2013 ryerekeye kohererezanya ukurikiranweho icyaha iteganya ko "Mbere yo gusaba ko ukurikiranweho icyaha yoherezwa, igihugu gisaba gishobora kubanza gusaba ko umuntu ushakishwa aba afunzwe by'agateganyo...." Naho ingingo ya 27, igika cya mbere, y'iryo Tegeko ikavuga ko "Urukiko Rukuru [ari] rwo ruburanisha ibirego byose byerekeranye n'iyoherezwa ry'ukurikiranweho icyaha. Ubushinjacyaha cyangwa ukurikiranyweho icyaha usabirwa iyoherezwa nibo bonyine bemerewe gutanga ikirego n'inyandiko zose zijyanye n'iyoherezwa mu Rukiko Rukuru."

Naho ingingo ya 26, igika cya 2, y'iryo Tegeko ikavuga ko Inkiko z'Ibanze arizo ziburanisha ibirego byerekeye ifunga n'ifungurwa by'agateganyo ku rwego rwa mbere.

[12] Dosiye y'urubanza irimo *International Arrest Warrant* yatanzwe na Leta ya Dubai ku wa 22/10/2017, isaba ko SANJU Kilimanoor Sasidharan Nair afatwa agafungwa agashyikirizwa inkiko z'igihugu cyangwa inkiko mpuzamahanga, harimo kandi inyandiko yitwa *Interpol Red Notice* yo ku wa 14/03/2018 igaragaza ko SANJU Kilimanoor Sasidharan Nair yahanishijwe igifungo cy'imyaka itatu kubera gutanga sheki itazigamiwe, izo nyandiko zikaba zisaba ko afatwa agafungwa nk'uko biteganywa n'amategeko y'igihugu cyangwa amasezerano mpuzamahanga, yamara gufatwa bakabimenyeshwa kugirango ahite asabwa yohererezwe igihugu yakoreyemo icyaha nk'uko biteganywa n'amategeko y'igihugu cyangwa amasezerano mpuzamahanga.

[13] Urukiko rurasanga kuba Leta ya Dubai na Polisi Mpuzamahanga (INTERPOL) byarasabye ko SANJU Kilimanoor Sasidharan Nair afatwa, ubwabyo ntibisobanuye ko yahise asabirwa kwoherezwa mu gihugu yakoreyemo ibyaha (extradition), ahubwo nkuko byasobanuwe haruguru, yafashwe hagamijwe ko hakorwa ibyo amategeko ateganya, asabwe kandi yoherezwe, byumvikanisha ko ifatwa n'ifunga bye by'agateganyo bitagengwa n'itegeko ryerekeye kohererezanya ukurikiranweho icyaha (*loi sur l'extradition*) kuko igihe cyo gushingira kuri iryo tegeko cyari kitaragera. Ibi kandi nibyo

bigaragara mu ngingo ya 13, igika cya mbere, y'Itegeko N° 69/2013 ryo ku wa 02/09/2013 ryerekeye koherezanya ukurikiranweho icyaha iteganya ko “ *Mbere yo gusaba ko ukurikiranweho icyaha yoherezwa*, igihugu gisaba gishobora kubanza gusaba ko umuntu ushahishwa aba afunzwe by'agateganyo...”, bikaba bitakumvikana uburyo ifunga ry'agateganyo ryashingira kuri iryo tegeko ryerekeye koherezanya ukurikiranweho icyaha kandi riba ritatangira gukurikizwa kuko ubusabe bw'igihugu aribwo butuma ritangire gukurikizwa.

[14] Urukiko rurasanga uyu murongo ari nawo ushimangirwa n'amategeko y'ibindi bihugu nkaho mu Bwongereza ingingo ya 4(3), ya *Extradition Act 2003* iteganya ko ukurikiranweho icyaha ashobora gufatwa n'umupolisi yaba afite cyangwa adafite inyandiko imufata, ariko ukurikiranweho icyaha agashikirizwa Urukiko rubifitiye ububasha mu gihe cya vuba gishoboka,¹ iryo tegeko risobanura ko muri *England* na *Wales* Urukiko ruba rufite ububasha nk'ubw'Urukiko rusanze (Magistrates Court) iyo rwumva ibirego byihutirwa bishingiye ku Itegeko ryerekeye imiburanishyirize y'imanza z'inshinjabyaha, muri *Scotland*, Urukiko rukaba rufite ububasha nk'ubw'Urukiko ruri gusuzuma ikirego cyihutirwa ku cyaha cyakozwe n'ushaka kwoherezwa, naho muri Irlande y'Amajyaruguru (*Northern Ireland*), Urukiko rukagira ububasha nk'ubw'Urukiko rwaregwe icyaha cyakozwe n'ushaka kwoherezwa mu mahanga,² nabyo byumvikanisha ko ifunga n'ifungurwa by'agateganyo by'ukurikiranweho icyaha ugomba kwoherezwa bishingira ku mategeko asanzwe agenga imiburanishyirize y'imanza z'inshinjabyaha n'ububasha bw'inkiko by'igihugu arimo.

[15] Urukiko rurasanga kandi abahanga Michel Franchimont, Ann Jacobs na Adrien Masset basobanura ko mu Bubiligi, umunyamahanga usabirwa kwoherezwa aho yakoreye icyaha ashobora gufatwa byihutirwa, agafungwa by'agateganyo kugirango adatoroka, kandi ko ibyo ari uburyo bwo gutuma imikoranire y'ibihugu mu guhererekanya abanyabyaha igera ku ntego zayo, ko icyo gihe ifunga ry'agateganyo ndetse n'uburyo bwo kurijuririra biba bigengwa n'amategeko asanzwe ajyanye n'ifunga ry'agateganyo,³ umuhanga Colin Warbrick avuga ko ibyo biterwa n'uko inzira ijyanye no kwohereza ukurikiranweho icyaha iba itatangira, iyo nzira ikaba itangizwa n'ubusabe bw'uhagarariye igihugu uwo munyamahanga azoherezwamo,⁴ naho Charles Doyle akavuga ko icyo gufungwa by'agateganyo bisobanuye ari ugufata ukurikiranweho icyaha ugomba koherezwa mbere y'uko haboneka ibyangombwa byose byatuma inzira yo kumwohereza itangira,⁵ byose bishimangira ko ifunga n'ifungura by'agateganyo mbere yo gusaba ko ukurikiranweho icyaha yoherezwa, bigengwa n'amategeko agenga imiburanishyirize y'imanza z'inshinjabyaha n'ububasha bw'inkiko by'igihugu arimo.
