

MWINURA N'ABANDI v. GT BANK RWANDA LTD

Amategeko agenga amasezerano – Amasezerano y'umwenda wa banki – Kudasaba guhagarika kubara inyungu nyuma yo gusesa amasezerano no kongererwa igihe cyo kwishyura umwenda – Umwenda ukomeza kubarirwa inyungu na nyuma y'iseswa ry'amasezerano mu gihe impande zabyumvikanyeho mu masezerano – Gusaba kongererwa igihe cyo kwishyura umwenda igihe ababuranyi bananiwe kwishyura ntibiba mu nshingano z'urukiko ahubwo begera Banki yabahaye umwenda bakumvikana uburyo bayishyura.

Incamate y'ikibazo: GT Bank yahaye inguzanyo sosiyete Rwanda Petroleum Development Corporation (RPDC) yishingirwa na Winene na Mwinura. Sosiyete ntiyishyuye umwenda bituma GT Bank iregera umwenda n'inyungu zawo kugeza umaze kwishyurwa mu Rukiko rw'Ubucuruzi rwa Nyarugenge. Urukiko rwemeje ko ikirego cya GT Bank gifite ishingiro rwemeza ko sosiyete n'abishingizi bayo bishyura umwenda wari umaze kuba 109.935.037 Frw.

Sosiyete RPDC, Winene na Mwinura wavugaga ko ntaho ahuriye n'umwenda watanzwe, bajuririyeye Urukiko Rukuru rw'Ubucuruzi RPDC na Winene bo bavuga ko GT Bank yagenewe amafaranga y'umurenge ngo kuko yabariwe inyungu nyuma yo gusesa amasezerano. Urukiko Rukuru rw'Ubucuruzi rwemeje ko nta gihindutse ku rubanza rwaciye ku rwego rwa mbere rubategeka kwishyura 2.200.000 frw yo gushora GT Bank mu manza, igihembo cya Avocat n'amafaranga y'ikurikiranarubanza.

Mwinura, Winene na RPDC bongeye bajuririra Urukiko rw'Ikirenga ariko urubanza ruburanishwa n'Urukiko rw'Ubujurire kubera ivugurura ry'amategeko agenga ububasha bw'inkiko yari amaze kuvugururwa.

Ku ruhande rwa Mwinura yavuze ko ntaho ahuriye n'umwenda watanzwe kuko uwo yari yishingiye mbere wari wamaze kwishyurwa, asaba guhabwa icyangombwa cy'inzu ye yari yatanzeho ingwate. Yongeye avuga ko yakorewe uburiganya mu gusinyishwa amasezerano y'ubwishingire ngo kuko yari ku miti bigatuma yibagirwa; asaba ko ayo masezerano yatashwa agaciro.

Ku ruhande rwa Winene na RPDC bo bajuririyeye bavuga ko Mwinura atagomba guhakana ko yishingiye umwenda uburanwa ko kandi Urukiko Rukuru rw'Ubucuruzi rwageneye GT Bank amafaranga y'umurenge kuko amasezerano yari yasheshwe ikomeza kubara inyungu kandi zaragomabaga guhagarara. Bongeye kandi basaba ko bakongererwa igihe cyo kwishyura.

Kuri izi ngingo GT Bank yireguye ivuga ko ubujurire bwabo nta shingiro bufite kubera impamvu zikurikira: ku ruhande rwa Mwinura, ivuga ko atagaragaza ko umwenda yishingiye warangije kwishyurwa. Ku bijyanye n'uburiganya avuga yakorewe, GT Bank yireguye ko icyo kibazo nta kirego Mwinura yagutangiyeye mu Ruko rw'Ubucuruzi rwa Nyarugenge.

Ku ruhande rwa Winene na RPDC, GT Bank nabo yavuze ko ubujurire bwabo nta shingiro bufite kuko batabashije kuvuguruzanya ibyo inkiko zemeje ku bijyanye n'inyungu, ko kandi banki zibereyeho gutanga inguzanyo zibyara inyungu, bakaba kandi badahakana ko barimo umwenda wayo.

Ku byerekeye kongererwa igihe cyo kwishyura, GT Bank yavuze ko Wenene John Martin na RPDC Ltd ntacyo bakoze ngo bishyure kugeza mu kwezi kwa 12/2017, urubanza rucibwa, ko nta n'ikimenyetso batanga cy'uko baramutse bongerewe igihe bakwishyura, uretse kubivuga gusa.

Kayitesi Stella yagobotse ku bushake mu rubanza avuga ko inzu ye na Mwinura Eugene bayihaye RPDC Ltd ngo iyitangeho ingwate ku mwenda yafashe muri GT Bank Rwanda Ltd, ariko ko uwo mwenda warangiye kwishyurwa, andi masezerano yakurikiyeho bakaba batarigeze bayamenya.
