Yongeraho ko imyaka amaze muri gereza, amaze kugororoka ku buryo atazabisubiramo.

## **Urubanza**

[2] Mu rubanza n° RP 00383/2019/TGI/GSBO rwaciwe ku wa 23/4/2019, Urukiko Rwisumbuye rwa Gasabo rwemeje ko nta kimenyetso kigaragaza ko Butali Athanase acuruza ibiyobyabwenge byo mu bwoko bw'urumogi, rwemeza ko ahamwa no kurubika kuko urwo rumogi rwasanzwe muri boutique ye, rumuhanisha igihano cy'igifungo cy'imyaka makumyabiri n'itanu (25) n'ihazabu y'amafaranga y'u Rwanda miliyoni makumyabiri n'ibihumbi ijana (20.100.000).

Asobanura ko urumogi yafatanywe rwari mu ipantalo yari imanitse muri boutique acururizamo, akanayiraramo, ko uretse kuba rwari riri muri iyo pantalon, nta store y'urumogi yari afite, kuko iyo inzu ye ataricyo yagenewe.

[8] Butali Athanase avuga kandi ko Urukiko Rwisumbuye rwa Gasabo rwamuhamije icyaha cyo kubika urumogi, rusobanura ko nta kimenyetso ko yarucuruzaga, ariko ko Urukiko Rukuru rwo rwamuhamije icyaha cyo gucuruza urumogi, ko ibyo bigaragaza ukwivuguruza ku nkiko zombi.

[9] Butali Athanase asoza asaba uru Rukiko kwemeza ko ahamwa n'icyaha cyo gufatanwa urumogi, rukamugabanyiriza igihano kuko kuva mu ntangiriro ry'ikurikaranwa rye, yemeye ko yafatanywe udupfunyika umunani (8) tw'urumogi, kandi ko abisabira imbabazi no kuba ari ubwa mbere akoze icyaha. Yongeraho ko imyaka amaze muri gereza, amaze kugororoka ku buryo atazabisubiramo.

[10] Mu myanzuro y'ubujurire, Me Ilimubahanga Jean de Dieu, wunganira Butali Athanase, avuga ko Urukiko Rukuru rwahamije Butali Athanase icyaha cyo gucuruza ibiyobyabwenge by'urumogi, rushingiye ku kuba yarafatanywe udupfunyika umunani (8) twarwo, kandi mu by'ukuri yararunywaga gusa, ko ariyo mpamvu icyaha yakoze ari icyo gufatanwa no kunywa urumogi.

[11] Me Ilimubahanga Jean de Dieu avuga ko mu guhamya Butali Athanase icyaha cyo kubika urumogi, Urukiko Rukuru rwirengagije ko kubika no gufatanwa urumogi byemezwa habanje kureba ingano y'urumogi ukurikiranyweho icyaha yafatanywe n'uburyo yafashwemo, ko hari igihe umuntu wese unywa urumogi arubika, ko ibyo bitafatwa nko kurubika hagamijwe kurucuruza cyangwa kurukwirakwiza, ariyo mpamvu nk'uko byemejwe mu bindi bihugu,

hagomba kurebwa mbere na mbere ingano y'urumogi umuntu urunywa ashobora kugira, ko harebwe udupfunyika umunani (8) tw'urumogi Butali Athanase yasanganywe, bitakwitwa kubika urumogi rwo gucuruza, ahubwo ko rwari urumogi rwe rwo kunywa.<sup>1</sup>

[12] Me Ilimubahanga Jean de Dieu akomeza avuga ko uretse n'ibyo, kugirango rwemeze ko Butali Athanase yacuruzaga urumogi, Urukiko Rukuru rwagombaga gusuzuma niba hari amafaranga menshi yafatanywe, niba yarafashwe arimo kurugurisha, niba hari ikimenyetso kigaragaza ko yavuganaga n'abaguzi be cyangwa se hari abo yaba arubikiye. [20] Nk'uko bigaragara mu gace ka cumi na rimwe (11) k'urubanza rujuririrwa, Urukiko Rukuru rwasobanuye ko BUTALI Athanase atemera icyaha cyo gucuruza urumogi, ariko ko yafatanywe urumogi rwinshi yari abitse, ko byumvikana neza ko yarucuruzaga, ndetse ko hari umutangabuhamya Nshizirungu Jean-Baptiste wahamije ko bahoraga bafata abantu bavuye kugura urumogi iwe muri boutique, bityo ko nta makosa Urukiko Rwisumbuye rwa Gasabo rwakoze rumuhanisha igihano cy'igifungo cy'imyaka makumyabiri n'itanu (25) n'ihazabu y'amafaranga y'u Rwanda miliyoni makumyabiri n'ibihumbi ijana (20.100.000).

[21] Nk'uko bigaragara mu nyandiko-mvugo yo ku wa 15/3/2019 ya Butali Athanase mu Bugenzacyaha, n'ubwo yamenyeshejwe ko akekwa kuba yarakoze ibikorwa byo kunywa no gucuruza ibiyobyabwenge, yasobanuye ko urumogi yafatanywe, yaruhawe n'umuturanyi witwa Tuyisenge urugurisha, ko yari agiye kurunywa no kurukoresha umuti wo gushyira ku gisebe.

[22] Dosiye y'urubanza igaragaza ko umutangabuhamya Nshizirungu Jean-Baptiste yasobanuye ko hari hashize amezi atatu (3) (abanyerondo) bafite amakuru ko Butali Athanase acuruza urumogi muri boutique ye kuko bahoraga bafata abantu barugurayo, ariko bakamuhishira, ko babibwiye abapolisi n'abasirikare bari kumwe, bese bakajya gusaka boutique ye ku wa 15/3/2019, bagasanga urumogi mu cyumba cye.

[23] Inyandiko-mvugo y'ifatira yo ku wa 15/3/2019 yakozwe n'Urwego rw'Igihugu rushinzwe Ubugenzacyaha (RIB) igaragaza ko ibyafatirwe byasanganywe Butali Athanase ari udupfunyika umunani (8) tw'urumogi. Iyi nyandiko-mvuga y'ifatira ariko ntivuga aho byafatirwe.

[26] Urukiko rw'Ubujurire rurasanga mu kwemeza ko Butali Athanase acuruza urumogi, Urukiko Rukuru rwaragombaga kugaragaza impamvu udupfunyika umunani (8) tw'urumogi yafatanywe ari twinshi ku buryo byanze bikunze yatugurishaga, ko atari atubitse cyangwa adufite kugirango atunywe. Rurasanga kandi mu gihe Urukiko Rukuru rwashingiye ku mvugo y'umutangabuhamya Nshirizungu Jean-Baptiste wari wemeje ko bari bafite amakuru ko Butali Athanase acuruza urumogi muri boutique ye kuko bahoraga bafata abantu baruguragayo, byari ngombwa ko rugaragaza abo bantu baruguragayo.

[28] Urukiko rw'Ubujurire rurasanga rero mu gihe Umushingamategeko yashatse guhana umuntu wese unywa, urya, witera cyangwa wisiga ibiyobyabwenge, byumvikana ko atashakaga no guhana ubifata (consommateur) nk'ukora icyaha cyo kubibika, kuko ubifata ashobora igihe cyose kubifatanwa (en possession), kubitwara cyangwa kubitunda (transporter).
