

# **RADIANT INSURANCE COMPANY LTD v. UNIVERSITY OF RWANDA**

[2] Kuwa 07/07/2016, Kaminuza y'u Rwanda yasheshe amasezerano y'isoko ivugako rwiyezamirimo atayubahirije, ku wa 28/07/2016, yandikira Radiant Insurance Company Ltd iyisaba kwishyurwa ingwate ya avansi yo gutangira imirimo kuko amasezerano yari yagiranye rwiyezamirimo yasheshwe, inayishyikiriza raporo y'agaciro k'imirimo yakozwe kangana na 544.166.689,50 Frw. [8] Uburanira Radiant Insurance Company Ltd, avuga ko impamvu ya mbere y'ubujurire irebana no kuba mu gika cya 22 cy'urubanza rujurirwa, Urukiko Rukuru rw'Ubucuruzi rwaravuze ko sosiyete aburanira igomba kwishyura ingwate ya avansi yo gutangira imirimo ngo kuko "avansi yo gutangira imirimo ari umwenda utanga isoko aba ahaye uwaritsindiye kugira ngo atangire akazi noneho akazagenda amukata uko amwishyuye cyangwa se mu buryo bumvikanyeho mu masezerano (...), byumvikana rero ko isoko ryarangizwa neza cyangwa ritarangizwa rigaseswa, avansi yo gutangira imirimo igomba gusubizwa, na cyane ko iramutse idasubijwe kandi rwiyezamirimo yarahawe n'ikiguzi cy'isoko yatsindiye haba hiyongereyeho n'aya avansi atarashubijwe", ariko akaba atemeranya n'iryo sesengura, kuko hashingiwe ku biteganywa n'ingingo ya 88 y'Itegeko no 12/2007 ryo ku wa 27/03/2007 rigenga amasoko ya Leta, iteganya ko ingwate ishobora gufatirwa yose cyangwa igice cyayo, bivuze ko avansi idasubizwa yose, ahubwo hakwiye gusuzumwa no guha agaciro ibyo yakoreshejwe hanyuma hakishyurwa ikinyuranyo, cyangwa kigafatirwa ku ngwate yatanzwe; ko Radiant Insurance Company Ltd yagaragaje ko avansi yatanzwe yakoreshejwe neza ku buryo imirimo yakozwe ifite agaciro kayiruta nk'uko bigaragazwa na raporo Kaminuza y'u Rwanda yatanze, bivuze ko ntacyo rwiyezamirimo ndetse n'umwishingizi bakwiye kubazwa, ko ahubwo Kaminuza y'u Rwanda ishaka indonke (enrichissement sans cause) kuko ishaka kugumana iyo mirimo ikanasaba guhabwa avansi yatanze.

[9] Avuga kandi ko hashingiwe ku ngingo ya 89 y'Itegeko no 12/2007 ryo ku wa 27/03/2007 ryavuzwe haruguru, Kaminuza y'u Rwanda yagombaga kugira amafaranga ikata kuri factures rwiyezamirimo yayihaga, ko kuba mu masezerano yagiranye na rwiyezamirimo, barumvikanye ko ayo mafaranga azakatwa kuva kuri facture ya gatatu, ibyo bitareba Radiant Insurance Company Ltd kuko itayasinyeho, ko ahubwo niba uwari ufite ubwishyu atariyishyuye kandi biteganywa n'Itegeko, bitagira ingaruka kuri Radiant Insurance Company Ltd hashingiwe ku ngingo ya 113 y'Itegeko rigenga amasezerano. Asanga kandi ibyo gukata amafaranga ku nyemeza buguzi za rwiyezamirimo biteganywa n'ingingo ya 89, nta masezerano yabivuguruzwa (disposition imperative), kuko iteganya uburyo bwo kugaruza amafaranga ya Leta yatanzwe igihe kitaragera, ko rero amasezerano cyangwa igice cyayo bikozwe mu buryo bunyuranyije n'iyi ngingo, nta gaciro byahabwa mu mategeko.

Asobanura ko kuba mu masezerano y'ingwate, Radiant Insurance Company Ltd yarashingiye ku ngingo ya 51, agace ka gatatu, y'amasezerano y'isoko, bitavuze ko yari izi ko avansi izatangira gukatwa kuri facture ya gatatu, ahubwo yashingiye kuri iyi ngingo kuko ariyo iteganya ibya avansi yo gutangira imirimo, naho iby'uko avansi izatangira kwishyurwa kuri facture ya gatatu bikaba bivugwa mu ngingo z'ihariye z'amasezerano (conditions spéciales), Radiant Insurance Company Ltd itamenyeshajwe, bivuze ko yatanze "garantie" hari ibyo yahishwe, ko kandi ingingo ya 2 y'amasezerano y'ibanze ari yo igaragaza ibiyagize.

[11] Asanga kandi uwatanze isoko atakwitwaza ko afite ingwate ngo areke gukata amafaranga ya avansi yatanze, nta n'uburenganzira afite bwo gukata iyo avansi ahereye kuri facture ashatse kuko byaba binyuranyije n'ingingo ya 86 y'Itegeko no 12/2007 ryo ku wa 27/03/2007 rigenga amasezerano, bikananyuranya n'inyungu z'abagiranye amasezerano; ko asanga hashingiwe ku biteganywa n'ingingo za 64, 65 na 70 z'Itegeko rigenga amasezerano, Radiant Insurance Company Ltd atariyo ikwiye gusabwa kwishyura kuko habaye uburiganya.

[12] Asobanura kandi ko igihe uru rubanza rwaburanwaga, habayeho n'urubanza nshinjabyaha (RPA00696/2018/HC rwaciwe ku wa 15/11/2019) haregwa MUNYANEZA Félicien, Représentant légal akaba na Managing Director wa JV EXERT ENGINEERING GROUP LTD & CHEON KWANG ENGINEERING AND CONSTRUCTION Co LTD (JV) hamwe n'undi munya Kenya, baregwa gukoresha amafaranga y'isoko icyo atateganyirijwe; ko nubwo urwo rubanza rwaciwe nyuma y'urubanza rujuririrwa, hari ibidashobora guhinduka bitakwiringagizwa (faits constants) by'uko amafaranga yakoreshejwe neza, ko MUNYANEZA Félicien, Radiant Insurance Company Ltd yishingiye, atagomba kuyasubiza, akaba yibaza impamvu Radiant Insurance Company Ltd yamwishyurira. Asanga ahubwo Kaminuza y'u Rwanda yaratangiye urubanza nshinjabyaha yizeye ko MUNYANEZA Félicien azategekwa kwishyura amafaranga iregera ubu, ibonye bidakunze irega mu Rukiko rw'Ubucuruzi, ko icyo nacyo ari ikimenyetso cy'uko Radiant Insurance Company Ltd idakwiye kwishyura amafaranga Kaminuza y'u Rwanda iregera.

[13] Uburanira Kaminuza y'u Rwanda, avuga ko ibyo Urukiko Rukuru rw'Ubucuruzi rwashingiyeho mu gika cya 22 cy'urubanza rujuririrwa nta nenge bifite, kuko rwiyezamirimo ahabwa avansi ntacyo arakora, akagenda ayishyura mu gihe yishyura imirimo amaze gukora, agakatwa amafaranga kuri factures atanze kugeza arangije kwishyura amafaranga yose ya avansi.

[14] Avuga kandi ko ikigomba kurebwa muri uru rubanza, atari amasezerano yabaye hagati ya Kaminuza y'u Rwanda na rwiyezamirimo kuko atariyo ikirego gishingiyeho, ko ahubwo harebwa amasezerano y'imberame (contrat unilatéral) Radiant Insurance Company Ltd yasinye, aho yashingiye ku ngingo ya 51 y'amasezerano y'isoko irebana na avansi, yiyemeza kwishyura nta mananiza 527.117.404 Frw Kaminuza y'u Rwanda ikimara kuyasaba nk'uko bigaragazwa n'inyandiko y'ingwate ubwayo (We, Radiant Insurance Company Ltd, as instructed by the contractor, agree unconditionally and irrevocably to guarantee as primary obligation and not as surety merely, the payment to University of Rwanda on his first demand without whatsoever right of objection and without his first claim to the contractor, the amount not exceedind 527.117.404 Frw). Asanga kandi ingingo ya 89 y'Itegeko no 12/2007 ryo ku wa 27/03/2007 ryavuzwe haruguru yashingiyeho mu guca urubanza rujuririrwa, yarakoreshejwe uko bikwiye.

[15] Akomeza avuga ko ibivugwa n'uburanira Radiant Insurance Company Ltd ko habayeho uburiganya (dol), ngo kuko itamenye ko avansi izatangira gukatwa rwiyezamirimo kuva kuri facture ya gatatu, ko kandi binanyuranyije n'ingingo ya 89 y'Itegeko rigenga amasoko ya Leta, nta shingiro bifite, kuko amasezerano y'ingwate Radiant Insurance Company Ltd yasinye agaragaza ko yashingiye ku ngingo ya 51 y'amasezerano y'isoko (in accordance with the provision of the conditions of contract, clause 51 (advance payment) of the above mentioned contract), kandi iyo ngingo ivuga igihe avansi izatangirira kwishyurwa, bivuze rero ko Radiant Insurance Company Ltd itavuga ko itari ibizi, ko kandi itakwitwaza ko biri mu ngingo zihariye (conditions spéciales) kuko nazo ziba zigize amasezerano, ikaba yaragombaga kubirebera hamwe, ikaba rero itavuga ko yashingiye ku ngingo y'amasezerano itazi, mu gihe nyamara byari biteganyijwe mu ngingo ya

51,3 y'ingingo zihariye; ko usibye no kuba yari ibizi, kuba impande zakoranye amasezerano zaremeranyijwe ko avansi izatangira gukatwa kuri facture ya gatatu, ntaho binyuranyije n'Itegeko, kuko icyo ingingo ya 89 y'Itegeko rigenga amasoko ya Leta itegeka, ari uko habaho gukata amafaranga ya avansi kuri factures za rwiyezamirimo, ikaba ariko itavuga ko bigomba gukorwa kuva kuri facture ya mbere, keretse ahubwo Radiant Insurance Company Ltd igaragaje ko abakoranye amasezerano bemeranyijwe ko nta gukata avansi bizabaho, kandi Kaminuza y'u Rwanda ikaba yari yakoze imibare y'uburyo avansi yose yishyuye izagaruzwa.

[16] Avuga kandi ko ntacyo Radiant Insurance Company Ltd yagombye kwitwaza yanga kwishyura ibyo yiyemeje, kuko amasezerano yasinye agaragaza ibintu bitatu by'ingenzi : kwishyura nta yandi mananiza, kwishingira avansi kugeza yose yishyuwe, kuba nta nzitizi n'imwe (pas d'objection) yashyira kuri Kaminuza y'u Rwanda, ibyo kandi bikaba bishingiye ku miterere y'ubwishingizi (garantie) yasinye. Asanga ahubwo Urukiko rw'Ubucuruzi rwa Nyarugenge rwaribeshye rujya gushakisha icyo avansi yakoreshejwe nk'uko na Radiant Insurance Company Ltd ibivuga, nyamara icyishingiwe atari icyo rwiyezamirimo azakoresha avansi ahubwo hishingwiye ko azayishyura yose.

[17] Akomeza avuga ko ibivugwa n'uburanira Radiant Insurance Company Ltd, ko Kaminuza y'u Rwanda ishaka kwikungahaza nta mpamvu (enrichissement sans cause), nta shingiro bifite, kuko nk'uko bisobanuwe mu gika cya 8 cy'urubanza rujurirwa, hari 896.068.611 Frw yagaragaye nk'ikinyuranyo hagati y'amafaranga JV EXERT ENGINEERING GROUP LTD yari imaze kubona n'agaciro k'imirimu yari imaze gukora, bivuze ko hari amafaranga Kaminuza y'u Rwanda yishyuye ariko ntiyabona imirimu (contre partie), binavuze ko hari amafaranga yiyongereye kuri avansi yatanze.

[18] Asanga rero ibivugwa n'uburanira Radiant Insurance Company Ltd ashingiyeye ku ngingo za 64, 65 na 70 z'Itegeko rigenga amasezerano nta shingiro bifite, kuko nta buriganya (dol) cyangwa uburyarya Kaminuza y'u Rwanda yakoresheje, kandi amasezerano yasinye arasobanutse, ikaba yagombye kuyubahiriza.

[19] Ku birebana n'urubanza nshinjabyaha uburanira Radiant Insurance Company Ltd aburanisha, avuga ko rutavanaho ibyo Radiant Insurance Company Ltd yishingiye, kuko rwabaye hagati y'Ubushinjacyaha n'abarezwe, Kaminuza y'u Rwanda na Radiant Insurance Company Ltd bakaba batararubayemo abaturanyi, ngo habe hari icyemezo cyafashwe cyagira ingaruka ku byo Radiant Insurance Company Ltd yishingiye, ko ahubwo kuba Urukiko rwarasanze nta mafaranga MUNYANEZA Felicien agomba gusubiza, bishimangira inshingano ya Radiant Insurance Company Ltd yo gusubiza avansi atishyuye; ko no kuvuga ko Kaminuza y'u Rwanda yabanye kunyura mu nzira y'ikirego cy'inshinjabyaha ataribyo kuko atariyo yatanze icyo kirego, ikaba kandi itari iyobewe ko ko ari ikibazo cy'ubucuruzi kigomba gukemurwa n'inkiko z'ubucuruzi.

## **UKO URUKIKO RUBIBONA**

[22] Ku kibazo cyo kumenya niba ntacyo Radiant Insurance Company Ltd ikwiye kubazwa kuko agaciro k'imirimu rwiyemezamirimo yakoze karenze aka avansi yahawe, bikaba bivuze ko yakoreshejwe neza, Urukiko rurasanga nta shingiro bifite, kuko nk'uko byasobanuwe n'Urukiko rw'Ikirenga<sup>1</sup> bikanashingirwaho n'uru Rukiko mu rundi rubanza Radiant Insurance Company Ltd yaburanye na RAB<sup>2</sup> avansi yo gutangira imirimu ni amafaranga ahabwa uwatsindiye isoko kugira ngo abashe gushyira mu bikorwa isoko yatsindiye, ko nta gice cy'umurimo runaka ayo mafaranga aba yishyuriwe ku buryo yafatwa nk'ubwishyu, ahubwo uko uwatsindiye isoko agenda yishyura imirimu yakoze, agenda avanamo ingano runaka ya avansi nk'uko impande zakoranye amasezerano zabyumvikanye, akazarangiza kwishyura imirimu yakoze yose, avansi yose isubijwe uwamuhaye isoko, ko rero kuba avansi isubizwa uwatanze isoko, itafatwa nk'ubwishyu kuri iryo soko.

[23] Nk'uko inyandiko y'ingwate ya avansi yo gutangira imirimu<sup>3</sup> ibigaragaza, Radiant Insurance Company Ltd yishingiye 527.117.404 Frw, inemera ko izayishyura ikibisabwa bwa mbere kandi nta kindi ishobora kwitwaza<sup>4</sup>, mu gika cya nyuma cy'iyi nyandiko hakaba havugwamo ko iyo ngwate izagumana agaciro kugeza Kaminuza y'u Rwanda yishyuwe avansi yose<sup>5</sup>.

[24] Urukiko rurasanga rero, kuba agaciro k'imirimu yari imaze gukorwa na rwiyemezamirimo kari karenze avansi yahawe nk'uko Radiant Insurance Company Ltd ibivuga, bitayivanaho inshingano yiyemeje mu nyandiko yasinye, kuko nk'uko byasobanuwe haruguru, avansi si ubwishyu ku buryo kuyisubiza byashingira ku gaciro k'imirimu yari imaze gukorwa, ahubwo nk'uko ingingo ya 89 yavuzwe haruguru ibiteganya, iyo avansi igomba gusubizwa uwatanze isoko nk'uko byanateganyijwe mu nyandiko y'ingwate (..untill UR receive full repayment of the same amount from the contractor). Urukiko rurasanga kandi ibivugwa na Radiant Insurance Company Ltd ko Kaminuza y'u Rwanda ishaka indonke kuko imirimu yakozwe iruta avansi yatanzwe, nta shingiro bifite, kuko rwiyemezamirimo atahawe avansi gusa, ahubwo yanahawe amafaranga y'imirimu yari amaze gukora.

[25] Ku kibazo cy'uko Radiant Insurance Company Ltd itakwishyura amafaranga iregwa kuko Kaminuza y'u Rwanda itakase avansi kuva kuri facture ya mbere rwiyemezamirimo yatanze,

[26] Nk'uko byasobanuwe haruguru, Radiant Insurance Company Ltd yemeye ko izishyura 527.117.404 Frw ikibisabwa bwa mbere, aribyo byitwa *garantie à première demande* ou *garantie sur demande*. Abahanga mu mategeko bavuga ko iyo *garantie* itandukanye n'ubwishingizi (*cautionnement*), ko inshingano zishingiye kuri iyo *garantie* ziba zihagije, ko zidashingiye ku yandi masezerano. Ko ubwo bwoko bw'amasezerano bukoresheya cyane mu masoko ya Leta cyangwa ay'abantu ku giti cyabo<sup>6</sup>. Basobanura ko icy'ingenzi muri izo *garantie* ari uko inshingano z'ubwishingiye ziba zihagije, ko zidashingira ku masezerano y'ibanze<sup>7</sup>.

[28] Urukiko rurasanga hashingiye ku bisobanuro by'abo bahanga, nta kindi Radiant Insurance Company Ltd yagombye kwitwaza yanga kwishyura Kaminuza y'u Rwanda, kuko inyandiko y'ingwate yasinye yihagije ubwayo, ikaba itatuma ishakira indi mpamvu yo kutishyura mu masezerano Kaminuza y'u Rwanda yagiranye na rwiyemezamirimo, cyane cyane ko nayo ubwayo yiyemeje ko izishyura, ko nta kindi izitwaza.

[38] Uburanira Kaminuza y'u Rwanda avuga ko Radiant Insurance Company Ltd igomba gutegekwa kwishyura amafaranga y'indishyi kuko yanze kwishyura ku neza no kubahiriza *advance payment guarantee* yatanze ku wa 11/6/2014, bityo ikaba igomba kwishyura indishyi zingana na 10% z'amafaranga y'ingwate yanze kwishyura ku neza, zingana na 52.711.740 Frw kubera igihombo yayiteje, kuko Urukiko Rukuru rw'Ubucuruzi rwasanze indishyi zasabwe na Kaminuza y'u Rwanda zifite ishingiro, ariko mu kuzandika habamo kwibeshya rwandika 5.271.174 Frw aho kwandika 52.711.740 Frw, ariyo mpamvu asaba ko byakosorwa hashingiwe ku ngingo ya 141 y'Itegeko no 22/2018 ryo ku wa 29/04/2018 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsu. [40] Nk’uko ababuranyi babyemeranyaho, bigaragara ko habaye ikosa mu myandikire y’urubanza rujurirwa kuko mu gika cya 27, Urukiko rwavuze ko 10% ya 52.711.740 Frw Kaminuza y’u Rwanda isaba afite ishingiro, aho kwandika ko ari 10% ya 527.117.404 Frw kuko ariyo yasabye, ibyo bikaba byaratumye Urukiko ruvuga ko izo ndishyi zingana na 5.271.174 Frw aho kuba 52.711.740 Frw.

[44] Uburanira Kaminuza y’u Rwanda yiregura avuga ko ibyo Radiant Insurance Company Ltd isaba nta shingiro bifite, kuko uru rubanza rukomoka ku kutubahiriza amasezerano kwayo nk’uko byasobanuwe haruguru, ahubwo ko isaba amafaranga y’ikurikiranarubanza angana na 500.000 Frw yiyongera ku yari yarategetswe mu rubanza rujurirwa. Uburanira Radiant yiregura kuri aya mafaranga avuga ko nta shingiro ryayo kuko Kaminuza y’u Rwanda ariyo yayishoye mu manza.
