Incamake y'ikibazo: Uru rubanza rwatangiriye mu Rukiko rw'Ubucuruzi rwa Nyarugenge, MICON REAL LINE Ltd na BHAVAN ELECTRICALSS PVT zakoze *Joint venture* zirega EUCL ko bagiranye amasezerano yo kuzana no gushinga kuri *substation* ya Mont Kigali "Transformer 20 MVA" n'ibikoresho bijyanye nayo (*Supply and installation of a 20 MVA Transformer and Accessories at Mont Kigali Substation*), ariko ntiyubahirize, kuko ngo EUCL yatinze kwemeza imirimo bakoraga, bigatuma bakoresha igihe kirenze icyari giteganyijwe, basaba ko Urukiko ruyitegeka kubishyura 947.809,83 USD y'agaciro k'isoko.

Urukiko rw'Ubucuruzi rwa Nyarugenge rwemeje ko ikirego cya MICON REAL LINE Ltd na BHAVAN ELECTRICALSS PVT nta shingiro gifite ngo kuko EUCL ntaho yari itegetswe kwemeza ibikorwa bakoze.

MICON REAL LINE Ltd na BHAVAN ELECTRICALSS PVT bajuriye mu Rukiko Rukuru rw'Ubucuruzi bavuga ko Urukiko rw'ubucuruzi rwa Nyarugenge rwirengagije ko hari ibyo EUCL yagombaga kubanza kwemeza, ko rutahaye agaciro imirimo yakozwe mbere y'uko EUCL iyegukana, ko kandi itasubijwe "performance guarantee" yatanze.

Urukiko Rukuru rw'Ubucuruzi rwemeje ko hari ibyo EUCL itubahirije ku ruhande rwayo byo kwemeza "*Drawings za Transformer na accessories*" zari zakozwe, ko ariko nanone na MICON REAL LINE Ltd na BHAVAN ELECTRICALSS PVT nayo itubahirije izayo zo kuzana "transformer" ku gihe. Ku bijyanye n'agaciro k'imirimo yakozwe, rwasanze ihwanye na 60.806 USD ariko rwanzura ko batagomba kuyahabwa kuko yari muni ya avance bahawe.

Ku byerekeye no gusubizwa “performance guarantee” rwemeje ko batayihabwa kuko batubahirije inshingano zabo.

MICON REAL LINE Ltd na BHAVAN ELECTRICALSS PVT bajuriye mu Rukiko rw’Ubugurire bavuga ko Urukiko Rukuru rw’Ubucuruzi rwirengagije gusuzuma ukwica amasezerano kwa EUCL n’uburiganya bwayo, kandi ko rutayitegetse kwishyura agaciro k’imirimo yose yakozwe, no gusubiza *performance guarantee*, ntirwanabagenera indishyi zitandukanye basaba n’amafaranga y’igihembo cya Avoka.

EUCL yireguye ivuga ko itishe amasezerano ahubwo ko yishwe n’abajuriye kuko ntaho yari itegegetse kwemeza ibyo bakoze ko ahubwo yari kujya ibisura. Yongeye kandi ivuga ko ikibazo cyaje kuba aho abajuriye nanone batatanze konti yo kwishyurirwaho nk’uko byari bitegeanyijwe mu masezerano aho bagahimba indi konti yo mu yindi banki byatumye banki yagombaga gutanga “letter of credit” itayitanga kuko nta mafaranga yariho.

Kubijyanye n’uburiganya, EUCL yireguye ivuga ko ntabwo yakozwe kuko kuba yarizaniye “transformer” byaturutse ku kibazo abajuriye bagiranye na banki yagombaga kubaha amafaranga yo kuyigura amasezerano akarinda arangira ntayaratangwa.

Ku ngingo ijyanye no gusubizwa amafaranga y’imirimo yakozwe EUCL yireguye ivuga ko EUCL itasabwa kwishyura amafaranga basaba bavuga kandi batabitangira ibimenyetso.

Kubijyanye na “performance guarantee”, EUCL yireguye ivuga ko iyi mpamvu y’ubujurire nta shingiro ifite, kuko ingingo ya 17 y’amasezerano itanga igisubizo cy’uko aya mafaranga yagombaga gufatirwa kuko abajuriye batubahirije amasezerano.

Ku kibazo cy’indishyi zasabwaga n’abajuriye, EUCL yireguye ivuga ko nta shingiro zifite kuko ari bo bananiwe kubahiriza amasezerano kandi ari bo bishoye mu manza z’amaherere, bityo ko batari kuzihabwa.

EUCL nayo yatanze ubujurire bwuririye ku bundi isaba indishyi zo gushorwa mu manza n’igombo yagize. Abajuriye nabo biregura bavuga ko nta shingiro yazo kuko indishyi EUCL isaba zidakwiye kuko ari yo yatumye uru rubanza rubaho.

Bityo, ibyo MICON REAL LINE Ltd BHAVAN ELECTRICALS PVT bavuga ko EUCL ari yo yatinze kubyemeza nta shingiro byahabwa, kuko niba hari ibyo batangaga hanyuma EUCL ikabaha ibigomba gukosorwa (*comments*) mu minsi itarenze icumi (10) kandi nabo bakavuga ko bagiye kubikosora kugeza ubwo zemejwe ku wa 06/10/2018, ntaho bahera bavuga ko EUCL yamaze iminsi mirongo ine n’ibiri (42) itabasubiza kuko iyo babikosora vuba cyangwa se bakabikora neza bitari gufata iyo minsi 42.

2. Ntibyitwa uburiganya mu masezerano mu gihe uwatanze isoko aguze ku ruganda ibyari byarakoreshejwe n’uwatsindiye isoko mu gihe yananiwe gusohoza inshingano ze ku gihe cyari giteganyijwe mu masezerano, kandi mu gihe cyo kubigura akaba nta masezerano yari afitanye nawe. Bityo, kuba EUCL yarafashe umwanzuro wo gusaba IMP POWERS kuyigemurira *transformer*, ni kuko MICON REAL LINE Ltd-BHAVAN ELECTRICALS PVT bari bananiwe gusohoza inshingano biyemeje zo kuyigemura mu gihe cyateganyijwe. Byongeye kandi nuko ntaho MICON REAL LINE Ltd-BHAVAN ELECTRICALS PVT Ltd bagaragaza ko mu mpamvu

zatumye batubahiriza amasezerano bari bafitanye na EUCL kugeza kuri 27/02/2021, hari aho IMP POWERS yayinaniye ku birebana no kugemura iyo *transformer* biturutse kuri EUCL.

3. Amafaranga agomba gusubizwa MICON REAL LINE Ltd-BHAVAN ELECTRICALS PVT Ltd ari ayo bafitiye ibimenyetso kandi yakoreshejwe mu rwego ryo gushyira mu bikorwa amasezerano. Bityo, bakaba bagomba gusubizwa **162.880 USD, 2.677.980 Frw na 28.856 Rupees.**

4. Uwatsindiye ntiyasaba gusubizwa ingwate yo kurangiza neza isoko mu gihe atubahirije ibyari bikubiye mu masezerano yagiranye n'uwatanze isoko bijyanye no kumushyikiriza cyangwa kumwegurira ibyo yiyemeje kumukorera. Kuba MICON REAL LINE Ltd-BHAVAN ELECTRICALS PVT Ltd batari bujuje ibisabwa n'ingingo ya 17.4 y'amasezerano bagiranye ntiyari gutuma basubizwa *performance guarantee*, bityo ubujurire byabo kuri iyi ngingo, nta shingiro bufite.

[5] Ku birebana n'imirimu MICON REAL LINE Ltd-BHAVAN ELECTRICALS PVT bavuga ko bakoze kandi bagomba kwishyurwa, Urukiko Rukuru rw'Ubucuruzi rwasanze koko hari imirimu yakozwe ahari gushyirwa *transformer* ifite agaciro ka 60.806 USD, ariko bakaba batagomba kuyishyurwa kuko ayo madolari ari muni y'ayo bahawe nka avansi angana na 189.000 USD. Ku byerekeranye no gusubizwa amafaranga ya *performance guarantee*, Urukiko Rukuru rw'Ubucuruzi rwasanze nta mpamvu yo gusubiza abahawe isoko iyo ngwate, kuko batubahirije inshingano zabo, maze rwanzura ko ubujurire bwatanzwe na MICON REAL LINE Ltd - BHAVAN ELECTRICALS PVT Ltd bufite ishingiro kuri bimwe, kandi ko nta ndishyi zigomba gutangwa kuko buri ruhande mu baburanyi rutubahirije zimwe mu nshingano zarwo z'amasezerano bagiranye.

[7] Urubanza rwatangiye kuburanishwa mu ruhame ku wa 21/01/2020, MICON REAL LINE Ltd-BHAVAN ELECTRICALS PVT bahagarariwe na GACINYA Chance Denys, bakunganirwa na Me Safari Kizito hamwe na Me Uwamahoro Marie Grâce, naho EUCL ihagarariwe na Me Ngilishuti Jean Bosco, uwo muni Urukiko ruburanisha ku nzitizi y'iburabubasha yatanzwe na EUCL ivuga ko abajuriye batsinzwe mu nkiko zombi zabanje hashingiwe ku mpamvu zimwe, bityo ko ubujurire bwabo butagomba kwakirwa.

[8] Ku wa 31/01/2020, Urukiko rw'Ubujurire rwaciye urubanza rubanziriza urundi, rwemeza ko inzitizi yatanzwe na EUCL nta shingiro ifite, rutegeka ko iburanisha rizakomeza ku wa 25/03/2020, kuva icyo gihe urubanza rugenda rusubikwa ku mpamvu zitandukanye.

[9] Iburanisha mu ruhame ryasubukuwe ku wa 15/07/2020, ababuranyi bahagarariwe kandi bunganiwe nka mbere, uwo muni abajuriye babwira Urukiko ko impamvu z'ubujurire zabo

zikubiye mu ngingo enye, ari zo: 1° kuba Urukiko rwarirengagije gusuzuma kwica amasezerano kwa EUCL n'uburiganya bwayo, 2° kuba rutarategetse ko EUCL yishyura agaciro k'imirimo yose yakozwe, 3° kuba rutarategetse ko abajuriye basubizwa *performance guarantee*, no kuba rutarategetse ko bagenerwa indishyi n'igihembo cya Avoka.

Uwo muni ugeze, urubanza rwarimuwe, ariko Abavoka b'impande zombi bacibwa ihazabu mbonezamubano kubera gutinza urubanza.

[12] Gacinya Chance Denys n'umwunganizi we, Me Safari Kizito, bavuga ko sosiyete MICON REAL LINE Ltd-BHAVAN ELECTRICALS PVT zapiganiwe isoko ryo kuzana no gushinga kuri *substation* ya Mont Kigali "*Transformer 20 MVA*" n'ibikoresho bijyanye nayo (*accessories*) ryatanzwe na EUCL, nyuma basinyana amasezerano ku wa 11/07/2016 ndetse bakorana inama ku wa 27/07/2016, muri iyo nama bemeranya ko abatsindiye isoko bazajya bamenyesha EUCL ikintu cyose kigiye gukorwa mu gihe cy'iminsi icumi (10) ikabemerera kugikora (*approval*) nk'uko bikubiye no mu masezerano impande zombi, nyamara ko EUCL itabyubahirije kuko yabakerejeho iminsi 123 yose nk'uko byanemejwe n'Urukiko Rukuru rw'Ubucuruzi, bituma batarangiza isoko bari batsindiye; bakaba bumva EUCL igomba kubiryoza, ariko ko Urukiko Rukuru rw'Ubucuruzi rwabyirengagije.

[13] Bakomeza bavuga ko ku birebana na *transformer*, ku wa 04/08/2016 bamenyesheje EUCL uruganda ruzayikora rwo mu Buhinde, babemerera ku wa 06/10/2016, nyuma itangira gukorwa ndetse ku wa 25/01/2017 bajyana n'abakozi ba EUCL kuyisura kuko bari barumvikanye ko EUCL ishobora kugenzura ibikoresho kugira ngo bizaze bimeze neza, basanga imashini yubatswe neza, impande zombi zirabisinyira, ndetse ikaba yarashyizwe ahari hataganyijwe ko izaterekwa kuri Mont Kigali.

[14] Bavuga ariko ko n'ubwo EUCL yasuye *transformer* igasanga yarakozwe neza, yakoze uburiganya bwo kubaca inyuma ibuza ECOBANK Ltd gukora LC (Letter of Credit) yagombaga kwifashishwa mu kwishyura uruganda IMP POWERS rwari rwakozwe iyo mashini, ECOBANK Ltd nayo kugira ngo ibishyire mu bikorwa isaba abajuriye ko mbere yo kwishyura igomba kubona *approvals* ziturutse muri EUCL kuri *accessories* na *transformer*, nyamara uregwa yanga kuzikora kubera uburiganya, bikaba byumvikana ko IMP POWERS itari kurekura *transformer* itishyuye. Bavuga ko muri ubwo buriganya bwa EUCL, bamaze kubuza ECOBANK Ltd kwishyura uruganda

IMP POWERS yatangiye kugirana imishyikirano na EUCL iyisaba ko bakwikoranira imashini bakayizanira ku giti cyayo yirengagije ko hari *avance* bari baratanze, bababwira ko Bank itakwishyura EUCL idatanze uburenganzira, ibi bikaba bigaragazwa n'ubutumwa butandukanye bohererezanyaga.

[15] Me Ngilinshuti Jean Bosco avuga ko amasezerano EUCL yagiranye na MICON REAL LINE Ltd-BHAVAN ELECTRICALS PVT yagombaga kurangira ku wa 26/02/2017, akaba anateganya Banki yagombaga gucishwaho amafaranga, ko ikibazo cyavutse ubwo Gacinya Chance Denys yahabwaga avansi yari yasabye ya 20% ihwanye na 189.562 USD atanga na konti yagombaga kunyuzwaho amadolari muri ECOBANK Ltd, ariko ko nyuma yahimbye indi yafunguye muri GT Bank Ltd aba ariho ayo madolari acishwa, nuko ECOBANK Ltd yanga gukora *Letter of Credit* nk'uko bari babisezeranye, ari nacyo cyatumye aregwa mu rubanza nshinjabyaha.

[16] Ku birebana na *approvals* z'ibyagombaga gukorwa, Me Ngilinshuti Jean Bosco avuga ko zitari ziteganyijwe mu masezerano ndetse ko zitari na ngombwa, cyane cyane ku birebana na *accessories*, kuko byari bizwi ko isoko rigamije kuzana *transformer* na *accessories* zayo, nk'uko binagaragarira mu ibaruwa yo ku wa 25/04/2017, ko ahubwo EUCL yagombaga gusura ibikoresho byakozwe, kandi ko no mu nama yo ku wa 14/02/2017, Gacinya Chance Denys, uhagarariye MICON REAL LINE Ltd-BHAVAN ELECTRICALS PVT yavuze ko ibyo bikoresho byaje, ko mu minsi 25 bizaba bigeze i Dar-es-Salam, ibivugwa ko hari inama yemeje *approval* z'ibyagombaga gukorwa, bikaba nta gaciro byahabwa kuko inyandikomvugo y'inama idasimbura amasezerano, kandi ko abatsindiye isoko bataburanisha *approvals* mu gihe biyemereye ko *transformer* na *accessories* zayo babyohereje.

[17] Ku byerekeranye n'uko EUCL yaba yarakoze uburiganya ibuza ECOBANK Ltd gutanga amafaranga, Me Ngilinshuti Jean Bosco avuga ko ibibazo byabaye hagati y'abatsindiye isoko n'iyi Banki nta ruhare EUCL yabigizemo, kandi ko byaturutse kuri Gacinya Chance Denys wafunguye indi konti muri GT Bank Ltd, ECOBANK Ltd ikabura amafaranga yagombaga kujya kuri konti yayo, nyamara yari azi ko bitari byemewe gushaka uwo nawe yaha isoko (subcontractor) batabanje kubyumvikanaho, EUCL ikaba rero nta kosa yakoze mu kwizanira *Transformer* kuko itayibye.

A. Kumenya uruhande rwaba rwarishe amasezerano
