**Incamake y'ikibazo:** Uru rubanza rwatangiriye mu Rukiko Rwisumbuye rwa Nyarugenge, Habyarimana aregwa ko ubwo yari mu nzego z'ubuyobozi bw'ishyaka rya MRND ku rwego rwa Perefegitura y'Umujyi wa Kigali yakoze ibyaha bigamije gucira umugambi, gutegura, gushishikariza abandi, kugenzura no kuyobora jenocide cyangwa ibindi byaha byibasiye inyokomuntu. Uru rukiko rwemeje ko ahamwa n'ibikorwa byo gushishikariza, kurema umutwe w'abagizi ba nabi no kuyobora za bariyeri ziciweho abatutsi hagamijwe gukora icyaha cya jenocide n'ibyaha byibasiye inyoko muntu. Ku kijyanye n'inzitizi yari yatanze yo kuba yarafunzwe mu buryo bunyuranyije n'amategeko, Urukiko rwemeje ko itahabwa agaciro kuko yayitanze mu buryo budakurikije amategeko, rumuhanisha igifungo cya burundu y'umwihariko.

Uregwa yajuririye Urukiko Rukuru, Urugereko Rwihariye ruburanisha ibyaha mpuzamahanga n'ibyaha byambuka imbibe avuga ko Urukiko rwabanje rwirengagije ko yafunzwe mu buryo bunyuranyije n'amategeko, rumuburanisha atunganiwe, kandi ko rwaburanishije urubanza mu mizi rutabanje gusuzuma inzitizi yatanze. Urukiko Rukuru rwemeje ko iyo nzitizi yagombaga kubanza gusuzumwa ariko ko kuri uru rwego rw'ubujurire rutayisuzuma kuko urubanza mu mizi rwamaze gucibwa.

Ku bijyanye n'ibirego bishya Uregwa yasabaga ko bitasuzumwa kuko byazanywe mu bujurire n'Ubushinjacyaha kandi bitari mu mbibi z'ibyajuririwe, Urukiko Rukuru rwasanze ibikubiye mu bimenyetso byatanzwe n'Ubushinjacyaha biri mu mbibi z'ubujurire bwe kuko birebana n'uruhare rwe nk'umwe mu bayobozi b'ishyaka rya MRND mu kwitabira inama zitegura jenocide, gutoranya uruburiko, kuruha imyitozo n'ibikoresho, bikaba atari ibirego bishya uretse uruhare rwe mu ishingwa rya radiyo RTLM rutagomba gusuzumwa kuko ataruzwe ku rwego rwa mbere. Bityo, rwemeza ko ahamwa n'icyaha cy'ubwumvikane bugamije gukora jenocide n'icyo kuba icyitso cy'abakoze jenocide kubera gushishikariza gukora jenocide no gutanga intwari zakoreshejwe jenocide, ariko ko adahamwa no kuyobora za bariyeri ziciweho abatutsi yahamijwe n'Urukiko Rwisumbuye, ruhamishaho igihano cy'igifungo cya burundu y'umwihariko yahanishijwe ku rwego rwa mbere.

Ibi byatumye ajuririra Urukiko rw'Ikirenga ariko urubanza rwe rwoherezwa mu Rukiko rw'ubujurire kubera impinduka zakozwe mu rwego rw'ubucamanza, hagashyirwaho uru Rukiko. Mu bujurire bwe yakomeje agaragaza ko yafunzwe mu buryo bunyuranyije n'amategeko ariko Ubushinjacyaha bugasobanura ko adafunzwe muri ubwo buryo kuko yahanishijwe igifungo cya burundu y'umwihariko, kuba icyo cyemezo cyarafashwe hatagaragajwe itegeko ryashingiweho ntacyo bihindura dore ko ari ikibazo cy'imyandikire y'urubanza atari ibigize inenge yarwo.

4. Nubwo kidateganyijwe mu mategeko y'u Rwanda, icyaha cy'ubwumvikane bugamije gukora jenocide ni icyaha cyo gucura umugambi wo gukora jenocide.

## Urubanza

### I. IMITERERE Y'URUBANZA

[1] Habyarimana Jean yari Perezida w'ishyaka rya MRND (*Mouvement Révolutionnaire National pour le Développement*) muri Perefegitura y'Umujyi wa Kigali, akaba n'umwe mu bari bagize Biro Politiki (*Bureau Politique*) y'iryo shyaka ku rwego rw'igihugu. Aregwa ko ubwo yari mu nzego z'ubuyobozi bw'ishyaka rya MRND ku rwego rwa Perefegitura y'Umujyi wa Kigali yakoze ibyaha bigamije gucura umugambi, gutegura, gushishikariza abandi, kugenzura no kuyobora jenocide cyangwa ibindi byaha byibasiye inyokomuntu, by'umwihariko kurema umutwe w'abagizi ba nabi atoranya uruburiko rwo guha imyitoto ya gisirikare, akanaruka ibikoresho byicishijwe abatutsi, kujya mu nama zitegura jenocide, kugenzura za bariyeri ziva Nyabugogo ku isoko kugeza ku Muhima ku ishuli rya APACOPE, ari naho hiciwe abantu benshi barimo uwitwa Rutayisire alias Tigana.

[2] Urubanza rwatangiriye mu Rukiko Rwisumbuye rwa Nyarugenge, ku itariki ya 01/03/2016, uru Rukiko ruca urubanza RP GEN 0002/15/TGI/NYGE rwemeza ko Habyarimana Jean ahamwa n'ibikorwa byo gushishikariza, kurema umutwe w'abagizi ba nabi no kuyobora za bariyeri ziciweho abatutsi hagamijwe gukora icyaha cya jenocide n'ibyaha byibasiye inyokomuntu, ruvuga ko inzitizi irebana no gufungwa mu buryo bunyuranyije n'amategeko yari yatanze na Habyarimana Jean itahabwa agaciro kuko yayitanze mu buryo budakurikije amategeko, rumuhanisha igifungo cya burundu y'umwihariko.

[3] Habyarimana Jean ntiyishimiye imikirize y'urubanza, ajuririra Urukiko Rukuru Urugereko Rwihariye ruburanisha ibyaha mpuzamahanga n'ibyaha byambuka imbibi<sup>1</sup>, avuga ko Urukiko Rwisumbuye rwirengagije ko yafunzwe mu buryo bunyuranyije n'amategeko, ko rwamuburanishije atunganiwe, kandi ko rwaburanishije urubanza mu mizi rutabanje gusuzuma inzitizi yatanze.

[4] Mu bujirire bwe kandi, Habyarimana Jean yavugaga ko Urukiko Rwisumbuye rwirengagije ko atari gukurikiranwaho icyaha cyo kurema umutwe w'abagizi ba nabi kubera ko cyashaje, ko yahamijwe ibyaha hashingiwe ku buhama budafatika, bwashatswe hagamijwe kumuhama ibyaha ndetse ko ababutanze batahamagawe mu Rukiko, kandi ko Urukiko rwanze ko Ubushinjacyaha buzana zimwe mu nyandiko zimurenganura zirimo inyandikomvugo y'iburanisha ku ifunga n'ifungurwa ry'agateganyo n'iperereza ryakozwe n'Ubushinjacyaha mu murenge wa Muhima.

[6] Ku birebana n'ibirego bishya Habyarimana Jean yavugaga ko Ubushinjacyaha bwazanye mu bujirire, avuga ko bitari mu mbizi z'ibyajuririwe, agasaba ko bitasuzumwa, muri byo akavuga inama aregwa ko yakoranye na Renzaho Tharcisse mu rwego rwo gutegura jenocide, uruhare rw'ishyaka rya MRND mu gutegura jenocide, kuba mu bashinze radiyo RTL (Radio Télévision Libre des Mille Collines) no kuyobora ibitero hirya no hino mu gihugu uretse ku Muhima, Urukiko rwasanze ibikubiye

[11] Habyarimana Jean na Me Nyirihirwe Hilaire, umwunganira, bavuga ko mu gika cya 12 cy'urubanza rwajuririwe muri uru Rukiko, Urukiko Rukuru rwasanze Urukiko Rwisumbuye rwa Nyarugenge rwaragombaga kubanza gukemura inzitizi Habyarimana Jean yari yatanze ku rwego rwa mbere irebana n'uko yafunzwe mu buryo bunyuranyije n'amategeko mbere yo kuburanisha urubanza mu mizi nk'uko byateganywaga n'ingingo ya 105, igika cya 3, y'Itegeko N° 30/2013 ryo ku wa 24/05/2013 ryerekeye imiburanishirize y'imanza z'inshinjabyaha ryakurikizwaga igihe urubanza rwaburanishwaga, ariko ko urwo Rukiko Rukuru rutakosoye iyo nenge, ko ahubwo rwasobanuye ko ntacyo rwabikoraho kuko afunzwe hashingiwe ku rubanza rwamukatiye igifungo cya burundu y'umwihariko, maze ruhita ruburanisha urubanza mu mizi rutabanje gufata icyemezo kuri iyo nzitizi, kandi ko rutagaragaje amategeko rwashingiyeho rufata icyo cyemezo. Basaba uru Rukiko ko rwafata icyemezo kuri iyo nzitizi kugira ngo Habyarimana Jean afungurwe by'agateganyo mbere y'icibwa ry'urubanza mu mizi.

[12] Habyarimana Jean asobanura ko yafashwe ku wa 20/12/1996, hashingiwe ku rutonde rw'abakoze icyaha cya jenocide yakorewe Abatutsi mu mwaka wa 1994, afungirwa muri Gereza ku wa 12/03/1997, ko ku wa 02/04/1997 yakorewe inyandiko imufunga by'agateganyo (MAP)<sup>4</sup>, ariko ko atigeze ashidikirizwa umucamanza kugira ngo amufatire icyemezo kimufunga by'agateganyo, ko ahubwo mu mwaka wa 2009, aribwo yamenye ko atagira dosiye, nyamara uwari Umuyobozi wa Gereza witwa Gahima Rusa n'uwari Porokireri ku Rwego Rwisumbuye witwa Ndibwami Rugambwa bakomeje kumufunga mu buryo bunyuranyije n'amategeko bashingiye ku nyandiko zimufunga by'agateganyo zataye agaciro bituma agira igihombo gikomere n'iyicarubozo ryo mu bwoko (*Torture psychologique*) kuko yahatiwe kwemera ibyaha atakoze no kubishinje bagenzi be, kuvutswa uburenganzira n'amahirwe yo kuburana adafunzwe no kubona umwunganizi, ariko ko azabitangira ikirego cyihariye mu Rukiko rubifitiye ububasha kugira ngo abo bayobozi bamufunze mu buryo bunyuranyije n'amategeko mu gihe cy'imyaka 20 yose bazabihanirwe n'amategeko banabimuhere indishyi kabone n'ubwo zaba ari symbolique.

[13] Habyarimana Jean n'umwunganira bavuga ko hashingiwe ku ngingo ya 78, 8° na 96, igika cya 3, z'Itegeko N° 027/2019 ryo ku wa 19/09/2019 ryerekeye imiburanishirize y'imanza z'inshinjabyaha, akwiye gufungurwa by'agateganyo mbere y'icibwa ry'uru rubanza kuko nta cyemezo cy'umucamanza kimufunga by'agateganyo cyigeze gikorwa, kandi ko agifatwa nk'umwewe nk'uko biteganywa n'ingingo ya 19 y'Itegeko Nshinga rya Repubulika y'u Rwanda. Basaba uru Rukiko ko rwazashingira ku rubanza RP 00036/2017/HC/KIG rwaciwe n'Urukiko Rukuru, ku wa 06/12/2018, Ubushinjacyaha buburana na Nshimiyimana Diane Rwigara na Mukangemanyi Adeline Rwigara, kuko urwo Rukiko rwarekuye abaregwa kandi bari bafunzwe by'agateganyo.

[14] Uhagarariye Ubushinjacya avuga ko Habyarimana Jean adafunzwe mu buryo bunyuranyije n'amategeko kuko yahanishijwe igifungo cya burundu y'umwihariko nk'uko n'Urukiko Rukuru rwabisobanuye mu gika cya 12 cy'urubanza rujuririrwa, ko kuba umucamanza w'urwo Rukiko ataragaragaje ingingo z'Itegeko yashingiyeho afata icyo cyemezo kijyanye n'uko adafunzwe mu buryo bunyuranyije n'amategeko, ari uburyo bw'imyandikire y'urubanza ariko bitagize inenge yarwo.

[15] Avuga kandi ko hatashingirwa ku ngingo ya 96, igika cya 3, y'Itegeko N° 027/2019 ryo ku wa 19/09/2019 ryerekeye imiburanishirize y'imanza z'inshinjabyaha, kuko Habyarimana Jean atajuririye icyemezo kimufunga by'agateganyo, kandi ko no mu Rukiko Rukuru, Habyarimana Jean atari agifunze by'agateganyo, ko ahubwo yajuririye urubanza rwaciwe ku rwego rwa kabiri rwamuhanishije igifungo cya burundu y'umwihariko, bivuze rero ko agomba kuguma muri "situation" yo gufungwa yashyizwemo n'inkiko zabanje, maze akaburana ubujurire bwe bwa kabiri afunze nk'uko biteganywa

[47] Na none ingingo ya 65 y'Itegeko ryavuzwe haruguru, iteganya ko Urukiko ari rwo rwonyine rupima ko imikirize y'abatangabuhamya ihuye n'ikiburanwa, ko ifite ingingo zikiranuye kandi ko ikiye kwemerwa cyangwa guhakanwa, ko rutitsitsa ku mubare w'abatangabuhamya, ko ahubwo rwita cyane cyane ku bumenyi bwabo bw'ibyabaye, no ku buryo babivuga uko byagenze nta cyo bihimbirira.

[58] Habyarimana Jean yunganiwe na Me Nyirihirwe Hilaire avugaga ko hari ubuhamya bumushinjura Urukiko Rukuru rutahaye agaciro, muri bwo hakaba harimo ubuhamya bwa Setiba Joseph wari Perezida w’Interahamwe muri Segiteri ya Kigali wavuze ko uwitwa Turatsinze Jean Pierre ari we wayoboraga interahamwe muri Kigali Ngali, kandi ko ari we wakumiriye interahamwe ubwo zari zigiyeye gutera iwe zishakaga abatutsi yari yarahishe, akanasobanura ko intwari zahabwaga izo nterahamwe zatangirwaga ku Kigo cya gisirikare ahakorerwaga imyitoto; bivuze ko rero atari we wazitangaga nk’uko yabirezwe.

[59] Akomeza avugaga ko undi mutangabuhamya wiswe HJD wari Perezida w’Interahamwe muri Segiteri ya Nyakabanda yatumiye kugira ngo aze amushinjura ku birebana n’ubuhamya bwari bwatanze n’umutangabuhamya HJC, uyu akaba yari interahamwe yamamaye nk’uko byemejwe n’umutangabuhamya wiswe ALJ mu Rukiko Mpanabyaha Mpuzamahanga rwashyiriweho u Rwanda na HJE mu Rukiko Rukuru, mu buhamya bwa HJC akaba yari yemeje ko ku wa 15/05/1994 habaye inama yo guhiga abatutsi bari basigaye muri za Segiteri na za Nyumbakumi yari iyobowe na Renzaho Tharcisse; nyamara Urukiko Rukuru rukaba rutarahaye agaciro ubuhamya bw’uyu HJD wavuze ko iyo nama yo ku wa 15/05/1994 ntayabaye, ko ahubwo ku wa 20/05/1994 ari bwo habaye inama ku ishuri

[60] Habyarimana Jean avuga ko ubundi buhamya butitaweho n'Urukiko Rukuru ari ubw'uwitwa Mucanda Vital wavuze ko ari we (Habyarimana Jean) wakiraga inama na za mitingi (*meetings*) kandi ko zabaga zirimo abahutu, abatutsi n'abatwa, nyamara ibyo yavuze urwo Rukiko rukaba rwarabyirengagije mu gufata icyemezo.

[61] Ku byerekeye inama yo ku wa 16/01/1994; Habyarimana Jean asobanura ko nyuma y'uko FPR iteye habayeho urwicyekwe hagati y'abahutu n'abatutsi, hakaba hari n'ikindi kibazo gikomeye cy'abakiga n'abanyenduga, ndetse no guhangana gushingiye ku Turere hagati y'ishyaka rya MDR rya Kayibanda na MRND ya Habyarimana, iyi nama rero ikaba yari igamije kubwira interahamwe ko zigomba kwitonda. [62] Me Nyirihirwe Hilaire wunganira Habyarimana Jean avuga ko muri ubwo buhamya bushinjura Habyarimana Jean, abatangabuhamya bagaragaje ko atari we wagize uruhare muri za mitingi zo gukangurira abahutu kwica abatutsi no mu itegurwa rya jenocide, ko Ubushinjacyaha butabasha gutanga ibimenyetso bigaragaza ko Habyarimana Jean yagize uruhare mu gushishikariza abahutu n'interahamwe gukora jenocide yakorewe abatutsi, maze asaba ko bugaragaza cassette, extrait cyangwa ubuhamya bwanditse byerekana uruhare rwe ku buryo bufatika. Avuga na none ko uwo yunganira yahamijwe ko yari mu nama yabereye kuri stade ya Nyamirambo ishishikariza abahutu kwica abatutsi, nyamara icyo yari igamije ari ukwamagana urupfu rwa Ndadaye wari Perezida w'u Burundi ndetse ko Habyarimana adahakana ko yari ayirimo kandi ko yafashemo ijambo, ko ariko yari agamije guhumuriza abantu muri rusange no guhosha insoresore zari zitangiye gukora ibikorwa bibi.

[63] Uhagarariye Ubushinjacyaha avuga ko imvugo za Setiba Joseph zivuguruzanya n'iz'abandi batangabuhamya, harimo HJE, HJA ndetse n'iza Habyarimana Jean ubwe nk'uko bigaragara mu bika bya [69] kugeza kuri [77] by'urubanza rwajuririwe, aho Urukiko Rukuru rwagiye rugaragaza impamvu rutahaye agaciro imvugo z'abatangabuhamya, kandi ko bitumvikana ukuntu Setiba Joseph wari watangariye Ubushinjacyaha ko atazi Habyarimana Jean, ubwo bwamubazaga bumusanze muri Gereza yageze mu Rukiko akavuga ko amuzi kandi ko nta kibi yakoze muri jenocide yakorewe abatutsi, ko rero uku kwivuguruzanya ari ko kwatumye Urukiko Rukuru rudashingira ku buhamya bwe.

ryabagamo interahamwe, kwemeza ko atagize uruhare mu itangwa ry'intworo zakoreshejwe jenoside byaba ari ukubeshya kuko yahuraga kenshi n'abandi bayobozi muri gahunda zose, harimo n'aba gisirikare.

[66] Uhagarariye Ubushinjacyaha avuga ko amagambo Habyarimana Jean yavugiye muri “*meeting*” yo ku wa 23/10/1993 n'iyo ku wa 16/01/1994 akangurira abahutu kwishyira hamwe ngo barwanye umwanzi agaragara mu bika bya [521], [522], [514], [517], [518] na [519] by'urubanza rwa Karemera Edouard na Matayo Ngirumpatse naho mu gika cya [524] cy'urwo rubanza ho hakaba hagaragara aho yavugiye ibyerekeye idéologie hutu power. Avuga ko muri meeting yo ku wa 16/01/1994 nk'uko bigaragara by'umwihariko mu bika bya [573] na [574], Habyarimana Jean yavuze ko agiye gutanga inyandiko igaragaza ikibazo kiri hagati y'abahutu n'abatutsi n'uburyo bwo gukosora umwanzi ari we mututsi. Uhagarariye Ubushinjacyaha avuga kandi ko umutangabuhamya HJC ari we wasobanuye ko Conseiller Karushara Rose yasabye imbunda mu nama bari barimo, nyamara Habyarimana Jean akaba ataramuvugurije, bivuze ko yari ashigikiye ibyo yavuze; ibi bikaba bigaragaza uruhare rwe mu bikorwa byo gushishikariza abantu gukora jenoside no kubashyigikira.

[68] Dosiye igaragaza ko mu rubanza rwajuririwe, Setiba Joseph, HJD na Mucanda Vital bemeje ko nta mikoranire yari hagati y'interahamwe n'ubuyobozi bw'ishyaka rya MRND, ko nta n'umuyobozi w'ishyaka rya MRND wagize uruhare mu gikorwa cyo gutoranya urubyiruko rwatojwe ibya gisirikare, Urukiko Rukuru rukaba rwaremeje ko izo mvugo nta shingiro zifite, kuko nabo ubwabo bemeza ko hari ibikorwa interahamwe zahuriragamo n'abayobozi ba MRND birimo za meeting, kurindira umutekano abarwanashyaka bazirimo, imyigaragambyo no gushishikariza urubyiruko kujya mu ishyaka rya MRND<sup>19</sup>.

Ku birebana n'imyitoto n'imbunda byahabwaga interahamwe, Setiba Joseph yavuze ko byari bishinzwe abasirikare ari nabo babajyanaga i Gabiro, kandi ko nta muyobozi n'umwe w'ishyaka wabaga ahari.

Yavuze ko ntaho bahuriraga na Habyarimana Jean, uretse mu myigaragambyo no muri za mitingi, ko atageraga mu nama zabo, aho yibuka bahuriye akaba ari muri mitingi yabereye i Nyamirambo mu mwaka wa 1993, akaba yaranayifashemo ijamba avuga ko ari abatwa, abatutsi, n'abahutu bagomba kumenya ko umwanzi w'u Rwanda ari nawe mwanzi w'u Burundi, ko bose bamaganye iyicwa rya Perezida Ndadaye.

[92] Ubushinjacyaha buvuga ko uru rubanza rwa Ngirumpatse Matayo na Karemera rutarengera Habyarimana Jean kuko adakurikiranyweho kuba yari umuyobozi w'Interahamwe, ko ahubwo ariyozwa uruhare yagize mu ishyirwaho ry'uwo mutwe no kuwutoza ibya gisirikare hagamijwe kurimbura abatutsi nk'uko byemejwe n'abatangabuhamya.

[107] Urukiko rw'Ubujurire rurasanga rero Habyarimana Jean ahamwa n'ibyaha byose uko ari bitatu, aribyo gucura umugambi wo gukora jenocide, kuba icyitso mu gukora jenocide no gushishikariza gukora jenocide, bikaba bigize impurirane mbonezamugambi nk'uko isobanurwa mu ngingo ya 84 y'Itegeko-Ngenga N° 01/2012/OL ryo ku wa 02/05/2012 ryibukijwe haruguru<sup>44</sup> kubera ko byose byakozwe mu mugambi umwe wo gukora jenocide, bityo Habyarimana Jean akaba agomba guhanishwa igihano cy'igifungo cya burundu giteganyirijwe ibyo byaha, aho kuba igifungo cya burundu y'umwihariko yari yahanishijwe n'Urukiko Rukuru kuko icyo gihano kitateganyijwe ma mategeko y'u Rwanda hashingiwe ku ngingo ya 26 y'Itegeko N° 68/2018 ryo ku wa 30/8/2018 riteganya ibyaha n'ibihano muri rusange.<sup>45</sup>

[108] Hakurikijwe ibisobanuro bitanzwe haruguru, Urukiko rw'Ubujurire rurasanga ubujurire bwa Habyarimana Jean nta shingiro bufite kuko nk'uko n'Urukiko Rukuru rwabibonye nta bimenyetso yatanze bivuguruzwa ibyashingiweho n'Urukiko Rukuru mu kumuhamya ibyo byaha, bityo urubanza RPA GEN 00002/16/HCCI rwaciwe n'Urukiko Rukuru ku wa 28/04/2017 rukaba rutagomba guhinduka, uretse gusa ku birebana n'inyito zari zahawe ibyaha Habyarimana Jean yahamijwe no ku birebana n'igihano.
