Indishyi – Igenwa ry’ indishyi zikomoka ku ikosa – Usaba indishyi kubera ibyo yangirijwe agomba kugaragaza ikosa yakorewe, ibyo yangirijwe, n’isano hagati y’ikosa n’ibyo yangirijwe.

Incamake y’ikibazo: Nyuma yaho Tukakira, Mutesi, Bayitake na Rubagumya bivurije kuri HOPITAL LA CROIX DU SUD bakabatera umuti wa *ndlr lidocaine 2%* ukabagiraho ingaruka mbi bareze ibyo bitaro mu Rukiko Rwisumbuye rwa Nyarugenge basaba gusubizwa amafaranga batanze bivuzwa uburwayi batewe nuwo muti, amatike bakoresheje bagiye kwivuza; guhabwa indishyi z’ububabare bagize bakimara guterwa umuti, iz’akababaro; iz’ikurikirana rubanza no gushorwa mu nkiko.

HOPITAL LA CROIX DU SUD yahamagaje mu rubanza SONARWA G.I.CO. Ltd nk’umwishingizi wayo ndetse na ABACUS Pharma Rwanda Ltd nkiyayigurishije umuti *ndlr lidocaine 2%* watewe abarega; Urukiko Rwisumbuye rwemeje ko ikirego cyabo gifite ishingiro kuri bimwe ko kandi umuti *ndlr lidocaine 2%* batewe wabagizeho ingaruka mbi ariko ko nta kosa ry’ubuganga ryakozwe na HOPITAL LA CROIX DU SUD ikoresha uwo muti bityo rero ko idakwiye kuryozwa indishyi zisabwa n’abaregwa ndetse ko SONARWA G.I.CO. Ltd nta nshingano ifite yo gutanga indishyi muri uru rubanza maze rutegeka ko ABACUS Pharma Rwanda Ltd ariyo ifite inshingano yo kuryozwa indishyi zose zisabwa muri uru rubanza kuko ariyo yagurishije umuti watewe abarega ukabagiraho ingaruka mbi.

Abarega bose kimwe na ABACUS Pharma Rwanda Ltd ntibishimiye imikirize y’urubanza bajuririra Urukiko Rukuru bavuga ko batemera uko indishyi zatanze n’uburyo zabazwe.

Mu Rukiko Rukuru hasuzumwe niba hari isano hagati yo guterwa *lidocaine 2% batch CM 4032* n’ingaruka mbi abayitewe bagize hamwe no kumenya niba indishyi zisabwa zigomba gutangwa.

ABACUS Pharma Rwanda Ltd yiregura ivuga ko Urukiko rubanza rwashingiye ku kuba harakoreshejwe *ndlr lidocaine 2%* itujuje ubuziranenge nyamara rwirengagiza ko niyo byaba aribyo koko hagomba kugaragazwa isano yaba iri hagati yo guterwa uwo muti uvugwa n’ingaruka mbi abayitewe bagize, ikomeza ivuga ko yagaragarije urukiko ibimenyetso byinshi byerekana ko harimo ugushidikanya kunini mu kwemeza ko ibibazo abareze bagize baba barabitewe na *lidocaine 2% batch CM 4032* bateweho ikinya.

Tukakira, Mutesi, Bayitake na Rubagumya bavuga ko Urukiko rutirengangije isano riri hagati y’uwacurujwe umuti n’uwo wagizeho ingaruka kandi ABACUS Pharma Rwanda Ltd igomba kwishingira ko ibicuruzwa byayo bifite ubuziranenge.

HOPITAL LA CROIX DU SUD ivuga ko abarega mu rwego rwa mbere bose bagize ikibazo bakimara kuvurwa, ibyo rero bigaragaza isano iri hagati n’umuti batewe kandi hari n’ibindi bimenyetso bigaragaza ko uwo muti batewe utujuje ubuziranenge bigizwe na raporo zitandukanye zakozwe *laboratoire* zinyuranye bityo rero ABACUS Pharma Rwanda Ltd niyo igomba kuryozwa ingaruka mbi zatewe nuwo muti.

Minisiteri y'ubuzima yabajijwe uko bigenda mu gihe umucuruzi wahawe uruhushya rwo gutumiza imiti azanye umuti utujuje ubuziranenge ivuga ko ariwe wirengera ingaruka zose zaterwa nuwo muti.

3. HOPITAL LA CROIX DU SUD ntiyaryozwa indishyi zogutererana abarega kuko nta kosa ry'ubuvuzi yakoze ahubwo amakosa yakozwe na ABACUS Pharma Rwanda Ltd kuko ariyo yagurishije umuti utujuje ubuziranenge.

4. Igihe ubujurire nta shingiro bufite indishyi zikurikirana rubanza n'igihembo cy'avoka ntizitangwa n'urukiko.

[5] Uhagarariye ABACUS Pharma Rwanda Ltd avuga ko Urukiko rwashingiye ku kuba hakoreshejwe *lidocaine 2%* yaba itujuje ubuziranenge, nyamara rwirengagiza ko niyo byaba ari byo koko (*lidocaine 2%* itujuje ubuziranenge) hagomba kugaragazwa isano (lien de causalité entre le dommage (préjudice) subi et la faute invoquée.) nk'uko rwari rwabigaragarijwe mu gihe cy'iburanisha ariko ntirubihe agaciro kandi binyuranije n'amahame y'ingenzi agenderwaho muri rusange nk'uko abahanga¹ (doctrine) babyemeza, kandi byaribukijwe urukiko mu gihe cy'iburanisha.

[6] Uhagarariye ABACUS Pharma Rwanda Ltd avuga ko mu isesengura ry'iyi ngingo kandi, urukiko rwirengagije nta mpamvu rugaragaje ibimenyetso byinshi byerekana ko harimo gushidikanya kunini mu kwemeza ko ibibazo abareze bagize baba barabitewe na *lidocaine 2% batch CM 4032* batewe nk' ikinya, kuko muri dosiye y'urukiko rubanza, hariho urutonde rwakozwe na ABACUS Pharma Rwanda Ltd rugaragaza aho umuti wagurishizwe mu gihugu cyose, kandi urukiko rwarabimeneshejwe, ariko mu mwanzuro warwo ntirwabiha agaciro nk'uko rwabyanzuye ruvuga ko : “ ...Kuba Me Viateur Mutanguha uburanira ABACUS avuga ko uwo muti wagurishijwe andi mavuliro n'ibitaro nti hagira ingaruka bitera, Urukiko rusanga nta shingiro byahabwa kuko atagaragariza urukiko aho uwo muti wakoreshejwe n'umuntu watewe uretse kubivuga gusa”. Aha rero basanga habayeho kwirengagiza nkana ibimenyetso urukiko rwari rwashyikirijwe kandi hari hagamijwe kwerekana ko hagombye kubaho gushidikanya mu kwemeza ko umuti *lidocaine 2% batch CM 4032* wateye ikibazo gusa ku bantu bane bivuriye mu bitaro bimwe (Hopital la Croix du Sud) ahatanze 100 fl mu gihe hagurishijwe mu gihugu cyose 4282 fl de 30ml.

[7] Ko nyuma y'uko ikibazo cyavugwaga muri Hopital la Croix du Sud kimenyekaniye, ABACUS Pharma Rwanda Ltd, mu rwego rwo gukumira (prévention), yasabye ko ibigo, ibitaro n'Amavuriro byose byaguze umuti *lidocaine 2% batch 4032* biwugarura, ariko Hopital ya Gitwe niyo yonyine yagaruye 50 fl kuri 69 fl yari yatwaye kandi nta kibazo yigeze ivuga ku barwayi bari barakoreshejweho 19 fl, zindi zigaragara kuri raporo yabyo. Kandi Hopital la Croix du Sud ubwayo yaguze 100 fl za *lidocaine 2% batch CM 4032*, nyamara ikibazo kimaze kuvugwa kuri uwo muti, nayo yasabwe kugarura *flacons* zari zisigaye zitakoreshwa ariko ntiyigeze ibikora ku buryo habaho kwibaza niba izindi zose zitaba zarakoreshejwe ariko ntizigire ingaruka mbi zitera. Kubera izo mpamvu zose rero, hashingiwe ku mahame (principes juridiques : « les mêmes causes produisent les mêmes effets - Eandem causam producunt effectus », « Cum hoc ergo prompter hoc- Même cause, même effet »), habaho gushidikanya gukomeye mu kwemeza ko umuti *lidocaine 2% batch CM 4032* wateye ingaruka mbi ku barwayi bane gusa ku bantu 8564 waba warakoreshejweho.

[8] Abahagarariye Tukakira Rugigana Deus, Mutesi Scola, Bayitake Angelique na Rubagumya Clinton Innocent bavuga ko Urukiko ntirwirengagije isano iri hagati y'uwarurujwe umuti n'uwo wagizeho ingaruka (causal link). Nukuvuga ko ABACUS PHARMA LTD igomba gutanga garantie ko ibicuruzwa byayo bifite ubuziranenge kandi ko uwabikoresha wese bitamugiraho ingaruka. Ubikoresha uwo ariwe wese bikamugiraho ingaruka, ABACUS PHARMA LTD igomba kwirengera izo ingaruka. Bityo basanga urukiko ntirwibeshye mu gihe rwafataga icyemezo cyo guca indishyi kuko ibisebe n'ibikomere byabarega bagize byakomotse k'umuti batewe wacurujwe na ABACUS PHARMA LTD.

[9] Abahagarariye Tukakira Rugigana Deus, Mutesi Scola, Bayitake Angelique na Rubagumya Clinton Innocent bavuga kandi ko ABACUS PHARMA LTD ubwayo yemera ko ariyo yacurujwe umuti wateye ikibazo ndetse nyuma yo kumenyeshwa ko umuti yacurujwe wateye ikibazo, yihutiye kuwuhamagaza ngo udakomeza gukwirakwizwa ku barwayi benshi; kandi yemera ko ariyo yacurujwe

subi ainsi que le lien de causalité entre la défectuosité du produit et la survenance du dommage. En effet, ce lien de causalité doit être certain.... La preuve du lien de causalité...admet la possibilité de recourir à des présomptions graves, précises et concordantes. Ces présomptions ne seront admises que si trois conditions sont réunies. En premier lieu, le fait doit pouvoir être matériellement une cause génératrice du dommage à l'égard des données acquises de la science. Egalement, il doit être hautement probable que le facteur ait été à l'origine du dommage. Enfin toutes les autres causes de possibles du dommage doivent avoir été exclues »

lidocaine 2% igakoreshwa kubarwayi nkikinya igatera ingaruka bagaragaje mu mafoto n'impapuro za muganga bigaragaza ko ariyo nyirabayazana kuko yacuruze umuti udafite ubuziranenge.

[10] Abahagarariye Hopital la Croix du Sud bavuga ko kuvuga ko icyemezo cy'urukiko kitagaragaza isano (lien de causalite) yaba iri hagati yo guterwa *lidocaine* 2% BATCH CM 40 32 n'ingaruka mbi bagize mukwiregura kwiyi ngingo, Hopital La Croix Du Sud irasanga ABACUS itarigeze izana inzobere mu byerekeye imiti kugirango avuguruzwe raporo yatanzwe na *laboratoire* yo mu Rwanda ndetse niyo hanze kugirango bibaye ngombwa abazwe n'urukiko cyangwa ababuranyi. Ikindi kuberekeye isano biragaragara ku rupapuro rwa mbere ya kopi y'urubanza mu gace kambere aho abarega bo mu rwego rwambere bose bavuga ko nyuma mu gihe gito bamaze kuvurwa bahitaga bagira ikibazo bikagaragaza isano n'umuti batewe. Ikindi n'ibimenyetso bigaragaza ko umuti wikinya utujuje ubuziranenge bikemezwa na ma raporo atandukanye: 1) Raporo ya mbere yo kuwa 15/04/2015 ya *laboratoire* ya Kaminuza y'u Rwanda, iyi *rapport* isoza igaragaza ko muri *physical chemico test* ku ngingo ya gatatu yitwa *Assay* umuti ufite 94.1 kandi ugomba kuba hagati 95.0% -105.0 % noneho *laboratoire* ikanzura ivuga ko umuti utujuje ibisabwa; 2) Raporo ya kabiri niya SGS ya *Laboratoire waver* yo mu Bubiligi yo kuwa 19/08/2015, iyi *laboratoire* ikaba yemewe na OMS (organization mondial de la santé) ibi kandi bikaba binashimangirwa na raporo y'uruganda LINCOLN PHARMACEUTICALS rwakoze uwo muti *Lidocaine injection* 2% aho bigaragara ko BATCH CM 40 32 bagurishije ABACUS PHARMA ushobora gutera ingaruka zitifuzwa zirimo: *allergies* na *necrosis*. Ko mu gihe bigaragara ko n'uruganda rwagurishije uwo muti uvuga ko ufite ikibazo, ABACUS ikabyirengagiza ikagura uwo muti, aho harimo ikibazo nibo bagomba kubiryoza. Ibi rero basanga ari ibimenyetso bikomeye bisobanutse kandi bihuje bikemeza ko uwo muti wari ufite ikibazo ikaba arinayo sano hagati y'ibikomere n'umuti wateye iki kibazo kubatanze ikirego kurwego rwambere, iyi raporo ikaba igaragaza ko umuti ufite 94.5% kandi wagombaga kuba hagati ya 95.0% na 105.0%, bagasoza bavuga ko umuti uri « fail »!

[11] Urukiko rwatumije mu rubanza umuhanga mu by'imiti wo muri minisiteri y'ubuzima, hitabye uwitwa Semana Edmond, hamwe n'umunyamategeko wo muri iyo ministeri; hatumijwe kandi umuyobozi wa HOPITAL LA CROIX DU SUD, nawe yitabye hamwe n'ushinzwe *laboratoire* muri ibyo bitaro witwa Kwizera Gad, bose bakaba baratujijwe mu rubanza kugira ngo batange amakuru ku bijyanye n'umuti wa *Lidocaine injection* 2% uburanwa muri uru rubanza.

[12] Semana Edmond yasobanuriye urukiko ko abemerewe kwinjiza imiti mu Rwanda ni *depot pharmaceutique* n'ibigo by'ubuzima, bakagira ibyangombwa byaho bakura imiti bigaragaza ko imiti yujuje ibisabwa kandi bakagaragaza ko ukora imiti (*fournisseur*) yujuje ibyangombwa byo gukora imiti; ko hari lisiti y'imiti yemewe kwinjira mu gihugu, kandi iyo umuti ugeze mu gihugu uwayizanye yemerewe kuwutanga kuri *pharmacie detaillant*, ibigo by'ubuzima, kandi iyo umuti ugeze muri *depot* z'ibyo bigo, abaganga bashobora kuwandikira abarwayi. Ikindi abo imiti ica mu ntoki bagomba gukomeza kuwubungabunga kugira ngo utazapfa, ukabikwa neza kuri *temperature* yemewe, kandi bagomba kugumana inyandiko zerekana aho umuti wavuye kugira ngo ni ugira ikibazo bamenye aho umuti wavuye. Kubijyanye na *procedure de rappel* asobanura ko iyo umuti ugize ikibazo bakawutangaho amakuru uhita uhagarikwa gutangwa hakarebwa aho wavuye, uwawutumije, bakamubaza aho yawutanze hose naho wagize ingaruka ni impamvu zaba zarabiteye.

[13] Semana Edmond akomeza avuga ko kuri *lidocaine injection* 2% Minisiteri y'ubuzima yamenyeshejwe ikibazo wateye aho byabereye, n'aho waguzwe, maze Minisiteri y'ubuzima yasuye ibitaro byabereyemo bahagarika « Batch number » yari iri mu isoko, n'umuti uhita uhagarikwa.

Akomeza avuga ko mu Rwanda hemerwa imiti ya *Pharmacopoeia 5: USP* (US Pharmacopoeia), *BP* (British Pharmacopoeia), *European Pharmacopoeia*, *JP* (Japanese Pharmacopoeia), *Pharmacopoeia international*. Ko iyo hagiye kuba isuzuma harebwa cya gitabo wakoze, ni ukuvuga niba umuti uri *BP* isuzuma ryakorwa hakurikijwe gitabo cya *British Pharmacopoeia*. Ikindi niba basanze umuti ufite ikibazo uvanwa ku isoko burundu, kandi ibyo byose bimenyekana hamaze gukorwa amasuzuma akwiye.

[14] Semana Edmond avuga kandi ko kubijyanye n'ubuziranenge bw'umuti, bivugaga ko umuti wujuje ibisabwa cyangwa ukiri mu bipimo biri cyangwa bitari muni y'uwo umuti cyangwa uhuje n'ibitabo ngenga mikorere, ko umuti uzajya muni cyangwa ukarenga gitabo ngenga mikorere, ubwo umuti uba utujuje ubuziranenge cyangwa se harebwa ibara ry'umuti niba udasa nawo ubwo ntuba wujuje ubuziranenge, ikindi hari ubuziranenge bugaragarira ijisho ni ubutagaragarira ijisho bigaragara hakoreshejwe ibipimo. Ariko ko mu Rwanda nta nganda zihari zo gukora amasuzuma ko umuti wujuje ubuziranenge. Ikindi hagomba kurebwa kandi niba ibikoresho bikoreshwa mu gutanga umuti nabyo byujuje ubuziranenge.

Chromatographic analysis of Lidocaine HCl injection B.P 2% (Batch N^o.CM4032 LINCOLN PHARMACEUTICAL, INDIA) both concentrated and diluted samples reveal impurities which are normally present when comparing with Lidocaine injection BP 2% samples from other manufactures. The UV spectrum has been found but we are unable to identify which molecule he is. We suggest that the client to send (submit) to other laboratories for further identification with advanced technique like IR or NMR.

Chromatographic analyses of Lidocaine HCl injection B.P 2% (Batch N^o. E0889, MAC'S PHARMACETICAL. Nairobi , KENYA) both concentrated and diluted samples reveal the presence of a second excipient **Propyl Paraben** in the product which it presence is not labelled or indicated in the vial of Lidocaine HCl injection B.P 2%; The UV spectrum and the retention time of **Propyl Paraben** containing the sample match with those of reference standard. We recommend the client not to use it without ensuring that it can adverse effect to patients (not conform to Lidocaine HCl injection B.P 2%).

As requested by the client, research, identification, assay and research of impurities has been done. However, these impurities have not been identified due to lack more advanced techniques of detection"
