*Amategako agenga imiburanishirize y'ianza – Gusubirishamo urubanza ingingo nshya – Urubanza rwaciwe ku kirego cyo gusubirishamo urubanza ku mpamvu z'akarengane - Urubanza rwaciwe ku kirego cyo gusubirishamo urubanza ku mpamvu z'akarengane ruba ari urwanyuma ndetse ntirushobora gusubirishwamo ingingo nshya kuko gusubirishamo urubanza ku mpamvu z'akarengane ari inzira idasanzwe idashobora gufungura izindi nzira z'ubujurire kuko ziba zararangiyeye.*

**Incamake y'ikibazo:** Uru rubanza rwatangiriye mu Rukiko rw'Ibanze rwa Nyamata aho Mukandamage yatanze ikirego arega uwitwa Rwabuhiri asaba urukiko gutesha agaciro icyemezo cy'ubutaka yabaruye kuri "Succession" Ntagozera ihagarariwe na Rwabuhiri. Urega yavugaga ko Rwabuhiri ari musaza we wo kwa se wabo witwa Ntagozera kuko yavukanaga na se witwa Rusake bombi bakaba babyarwa na Ngombababiri iyo sambu rero ikaba ari iyasizwe na Ngombababiri bityo nawe akaba ayifiteho uburenganzira. Urukiko rwemeje ko icyemezo cy'iyandikisha ry'ubutaka bubaruye kuri "Succession" Ntagozera giteshejwe agaciro ariko Rwabuhiri ntiyakishimira akijuririra mu Rukiko Rwisumbuye rwa Gasabo avuga ko isambu iburanwa atari iy'umuryango kuko yayisigiwe na se. Urukiko rwasanze ubujurire bwe bufite ishingiro maze rwemeza ko isambu iburanwa ari iya Rwabuhiri.

Mukandamage yasabye ko urubanza rwe rusubirwamo ku mpamvu z'akarengane maze arabyemererwa, rwongera kuburanishwa n'Urukiko Rukuru, rwemeza ko ikirego cye gifite ishingiro, rutegeka ko icyemezo cy'iyandikisha ry'ubukode bw'ubutaka kibaruye ku mazina ya "Succession" Ntagozera ihagarariwe na Rwabuhiri, giteshejwe agaciro kandi ko Mukandamage agomba kwandikwaho igice cy'ubutaka Rwabuhiri yari yaribarujeho.

Uwitwa Gihana yaje gutambamira imikirize y'urwo rubanza ariko Mukandamage atanga inzitizi yo kutakira ikirego avuga ko uwagitanze adafite inyungu n'ububasha kuko urubanza atambamira rwaburanyweho rurapfundirwa burundu. Gihana avuga ko iyo nzitizi itahabwa ishingiro kuko umutungo waburanwe na we awufiteho uruhare kuko ukomoka kuri se ubabyara witwa Ngombababiri. Rwabuhiri we avuga ko mu iburana birengagije ko Gihana na we afite uburenganzira kuri iyo sambu bityo ibyo avuga bikaba byahabwa agaciro.

## **Urubanza**

### **I. IMITERERE Y’URUBANZA**

[1] Uru rubanza rukomoka k’urubanza Mukandamage Gaudence yarezemo Rwabuhiki John asaba urukiko gutesha agaciro icyemezo cy’iyandikisha ry’ubukode bw’ubutaka kibaruye kuri numero 2367 ibaruye kuri “succession” Ntagozera ihagarariwe na Rwabuhiki John, avuga ko Rwabuhiki ari musaza we kwa se wabo Ntagozera kuko Ntagozera avukana na se witwaga Rusake bese babyarwa na Ngombababiri w’itabye Imana mbere ya 1994 ariko ngo agasiga buri mwana amuhaye umunani; Mukandamage Gaudence avuga ko ubu akorera mumunani wa se Rusake kuva mu 2004 kugeza uyu muni, mu gihe cy’ibarura ry’ubutaka bumvikana na Rwabuhiki John ko babaruriza hamwe kugirango bajye basora amafaranga make ariko ko bazakomeza gukoreramo uko bisanzwe, nyuma Rwabuhiki John akabaheza mu isambu avuga ko ngo ubutaka bwa Rusake yari yarabugurishije kera yirengagije ko ubwo butaka Mukandamage Gaudence abukoreramo ndetse yabuzwemo na se Rusake ubwo yitabaga Imana muri 2004. Ikirego cya Mukandamage Gaudence cyatanze mu rukiko rw’ibanze rwa NYAMATA cyandikwa ku nimeru RC 0032/16/TB/NMTA, urubanza rwaburanishijwe Rwabuhiki John adahari. Urubanza RC 0032/16/TB/NMTA rwakijije ko ikirego cya Mukandamage Gaudence gifite shingiro, rwemeza ko icyangombwa cy’ubutaka gifite numero 2367 kibaruye kuri “succession” Ntagozera ihagarariwe na Rwabuhiki John giteshejwe agaciro ku mpamvu zasobanuwe muri urwo rubanza, rwemeje ko nta ndishyi zihabwa Mukandamage Gaudence muri uru rubanza ku mpamvu zavuzwe muri urwo rubanza, rutegeka ko Rwabuhiki John atanga amagarama y’urubanza angana n’ibihumbi 25.000frw, atayanga urubanza rwabaye ntakuka akavanwa mubye ku ngufu za Leta.

Mu rubanza RCA 00198/2016/TGI/GSBO Rwabuhiki John yavugaga ko Mukandamage Gaudence yabeshye urukiko avuga ko isambu yaburanye ari iy’umuryango kandi ko nawe ayifiteho uruhare nyamara ngo ari iya Rwabuhiki John yasigiwe na se, ngo ibyo akaba yarabigezeho amaze gukora uburiganya bwo kubeshya mu ihamagara yemeza ko Rwabuhiki John yabuze, kugira ngo atitaba akamuburanya ngo kubera ko yari azi neza ko iyo aza kuba ahari atari gutsinda urubanza. Mukandamage Gaudence we yaburanye avuga ko ubutaka Rwabuhiki amuburanya ari ubwo yasigiwe na se Rusake wapfuye mu mwaka wa 1954, kandi ko kuva icyo gihe kugeza ubu yakomeje kubukoreramo mu bwisanzure ku buryo ngo hari abantu benshi bashobora kubihama. Urukiko rwisumbuye rwa Gasabo rwakijije urubanza RCA 00198/2016/TGI/GSBO ko ubujurire bwa Rwabuhiki John bufite ishingiro, rwemeza ko urubanza RC 0032/16/TB/NMTA ruvanyweho,

ko isambu iburanwa muri uru rubanza ari iya Rwabuhiri John, kandi ko ibyemezo biyimuhesha bigumanye agaciro kabyo, rutegeka Mukandamage Gaudence kwishyura Rwabuhiri John indishyi z'akababaro zihwanye n'amafaranga 500.000, hiyongereyeho amafaranga 500.000 y'igihembo cya avoka, akanamusubiza amafaranga 50.000 yishyuye igarama, atayishyura mu minsi cumi n'itanu uru rubanza rubaye ntakuka, aya mafaranga agakurwa bye ku ngufu za Leta.
