Amategeko agenga imanza z'imbonezamubano – Amasezerano – Kugura umutungo utimukanwa – icyemezo cy'iyandikisha ry'ubutaka - Ikigaragaza ko ubutaka cyangwa umutungo utimukanwa ari uw'umuntu runaka ni uko agomba kuba afite icyemezo cy'iyandikisha ryabwo. Uvuga ko ubutaka cyangwa umutungo utimukanwa wanditse ku wundi muntu ari uwe, afite inshingano yo kubigaragariza ibimenyetso.

Incamake y'ikibazo: Uwizeye yagurishije inzu iherereye mu karere ka Bugesera Umurenge wa Ntarama, uwitwa Hategekimana ku mafaranga 25.000.000 Frw bakora amasezerano y'agateganyo amwishyura 5.000.000 Frw andi anagana na 20.000.000 ayishyura kuri konti ya Uwizeye yari muri Unguka Bank kugirango hishyurwe umwenda yari afitiye iyo banki. Baje kujya kwa noteri kugirango habeho ihererekanya mutungo Uwizeye aha Sebukayire ububasha bwo kumugurishiriza iyo nzu ngo kuko we yari mu mahugurwa atabasha kuboneka maze habaho ubugure imbere ya noteri bitangirwa n'icyangombwa.

Uwizeye yaje gutanga ikirego mu Rukiko rwisumbuye rwa Nyarugenge arega Hategekimana wari muramu we na se wabo Sebukayire avuga ko bamuriganije bakandika ko baguze kandi ari umwenda bari bamuhaye yari kuzabishyura nyuma aho yahawe 20.000.000 Frw yagombaga kwishyura yongeyeho 5.000.000 Frw akaba yaramuhaye ingwate y'iyi nzu.

Urukiko rwisumbuye rwemeje ko nta masezerano y'ubugure yabayeho kuko hakozwe amasezerano y'agateganyo gusa ariko hatigeze habaho amasezerano ya burundu imbere ya noteri maze rutegeka ko icyangombwa cy'umutungo cyatanzwe giteshejwe agaciro kandi ko uwo mutungo wakwandikwa kuri Uwizeye Françoise. Abaregwa baje kujurira mu Rukiko Rukuru maze narwo rusuzuma ikibazo cyo kumenya niba amasezerano y'ubugure yabaye hagati ya Hategekimana Jean Paul na Uwizeye Françoise ataragombaga guseswa kuko yakozwe mu buryo bukurikije amategeko.

Urega mu bujurire avuga ko Urukiko rwusumbuye rwafashe ibintu uko bitari kuko rwavuze ko nta masezerano ya burundu yabayeho kandi ubwo bari kwa Noteri hari amasezerano yakozwe ndetse akajyamo n'igiciro yerekeranye no kugura iyo nzu. Ayo masezerano akaba yarakozwe ku ruhande rwa Uwizeye hari Sebukayire yari yahaye ububasha bwo kumuhagararira.

Uwizeye asobanura ko inyandiko zakorewe imbere ya noteri ariko akirengagiza ko yakozwe mu buryo bw'uburiganya kuko habayeho guhendwa cyane ndetse n'amasezerano yabereye kwa Noteri Uwizeye akaba atarayagizemo uruhare kuko yakozwe hagati ya Hategekimana na Sebukayire.

I. IMITERERE Y’URUBANZA

[1] Uwizeye Françoise yagurishije inzu ye ibaruye kuri UPI: 5/07/09/02/3998 iherereye mu karere ka Bugesera, Umurenge wa Ntarama, Akagari ka Kanzenze, Umudugudu wa Kabeza, ayigurisha uwitwa Hategekimana Jean Paul bagirana amasezerano y’ubugure bw’agateganyo yo kuwa 24/7/2018 yabereye imbere ya noteri. Iyo nzu yagurishijwe miliyoni makumyabiri n’eshanu (25.000.000 FRW) yatanzwe mu byiciro, miliyoni eshanu (5.000.000 FRW) yatanzwe kashi nyuma y’isinya ry’amasezerano naho miliyoni makumyabiri (20.000.000 FRW) zishyurwe UNGUKA Bank muri compte y’ugurushije ariwe Uwizeye Françoise mu rwego rwo kugirango UNGUKA Bank yishyurwe umwenda iberewemo. Nyuma y’ayo masezerano y’agateganyo, tariki ya 6/9/2018 habaye amasezerano ya burundu yabereye imbere ya noteri, Hategekimana Jean Paul yandikwaho umutungo utimukanwa yaguze nk’uko bigaragazwa n’amasezerano y’ubukode burambye.

[2] Uwizeye Françoise yatanze ikirego mu Rukiko rwisumbuye rwa Gasabo arega Hategekimana Jean Paul anagobokesha ku gahato Kavamahanga Alexandre, asaba gusesa amasezerano y’ubugure bw’inzu yo ku wa 24/07/2018. Impamvu ituma asesa ayo masezerano byatewe n’ikibazo yari afitanye na UNGUKA Bank Ltd cy’umwenda yari yarananiwe kwishyura bashaka kugurisha inzu ye muri cyamunara, mu kwandika aya masezerano se wabo witwa Kavamahanga Alexandre afatanyije na muramu we witwa Hategekimana Jean Paul bamushutse bandika ko agurishije inzu iri mu butaka bubaruye kuri UPI: 5/07/09/02/3998, nyamara baramugurije 20.000.000Frw kugira ngo yishyure Banki maze mu kubishyura azabungukire 5.000.000Frw, hanyuma namara kubishyura 25.000.000Frws bazamusubize ibyangombwa by’inzu ye. Iyi nzu ifite agaciro ka 80.000.000Frws, ko rero atashoboraga kuyigurisha kuri 25.000.000 FRW. Uwizeye Françoise yari yizeye ko se wabo atamuhemukira, bamusabye guha se wabo Kavamahanga Alexandre ububasha (procuration) bwo kuzamuhagararira mu ihererekanya ry’uburenganzira ku butaka (mutation), arabikora. Uwizeye Françoise asaba Urukiko ko rwategeka ko ariya masezerano asheshwe kubera uburiganya yakoranywe, abaregwa bagategekwa kumuha indishyi z’akababaro n’amafaranga y’igihembo cya Avoka.

[3] Hategekimana Jean Paul avuga ko amasezerano yakozwe n'abantu bakuru, bafite ikigero cyo hejuru cy'imyumvire kuko bafite byibura ikigero cya kabiri cya kaminuza, akorwa neza mu buryo bukurikije amategeko, uguze abona ubutaka n'imitungo iburiho, ugurishije abona amafaranga yumvikanyweho, byose bikorerwa imbere ya Notaire, haba iherekanya mu gihe cyagenwe mu masezerano. Hategekimana Jean Paul asaba ko ikirego cya Uwizeye Françoise kitahabwa ishingiro, agategekwa gutanga indishyi z'akababaro, amafaranga y'ikurikiranarubanza n'ay'igihembo cy'avoka.

[4] Kavamahanga Alexandre (Sebukayire Alexandre) ntiyitabye kandi yaramenyeshye mu buryo bukurikije amategeko, maze bisabwe na Uwizeye Françoise, urubanza ruburanishwa adahari hashingiwe ku ngingo ya 57 y'Itegeko n° 22/2018 ryo ku wa 29/04/2018 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi.

[5] Mu rubanza RC 00050/2022/TGI/GSBO rwaciwe ku wa 29/12/2022 n'urukiko rwisumbuye rwa Gasabo rwemeje ko amasezerano y'ubugure yabaye ku wa 24/07/2018 hagati ya Uwizeye Françoise na Hategekimana Jean Paul ku butaka bubaruye kuri UPI: 5/07/09/02/3998 buherereye mu Karere ka Bugesera, Umurenge wa Ntarama, Akagari ka Kanzenze, Umudugudu wa Kabeza, asheshwe. Bityo amasezerano y'ubukode burambye yahawe Hategekimana Jean Paul akaba agomba guteshwa agaciro ubutaka bukurikwa kuri Uwizeye Françoise. Rutegetse Uwizeye Françoise gusubiza Hategekimana Jean Paul amafaranga 20.000.000Frws yamwishyuriye muri UNGUKA Bank, akanamuha n'inyungu zayo zingana na 8.298.170 Frw. Rutegetse Uwizeye Françoise guha Hategekimana Jean Paul amafaranga 100.000Frws y'ikurikiranarubanza n'amafaranga 500.000Frw y'igihembo cya Avoka. Rutegetse ko amafaranga 20.000 Frw Uwizeye Françoise yatanzeho ingwate y'amagarama ahwanyeye n'ibyakozwe muri uru rubanza.

[6] Mu gufata icyo cyemezo, urukiko rwasanze amasezerano y'ubugure yabaye hagati ya Uwizeye Françoise na Hategekimana Jean Paul ari amasezerano y'ubugure y'agateganyo nk'uko nabo ubwabo bayise, amasezerano y'ubugure ya burundu akaba yaragombaga gukorwa ari uko hagiye kuba iherekanya ry'uburenganzira ku butaka, ariko nta kigaragaza ko amasezerano y'ubugure ya burundu yigeze abaho kuko Hategekimana Jean Paul ntayo yabashije kugaragaza. Kuba iherekanya ry'uburenganzira kuri uwo mutungo utimukanwa ryarakozwe nta masezerano y'ubugure bwa burundu abayeho, ni inenge ituma ayo masezerano ateshwa agaciro.

[7] Hategekimana Jean Paul yajuririye uru rukiko rukuru, urubanza ruhabwa N° RCA 00059/2023/HC/KIG, ruburanishwa mu ruhamwe ku wa 20/06/2024, Hategekimana Jean Paul yitaba urukiko yunganirwe na Me Twizeyimana Theophile, abaregwa batibabye kandi baramenyeshye itariki y'iburanisha mu buryo bukurikije amategeko bituma baburanishwa badahari kubera ko impamvu itangwa na Uwizeye Françoise yo gusesa amasezerano y'umwunganizi we wari umuhagarariye ntashyireho undi ari uburyo bwo gutinza urubanza cyane ko avoka umuhagarariye yari yaragiye mu nama ntegururubanza ndetse no kuba uregwa ari hanze y'igihugu agashaka ko urubanza rwazaburanishwa nyuma y'umwaka arangije ubutumwa nabyo bigaragaza gutinza urubanza.

[8] Mu myanzuro y'ubujurire no mu miburanire, Hategekimana Jean Paul n'umwunganira bavugaga ko urukiko rwarafashe icyemezo cyo gusesa amasezerano yakozwe kuwa 24/07/2018 nyamara rwirengagije amategeko n'ibimenyetso byatanzwe kandi ayo masezerano afite andi ya burundu yayasimbuye yo kuwa 06/09/2018. Kuba Urukiko mu gufata icyemezo rwarashingiye ku

butumwa ababuranyi bandikiranaga kuri whatsapp nyamara rwirengagije ko hari amasezerano rwahawe kandi yakorewe imbere ya Noteri. Barasaba indishyi z'akababaro zingana na 5.000.000 Frw, ikurikirana rubanza ringana na 2,000,000 Frw ndetse n'igihembo cy'avoka kingana na 1500,000Frw.

[9] Uhagarariye Uwizeye Françoise avuga ko Urega mu bujurire avuga ko inyandiko zakorewe imbere ya notaire ariko akirengagiza ko yakozwe mu buryo bw'uburiganya bikaba arikimwe mubyo umucamanza yahereyeho ayasesa habaye vice de consentement (*La lesion*). Amasezerano yo kuwa 24/7/2018 yabaye hagati ya Uwizeye na Hategekimana ubwo yamugurizaga miliyoni makumyabiri bakumvikana kwazamusubiza makumyabiri n'eshanu (25.000 FRW) yamuhayeho garantie ya parcelle irikuburanwa. Amasezerano yo kuwa 6/9/2018 yakozwe hagati ya Hategekimana Jean Paul na Sebukayire wahozwe yitwa Kavamahanga Alexandre muramu we akaba sewabo wa Uwizeye. Ni naho mu gika cya 15 urukiko rwemeje ko nta masezerano ya burundu yabaye kuko nyirubwite atayagizemo uruhare.

Bityo rero mu rwego rw'amategeko iyo nyandiko niyo ifatwa nk'amasezerano y'ubugure bwa burundu nk'uko bigaragazwa n'amasezerano y'iherekanya ry'ubutaka yakozwe tariki ya 6/09/2018, ndetse harimo n'izindi nyandiko zitandukanye zose ziteganwa n'itegeko n'amabwiriza agenga ubutaka nk'inyandiko zikorwa mu gihe uburenganzira k'ubutaka buva k'umuntu bujya k'uwundi hashingiwe ku bugure ariko urukiko rwarazirengagije.

Uwizeye Françoise yahaye Kavamahanga Alexandre Procuration yo kuwa 24/07/2018 kugirango azamuhagararire muri ibyo bikorwa byombi bitewe nuko we atari kuboneka ku mpamvu z'uko yarari mu mahugurwa i Huye, kuwa 06/09/2018 byagenze uko bari babyumvikanye nuko Kavamahanga Alexandre ahagararira Uwizeye Françoise,

habaho amasezerano ya burundu ndetse n'iherekanya nk'uko bigaragara mu nyandiko zitandukanye zibitswe n'ikigo cy'igihugu cy'ubutaka. izo nyandiko ubu ninazo shingiro yo kuba Hategekimana Jean Paul atunze umutungo we mu buryo bukurikije amategeko.

Muri urwo rubanza, urukiko rwasanze ikigaragaza ko ubutaka cyangwa umutungo utimukanwa ari uw'umuntu runaka ni uko agomba kuba afite icyemezo cy'iyandikisha ry'ubutaka kimwanditseho, ibicyanditseho bifatwa nk'ukuri kudashidikanywaho. Uvuga ko ubutaka cyangwa umutungo utimukanwa wanditse ku wundi muntu ari uwe, afite inshingano ikomeye yo kugaragaza ibimenyetso bidashidikanywaho kandi by'ukuri byerekana uburyo ubwo butaka cyangwa uwo mutungo utimukanwa ari uwe koko n'aho awukomora, ku buryo ibyo bimenyetso bishingirwaho hahashwa agaciro icyangombwa cy'ubutaka.

Urukiko rw'Ikirenga rwasanze amasezerano y'ubugure bw'ubutaka yakozwe mu buryo bw'inyandikompamo niyo agira agaciro. Uwaguze hakozwe amasezerano mu buryo bw'inyandiko bwite, ubugure bwe buba ari imfabusa. Hari kandi urubanza RS/INJUST/RC 00012/2021/SC rwaciwe kuwa 22 Ukwakira 2022 n'urukiko rw'ikirenga narwo rwemeje ko ku bijyanye n'ubugure bw'umutungo utimukanwa, kwemeranya kw'abagiranye amasezerano ku kintu no ku kiguzi ubwabyo ntibihagije, ahubwo hari n'ibindi bigomba kubahirizwa nko kuba mu ikorwa ry'amasezerano no kuyashyiraho umukono bigomba gukorerwa imbere y'umukozi ubifitiye ububasha, bitaba ibyo amasezerano y'ubugure akaba nta gaciro afite.

Arasaba indishyi z'akababaro zingana na 5.000.000 FRW, ikurikirana rubanza ringana na 2,000,000 Frw ndetse n'igihombo cy'avoka kingana na 1.500.000 Frw.

[20] Uwizeye Françoise avuga ko ibisabwa n'urega ntabyo yahabwa kuko niwe wanze kumvikana ngo bakemure ikibazo nk'uko bari babyumvikanyeho mu masezeranyo yo kuwa 24/7/2018.

[21] Ingingo ya 111 y'itegeko N° 22/2018 ryo ku wa 29/04/2018 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi iteganya ko ikirego cy'amafaranga y'ikurikiranarubanza ni ikirego gishamikira ku kirego cy'iremezo kigamije kwishyura ibyakoreshejwe mu rubanza. Ikirego cy'amafaranga y'ikurikiranarubanza kiburanishirizwa rimwe n'ikirego cy'iremezo. Gishobora kandi kwakirwa kikanaburanishwa n'iyo ikirego cy'iremezo cyaba kitakiriwe.

Avoka w'uregwa akena ibihembo bye akurikije agaciro k'ikiburanwa, ingorane iri mu rubanza, hamwe n'ibyo agomba kubanza gukora byose, ndetse n'ingaruka z'icyemezo cyafashwe, ariko igihembo ntikijye muni y'amafaranga 500.000 kandi ntikirenge amafaranga 3.000.000.

[23] Urukiko rurasanga Hategekimana Jean Paul yahabwa na Uwizeye Françoise igihembo cy'avoka n'amafaranga y'ikurikiranarubanza angana na miliyoni imwe (1.000.000 FRW) kubera ko yashomwe mu manza zitari ngombwa kuko ubugure bwabaye bwakurikije amategeko. Izindi ndishyi zisabwa na Hategekimana Jean Paul nta shingiro zifite kubera ko atazitangira ibimenyetso.
