

## SONARWA v SHIKAMA

[Rwanda URUKIKO RUKURU - RCA 00034/2023/HC/NYZ (Badara, P.J.) 14 Gicurasi 2024]

*Amategeko agenga imanza z'imbonezamubano – Impanuka zikozwe n'ibinyabiziga – Indishyi z'ibangamira ry'uburambe ku kazi – Uwahohotewe wagize ubumuga buhoraho ahabwa indishyi z'ibangamira ry'uburambe mu kazi kubera ubwo bumuga butuma atabasha gukomeza gukora akazi ke mu buryo bumworoheye nkuko yagakoraga mbere atarakora impanuka.*

**Incamake y'ikibazo:** Uru rubanza rukomoka ku mpanuka yabaye igakomerekeramo Shikama ubwo yari mu modoka yavaga mu mujyi wa Huye yerekeza ku Gateme mu karere ka Huye igeze yomugusha hasi arakomereka agira ubumuga bwemejwe n'abaganga bungana na 80%. Shikama yatanze ikirego mu Rukiko Rwisumbuye rwa Huye arega SONARWA GENERAL INSURANCE COMPANY Ltd (SONARWA) asaba indishyi zitandukanye. Urukiko rwamugeneye indishyi zikubiyemo indishyi mbangamiraburambe mu kazi, indishyi z'ibangamirabukungu n'izindi. SONARWA ntiyanyuzwe n'icyo cyemezo ikijuririra mu Rukiko Rukuru ivuga ko hatanzwe indishyi z'ibangamira burambe ku kazi kandi uwahohotewe nta kazi yagiraga kandi ko indishyi mbangamirabukungu nazo zikaba zarabariwe ku gipimo cy'ibitsa kitari cyo.

Urukiko rwasuzumye ikibazo cyo kumenya niba Shikama yaragombaga kubona indishyi z'ibangamira ry'uburambe ku kazi no kumenya niba indishyi z'ibangamirabukungu zarabazwe neza.

SONARWA ivuga ko indishyi z'ibangamirabukungu zabariwe ku gipimo cy'ibitsa kitari cyo bituma itegekwa kiwshyura indishyi nyinshi. Ikomeza ivuga ko Shikama nta kazi yagiraga bityo tari akwiye guhabwa indishyi z'ibangamira burambe ku kazi. Uregwa asobanura ko indishyi z'ibangamira bukungu zabazwe neza kuko igipimo cy'ibitsa gihindagurika. Akomeza avuga ko yari afite akazi kuko yakoraga muri Koperative abahuje umurimo ba Huye bapakira bakanapakurura imodoka no gutwaza abantu ariko ubumuga yagize ntabwo bumwemerera kuba yakongera gukora aka kazi kuko umugongo wacitse akaba agendera mu igare. ## Urubanza

### I. IMITERERE Y'URUBANZA

[1] Tariki ya 25/01/2022 mu gihe cya saa 18h00 z'umugoroba, mu mudugudu wa Mukoni, akagali ka Cyarwa, Umurenge wa Tumba, akarere ka Huye habereye impanuka ya Truck Mitsubishi fuso ifite plaque RAD 479G ikaba yari itwawe na MUVUNYI Jean de Dieu w'imyaka 39 yavaga mu mujyi wa Huye yerekeza ku Gateme atwaye mu modoka inyuma uwitwa Shikama Kidamage w'imyaka 35 ageze aho havuze nibwo yagushaga uwo yari atwaye mu modoka inyuma arakomereka.

[2] Shikama Kidamage yatanze ikirego mu rukiko rwisumbuye rwa Huye asaba indishyi zitandukanye zirimo indishyi mbangamirabukungu, indishyi z'akababaro, indishyi zo gutakaza amahirwe yo gushaka, indishyi z'ibangamiraburanga, indishyi z'ibangamira ry'uburambe mu kazi, gusubiza amafaranga yakoresheje ajya anava kwa muganga, gusubiza amafaranga yaguzwe ibyangombwa bitandukanye, gusubiza amafaranga yatanzwe kwa muganga no gusubiza amafaranga y'igihembo cy'avoka n'ikurikiranarubanza.

[7] Mu myanzuro y'ubujurire no mu miburanire, Uhagarariye SONARWA GENERAL INSURANCE LTD avuga ko umucamanza yashingiye ku gipimo cy'ibitsa cya BNR iheraho imyenda amabanki aho gukoresha igipimo cy'ibitsa kiriho kuri depots zashyizwe muri bank. Iyo umucamanza abara indishyi yari kubona 893.617 FRW. Ku bijyanye n'indishyi z'uburambe mu kazi, nta kintu na kimwe kigaragara ko yakoraga akaba ari nayo mpamvu yabariwe kuri SMG. Ibi rero basanga ari nako byari kugenda kuri izi ndishyi kuko udashobora kubura uburambe mu kazi ntako ugira. Izi ndishyi z'ibangamira ry'uburambe mu kazi zikaba zitaragombaga gutangwa. Ikindi

hari amafaranga 405.000 FRW umucamanza yageneye Shikama ngo yakoreshejwe ku ngendo nyamara nk'uko babisobanuye Taxis Voiture zose zitanga Facture IBM. Kuvuga rero kuyakoresheje Taxis ntagaragaze Facture yemewe n'amategeko barasanga aya mafaranga atari gutangwa.

[8] Shikama Kidamage n'umwunganira bavuga ko igipimo cy'ibitsa gihinduka umunsi ku munsi, kuba rero harabariwe kuri 7 niko umucamanza yabibonye kandi nawe azi amategeko. Shikama Kidamage asobanura ko yari afite akazi nk'uko babigaragarije urukiko ko yakoraga muri Koperative abahuje Umurimo ba Huye bapakira bakanapakurura imodoka no gutwaza abantu ariko ubumuga yagize ntabwo bumwemerera kuba yakongera gukora aka kazi kuko umugongo wacitse akaba agendera mu igare.

[9] Ku bijyanye n'amafaranga y'ingendo atatangiwe IBM, Shikama Kidamage asobanura ko Facture kuba atari iza EBM bidakuraho ko ari facture, ntabwo bikuraho kandi ko ayo mafaranga yakoreshejwe ibyo rero ntabwo bikwiye kuba urwitwazo kuko ntaho amategeko avuga ko facture zitari iza EBM zitemewe kuko na RRA yemera ko 27% ya facture zose iyo atari EBM nta kibazo kuko abantu bose n'ibicuruzwa bose ntibishobora kubona facture ya EBM.

[10] Shikama Kidamage n'umwunganira barasaba urukiko rwasuzuma kandi rugategeka SONARWA G.I guha uregwa indishyi zo gutakaza amahirwe yo gushaka zingana 1.080.000 Frw. Nk'uko biteganywa n'ingingo ya 19 y'iteka rya Perezida N° 31/01 ryo kuwa 25/08/2003 rishyiraho uburyo bwo kwishyura indishyi iteganywa ko umuntu uhabwa izi ndishyi ari ufite ubumuga buhoraho bungana cg burengeje 50%. Uyu Shikama we akaba afite 80% izi ndishyi kandi Sonarwa yemeye ko zitangwa no muri system harimo Attestation de Celibat. Barasaba urukiko gutegeka SONARWA G.I gutanga amafaranga y'igihembo cya avoka ku rwego rw'ubujurire kingana na 500,000Frw kuko SONARWA G.I ikomeje gushora Shikama Kidamage mu manza bigatuma ashaka avoka wo kumuburanira, bityo rero basaba ko bahabwa igihembo cy'avoka kingana na 500.000 FRW.

[23] Shikama Kidamage n'umwunganira basobanura ko kuba Facture atari iza EBM bidakuraho ko ari facture, ntabwo bikuraho kandi ko ayo mafaranga yakoreshejwe ibyo rero ntabwo bikwiye kuba urwitwazo kuko ntaho amategeko avuga ko facture zitari iza EBM zitemewe kuko na RRA yemera ko 27% ya facture zose iyo atari EBM nta kibazo kuko abantu bose n'ibicuruzwa bose ntibishobora kubona facture ya EBM.

[25] Kuri iki kibazo, ingingo ya 13 y'Iteka rya Perezida N° 31/01 ryo ku wa 25/08/2003 rishyiraho uburyo bwo kwishyura indishyi ku bubabare bw'umubiri buturutse ku mpanuka zitewe n'ibinyabiziga ivuga ko amafaranga yo kwivuzwa, yo gushyirwa mu bitaro, yo kugura imiti, yo gutwarwa mu modoka itwara abarwayi, yo kongera kumenyereza umubiri, yo kugorora ingingo, y'ibyuma bikoreshwa, y'insimburangingo n'ay'ingendo zo kujya kwivuzwa arihwa n'uwateje impanuka cyangwa umwishingizi we, hakurikijwe ibiciro biriho mu Rwanda. Agomba kwishyurwa n'abo bombi, bamaze kubona inzandiko zibihamya mu kwezi kw'iyakirwa ry'izo nyandiko. Iyo harimo ukwivuriza ahandi hatari mu Rwanda uwahohotewe agenda bimaze

kwemezwa n'akanama k'ubuvuzi kagizwe n'umuganga w'uwahohotewe, n'umuganga w'urnwishingizi hamwe n'impuguke yasabwe n'abo bombi.

[26] Urukiko rurasanga kuba urukiko rutarashingiye kuri factures za IBM atari impamvu yatuma izo ndishyi zivanwaho cyane ko bigaragara ko yakoze ingendo ajya kwivuza kandi kuba impanuka yaramwangije umugongo ikamutera ubumuga buhoraho bwa 80 bigaragara ko yakoreshegaga imodoka imutwara bityo kuba uwamutwaye ataramuhaye factures ya IBM ntabwo ariwe byabazwa.

[28] Ingingo ya 19 y'iteka rya Perezida ryavuzwe haruguru ivuga ko iri bangamira rishobora gusa gutangirwa indishyi ku muntu w'ingaragu kandi bitewe n'uko nyuma y'impanuka yagize: (a) ubumuga buhoraho bungana cyangwa burengeje 50%, (b) ibangamira ry'uburanga ringana cyangwa rirengeje urwego rwa 5 rwavuzwe haruguru. Iyo rishobora kwemerwa, iryo bangamira ritangirwa indishyi ku buryo bukurikira: (a) 2 X umushahara w'umwaka muto ntarengwa wemewe n'amategekoyi uwahohotewe atagejeje ku myaka 25, (b) 1 X umushahara w'umwaka muto ntarengwa wemewe n'amategeko iyo uwahohotewe arengeje imyaka 25.

[29] Urukiko rurasanga Shikama Kidamage atujuje ibisabwa kugirango umuntu ahabwe indishyi zo gutakaza amahirwe yo gushaka kuko nubwo ari ingaragu kandi akaba yaragize ubumuga buri hejuru ya 50% yagombaga no kuba afite ibangamira ry'uburanga ringana cyangwa rirengeje urwego rwa 5 nyamara yagize urwego rwa 4. Ibi rero bituma atahabwa izo ndishyi.
