

NAEB v. SINFOTEC Sarl

Amategeko agenga imiburanishirize y'imanza z'ubutegetsi – Ikimenyetso ku mpamvu ntakumirwa – Inshingano y'urega yo kugaragaza ibimenyetso – Urega agomba kugaragaza ibimenyetso by'ibo aregera. Iyo abibuze, uwarezwe aratsinda –Kuba SINFOTEC itaragaragarije Urukiko ibimenyetso byerekana ko ubwato bwari butwaye “matières premières” bwagize ikibazo, OCIR-THE ikaba itagomba kuyishyura amafaranga yari yayikase nk'indishyi z'ubukererwe bw'iminsi 12 – Itegeko n° 21/2012 ryo kuwa 14/6/2012 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi, ingingo ya 9 – Itegeko n° 15/2004 ryo kuwa 12/6/2004 ryerekeye ibimenyetso mu manza n'itangwa ryabyo, ingingo ya 3.

Incamake y'ikibazo: SINFOTEC Sarl yagiranye amasezerano na OCIR-THE, ubu yahindutse NAEB, yo kuyigemura imifuka yo gupfunyikamo icyayi ku gaciro ka 208.250.000Frw. Yishyurweho amafaranga y'igice cya mbere yari imaze kugemura, hasigara 45.968.585Frw, ariko irangije kugemura igice gisigaye NAEB iyishura 19.570.252Frw, kuko NAEB yayikase 14.855.333Frw y'ibihano by'ubukererwe, 11.543.000Frw yajyanywe n'Umuyobozi wa EIS akaba ari nawe Muyobozi wa SINFOTEC Sarl, yose hamwe ikaba yarakaswe 26.398.333Frw.

SINFOTEC Sarl yareze mu Rukiko Rukuru isaba gusubizwa ayo mafaranga no kwishyurwa indishyi zitandukanye, ay'ibihano by'ubukererwe ku mafaranga itishyuriwe igihe angana na 0,1% buri muni, ikishyurwa nanone indishyi yakaswe na FINA Bank zibariwe ku gaciro ka 25% buri kwezi, hakiyongeraho indishyi zingana n'agaciro mbumbe (forfait) kangana na 1.000.000Frw kubera ko amafaranga yayo yakoresheje yari umwenda wa Banki yagombaga kwishyura. Isaba inyungu kuri ayo mafaranga ingana na 10.074.427Frw, ikanasaba kwishyurwa amafaranga y'igihembo cy'avoka angana na 10% y'agaciro k'ikiburanwa na 1.000.000Frw y'ikurikiranarubanza. Urukiko rwemeje ko ikirego cya SINFOTEC Sarl gifite ishingiye ku bijyanye n'amafaranga y'ubukererwe bw'iminsi 12 yakaswe binyuranije n'amasezerano kuko yagaragaje ko yahuyen'impamvu ntarengwa no ku bijyanye n'amafaranga yafatiriwe na OCIR-THE.

OCIR-THE yajuriye mu Rukiko rw'Ikirenga, ivuga ko Urukiko Rukuru rwemeje ko habayeho impamvu ntarengwa yatumye habaho ubukererwe bw'iminsi 12 mu kugemura icyiciro cya mbere cy'imifuka kandi SINFOTEC Sarl itarigeze igaragaza ikimenyetso kiyishimangira, ikanavuga ko indishyi z'ibihano by'ubukererwe zagenewe SINFOTEC Sarl zidakwiye kuko zabazwe ku mafaranga itagombaga guhabwa.

SINFOTEC Sarl yireguye ivuga ko ikimenyetso cy'impamvu ntarengwa cyatanzwe mu iburanisha kandi ko umucamanza yabashije kubisobanukirwa akabishingiraho. SINFOTEC Sarl nayo yararujuririye ivuga ko Urukiko Rukuru rwirengagije ko OCIR-THE ariyo yateje ubukererwe, ko Urukiko Rukuru rutabashije kubona ko habaye impamvu itunguranye kandi itigobotorwa (cas de force majeure) yatumye itarashoboye kubahiriza amasezerano, ko Urukiko Rukuru rwanze kuyigenera indishyi zo kutishyura ku gihe biturutse ku makosa ya OCIR-THE.

2. OCIR-THE ntiyagombaga gufatira amafaranga y'ubwishyu yagombaga SINFOTEC Sarl mu rwego rw'ihwanya ry'inyenda kubera y'uko ayo mafaranga OCIR-THE yari yayishyuye indi sosiyete yitwa E.I.S., itandukanye na SINFOTEC Sarl, bityo OCIR-THE ikaba igomba kuyatangira indishyi z'ubukererwe.

3. Kuba OCIR-THE yaramenyeshije SINFOTEC Sarl ibizandikwa ku mifuko nyuma y'iminsi 43 uhereye igihe basinyiye amasezerano, bigaragara ko urukiko Rukuru rutibeshye ku itariki yo gutangiraho kubara ubukererwe kuko SINFOTEC Sarlyagombaga gutegereza ko imenyeshwa ibizandikwa ku mifuka kugirango ishyire mu bikorwa amasezerano n'ukuvuga kuwa kuwa 13/10/2008 kugeza kuwa 28/11/2008 bityo ubujurire bwa SINFOTEC Sarl nta shingiro bufite.

4. Impamvu ishingiyeye ku kuba SINFOTEC Sarl yaramenyeshije mu ibaruwa OCIR-THE ko uruganda rukora imifuka rwo muri Kenya rwahagaritse imirimo yarwo kubera ikibazo cy'ubukungu ku isi ntiyafatwa nk'impamvu ntakumirwa kuko igemurwa ry'imifuka ryagombaga gukorwa mu minsi 45 kandi iyo mpamvu yabaye nyuma y'iyi minsi iteganywa mu masezerano bityo indishyi z'ubukererwe zaciwe na OCIR-THE ku mafaranga yari yarasigaye SINFOTEC Sarl igemura icyiciro cya kabiri cy'imifuka zirakwiye.

5. Indishyi zituruka ku kwica amasezerano zishobora guteganywa mu masezerano ariko hakagenwa umubare ukwiye ugendeye ku gihombo nyakuri kiriho cyangwa cyiteguwe ko cyabaho mu gihe amasezerano atubahirijwe cyangwa mu gihe cy'ingorane zo kubona ibimenyetso by'igihombo, bityo ingingo ya 258 y'Itegeko ryo kuwa 30 Nyakanga 1888 rigenga masezerano cyangwa imirimo nshinganwa ikaba idashobora gukoreshwa muri uru rubanza kuko rurebana n'ikibazo cyo gukora ibisabwa mu masezerano.

6. Indishyi zagenwe n'Urukiko zigomba kugaragara mu cyemezo cy'urubanza, bityo iryo kosa rigomba gukosorwa.

7. Iyo kwica amasezerano birebana no kutishyura amafaranga cyangwa kudakora igisabwa gishobora kubarwa mu mafaranga azwi cyangwa ashobora kumenyekana, inyungu zibarwa

uhereye igihe igisabwa cyagombaga gukorwa hakuwemo ibyo uruhande rwishe amasezerano rufiteho uburenganzira.

8. Umucamanza aca urubanza ku cyasabwe cyose kandi kuri icyo cyonyine kandi ica ry'urubanza risobanura itegeko ryakurikijwe n'ingingo zishingiye ku byabaye zagaragajwe mu rubanza bityo kuba Urukiko rukuru rwarategetse ihwanya ry'amafaranga y'ukurikiranarubanza n'igihembo cy'avoka byasabwaga na buri muburanyi rutabanje kugaragaza ayo rwageneye buri ruhande n'ibisobanuro ruyashingiraho, Urukiko rw'ikirenga rukaba rusanga Urukiko Rukuru rutarubahirije amategeko.

9. OCIR-THE yari ifitiye uburenganzira bwo gukata SINFOTEC Sarl indishyi z'ubukererwe ariko nta burenganzira yari ifite bwo gufatira amafaranga ya SINFOTEC Sarl kubera ihwanya ry'inyenda itari iyayo. OCIR-THE ikaba igomba gutanga indishyi z'ubukererwe z'iminsi 1753 (jours), kuva ku itariki yagombaga kuyishyura kugeza umunsi w'isomwa ry'urubanza, ku gipimo cya 0.1% y'ayo mafaranga ku munsi.

10. Ku byerekeye 31.623.000Frw asabwa na SINFOTEC Sarl arebana n'igihombo OCIR-THE yayiteye kuko ku makosa yayo itashoboye kuriha ideni rya FINA Bank ($26.398.333 \times 25\% \times 57,5 \text{ mois}/12 \text{ mois} = 31.623.000\text{Frw}$), Urukiko rw'ikirenga rurasanga itayahabwa, kuko idashobora gusaba indishyi zishingiye ku ngingo ya 258 y'Igitabo cya gatatu cy'urwunge rw'amategeko mbonezamubano mu bibazo birebana n'irangiza ry'amasezerano.

11. Ku byerekeye 1.000.000Frw ya forfait asabwa na SINFOTEC Sarl, ntikwiye kuyabona kuko idasobanura impamvu yayo.

12. Ku byerekeye igihembo cy'avoka n'amafaranga y'ukurikiranarubanza bingana na 10% y'indishyi yose igomba guhabwa na OCIR-THE, Urukiko rw'ikirenga rurasanga, aya mafaranga ari ikirenga, bityo ikiba igenewe akwiye mu bushishozi bwaryo.
