Mukarushakiro, Bagenzi na Mukangenzi bajuririye Urukiko Rukuru, bavuga ko urukiko rwategetse Bagenzi kwishyura ibyakozwe kandi ko Gahire yaguzwe nta buryarya nyamara rwaremeje ko yakozwe amasezerano y’ubugure ari umwana, anakagurisha ibitari ibye. Bavuga kandi ko Urukiko rwashingiye ku buhama bw’umuhanga “expertise” hadakozwe inyandiko y’undi muhanga ngo zigereranywe mu rwego rw’ivuguruzanya “contre expertise”.

Gahire nawe yajuriye avuga ko Urukiko Rwisumbuye rwatesheje agaciro amasezerano y’ubugure kandi atari cyo cyaregowe, ko rwirengagije ko Bagenzi yagurishije afite imyaka y’ubukure, kandi ko urwo Rukiko ntacyo rwavuze ku nzitizi zari zatanze.

Urukiko Rukuru rwemeje ko ubujurire bwa Mukarushakiro, Bagenzi na Mukangenzi nta shingiro bufite, ariko ko ubwanzwe na Gahire bufite ishingiro, bityo ko amasezerano y'ubugure agumyeho.

Mu rubanza RCA0039/2016/HC/KIG rwo ku wa 09/11/2016 rukosora urundi, hemejwe ko ikirego cye nta shingiro gifite kuko nta kosa ryakozwe rihari rikwiye gukosorwa.

Nyuma y'icyo cyemezo ku kirego gikosoza urubanza rw'Urukiko Rukuru, Mukangenzi nawe yajuririyeye Urukiko rw'Ikirenga, avuga ko Urukiko Rukuru rwivuguruye rukanitiranya ibintu kandi ko rwashingiye ku manza zo mu mahanga zivuguruzwa amategeko y'u Rwanda ku byerekeranye n'uwakoze amasezerano ataragira imyaka y'ubukure. Avuga kandi ko rwakoresheje nabi ingingo ya 159 y'Itegeko rigenga amasezerano ku byerekeranye n'igihe ntarengwa cyo gukurikirana no gufata amasezerano yakozwe n'umuntu udafite imyaka y'ubukure nk'aho yemewe, rubiheraho rutwerera Gahire ukutagira uburyarya.
