Amategeko agenga Umusoro – Igihe cyagenwe cyo gusoresha – Kuba Ikigo cy'Imisoro n'Amahoro cyari gifite uburenganzira bwo gukosora inyandiko y'imenyekana ry'umusoro ariko ntikibikore mu gihe cyagenwe n'amategeko ubwo burenganzira burazima – Itegeko N°25/2005 ryo kuwa 04/12/2005 rigena imitunganyirize y'isoresha, ingingo ya 26 n'ya 27.

Incamake y'ikibazo: RRA yakoreye Ruhando igenzura, imusoresha nta nteguza umusoro ku nyungu wo mu mwaka wa 2008 n'uwa 2010 ku mpamvu yuko atometse urutonde rwabo abereyemo imyenda ku imenyekanisha yakoze. Yanamuciye nanone umusoro ku nyongeragaciro ku mwaka wa 2008 hamwe n'inyungu z'ubukererwe. Ruhando ntiyishimiye ibyavuye muri iryo genzura maze atakambira Komiseri Mukuru w'Ikigo cy'Imisoro n'Amahoro asaba kuvanirwaho iyo misoro. Nyuma aza kumenyeshwa ko itakamba rye rifite ishingiro gusa ku ngingo ijyanye n'igihombo gikomoka ku mwaka wa 2007.

Ruhando yajuriye mu Rukiko Rukuru rw'Ubucuruzi, rwemeza ko ikirego cye gifite ishingiro, maze rutegeka ko umusoro ku nyungu urebana n'umwaka wa 2008 n'uwa 2010 uvanyeho kandi rwemeza ko umusoro ku nyongeragaciro wishyuwe ku kiranguzo ku mwaka wa 2008 uhwanyeye na 73.131.312Frw aho kuba 56.623.239Frw ndetse rutegeka RRA kwishyura Ruhando igihembo cya Avoka.

RRA yajuriye mu Rukiko rw'Ikirenga ivuga ko Urukiko Rukuru rw'Ubucuruzi rwemeje ko isoresha nta nteguza ryakozwe mu buryo budakurikije amategeko nyamara rwirengagije ko ubuyobozi bw'imisoro bufite uburenganzira bwo gusoresha nta nteguza iyo imenyekanisha ry'umusoro ryakozwe n'umusoreshwa ridaherekejwe n'inyandiko zose za ngombwa zirimo n'urutonde rw'abo abereyemo imyenda n'abayimubereyemo nk'uko biteganywa n'itegeko. Ruhando we yisobanura yemera ko n'ubwo itegeko riteganywa ko hari inyandiko zigomba guherekeza imenyekanisha ry'umusoro ariko ntiriteganywa izo ari zo ndetse n'umuntu ufite ububasha bwo kuzigena, bityo ko Komiseri yihaye ububasha ashyiraho amabwiriza arebana n'urutonde atari ngombwa akaba asaba urukiko kubikosora.

Indi mpamvu y'ubujurire ya RRA ni uko urukiko rwemeje ko umusoro waciwe Ruhando hagendewe ku gipimo cya 4% cy'ibyacuujwe mu mwaka binyuranyije n'amategeko nyamara rwirengagije ko iyo habaye isoresha nta nteguza bidashoboka kujya muni y'umusoro ucibwa hakoreshejwe inyungu zicishirije nk'uko biteganywa n'amategeko. Ruhando yiregura avuga

ko usoreshwa nta nteguza ari uba agomba gusora nyamara we akaba atagomba gusora kuko ari mu gihombo.

Indi mpamvu y'ubujurire ya RRA ni uko Urukiko Rukuru rw'Ubucuruzi rwirengagije ko umusoro ku nyongeragaciro watanzwe na Ruhando utari ukwiye kubarwa nk'uwishyuwe rushingiye ku kuba itari ifite uburenganzira bwo kuwugenzura kuko igihe cyo gukora igenzura cyari cyarazimye. Ruhando we yiregura avuga yuko iyo umusoreshwa akoze imenyekanisha, umusoresha ntakore igenzura mu gihe giteganywa n'amategeko, ibyakozwe n'umusoreshwa biba ndakuka.

[2] Ruhando Ernest ntiyishimiye ibyavuye muri iryo genzura, maze kuwa 08/02/2012 ajuririra Komiseri Mukuru w'Ikigo cy'Imisoro n'Amahoro, nawe amububiza kuwa 30/03/2012 amumenyeshya ko itakamba rifite ishingiro ku ngingo ijyanye n'igihombo

gikomoka ku mwaka wa 2007, bityo ku musoro yari yaciwe ungana na 162.068.634Frw avanirwaho ungana na 11.240.413Frw, hasigara 150.828.221Frw ajyanye n'umusoro ku nyungu ku myaka ya 2008 (ungana na 62.583.302Frw) na 2010 (ungana na 66.628.196Frw) hamwe n'umusoro ku nyongeragaciro w'imyaka ya 2008 (ungana na 12.701.584Frw) na 2009 (ungana na 8.915.139Frw), naho inyungu z'ubukererwe zikazabarwa ku muni kwishyura. Ku bijyanye n'umusoro ku nyongeragaciro w'umwaka wa 2008, Komiseri Mukuru yavuze ko umusoro wemewe ko wishyuwe ungana na 56.623.239Frw aho kuba 73.131.312Frw.

Rwategetse Ikigo cy'Igihugu cy'Imisoro n'Amahoro kwishyura Ruhando Ernest (Rwatole) 500.000Frw y'igihembo cya Avoka.

Avuga ko, mu kumenya icyo iyo nyandiko yafasha, harebwa uburyo umusoro ku nyungu ubarwa, ko ingingo ya 16 y'Itegeko N°16/2005 ryo kuwa 18/08/2005 rigena imisoro itaziguye ku musaruro iteganya ko inyungu ari ikinyuranyo hagati y'ibyinjiye n'ibyasohotse, naho ingingo ya 21 y'iryo Tegeko igateganya ibisabwa kugira ngo ikintu cyemerwe ko cyasohotse.
