

MUKAZI v. MBABAZI

Amategeko agenga umuryango – Ivangamutungo – Imicungire y'umutungo w'abashyingiranywe mu gihe umwe yitabye Imana – Iyo umwe mu bashyingiranywe apfuye usigaye asigarana inshingano zo gucunga umutungo wose – Itegeko N° 22/99 ryo ku wa 12/11/1999 ryuzuzanya igitabo cya mbere cy'Urwunge rw'amategeko mbonezamubano kandi rishyiraho igice cya gatanu cyerekeye imicungire y'umutungo w'abashyingiranywe, impano n'izungura, ingingo ya 70,76.

Amategeko agenga amasezerano – amasezerano yo kwikiranura – agaciro k'amasezerano yashyizweho umukono imbere ya noteri – kuba hari inenge zishingiye ku byo amasezerano agaragaza nk'ukuri kutari ko, ntiyafatwa nk'inyandiko mvaho umukozi wa Leta wabigenewe yabereye umuhamba kuko biba binyuranyije n'amategeko ndetse n'ukuri – Itegeko N°15/2004 ryo ku wa 12/06/2004 ryerekeye ibimenyetso mu manza n'itangwa ryabyo, ingingo ya 13.

Incamake y'ikibazo: Nyuma yaho Munyabagisha na Mwitende bitabiye Imana imitungo yabo yasigaranywe n'abana babo, Rurangwa, Mukamurangwa na Mukazi maze mu nama bise «Convention de gestion de la masse successorale du défunt Munyabagisha André» bemeranya ukuntu iyo mitungo izacungwa n'ukuntu amakimbirane azakemurwe aramutse abayeho.

Rurangwa aza gukora impanuka y'imodoka yitaba Imana, asiga umugore n'abana batatu. Ku wa 23/10/2003, abazungura ba Rurangwa bahagarariwe na nyina wabo Mbabazi hamwe n'abazungura ba Munyabagisha barongeye bakorana amasezerano yiswe «ubwumvikane hagati y'abagize umuryango wa nyakwigendera Munyabagisha André», bumvikana ko ibigize umutungo wose uzungurwa harimo n'inzu iri mu kibanza N°1163 kiri Nyarugenge, yanditse kuri Rurangwa, ariko bemeranya ko n'ubwo imwanditseho ari iya Se Munyabagisha, ko Mbabazi azakora uko ashoboye agakura iyo nzu ku mazina y'umugabo we ikajya ku mazina ry'umuryango wa Munyabagisha. Mbabazi yahawe n'urukiko uburenganzira bwo gucungira abana yabyaranye na Rurangwa umutungo, yongera kandi ahabwa uburenganzira bwo kugurisha inzu iri mu kibanza N°1163 kiri muri quartier mateus, maze ayigurisha uwitwa Karemera.

Igurishwa ry'iyi nzu ryateje ikibazo maze umwe mu bazungura ba Munyabagisha ariwe Mukazi aregera Urukiko Rwisumbuye rwa Nyarugenge asaba gutesha agaciro amasezerano y'ubugure bwabaye hagati ya Mbabazi na Karemera ku inzu iri mu kibanza N°1163 avuga ko nta bubasha yahawe bwo kugurisha iyo nzu kuko atari iye, asaba Urukiko gutegeka ko umutungo wagurishijwe igarurwa mu mutungo wa Munyabagisha, asaba n'indishyi z'akababaro. Urukiko rwemeza ko Munyabagisha yapfuye yaramaze kugurisha Rurangwa iyo nzu iburanwa, bityo ko nta muntu wari ufite ububasha bwo kuyigarura mu mutungo wa Munyabagisha nkuko byakozwe na Mbabazi, rutegeko ko amasezerano yiswe «ubwumvikane hagati y'abagize umuryango wa nyakwigendera Munyabagisha André», nta gaciro afite, rwemeza kandi ko inzu iburanwa yagurishijwe mu buryo bwemewe n'amategeko kuko Mbabazi yayigurishije ashingiyeye ku cyemezo yahawe n'Urukiko kimuha uburenganzira bwo kuyigurisha, kandi icyo cyemezo akaba nta wagitambamiye.

Mukazi yajuririye mu Rukiko Rukuru, maze rwemeza ko urubanza ruhindutse ku bijyanye n'indishyi gusa; arongerera ajurira mu Rukiko rw'ikirenga avuga ko umucamanza wo mu Rukiko Rukuru yahaye agaciro amasezerano y'ubugure bw'inzu iburanwa. Mbabazi na Karemera batanze inzitizi y'iburabubasha ry'Urukiko rw'Ikirenga ishingiyeye ku gaciro k'ikiburanwa no kuba abajuririye batsinzwe ku rwego rwa mbere n'urwa kabiri ku mpamvu zimwe, urukiko rwemeza ko nta shingiro ifite.

Mukazi avuga ko inkiko zose zirengagije amasezerano yo kuwa 23/10/2003 kandi ariho ikibazo kiri asaba urukiko kureba icyo ayo masezerano yari agamije. Akomeza avuga ko inkiko nta bubasha zari zifite bwo gutesha agaciro amasezerano yo ku wa 23/10/2003 kuko atavuguruzwa kandi akaba yarashizweho umukono mbere ya notaire akanasinya ko abaye umuhamya, akaba anafite agaciro k'urubanza rwaciwe burundu.

Uhagarariye Mbabazi avuga ko amasezerano yo ku wa 23/10/2003 atari ayo kwikiranura kuko abaho igihe hari impaka, amakimbirane, cyangwa hari amakimbirane ashobora kuvuka nyamara ayo masezerano akorwa nta makimbirane yariho, akomeza avuga ko bitumvikana ukuntu abantu bagiye bakicara bagafata umutungo wundi muntu bakavuga ko nubwo umwanditseho ataruwe, asanga ko impamvu yatumye Mbabazi asinya aariya masezerano yatewe nubutamenya (ignorance complete).

Karemera avuga ko icyo abo baburana bita amasezerano yo kwikiranura kidakwiye kwitwa amasezerano, kuko amasezerano yose ateganyaga uburenganzira n'inshingano (les droits et obligations) nyamara mu masezerano bita ayo kwikiranura ibyo bikaba nta birimo.

Incamake y'icyemezo: 1. Iyo umwe mu bashyingiranywe apfuye usigaye asigarana inshingano zo gucunga umutungo wose. Bityo kuba Mbabazi yaremeye gukora ibisabwa kugira ngo inzu iburanwa ive ku mazina y'umugabo we ijye ku izina ry'umuryango wa Munyabagisha binyuranyije n'amategeko kuko nta bundi bubasha yari afite kuri uwo mutungo uretse ubwo kuwucunga gusa (la gestion).

Bityo, amasezerano yo ku wa 23/10/2003 akaba atari ntavuguruzwa kuko Noteri wa Leta yemeje ibintu binyuranyije n'amategeko kandi binyuranyije n'ukuri, ahamya ko Mbabazi azakora ibishoboka byose inzu iburanwa yanditse kuri Rurangwa ikagarurwa mu mutungo wa Munyabagisha kandi nta kimenyetso yagaragarijwe gihamya koko ko n'ubwo imwanditseho ari iya Se.

3. Kuba nta buriganya bwabaye mu buryo Mbabazi yabonyemo icyemezo cyamuhaye uburenganzira bwo kugurisha, amasezerano y'ubugure bw'inzu nta nenge yaba afite yatuma ateshwa agaciro.

[1] Munyabagisha André n’umugore we Mwitende Mariam bashyiranywe byemewe n’amategeto, babyarana abana batatu; Rurangwa Innocent, Mukamurangwa Rose na Mukazi Françoise. Bombi bitabye Imana mu bihe binyuranye, Mwitende Mariam muri 1994, na Munyabagisha André ku wa 20/08/2000.

[2] Ku wa 04/09/2003, abazungura ba Munyabagisha André na Mwitende Mariam bakoze inama bemeranywa ku micungire y’imitungo basigiwe n’ababyeyi babo, bagirana inyandiko yiswe «Convention de gestion de la masse successorale du défunt Munyabagisha André», bemeranya ko imitungo yabo ikomeza gucungirwa hamwe kugeza igihe hazakorerwa «liquidation judiciaire», bumvikana ku buryo bagabana ububasha bwo kuyicunga, n’uburyo amakimbirane yaramuka avutse yakemurwa.

[4] Ku itariki ya 23/10/2003, abazungura ba Rurangwa Innocent bahagarariwe na nyina Mbabazi Joy kuko bari bakiri bato, n'abazungura ba Munyabagisha André, bagiranye amasezerano yiswe «ubwumvikane hagati y'abagize umuryango wa nyakwigendera Munyabagisha André», basinyira imbere ya Noteri hari n'abatangabuhamya, bumvikana ku bigize umutungo wose uzungurwa wari umaze kumenyekana, harimo n'inzu iri mu kibanza N° 1163 kiri Nyarugenge, yanditse kuri Rurangwa Innocent, ariko bemeranya ko n'ubwo imwanditseho ari iya Se Munyabagisha André, Mbabazi Joy, umugore wa Rurangwa Innocent, yemera gukora ibisabwa n'amategeko kugira ngo iyo nzu ive ku mazina ya Rurangwa Innocent ijye ku izina ry'umuryango wa Munyabagisha André.

[6] Nyuma y'ibyo, ku wa 24/03/2005, Mbabazi Joy yahawe n'Urukiko rw'Akarere ka Nyarugenge uburenganzira bwo gucungira abana yabyaranye na Rurangwa Innocent umutungo se yabasigiye, naho ku wa 05/04/2005, abisabye Perezida w'urwo Rukiko, ahabwa uburenganzira bwo kugurisha inzu yubatswe mu kibanza N°1163 kiri muri «quartier Mateus», mu Karere ka Nyarugenge, ayigurisha Karemera Peninah ku wa 06/04/2005, igurishwa ry'iyi nzu akaba ari ryo ryabaye intandaro y'imanza baburana kugeza ubu.

[7] Mukazi Françoise yaregeye Urukiko Rwisumbuye rwa Nyarugenge, arusaba kwemeza ko amasezerano y'ubugure bw'inzu iri mu kibanza N°1163 kiri Nyarugenge, yabaye hagati ya Karemera Peninah na Mbabazi Joy ku wa 06/04/2005, nta gaciro afite kuko Mbabazi Joy yagurishije iyo nzu itari iye nta n'ububasha yahawe n'abazungura ba Munyabagisha André, asaba ko iyo nzu igarurwa mu mutungo wa Munyabagisha André, asaba n'indishyi z'akababaro.

[8] Urwo Rukiko rwaciye urubanza RC 0212/14/TGI/NYGE, ku wa 29/05/2014, rwemeza ko Munyabagisha André yapfuye yaragurishije umuhungu we Rurangwa Innocent inzu iburanwa, umugore we Mbabazi Joy n'abandi bazungura ba Munyabagisha André nta bubasha bari bafite bwo kuyigarura mu mutungo wa Munyabagisha André, ko n'amasezerano yo ku wa 23/10/2003, nta gaciro afite ku byerekeye iyo nzu. Rwemeje kandi ko inzu iburanwa yagurishijwe mu buryo bwemewe n'amategeko kuko Mbabazi Joy yayigurishije ashingiye ku cyemezo yahawe n'Urukiko rw'Akarere ka Nyarugenge kimuha uburenganzira bwo kuyigurisha, kandi icyo cyemezo akaba nta wagitambamiye;

[9] Mukazi Françoise yajuririye urwo rubanza mu Rukiko Rukuru, narwo ruca urubanza RCA 0340/14/HC/KIG, ku wa 27/02/2015, rwemeza ko urubanza rwajuririwe ruhindutse gusa ku bijyanye n'indishyi zasabwe, rutegeka Mukazi Françoise guha Mbabazi Joy na Karemera Peninah buri wese 1.000.000Frw, akubiyemo indishyi z'akababaro, amafarang y'ikurikiranarubanza n'igihembo cya Avoka ku rwego rwa mbere, na 700.000Frw buri wese na none akubiyemo indishyi z'akababaro, n'amafaranga y'ikurikiranarubanza n'igihembo cya Avoka ku rwego rwa kabiri, akanishyura amagarama y'urubanza.

[19] Ingingo ya 13 y’Itegeko N°15/2004 ryo ku wa 12/06/2004 ryerekeye ibimenyetso mu manza n’itangwa ryabyo, iteganya ko Inyandikomvaho ikemura impaka kuri bose mu byerekeye ibiyivugwamo umukozi wa Leta ubigenewe yabereye umuhama cyangwa yakoze ariko atarengeje ibyo yari ashinzwe gukora. Ibivuzwe muri iyo nyandikomvaho ntawe ushobora kubihakana, keretse biramutse bikurikiranywe mu rubanza rushinja icyaha cyo kubeshya mu nyandikomvaho cyangwa umuburanyi aregeye ko iyo nyandikomvaho ari impimbano. Ku byerekeye ibindi ihama, ibyo ivuga n’ukuri kw’ababuranyi, inyandikomvaho yemerwa iyo itavugurujwe n’ikindi kimenyetso cyanditswe cyangwa cyunganiwe n’ikimenyetso cyanditse kituzuye, iyo ihakanwa n’umuburanyi, naho iyo ihakanwa n’undi muntu ashobora kubitangira ikindi kimenyetso cyose cyemerwa n’amategeko.

[20] Mu gufata icyemezo ku byerekeranye n’uko inzu iburanwa itagomba kugarurwa mu mutungo wa nyakwigendera Munyabagisha André, Urukiko Rukuru rwashingiye ku mpamvu y’uko mbere y’uko yitaba Imana, Munyabagisha yari yarayigurishije umuhungu we Rurangwa Innocent ndetse inamwanditseho, ko Mbabazi Joy n’abazungura ba Munyabagisha André nta bubasha bari bafite bwo kuvana iyo nzu mu mutungo wa Rurangwa Innocent ngo bayisubize mu mutungo wa se, runagaragaza ko Mbabazi Joy yagurishije iyo nzu byemewe n’amategeko kuko yabihereye uburenganzira n’Urukiko.
