Yasabye kandi guhabwa indishyi z'akababaro kuko Ikigo cy'Imisoro n'Amahôro cyayifashe nka bihemu bituma ivanwa kuri *serveur* y'abashinzwe kumenyekanisha umusoro, isaba na none guhabwa amafaranga y'ikurikiranarubanza, igihembo cya Avoka no gusubizwa amagarama yatanze.

New Kigali Business Services Ltd yavuze ko ku wa 30/06/2016, yamenyesheje ikigo cy'Imisoro n'Amahôro iby'uko ibyo bicuruzwa bitageze mu Rwanda, aho kugira ngo kibyiteho, ku wa 25/07/2016, itungurwa no kubona iciwe umusoro n'ibihano bigana na 152.165.330 Frw no kubona ivanywe kuri serveur y'abamenyekanisha umusoro, isaba ko isubizwa kuri serveur, Kasese Distillers Ltd ikaryozwa umusoro n'ibihano yaciwe.
