Amategeko agenga ibimenyetso – Agaciro ka fotokopi y'inyandiko nk'ikimenyetso – Fotokopi y'inyandiko ishobora gukoreshwa nk'ikimenyetso iyo ishoboye gusuzumwa bikagaragara ko ifitiwe icyizere cyangwa uyikoresha akagaragariza Urukiko ko umwimerere wayo wazimiye mu bihe bidasanze.

Incamake y'Ikibazo: Kansiime James yaregeye Urukiko rw'Ubucuruzi rwa Nyarugenge asaba ko rwategeka Prime Insurance Ltd kubahiriza amasezerano y'ubwishingizi bagiranye aho avuga ko Prime Insurance Ltd yishingiye imodoka ye bemeranya ko mu gihe yaba igize ikibazo yahabwa amafaranga miliyoni cumi n'umunani (18.000.000 Frw) cyangwa akagurirwa imodoka nshya, ibi bikaba atariko byagenze ngo kuko nyuma yo kwangirika kw'Imodoka yishingiye Prime Insurance Ltd yayijyanye kuyikoresha mu garaje ibintu avuga ko binyuranyije n'amasezerano bagiranye. Mu guca urubanza Urukiko rw'Ubucuruzi rwemeje ko Prime Insurance Ltd itsinzwe ruyitegeka kwishyura Kansiime James miliyoni cumi n'umunani (18.000.000 Frw) zihwanye n'agaciro k'imodoka ndetse n'indishyi zitandukanye.

Prime Insurance Ltd ntiyishimiye imikirize ijuririra urwo rubanza mu Rukiko Rukuru rw'Ubucuruzi aho yavugaga ko Urukiko rw'Ubucuruzi rwirengagije ibimenyetso bifatika rwashyikirijwe, Kansiime James na we yatanze ubujurire bwuririye ku bundi avuga ko indishyi yagenewe ari nke. Urukiko Rukuru rw'Ubucuruzi rwaciye urubanza rwemeza ko ubujurire bwa Prime Insurance Ltd nta shingiro bufite, naho ubujurire bwuririye ku bundi bwa Kansiime James bufite ishingiro kuri bimwe, ko nta gihindutse ku mikirize y'urubanza rwajuririye uretse indishyi ziyongereye.

Prime Insurance Ltd yatanze ikirego mu rwego rw'akarengane, ivuga ko impamvu ishingiraho yemeza ko yagiriwe akarengane ari uko Inkiko zabanje zirengagije ikimenyetso yazishyikirije cy'inyandiko yiswe *Quittance de règlement* Kansiime James yasinyeho avana imodoka ye mu igaraji yemeza ko ntacyo agikurikiranye, ikomeza ivuga ko nubwo iyo nyandiko bayiburiye umwimerere ko Urukiko rwagombaga gushingira ku zindi nyandiko bafite KANSIIME James yasinyeho kandi adahakana hakagereranywa imikono izigaragaraho n'umukono uri ku nyandiko atemera. Kuri uru rwego, Kansiime James nawe yatanze ikirego kiregera kwiregura avuga ko Urukiko rwamugeneye indishyi nkeya.

Mu kwisobanura, Kansiime yavuze ko Urukiko rutagomba gushingira kuri fotokopi Prime Insurance Ltd yerekana ngo kuko kubwe iriya nyandiko ari impimbano biyandikiye bagamije kumuhuguza ibyo amasezerano bagiranye avuga. Ibi abishingira ko iriya nyandiko bagaragaza bananiwe kuyibonera umwimerere wayo, ikaba itaranabashije gupimwa n'abahanga ngo ukuri kwayo kumenyekane kandi ko Prime Insurance Ltd itanerekana uko byagenze ngo umwimerere wayo uzimire burundu.

Prime Insurance Ltd yiregura ku kirego kiregera kwiregura cyatanzwe na Kansiime uvuga ko yagenewe indishyi nkeya, ivuga ko iki kirego kidakwiye no kwakira ngo kuko cyatanzwe mu buryo bunyuranyije n'amategeko ngo kuko yagombaga kwandikira Perezida w'Urukiko rw'Ubujurire amugaragariza akarengane avuga yagiriwe n'Urukiko Rukuru rw'Ubucuruzi, aho kubikora gutyo rero akaba yarashisemo kuririra ku kirego cyabo kandi ibi bikaba bitandukanye n'ibyo amategeko ateganya ku birego bimeze nk'ibi.

I. IMITERERE Y'URUBANZA

[1] Uru rubanza rwatangiriye mu Rukiko rw'Ubucuruzi, Kansiime James arega Prime Insurance Ltd ko itubahirije amasezerano y'ubwishingizi bw'imodoka (assurance omnium) bagiranye ku itariki ya 08/07/2015, yanga kumwishyura agaciro k'iyo modoka nyuma y'aho igiriye impanuka ikangirika bikomeye ku buryo idashobora gukorwa. Prime Insurance Ltd yo yavugaga ko nyuma y'aho impanuka ibereye, impande zombi zumvikanye ko imodoka igomba gukoreshwa mu igaraji (HC GARAGE Ltd), irangiye Kansiime James yanga kuyitwara, ko rero nta masezerano yishe.

[2] Ku itariki ya 08/12/2016, Urukiko rw'Ubucuruzi rwaciye urubanza RCOM 01079/2016/TC/Nyge, rwemeza ko Prime Insurance Ltd itsinzwe no kubura ibimenyetso byerekana

ko Kansiiime James yemeye ko imodoka ye ijya gukoreshwa mu igaraji, ruyitegeka kumwishyura miliyoni cumi n'umunani (18.000.000 Frw) zihwanye n'agaciro k'imodoka, miliyoni zirindwi n'ibihumbi magana atatu na makumyabiri (7.320.000 Frw) yakoresheje akodesha imodoka yo kugendamo, miliyoni eshatu (3.000.000 Frw) y'indishyi z'akababaro, ibihumbi magana atanu (500.000 Frw) y'igihembo cya Avoka, no gusubiza Kansiiime James ibihumbi mirongo itanu (50.000 Frw) yatanze arega.

[3] Prime Insurance Ltd yajuririye urwo rubanza mu Rukiko Rukuru rw'Ubucuruzi, Kansiiime James na we atanga ubujurire bwuririye ku bundi avuga ko indishyi yagenewe ari nke. Ku itariki ya 02/10/2018, urwo Rukiko rwaciye urubanza RCOMA 00008/2017/CHC/HCC rwemeza ko ubujurire bwa Prime Insurance Ltd nta shingiro bufite, naho ubujurire bwuririye ku bundi bwa Kansiiime James bufite ishingiro kuri bimwe, ko nta gihindutse ku mikirize y'urubanza rwajuririwe uretse indishyi ziyongereye, rutegeka Prime Insurance Ltd kwishyura Kansiiime James indishyi zose hamwe zingana na miliyoni mirongo itatu n'eshatu n'ibihumbi magana cyenda (33.900.000 Frw).

[4] Ku birebana n'inyandiko yiswe "Quittance de règlement", ikimenyetso Prime Insurance Ltd iburanisha ubu, Urukiko Rukuru rw'Ubucuruzi rwavuze ko rutayishingiraho kuko ari fotokopi, Prime Insurance Ltd yayiburanishije ikaba itarabashije gutanga umwimerere wayo kugira ngo isuzumwe kubera ko Kansiiime James uyitirirwa yayihakanye. Urwo Rukiko rwanze no gushingira ku buhama bwa nyir'igaraji ruvuga ko nta kimenyetso na kimwe cyagaragajwe cyerekana ko ari Kansiiime James wamuhaye imodoka cyangwa ko hari ikindi kintu icyo ari cyo cyose bakoranye, rwanga no gushingira ku buhama bw'Umuhesha w'Inkiko kubera ko ibyari mu nyandiko ye ari ibyo yari yabwiwe, atari ibyo yari yiboneye mu rwego rw'akazi ke.

[5] Prime Insurance Ltd yandikiye Perezida w'Urukiko rw'Ubujurire imusaba ko yasuzuma akarengane yagiriwe muri urwo rubanza kugira ngo ruzasubirwemo ku mpamvu z'akarengane. Nyuma yo gusuzuma icyo kibazo, Perezida w'Urukiko rw'Ubujurire yandikiye Perezida w'Urukiko rw'Ikirenga amusaba ko urubanza RCOMA 00008/2017/CHC/HCC rwasubirwamo ku mpamvu z'akarengane.

[6] Ku itariki ya 18/12/2018, ashingiye kuri raporo yakozwe na Perezida w'Urukiko rw'Ubujurire, Perezida w'Urukiko rw'Ikirenga yafashe icyemezo ko urwo rubanza rwoherezwa mu Bwanditsi bw'Urukiko kugira ngo ruzongere ruburanishwe, ruhabwa N° RS/INJUST/RCOM 00005/2018/SC.

[7] Mu myanzuro yayo, Prime Insurance Ltd ivuga ko Urukiko Rukuru rw'Ubucuruzi rwirengagije ibimenyetso yarushyikirije birimo inyandiko Kansiiime James yasinyeho asaba ko Akagera Motors Ltd gutanga imodoka ye ikajya gukorwa na HC GARAGE Ltd ndetse n'inyandiko yiswe "Quittance de règlement" yasinyeho yemeza ko imodoka ye yakozwe neza ko ntacyo azabaza Prime Insurance Ltd.

[8] Kansiiime James we ariko avuga ko ibimenyetso Prime Insurance Ltd ishingiraho byose ari ibihimbano, kuko inyandiko zose yerekana ariyo yazikoreye igamije kuzazikoresha mu Rukiko. Avuga ko ahubwo nawe asaba Urukiko kuzasuzuma indishyi zigendanye n'amafaranga yakoresheje akodesha imodoka yo kumufasha mu kazi rukazongera kubera ko izo yagenewe n'Urukiko Rukuru rw'Ubucuruzi ari nkeya. Ibi binareba indishyi zo gusiragira mu manza kimwe n'amafaranga y'igihembo cya Avoka.

[9] Uru rubanza rwaburanishijwe mu ruhamwe ku itariki ya 07/01/2020, Prime Insurance Ltd ihagarariwe na Me Masumbuko NDE Emile, Kansiiime James yunganiwe na Me Bandora Alfred.

Aba bahise baregera ko inyandiko Prime Insurance Ltd ikoresha mu rubanza nk'ibimenyetso ari impimbano, basaba Urukiko ko zasuzumwa hakarebwa niba umukono uziraho ari uwa Kansiiime James koko kuko yemezaga ko atari we wazisinye. Izo nyandiko ni iyo ku itariki ya 10/02/2016 yandikiwe Umuyobozi w'Akagera Motors n'iyi ku itariki ya 06/06/2016 yiswe "Quittance de règlement".

[10] Prime Insurance Ltd yavuze ko inyandiko yo ku itariki ya 10/02/2016 itazayiburanisha mu rubanza, ko iyo izaburanisha ari "Quittance de règlement" yo ku itariki ya 06/06/2016 yonyine, ko ariko bafite ikibazo cyo kuba barabuze umwimerere wayo. Yavuze ariko ko hari izindi nyandiko bafite Kansiiime James yasinyeho kandi adahakana, ko bazitanga hakagereranywa imikono izigaragaraho n'umukono uri ku nyandiko atemera. Izo nyandiko ni izi zikurikira:

Amasezerano y'ubwishingizi (contrat d'assurance);

Imenyekanisha ry'impanuka (déclaration d'accident);

"Contre-expertise" yasinyweho na Kansiiime James yemera ko imodoka ye ishobora gukorwa;

Inyandiko Kansiiime James yandikiye Prime Insurance Ltd ayisaba gushyira mu bikorwa icyemezo cy'urukiko.

[14] Ku ruhanda rwa Kansiiime James bavuze ko bemeranya n'ibyatangajwe na Rwanda Forensic Laboratory ko bitashoboka gusuzuma inyandiko itari umwimerere, basaba Urukiko gutegeka Prime Insurance Ltd kuzana umwimerere w'inyandiko zose yasabwe kuko ariyo yazizanye mu Rukiko izimuregesha, bitaba ibyo iburanisha ry'urubanza rigakomeza nta suzumwa ry'inyandiko rikozwe, hakazashingirwa ku masezerano y'ubwishingizi impande zombi zakoranye kuko ziyemeranyaho,

[15] Iburanisha ry'urubanza ryongeye gusubukurwa ku itariki ya 18/05/2020, ababuranyi bombi bahari, Prime Insurance Ltd ihagarariwe na Me Masumbuko Nde Emile, Kansiiime James yunganiwe na Me Bandora Alfred, ku ruhande rwa Prime Insurance Ltd bakomeza kuvuga ko inyandiko y'umwimerere yo ku itariki ya 06/06/2016 yiswe "Quittance de règlement" idashobora kuboneka.

[16] Hakurikijwe imiterere y'uru rubanza, ibibazo by'ingenzi byasuzumwe ni ukumenya niba Prime Insurance Ltd yarubahirije amasezerano y'ubwishingizi bw'imodoka (assurance omnium) yagiranye na Kansiiime James, no kumenya niba indishyi Kansiiime James yagenewe n'Urukiko Rukuru rw'Ubucuruzi ari nkeya.

II. IBIBAZO BIGIZE URUBANZA N'ISESENGURWA RYABYO

a. Kumenya niba Prime Insurance Ltd yarubahirije amasezerano y'ubwishingizi bw'imodoka yagiranye na Kansiiime James.

[17] Mu myanzuro ye, Me Masumbuko Nde Emile uhagarariye Prime Insurance Ltd, avuga ko akarengane kari mu rubanza rwaciwe n'Urukiko Rukuru rw'Ubucuruzi basaba ko rwasubirwamo, ni uko urwo Rukiko rwirengagije ibimenyetso barushyikirije bagaragaza ko amasezerano y'ubwishingizi bagiranye na Kansiiime James bayubahirije. Avuga kandi ko berekanye ko HC. GARAGE Ltd ariyo yatsindiye isoko ryo gukora imodoka yishingiwe, Prime Insurance Ltd imaze kubyumvikanaho na nyirayo ariwe Kansiiime James. Anavuga ko imodoka irangije gukorwa, ku itariki ya 06/06/2016, Kansiiime James yagiye kuyifata mu igaraji agasinya inyandiko yabigenewe yitwa "Quittance de règlement", muri iyo nyandiko akaba yaremeje ko nta kindi kibazo afitanye na Prime Insurance Ltd, iyo nyandiko akaba ari yo Prime Insurance Ltd yahereyeho yishyura nyir'igaraji ku kazi kakozwe.

[18] Me Masumbuko Nde Emile avuga ko ikibazo kiri muri uru rubanza ari uko Kansiiime James ahakana inyandiko yasinye avana imodoka mu igaraji (Quittance de règlement) yitwaza ko ari fotokopi, n'Urukiko Rukuru rw'Ubucuruzi akaba ari byo rwagendeyeho, nyamara bakirengagiza ibiteganywa n'amategeko. Avuga ko ingingo ya 35, igika cya 3, y'Itegeko N° 15/2004 ryo ku wa 12/06/2004 ryerekeye ibimenyetso mu manza n'itangwa ryabyo, iteganya ko kopi y'inyandiko idateyeho icyemezo cy'uko ihuye n'inyandiko y'umwimerere igira agaciro igihe yunganiwe n'ikindi kimenyetso kitabujijwe n'amategeko, iyo inyandiko y'umwimerere idashobora kuboneka, ingingo ya 41 y'iryo Tegeko igateganya ko iyo umuburanyi ahakanye ko ariwe wanditse inyandiko, cyangwa ko atari we wayishyizeho umukono, Urukiko rushobora kubicaho rugaca urubanza, iyo rufite ibimenyetso bigaragaza ko iyo mvugo ari amayeri yo gutinza urubanza, bitaba ibyo rugategeka isuzumwa ry'inyandiko mu buryo buteganywa n'amategeko.

[19] Avuga ko muri uru rubanza, Urukiko Rukuru rw'Ubucuruzi rwari rwemeje isuzuma ry'umukono wa Kansiiime James ugaragara ku nyandiko baburanishaga harimo na "Quittance de règlement", bikaba bitarakozwe bitewe ni uko nta mwimerere w'izo nyandiko wabonetse. Avuga ko Urukiko rwirengagije ibiteganywa n'ingingo ya 35, igika cya 3, y'Itegeko ryerekeye ibimenyetso mu manza n'itangwa ryabyo ryavuzwe haruguru, ko niba inyandiko y'umwimerere ya "Quittance de règlement" baburanisha uyu munsu itarashoboraga kuboneka, Urukiko rwashoboraga gushingira kuri fotokopi yayo kubera ko yari yunganiwe n'ibindi bimenyetso bishingiye ku nyandiko z'umwimerere zavuzwe haruguru zigaragaza umukono wa Kansiiime James kandi adahakana,

ndetse no ku buhamya bwa nyir'igaraji ryakorewemo imodoka ye n'ubw'umuhesha w'inkiko w'umwuga wemeje ko iyo modoka yakorewe muri iryo garaji koko.

[20] Akomeza avuga ko uretse n'izo nyandiko, Urukiko Rukuru rw'Ubucuruzi rwirengagije ubuhamya bwatanzwe na nyir'igaraji ryakorewemo imodoka n'ibivugwa mu nyandiko y'Umuhesha w'Inkiko w'Umwuga, aba bombi bakaba bemeza ko imodoka ijya gukorerwa muri HC GARAGE Ltd, Kansiime James yari abizi. Avuga ko iyo iriya fotokopi ya “Quittance de règlement” iza gusuzumwa, Urukiko rukabona ko yunganiwe n'ibindi bimenyetso, rwagombaga kwifashisha ingingo ya 28³ y'Itegeko ryerekeye ibimenyetso mu manza n'itangwa ryabyo, bakayimutsindisha uko amategeko abiteganyaga.

[21] Arangiza avuga ko nyuma yo kwanga gukora isuzuma ry'inyandiko yagibwagaho impaka, Umucamanza yashingiye ku ngingo ya 12 y'Itegeko ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi, yemeza ko Prime Insurance Ltd itsinzwe kubera ko itagaragaje ibimenyetso by'umwimerere, ko mu myumvire ye, udafite inyandiko y'umwimerere aba adafite ibimenyetso, ko rero yirengagije ibiteganywa n'ingingo ya 35, igika cya 3, y'Itegeko ryerekeye ibimenyetso bakomeje kugarukaho.

[22] Mu myanzuro ye, Me Bandora Alfred wunganira Kansiime James, avuga ko nta karengane kagaragara mu rubanza rusabirwa gusubirwamo rwaciwe n'Urukiko Rukuru rw'Ubucuruzi, ko inyandiko zose Prime Insurance Ltd iburanisha ishaka kumvikanisha ko imodoka ya Kansiime James ijya gukorerwa muri HC GARAGE Ltd yari abizi ari impimbano yikoreye kugira ngo izazikoreshe mu rukiko, cyane cyane ko izo nyandiko yitirirwa zanditse mu rurimi rw'igifaransa atazi, ibyo ikaba yarabikoze ishaka kwanga kubahiriza amasezerano y'ubwishingizi bw'imodoka bagiranye.

[23] Avuga ko nta mpamvu Kansiime James yari kwemera ko imodoka ye ikorwa kandi afite “Assurance Omnium”, mu gihe *garage* Akagera Motors yari yamaze kumubwira ko yangiritse cyane ku buryo idashobora gukorwa, akaba nta nyungu yari afite yo kwemera ko bajyana imodoka ye kuyikoresha mu rindi garaji kandi amasezerano yari afitanye na Prime Insurance Ltd yaramwemereraga guhabwa imodoka nshya. Avuga ko ahubwo yategereje ko Prime Insurance Ltd imwishyura amafaranga ayiguze nk'uko byari mu masezerano cyangwa se ikamugurira indi modoka nshya agaheba.
