Sanlam Assurances Générales Plc yireguye ivuga ko nta ndishyi igomba kuryozwa kuko imodoka yahitanye Sinzabakwira yari yafashwe n'Akarere ka Kirehe, ipakiye abantu barenga umubare w'abo yishingiye, ndetse itwawe n'umuntu udafite uruhushya rwo kuyitwara.

Urukiko rwemeje ko Sanlam Assurances Générales Plc igomba gutanga indishyi z'impozamarira ku bareze kuko ibyo ivuga ko imodoka yafashwe n'Akarere ka Kirehe yari ipakiye abantu barenga umubare yari yemerewe gutwara, ndetse ikaba yari inatwawe n'utabifitiye uruhushya rwo kuyitwara bitayikuraho inshingano yo kwishyura abangirijwe n'icyo kinyabiziga kuko itagaragaza ko umunsi Akarere ka Kirehe kakoresheje iyo modoka, yari yasheshe amasezerano y'ubwishingizi yari ifitanye n'uwishingiwe.

Sanlam Assurances Générales Plc yajuririye Urukiko Rukuru, inasaba ko hagobokeshwa ku gahato abazungura ba Gatashya n'Akarere ka Kirehe kugira ngo baryozwe indishyi yaciwe ziturutse ku makosa bakoze yo kuba imodoka yaratwawe n'umushoferi utabifitiye uruhushya, agatwara umubare urenze uw'abantu bishingiwe ahagenewe gutwarwa imizigo. Abaregeye indishyi bireguye bavuga ko ubujurire bwayo nta shingiro bufite. Urukiko, rwemeje ko ukugobokeshwa ku gahato kw'Akarere ka Kirehe n'Abazungura ba Gatashya gufite ishingiro. Rwemeje kandi ko Gatashya n'Akarere ka Kirehe bishe amasezerano y'ubwishingizi kuko batwawe abantu 52 ahatwarwa imizigo, bemera kandi ko imodoka itwarwa n'umuntu utabifitiye uruhushya, rutegeka ko indishyi Sanlam Assurances Générales yaciwe mu rubanza rwajuririye zishyurwa na Succession Gatashya ifatanyije n'Akarere ka Kirehe ku buryo bungana.

Akarere ka Kirehe kajuririye Urukiko rw'Uburire kavuga ko kavukijwe amahirwe yo gutumirwa mu nama ntegurubanza kandi kari kagobokeshejwe ku gahato bwa mbere mu Rukiko Rukuru, ko

kandi Urukiko rwirengagije ibiteganywa n'amasezerano y'ubwishingizi yakozwe hagati ya Sanlam Assurances Générales Plc n'uwishingiwe. Urukiko rw'Ubujurire rwasanze indishyi zagenwe mu rubanza rwajuririwe zitageze ku ziteganywa n'amategeko rwemeza ko ubujurire butakiriwe ko kuko butari mu bubasha bwarwo.

Urukiko nyuma yo gusanga Akarere ka Kirehe ari ko konyine kasabye ko urubanza rwaciwe n'Urukiko rw'Ubujurire rusubirwamo ku mpamvu z'akarengane, rwavuze ko kuba hari ubujurire bwuririye ku bundi bwatanzwe n'abaregera indishyi mu Rukiko rw'Ubujurire ntibusuzumwe kubera ko ubujurire bw'iremezo butakiriwe, ntibagire icyo banenga icyo cyemezo, bigaragaza ko nta nyungu bari bagifite muri ubwo bujurire, bityo rwemeza ko no mu rubanza rusubirishwamo ku mpamvu z'akarengane badakwiye kugarura ingingo z'ubujurire bwuririye ku bundi bari batanze mu Rukiko rw'Ubujurire.

Ku bijyanye no Kumenya ukwiye kuryozwa indishyi zikomoka ku mpanuka y'imodoka ivugwa muri uru rubanza, Uburanira Akarere ka kirehe avuga ko Urukiko Rukuru, ntaho rwashingiye ruca Akarere ka Kirehe indishyi kuko rutagaragaje amakosa kaba karakoze, naho abaregera indishyi bavuga ko amategeko agenga ubwishingizi bw'ibinyabiziga bigenzwa na moteri ateganya ko impanuka yose, hatitawe ku cyayiteye, yishyurwa n'umwishingizi hanyuma akazikurikiranira uwamuteje igihombo. Asobanura ko Sanlam Assurances Générales Plc ariyo ikwiye kuryozwa indishyi.
