Atanga urugero rwo mu Gihugu cy'Ubugande aho abanyamakuru badasabwa uruhushya rwo gutara amakuru mu nkiko zabo ahubwo berekana gusa icyangombwa kibaranga.

Naho ingingo ya 12 y'iryo tegeko nayo ikaba yemerera umunyamakuru gutara amakuru ahariho hose no kuyatangaza yubahiriza ibiteganywa n'amategeko, akaba rero yumva kubanza gusaba uruhushya ari imbogamizi ikomeye. Asaba Urukiko kuzasuzuma ibyavuzwe mu rubanza rwa Mugisha Richard rwaciwe n'Urukiko rw'Ikirenga, aho mu gika cyarwo cya 65, rwavuze ko ubwisanzure bw'itangazamakuru ari uburenganzira bugomba kubahirizwa na buri wese.

[18] Me Musore Gakunzi Valéry nawe wunganira Byansi Samuel Baker, avuga ko ingingo ya 71 y'Itegeko N°22/2018 ryavuzwe haruguru iri mu cyiciro cya 2 kirebana n'iburanisha mu Rukiko. Asobanura ko gufata amajwi n'amafoto ari bimwe mu bigize itangazamakuru. Akaba asanga kugira ngo Urukiko rushobore gusuzuma niba iyo ngingo inyuranyije n'Itegeko Nshinga ari ngombwa

gusuzuma niba hari ubundi burenganzira cyangwa ubwisanzure byabangamira mu gihe umunyamakuru afata amajwi n'amafoto mu iburanisha nta ruhushya yabihereye.

[20] Ku birebana n'igisobanuro cy'imibereho bwite y'abantu (*privacy/vie privée*), avuga ko haba mu Itegeko Nshinga cyangwa mu Itegeko riteganywa ibyaha n'ibihano muri rusange, nta na hamwe hatangwa icyo gisobanuro. Itegeko N° 058/2021 ryo ku wa 13/10/2021 ryerekeye kurinda amakuru bwite n'imibereho bwite by'umuntu, mu ngingo ya 3, 6°, niryoyisobanura imibereho bwite y'umuntu nk'uburenganzira bw'ibanze bw'umuntu bwo kwemeza undi muntu ushobora kubona amakuru bwite ye, igihe n'ahantu yayabonera, impamvu yayabona, uburyo akoresha ayabona n'uburyo bwakoreshwa kugira ngo agerweho.

[21] Atanga urugero rw'urubanza rwaciye n'Urukiko rw'Ikirenga rugatanga umurongo ku bijyanye n'imibereho bwite, aho Gisa Frediane yasabye Urukiko gutegeka indishyi zikomoka ku kuba BRALIRWA yarakoresheje amashusho n'amafoto ye mu kwamamaza ikinyobwa cyo mu bwoko bwa Heineken atabiyihereye uburenganzira. Uburanira BRALIRWA Ltd, mu Rukiko Rukuru rw'Ubucuruzi, yemeye ko koko ayo mashusho n'amafoto yakoreshejwe na BRALIRWA Ltd mu kwamamaza inzoga zayo kandi nta masezerano yagiranye na Gisa Frediane, avuga ko BRALIRWA Ltd yayahawe na sosiyete EXP RWANDA, ariko ntiyashobora kugaragaza amasezerano yagiranye n'iyi sosiyete.

[22] Akomeza asobanura ko Urukiko rw'Ikirenga rwaciye urubanza ku ngingo ya 38 y'Itegeko Nshinga³ ruvuga ko ubwisanzure bwo kugaragaza ibitekerezo bugizwe no gutanga ibitekerezo ntacyo umuntu yikanga, n'uburenganzira bwo gushaka, kubona no gukwirakwiza amakuru n'ibitekerezo aho ariho hose. Bikumvikana ko icyo aricyo cyose harimo n'itegeko cyangwa ingingo yaryo, cyabubangamira kiba kinyuranyije naryo.

[23] Avuga ariko ko nk'uko n'amategeko y'u Rwanda nayo abiteganywa, ubwisanzure bw'itangazamakuru bugira irengayobora (*exceptions/restrictions*) harimo kutabangamira imibereho bwite y'umuntu (*privacy/vie privée*). Yifashisha urubanza *Affaire Pinto Coelho C. vs Portugal* (nimeru 2) rwaciye n'Urukiko rw'i Burayi rushinzwe uburenganzira bwa muntu mu gusobanura ibishingirwaho hemezwa ko ubwisanzure bw'itangazamakuru bubangamiye imibereho bwite y'umuntu.

[24] Avuga ko ikibazo cyari muri urwo rubanza gikomoka ku kuba umunyamakuru yaratangaje inkuru kuri televiziyo ku rubanza rwari mu rukiko rwakatiye umuntu, asobanura ko uwakatiwe arengana ashingiye ku mvugo y'abatangabuhamya, ushinja n'abandi 2 bashinjura, anerekana amafoto y'icyumba cy'iburanisha n'amajwi yafashwe mu iburanisha harimo n'ay'abacamanza 3 bagize inteko, ariko amajwi yayahinduye. Perezida w'inteko iburanisha yaramureze avuga ko yanyujijeho amajwi atangaza amafoto y'icyumba cy'iburanisha nta burenganzira yabihereye. Urukiko rurinda Itegeko Nshinga (*Tribunal constitutionnel*) rw'Igihugu cya Portugal rumuhamya icyaha.

n'uburenganzira ku mibereho bwite y'umuntu, hagomba kuba ibintu bitatu (3) byuzuzanya: i) niba iryo rengayobora cyangwa imbogamizi iteganyijwe n'amategeko; ii) gusuzuma niba iryo rengayobora cyangwa imbogamizi igamije intego yumvikana (*but légitime*); iii) gusuzuma niba uko kwivanga mu bwisanzure bw'itangazamakuru ari ngombwa mu gihugu kigendera kuri demokarasi (*si l'ingérence était nécessaire dans une société démocratique*).

[26] Avuga ko mu gusobanura izo ngingo eshatu, Urukiko rwashingiye ku mahame y'ingenzi yashingiweho mu manza rwaciye mbere harimo kuba amajwi n'amashusho yafashwe n'umunyamakuru mu gihe cy'iburanisha yarafashwe hagamijwe gutanga amakuru afitiye inyungu rubanda n'imytwarire y'uregwa, ko amajwi n'amafoto byafatiwe mu iburanisha atabibonye mu buryo budakurikije amategeko.

Asobanura ko ingingo ya 71, igika cya 5 y'Itegeko N° 22/2018 ishyiraho uko ubwisanzure bw'itangazamakuru n'iyubahirizwa ryabwo bikorwa mu iburanisha, ko atari ukubuzwa itangazamakuru kubona amakuru no kurishyiraho amananza nk'uko bivugwa n'urega, ko ahubwo ari inzira yo gushyira mu bikorwa ibiteganywa n'ingingo ya 38 y'Itegeko Nshinga rya Repubulika y'u Rwanda.

[29] Akomeza avuga ko ntaho Itegeko Nshinga riteganywa ko itangazamakuru rigomba kubona amakuru mu buryo ubwo aribwo bwose. Akaba ariyo mpamvu ryateganyije ubwo buryo mu ngingo ya 71, igika cya 5, y'Itegeko N° 22/2018 ryavuzwe haruguru, ahasobanurwa ko bisabirwa uburenganzira byibura mu masaha 48 mbere y'uko iburanisha ritangira.

[30] Avuga kandi ko kuba itegeko riteganywa ko umunyamakuru asaba uruhushya rwo gufata amajwi n'amashusho mu cyumba cy'iburanisha bidakuraho ihame ry'uko iburanisha ribera mu ruhame nk'uko bigaragara mu ngingo ya 71 y'Itegeko N° 22/2018 ryavuzwe haruguru, ibyo bikaba bigaragarira mu gika cya 6 cy'iyi ngingo, aho isobanura ko uburenganzira butangwa cyangwa bukimanwa hashingiye ku byavuye mu isuzuma ryakozwe na Perezida w'Urukiko, byumvikanisha ahubwo ko ibi byubahiriza ibiteganywa n'ingingo ya 38 y'Itegeko Nshinga rya Repubulika y'u Rwanda.

[31] Uhagarariye Leta y'u Rwanda avuga ko ingingo ya 41 y'Itegeko Nshinga iteganywa ko mu gukoresha uburenganzira n'ubwisanzure, buri wese azitirwa gusa n'itegeko rigamije kwemera no kubahiriza uburenganzira n'ubwisanzure bw'abandi ndetse n'imytwarire iboneye, ituze rusange rya rubanda n'imibereho myiza muri rusange biranga igihugu kigendera kuri demokarasi. Ko ibyo binareba uburenganzira n'ubwisanzure bw'itangazamakuru, akaba ariyo mpamvu avuga ko ingingo ya 71 y'Itegeko N° 22/2018 ryo ku wa 29/04/2018 ryavuzwe haruguru igamije kubahiriza ibiteganywa n'ingingo ya 38, igika cya 2, y'Itegeko Nshinga.

[32] Ku bijyanye no kutamenyera igihe imanza zizaburanishwa kugira ngo basabe uruhushya, uhagarariye Leta y'u Rwanda avuga ko Urukiko rutashingira kuri iyo mpamvu ngo rwemeze ko inyuranye n'Itegeko Nshinga, ko ahubwo hanozwa imikorere kugira ngo itangazamakuru rizajye

rimenya imanza zizaburanishwa ku gihe maze bifashe no kubahiriza igihe cyo gusaba uruhushya rwo gufata amajwi n'amafoto.

[33] Akomeza avuga ko kubera ko Ubutegetsi bw'Ubucamanza aribwo murinzi w'uburenganzira n'ubwisanzure bwa muntu nk'uko biteganywa n'ingingo ya 43 y'Itegeko Nshinga, inkiko zifite inshingano yo kugena uko itangazamakuru ritara amakuru mu cyumba cy'iburanisha mu rwego rwo kurinda uburenganzira n'ubwisanzure bw'abaturanyi by'umwihariko n'ubwa rubanda muri rusange.

UKO URUKIKO RUBIBONA

[34] Ingingo ya 71, igika cya 5, y'Itegeko N° 22/2018 ryo ku wa 29/04/2018 ryerekeye imiburanishirize y'imanza z'imbonezabumubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi, iteganya ko uburenganzira bwo gufata amajwi n'amashusho mu cyumba cy'iburanisha busabwa mu nyandiko nibura mu masaha mirongo ine n'umunani (48) mbere y'uko iburanisha ritangira.

[35] Ingingo ya 38, igika cya mbere, y'Itegeko Nshinga rya Repubulika y'u Rwanda ryo mu 2003 ryavugururwe mu 2015 iteganya ko ubwisanzure bw'itangazamakuru, ubwo kugaragaza ibitekerezo n'ubwo guhabwa amakuru bwemewe kandi bwubahirizwa na Leta. Ubwisanzure bwo kugaragaza ibitekerezo n'ubwo guhabwa amakuru ntibugomba kubangamira ituze rusange rya rubanda n'imyifatire mbonezabupfura, ukurengera uruburiko n'abana, n'uburenganzira bw'umwenehugu bwo kugira icyubahiro n'agaciro, ubwo kutagira uwivanga mu mibereho ye bwite n'iy'umuryango we. Uko ubwo bwisanzure bukoreshwa n'iyubahirizwa ryabwo biteganywa n'amategeko.

[36] Urukiko rurasanga ingingo ya 38 y'Itegeko Nshinga iteganya ko ubwisanzure bw'itangazamakuru bugizwe n'uburenganzira bwo kugaragaza ibitekerezo no guhabwa amakuru. Ubwo burenganzira kandi bunateganywa n'ingingo ya 19 y'Itangazo Mpuzamahanga ku Burenganzira bwa Muntu ryo muri 1948 aho ivuga ko buri wese afite uburenganzira bwo kugaragaza ibitekerezo bye ntacyo yikanga n'ubwo gushaka, kubona no gukwirakwiza amakuru akoresheje uburyo ubwo aribwo bwose.⁴ Byumvikana rero ko ubwisanzure bw'itangazamakuru ari uburenganzira buteganywa n'Itegeko Nshinga butagomba kuvogerwa. Uko kandi ni nako byemejwe n'Urukiko rw'Ikirenga mu rubanza rwa Mugisha Richard aho rwavuze ko icyo aricyo cyose harimo n'itegeko cyangwa ingingo yaryo cyahungabanyaga ubwisanzure bw'itangazamakuru cyaba kinyuranyije n'Itegeko Nshinga.⁵

[37] Urukiko rurasanga ariko mu ngingo ya 38 y'Itegeko Nshinga, Umushingamategeko yaratanze irengayobora ry'ubundi burenganzira ubwisanzure bw'itangazamakuru butagomba kubangamira. Mu isuzuma ry'ikibazo Byansi Samuel Baker yashyikirije Urukiko, rukaba rugiyeye gusuzuma mu bika bikurikira niba gusaba umunyamakuru kubona uburenganzira bwo gufata amajwi n'amafoto igihe cy'iburanisha byaba bihungabanyaga uburenganzira agenerwa n'Itegeko Nshinga, bityo bikaba binyuranyije naryo.

[38] Muri rusange, kwemerera itangazamakuru gufata amajwi n'amafoto mu nkiko igihe cy'iburanisha, bifatwa nk'uburyo bwo kwegera abatubera no gutuma inkiko zirushaho gukorera mu mucyo. Ikibazo gikunda kuvuka muri urwo rwego kikaba icyo kureba uko ubwo burenganzira bw'itangazamakuru butabangamira uburenganzira n'amahame yandi nk'uburenganzira

[39] Gufata amafoto cyangwa amajwi mu iburanisha ry'urubanza, ni igikorwa cyatangiye mu myaka ya vuba ukurikije iterambere ry'ikoranabuhanga. Ni muri urwo rwego ari ngombwa kureba mu mategeko cyangwa imanza zabaye kuri iyo ngingo mu bihugu byateye imbere cyane mu ikoranabuhanga ndetse byanatangiye icyo gikorwa mbere y'Inkiko z'u Rwanda.

[40] Mu rubanza rwaciwe n'Urukiko rw'Ikirenga rw'Ubujurire rwo muri Afurika y'Epfo haburana *The NDPP na Media 24 Limited & others, HC Van Breda na Media 24 Limited & others*, urwo Rukiko rwagaragaje ko uburenganzira bw'itangazamakuru (*freedom of the press*) n'ihame ryo kuburanisha mu ruhame (*principle of open justice*) biteganywa n'Itegeko Nshinga ryo muri icyo gihugu, byuzuzanya kandi bidashobora gutandukanywa kuko kimwe gikenera ikindi, kuko iyo itangazamakuru ritanze amakuru mu buryo bwa kinyamwuga ku migendekere y'urubanza n'uburyo imanza zicibwa, bituma icyizere rubanda bafitiye Urwego rw'Ubucamanza kiyongera.⁷

[41] Urwo Rukiko rwavuze ko n'ubwo ubwo burenganzira n'iryo hame byuzuzanya, ariko Urukiko rufite ububasha bwo kugena no gushyiraho imirongo ngenderwaho mu gutangaza ibibera mu iburanisha mu rwego rwo kurengera no kwita ku migendekere myiza y'iburanisha. Ibyo kandi bifasha Urwego rw'Ubucamanza mu kurinda no gusigasira amahame yo kutabogama n'ubwigenge bw'abacamanza mu nyungu z'ubutabera.⁸

[42] Urukiko rwagaragaje ko umucamanza agomba gusuzuma ubusabe bw'ibitangazamakuru kuri buri rubanza, bishaka gufata amashusho cyangwa amajwi, ashingiye ku bintu bikurikira:

- Kureba niba icyo gikorwa kidashobora kubangamira uburenganzira bw'ababuranyi ku butabera buboneye;
- Gusuzuma niba icyo gikorwa kitabangamira imigendekere y'iburanisha cyangwa ngo kigabanye agaciro n'icyubahiro by'Urukiko.⁹

Urwo Rukiko rwavuze ariko ko n'ubwo icyo gikorwa gifasha Urwego rw'Ubucamanza kandi kikaba gishingiye ku burenganzira buteganywa, kigomba gukorwa mu buryo butabangamiye agaciro n'icyubahiriro by'Urukiko, uburenganzira ku mibereho bwite y'abaturanyi cyangwa abatangabuhamyi (privacy rights) bari muri urwo rubanza, no kwirinda ikindi cyose cyabangamira imitangire y'ubutabera buboneye. bwo gutuma ivuguruzanya hagati y'ababuranyi riba mu ituze no mu mucyo kuko bituma urukiko rugera ku kuri hasigasirwa n'ihame ryo kutabogama ry'Urwego rw'Ubucamanza.¹³

[46] Mu gihe uru rubanza rwari rurimo gusuzumwa n'Urukiko Rusesa Imanza, hanatanzwe ikirego mu Rukiko Rurinda Iremezo ry'Itegeko Nshinga rw'Ubufaransa aho rwasabwagwa kwemeza ko gusaba uruhushya kugirango hafatwe amajwi n'amafoto mu iburanisha binyuranyije n'ingingo ya 38 ter y'Itegeko ryo ku wa 26/07/1881 ryerekeye ubwigenge bw'itangazamakuru. Ku bw'ibyo, kuba umuntu yabuzwa gukoresha ubwo burenganzira bigomba kuba ari ngombwa kandi bikwiriye ugereranyije n'ikigenderewe.
