Incamake y' ikibazo: Uwitwa Umubyeyi Marie Claire umunyamuryango wa koperative ya transport yitwa ba East African Cooperative of Transporters (EACT), avuga ko yumvikanye na sosiyete Letshego Rwanda Ltd kumugurira imodoka ku nguzanyo ya 37.500.000Frw ariko imodoka itinda kugera mu Rwanda, ibyo byatumye Letshego Rwanda Ltd imusaba gukoresha sosiyete ye yitwa Dieu avec Moi Ltd afata indi nguzanyo ya 15.981.328 Frw mu izina rya sosiyete ye kugira ngo abashe kwishyura ibirarane by'amezi atanu (5) bingana na 8.600.000Frw inguzanyo ya mbere yari imaze kugeramo.

Umubyeyi Marie Claire yavuze ko nyuma yaho byaje kugaragara ko imodoka yatinze kugera mu Rwanda biturutse ku makosa ya Letshego Rwanda Ltd, bituma ayirega mu Rukiko rw'Ubucuruzi asaba kumwishyura ayo mafaranga hiyongereyeho, n'inyungu yaciwe mu gihe imodoka itakoraga hamwe n'indishyi zitandukanye kuko abandi ba nyamuryango ba koperative basangiye umushinga bari mu cyiciro kimwe bahawe ibirarane keretse we.

Nyuma yo gusesengura, Urukiko rwemeza ko Umubyeyi Marie yagenerwa gusa amafaranga atahawe kandi ayafiteho uburenganzira nk'umunyamuryango wa EACT, hiyongereyeho indishyi z'akababaro.

z’akarengane kubera ko Urukiko Rukuru rw’Ubucuruzi rwaremeje ko Umubyeyi Marie Claire afite ububasha, ubushobozi n’inyungu byo kuregera 8.600.000 Frw akomoka ku nguzanyo yahawe sosiyete Dieu avec Moi Ltd nyamara iyo sosiyete itarabaye umuburanyi mu rubanza.

Umubyeyi yisobanura avuga ko Letshego Rwanda Ltd iteza urujijo mu rubanza kuko yasabwe kwifashisha sosiyete ye abereye umunyamigabane rukumbi gufata indi nguzanyo kugira ngo yishyure ibirarane by’inyungu ku nguzanyo y’imodoka, bityo ko nta cyamubuza gukurikirana umutungo wa sosiyete ye kuko inyungu ziyivamo zijya mu mutungo we.

Sosiyete Letshego Rwanda Ltd ivuga ko ntaho mu masezerano yakoranye na Umubyeyi Marie Claire byari biteganyijwe ko ariyo yari kumushyikiriza imodoka cyangwa igihe ntarengwa imodoka yari kumugeraho ku buryo byafatwa ko ariyo itarubahirije inshingano zayo kugeza ubwo ibiryozwe inyungu z’ubukererwe zingana na 8.600.000Frw.

Byatumye Letshego Rwanda Ltd imusaba gukoresha sosiyete ye yitwa Dieu avec Moi Ltd afata indi nguzanyo ya 15.981.328 Frw kugira ngo abashe kwishyura ibirarane by'amezi atanu (5) bingana na 8.600.000Frw inguzanyo ya mbere yari imaze kugeramo.

[2] Yavuze ko nyuma yaho byaje kugaragara ko imodoka yatinze kugera mu Rwanda biturutse ku makosa ya Letshego Rwanda Ltd, hanyuma Letshego Rwanda Ltd yemera gusubiza abandi banyamuryango ba *East African Cooperative of Transporters* (EACT) bari basangiye umushinga 8.600.000 Frw bishyuye ibirarane uretse we. Yasabye Urukiko gutegeka Letshego Rwanda Ltd kumwishyura ayo mafaranga, hiyongereyeho 3.483.807 Frw y'inyungu yaciwe mu gihe imodoka itakoraga, 10% y'inguzanyo ya mbere yemerewe na Letshego Rwanda Ltd kubera ko yishyuye mbere y'igihe giteganyijwe mu masezerano n'indishyi zitandukanye.

[3] Urubanza RCOM 00158/2018/TC rwaciwe ku wa 27/07/2018, Urukiko rusanga Umubyeyi Marie Claire yarahawe 10% y'inguzanyo ya mbere n'iya kabiri ahwanye na 4.426.631 Frw bityo akaba ntandi yemerewe, naho 8.600.000 Frw atahawe kandi nk'abandi banyamuryango ba EACT ayakwiriyeye, rutegeka Letshego Rwanda Ltd kuyamuha hiyongereyeho 500.000 Frw y'indishyi z'akababaro, 1.040.000 Frw y'ikurikiranarubanza na 500.000 Frw y'igihembo cya Avoka, yose hamwe aba 10.640.000 Frw.

[4] Letshego Rwanda Ltd yajuririye Urukiko Rukuru rw'Ubucuruzi ivuga ko Urukiko rw'Ubucuruzi rwafashe icyemezo ku nguzanyo yahawe Dieu avec Moi Ltd n'inyungu zayo kandi Dieu avec Moi Ltd itarabaye umuburanyi mu rubanza ndetse ko yategetswe kwishyura Umubyeyi Marie Claire indishyi hatabanje kugaragazwa amakosa yamukoreye.

Inyandiko-mvugo y'inama yo ku wa 10/02/2017, yahuje ubuyobozi bwa Letshego Rwanda Ltd n'ubwa *EACT, e-mail* yo ku wa 14/03/2018, umuyobozi wa Letshego Rwanda Ltd yandikiye iyo Koperative, bigaragaza ko yemereye abanyamuryango bose gusubizwa 8.600.000 Frw, bityo Letshego Rwanda Ltd ikaba itagaragaza impamvu Umubyeyi Marie Claire we atafatwa nk'abandi.

[7] Ku wa 13/05/2019, Me Serugo Jean-Baptiste mu izina rya Letshego Rwanda Ltd, yandikiye Perezida w'Urukiko rw'Ubujurire asaba ko urubanza RCOMA 00586/2018/CHC/HCC rwaciwe n'Urukiko Rukuru rw'Ubucuruzi ku wa 22/03/2019, rusubirwamo ku mpamvu z'akarengane. Perezida w'Urukiko rw'Ubujurire amaze gusuzuma ubwo busabe, yandikiye Perezida w'Urukiko rw'Ikirenga asaba ko urwo rubanza rwasubirwamo. Mu cyemezo N 260/CJ/2021 cyo ku wa 01/11/2021, Perezida w'Urukiko rw'Ikirenga yemeje ko urubanza rwoherezwa mu Bwanditsi bw'Urukiko rw'Ikirenga kugira ngo ruzongere ruburanishwe.

[10] Letshego Rwanda Ltd ivuga ko ku wa 18/04/2016, Dieu avec Moi Ltd, sosiyete ya Umubyeyi Marie Claire, yafashe inguzanyo ya 15.981.328 Frw kugira ngo uyu abashe kwishyura inyungu z'ubukererwe zingana na 8.600.000Frw ku nguzanyo y'imodoka yari yarahawe kuko yari amaze amezi atanu atishyura. Ivuga ko 8.600.000Frw Umubyeyi Marie Claire asaba gusubizwa atariwe wayahabwa ku giti cye kuko ari igice cy'inguzanyo yahawe sosiyete, ko kuba Urukiko

Rukuru rw'Ubucuruzi rwaremeje ko ayasubizwa rushingiye ku ihame rya "*piercing the corporate veil*" byatewe n'uko rwumvishe nabi iryo hame ubundi rigamije kuryoza nyiri sosiyete igihombo sosiyete yagize, nyamara muri uru rubanza hakaba ntaho Umubyeyi Marie Claire akurikiranyweho uburyozwe bwa sosiyete ye ndetse iyi sosiyete ikaba nta ruhare na ruto ifite mu nguzanyo y'imodoka.

[11] Ivuga ko ihame rya "*piercing the corporate veil*" ryasobanuwe neza mu ngingo 92, igika cya 5, y'Itegeko no 007/2021 ryo ku wa 05/02/2021 rigenga amasosiyete y'ubucuruzi iteganya ko "*Urukiko rushobora kurenga uburyozwe bushingiye ku migabane kugira ngo umunyamugabane ariyozwe inshingano za sosiyete, iyo rusanze uwo munyamugabane yarakoresheje nabi icyiciro cya sosiyete agamije uburiganya cyangwa kwica amategeko cyangwa yarafashe nabi umutungo wa sosiyete nk'aho ari umutungo w'abantu ku giti cyabo.*" Ku bwa Letshego Rwanda Ltd, iri hame ntaho ryemerera inkiko zabanje gufata icyemezo ku nguzanyo yahawe Dieu avec Moi Ltd kandi itarigeze iregwa uburyozwe cyangwa ngo ibe umuburanyi mu rubanza. Ivuga ko Umubyeyi Marie Claire ku giti cye nta bubasha, ubushobozi n'inyungu afite byo kuregera amasezerano atagizemo uruhare.

[12] Me Rutagengwa Jean Damascène, uburanira Umubyeyi Marie Claire, avuga ko Letshego Rwanda Ltd iteza urujijo mu rubanza. Asobanura ko nyuma yo gufata inguzanyo ya mbere, Umubyeyi Marie Claire yasabwe kwifashisha sosiyete ye abereye umunyamugabane rukumbi, agafata indi nguzanyo kugira ngo yishyure ibirarane by'inyungu ku nguzanyo y'imodoka. Avuga ko ntakibuzwa Umubyeyi Marie Claire gukurikirana umutungo wa sosiyete ye kuko n'ubundi inyungu ziyivamo zijya mu mutungo we. Avuga ko ibaruwa ya Letshego Rwanda Ltd yo ku wa 09/06/2017, igaragaza ko inguzanyo yahawe Dieu avec Moi Ltd ari iy'inyongera, bivuze ko idakwiye gutandukanywa n'inguzanyo yahawe Umubyeyi Marie Claire agura imodoka, byose bishimangira ko kuri iyi ngingo nta karengane kabaye mu rubanza rusabirwa gusubirishwamo.

[15] Urukiko rurasanga mu masezerano yo ku wa 13/07/2016 ntaho bivugwa ko ari ay'inyongera ku masezerano yo ku wa 19/11/2015, ikigaragara ni uko ari amasezerano hagati y'abantu batandukanye, nubwo EACT yayise amasezerano y'inyongera mu rwandiko rwo ku wa 13/01/2017, bikongerera bikagarukwaho mu nyandiko-mvugo y'inama yabaye ku wa 10/02/2017,

ndetse na Letshego Rwanda Ltd ikabatangira ibisobanuro mu rwandiko rwo ku wa 09/06/2017, nta cyari gutuma Urukiko Rukuru rw'Ubucuruzi rushingira ububasha, ubushobozi n'inyungu bya Umubyeyi Marie Claire ku kuba inguzanyo ivugwa mu masezerano yo ku wa 13/07/2016 ari iy'inyongera kuko iyo nguzanyo atariyo yaregerwaga, ahubwo haregerwaga uburenganzira bwa Umubyeyi Marie Claire kuri 8.600.000 Frw yahawe Letshego Rwanda Ltd, ikayasubiza abandi banyamuryango ba EACT bose bayatanze uretse we.

[16] Urukiko rurasanga na none iby'Urukiko Rukuru rw'Ubucuruzi rwavuze ko Umubyeyi Marie Claire yemerewe ku giti cye kuregera amasezerano yakozwe na sosiyete Dieu avec Moi Ltd hashingiwe ku ihame rya "*piercing corporate veil*" mu rwego rwo gushakisha ubutabera bw'ukuri, nabyo ataribyo. Iby'ikoreshwa ry'iri hame byasobanuwe ku buryo burambuye mu rubanza *Munyampundu Antoine n'undi baburanaga n'Ikigo cy'Imisoro n'Amahôro*,¹uru Rukiko rusanga umuyobozi cyangwa umunyamigabane wa sosiyete adashobora kuryozwa imisoro yaciwe sosiyete hatabanje kugaragazwa ko hari amakosa cyangwa imicungire mibi yakoze bigatuma sosiyete itishyura imisoro, ibyo kandi byemezwa n'Urukiko mu bushishozi bwarwo. Urukiko rwasanze "*gufatira umutungo wa Munyampundu Antoine na Mukarugambwa Béatrice hagamije kuwugurisha mbere yo kugaragaza uburyozwe bwabo mu gutuma sosiyete bari babereye abanyamigabane itishyura imisoro yaciwe ari ukwirengagiza itandukaniro riri hagati y'ubuzimagatozi bwa sosiyete n'ubw'abayobozi cyangwa abanyamigabane bayo, kubyirenganiza bikaba byatuma abayobozi cyangwa abanyamigabane baryozwa (mu buryo bunyuranyije n'amategeko) ibikorwa bya sosiyete nk'aho ari ibyabo igihe icyo aricyo cyose n'uwo ari ariwe wese..*"²

[17] Rushingiye ku murongo rwatanze mu rubanza Twagiramungu Venuste yaburanaga n'Ikigo cy'Imisoro n'Amahôro,³ aho uru Rukiko rwibukije ko "*uburyozwe bw'abayobozi cyangwa abanyamigabane ba sosiyete aribyo byitwa "piercing the corporate veil" cyangwa "lifting the veil of the corporation" (ari) umwihariko (exception) wemezwa gusa n'Urukiko, rukirengagiza itandukaniro riri hagati y'ubuzimagatozi bwa sosiyete n'ubwa ba nyirayo kugira ngo abayobozi cyangwa abanyamigabane baryozwe ibikorwa bya sosiyete nk'aho ari ibyabo...*" kandi ko "*... mu kwemeza uburyozwe, Inkiko zishimangira ko bidapfa gukorwa, ahubwo hagomba gushingirwa ku mpamvu zisobanutse (circumstances in which the corporate veil may be lifted are greatly circumscribed) zigaragaza igituma abayobozi cyangwa abanyamigabane bagomba kuryozwa ibyakaryojwe sosiyete.*"⁴
