Amategeko agenga imanza z'ubucuruzi – Amasezerano – Amasezerano y'ubukode – Kwishyura k'ukodesha – Ukodesha ntiyakwitwaza ko nta wamwishyuje ngo yibere mu nzu y'abandi atishyura kuko aba afite inshingano yo kwibwiriza akishyura ubukode hakurikijwe ihame risanzwe ry'uko abagiranye amasezerano bagomba kuyubahiriza nta buryarya – Nta kigomba kubuza ukodesha inzu y'undi kwishyura ubukode uretse igihe hari impamvu ikomeye yaba yaramubujije kuba muri iyo nzu cyangwa kuyikoresha yakodesheje nk'uko byemeranyijwe mu masezerano.

Incamate y'ikibazo: Umoja house Ltd na Hestia Ltd bagiranye amasezerano y'ubukode bw'inzu kuwa ku wa 01/01/2014. Ingingo ya kabiri y'ayo masezerano yateganyaga ko Hestia Ltd izajya yishyura ubukode bwa \$ 3.402 kandi bukishyurwa buri kwezi, naho ingingo ya munani ikavuga ko uwifuzaga gusesa amasezerano azatanga integuza y'amezi atandatu. Impaka zavutse aho mu kwezi kwa 7/2014, Umoja House yishyuriye Hestia Ltd amezi abiri, ukwa karindwi n'ukwa munani/2014, Hestia ikanga kwishyura; ubwumvikane bugatangira kuba buke kugeza ubwo Hestia Ltd iviriye mu nzu kuwa 28/11/2014, ikagenda idatanze integuza.

Umoja House Ltd yatanze ikirego mu Rukiko rw'Ubucuruzi, isaba kwishyurwa amafaranga y'amezi itishyuwe, amafaranga y'amezi atandatu y'integuza itishyuwe n'indishyi. Urubanza rwatangiriye mu Rukiko rw'Ubucuruzi rurangirira mu Rukiko Rukuru rw'Ubucuruzi; Hestia Ltd iratsindwa itegukwa kwishyura amezi itishyuye, indishyi ndetse n'amafaranga y'integuza y'amezi atandatu. Hestia Ltd yatanze ikirego gisaba gusubirishamo urubanza ingingo nshya nabwo

itegekwa kwishyura amafaranga yatsindiwe hakuwemo ay'ukwezi kumwe yari yatanze nka "caution".

Hestia yongeye isubirishamo urubanza ku mpamvu z'akarengane mu Rukiko rw'Ikirenga ivuga ko atariyo yishe amasezerano kuko yishyujwe mu buryo butumvikanyweho kandi ko itagomba kuryozwa amezi atandatu y'integuza mu gihe inzu yakodeshaga hari abandi bazigiyemo muri icyo gihe cy'integuza.

Umoja House yireguye ivuga ko Hestia igomba kwirengera ingaruka zo kwica amasezerano, kandi ko igomba kwishyura integuza y'amezi atandatu kuko abagiye bakodesha inzu yayo batahakodesheje hose.

Bityo, Hestia ikaba igomba kwishyura Umoja House \$9.072 kubera kudatanga integuza ariko zikagarukira aho yaboneye abandi bakodesha inzu zayo.

I. IMITERERE Y'URUBANZA

[1] Umoja House Ltd yagiranye amasezerano y'ubukode bw'inzu na Hestia Ltd y'imyaka 3 yishyura 3.402\$ ku kwezi, yagombaga gutangira ku wa 01/01/2014, bemeranya ku nshingano za buri ruhande n'uko bigenda igihe hari ushaka gusesa amasezerano.

[2] Umoja House Ltd yareze Hestia Ltd mu Rukiko rw'Ubucuruzi rwa Nyarugenge ivuga ko itubahirije amasezerano yishyura uko bikwiriye, isaba ko yategekwa kuyishyura umwenda uteye utya:

- Umwenda ungana na 17.110\$;
- Kwishyura 20.412\$ y'igihe cy'integuza;
- Indishyi n'igihembo cya Avoka kingana na 3.500.000frw.

[3] Hestia Ltd yaburanye ivuga ko atari yo itubahirije amasezerano ko ahubwo ari Umoja House Ltd yayishe kuko ariyo yatangiye kujya iyishyura amezi 2 kandi bari baremeranyije kwishyura buri kwezi; ibyanze Hestia Ltd isesa amasezerano. Hestia Ltd ivuga ko itakwishyura ubukode bw'amezi ane ko ahubwo yakwishyura ubw'amezi 3 n'iminsi irindwi bungana na 10.999,8\$ kandi ko yahabwa igihe gihagije cyo kuyishyura.

[4] Mu rubanza n° RCOM 1456/14/TC/NYGE, Urukiko rw'Ubucuruzi rwemeje ko ikirego cya Umoja House Ltd gifite ishingiro kuko:

- Hestia Ltd ari yo yishe amasezerano y'ubukode, yanga kwishyura buri kwezi nk'uko yari yabiyemeje;
- Hestia Ltd itubahirije ibyo yiyemeje mu ngingo ya 8 y'amasezerano y'ubukode yo ku wa 01/01/2014, ngo ibe yaramenyeshije Umoja House Ltd ko itagishaka gukomeza amasezerano y'ubukode bagiranye aho kureka kwishyura ntitange n'integuza (préavis);

Urwo rukiko, rushingiye kuri ibyo, rwategetse Hestia Ltd guha Umoja House Ltd 37.422\$, amafaranga y'u Rwanda 500.000 y'indishyi no gusubiza Umoja House Ltd 50.000frw y'igarama ry'urubanza.

[5] Hestia Ltd yajuririye urwo rubanza mu Rukiko Rukuru rw'Ubucuruzi ku impamvu zikurikira:

- Kuba Urukiko rwaremeje ko ari yo yasheshe amasezerano kandi atari byo;
- Kuba yarasabye kwishyura umwenda w'ubukode yemera mu gihe cy'amezi 12 ntibihabwe agaciro.

[6] Mu rubanza n° RCOMA 0228/15/HCC, Urukiko rwemeje ko ubujurire bwatanzwe na Hestia Ltd nta shingiro bufite, ko urubanza rwajuririwe rudahindutse, ruyitegeka guha Umoja House Ltd 600.000frw y'indishyi z'ibyatanzwe ku ikurikiranarubanza n'igihembo cy'Avoka kuri urwo rwego, rushingiye ku mpamvu zikurikira:

- Hestia Ltd ivuga ko ku wa 28/11/2014 yari yaramaze kuva mu nzu ariko ntiyerekana urwandiko yandikiye Umoja House Ltd nk'uko byari biteganyijwe mu ngingo ya 8 y'amasezerano y'ubukode;
- Hestia Ltd nta mpamvu ifite idasanze cyangwa itarashoboraga guteganywa yatuma Urukiko rwemeza ko (Hestia Ltd) yemerewe kwishyura mu byiciro, cyane ko itishyuraga ubukode nk'uko byari byarumvikanyweho mu masezerano.

[7] Nyuma y'icibwa ry'imanza zavuzwe haruguru, Hestia Ltd yongeye gutanga ikindi kirego mu Rukiko Rukuru rw'Ubucuruzi, isubirishamo urubanza n° RCOMA 0228/15/HCC ingingo nshya ku mpamvu zikurikira:

- Kuba hari inyandiko yatanze mu rubanza ariko Urukiko ntirwayibona (facture n° 20 yo ku wa 10/06/2014 yishyuzaga amezi abiri);
- Kuba Umucamanza yarirengagije ibikubiye mu masezerano y'ubukode cyane ibiri mu ngingo ya 6 ivuga ko mu kwishyura ibirarane Hestia Ltd yagombaga guhera ku 3.402\$ yari yatanze nk'ingwate cyane ko ababuranyi bayemeranywaho, ariko Umucamanza we akaba ntacyo yabivuzeho.

[8] Mu rubanza n° RCOMA 0490/15/HCC, Urukiko rwemeje ko ikirego cyatanze na Hestia Ltd gifite ishingiro ku byerekeranye no kuba mu mafaranga yagombaga kwishyura haragombaga kuvanwaho 3.402\$ yari yatanze y'ingwate, ibindi bikaguma uko byemejwe mu rubanza rusubirishwamo ingingo nshya, kubera impamvu zikurikira:

- Kuba inyandiko Hestia Ltd ishingiraho ivuga ko zitabonywe n'umucamanza atari byo, kuko umucamanza yazibonye ndetse akanazishingiraho, bitandukanye b'ibivugwa na Hestia Ltd.
- Kuba Umoja House Ltd idahakana ko yahawe 3.402\$ nk'ingwate kandi hakaba ntaho bagaragaza ko bayaburanyeho cyangwa ngo abe yarahereweho mu kwishyura;

[9] Hestia Ltd ntiyanyuzwe n'icyo cyemezo maze yandikira Urwego rw'Umuvunyi isaba ko urubanza n° RCOMA 0490/15/HCC rwasubirishwamo ku mpamvu z'akarengane kubera ko mu icibwa ryarwo hirengagijwe amategeko n'ibimenyetso bigaragarira buri wese.

[10] Urwego rw'Umuvunyi rwandikiye Perezida w'Urukiko rw'Ikirenga rusaba ko urubanza n° RCOMA0490/15/HCC rusubirwamo ku mpamvu z'akarengane, maze nawe, nyuma yo gusuzuma raporo y'Ubugenzuzi Bukuru bw'Inkiko, yemeza ko rwongera kuburanishwa; ruhabwa n° RS/INJUST/RCOM 00002/2018/SC.

[11] Urubanza rwahamagawe ku wa 06/06/2019, ariko uwo munsu ntirwaburanishwa, no ku matariki abiri rwagiye rwimurirwaho (ku wa 10/09/2019 no ku wa 08/11/2019) ntirwaburanisha ku mpamvu z'ababuranyi. Ku wa 09/01/2020 nibwo ababuranyi bose bitabye, Hestia Ltd ihagarariwe na Me Rugemintwaza Jean Marie Vianney naho Umoja House Ltd ihagarariwe na Me Bahati Vedaste; urubanza ruraburanishwa.

[12] Mu izina rya Hestia Ltd, Me Rugemintwaza Jean Marie Vianney yasobanuye impamvu z'akarengane kayo mu buryo bukurikira:

- Urukiko Rukuru rw'Ubucuruzi rwafashe icyemezo cy'uko Hestia Ltd yishyura 17.000\$ y'ubukode kandi icyaburanwaga kwari ukumenya uwishe amasezerano n'ugomba gutanga integuza;
- Umoja House Ltd imaze kwirukana Hestia Ltd mu nzu yahise ishyiramo abandi nyamara Urukiko Rukuru rw'Ubucuruzi ruyigenera amafaranga y'integuza, akaba isanga ibyo byaba ari ukwikungahaza nta mpamvu.

[13] Me Bahati Vedaste uhagarariye Umoja House Ltd avuga ko Hestia Ltd ariyo yishe amasezerano kuko yananiwe kwishyura ikava mu nzu idasezeye, idatanze n'integuza yirengagije ibyateganywaga n'ingingo ya 8 y'amasezerano y'ubukode bagiranye ku wa 01/01/2014.

[14] Ababuranyi bose basozza basaba indishyi.

[15] Urukiko rurasanga ibibazo bikwiye gusuzumwa muri uru rubanza ari ibi bikurikira:

- 1) Kumenya uwishe amasezerano hagati ya Hestia Ltd na Umoja House Ltd;
- 2) Kumenya niba Hestia Ltd igomba kwishyura amezi atandatu ya préavis itatanze;
- 3) Ibyerekeye indishyi zisabwa n'impande zombi.

II. ISESENGURA RY'IBIBAZO BIGIZE URUBANZA

1) Kumenya uwishe amasezerano hagati ya Hestia Ltd na Umoja House Ltd

[16] Me Rugemintwaza Jean Marie Vianney avuga ko ingingo ya 2 y'amasezerano y'ubukode bw'inzu Hestia Ltd yagiranye na Umoja House Ltd ku wa 01/01/2014 ivuga ko ubukode buzajya bwishyurwa buri kwezi (Le loyer est payé mensuellement). Avuga ko Hestia Ltd yishyuye amezi atatu y'avance n'ukwezi kumwe kwa caution ijya kwinjira mu nzu, ubundi ikaba yaragombaga kujya yishyura buri kwezi gushize. Nyamara, ngo ukwezi kwa 5/2014 gushize aho kugira ngo Umoja House Ltd ikore facture y'ukwezi kumwe kwa gatanu nk'uko amasezerano abiteganyaga, Umoja House Ltd yakoze facture n° 20 yo ku wa 10/06/2014 yishyura amezi abiri, ukwa 5/2014 kurangiye ishyiraho n'ukwezi kwa 6/2014, Hestia Ltd irayishyura kuko ngo Umoja House Ltd yari ifite ibibazo by'amafaranga yashakaga gukemura.

[17] Icyatangaje Hestia Ltd nk'uko Me Rugemintwaza Jean Marie Vianney abivugaga ngo ni uko Hestia Ltd yongeye kwishyuzwa ukwezi kwa 7 n'ukwa 8 yabaza impamvu yishyuzwa amezi abiri kandi atari byo biteganyijwe mu masezerano¹, ngo aho gukemura ikibazo, Umoja House Ltd igahita iyandikira ibaruwa ya mise en garde, ikanatanga ikirego mu Rukiko rw'Ubucuruzi rwa Nyarugenge ivuga ko yishe amasezerano kandi atari byo. icyakora, Hestia Ltd yemera ko itishyuye amezi atatu (Juillet, Août & Septembre) ukwezi kwa 10 itakwemera, igasobanura ko kutishyura yabitewe no kuba bari bari mu manza.

[18] Me Bahati Vedaste avuga ko Umoja House Ltd itigeze yishyura Hestia Ltd amezi abiri, ko ahubwo nk'uko bigaragara kuri facture, kubera ko Hestia Ltd yabaga itishyuye ukwezi kurangiye,

byabaga ngombwa ko yishyuzwa ukwezi gutangiye ndetse n'ikirarane cy'ukwezi kurangiye. Ibi kandi basanga Hestia Ltd yari yarabyemeye kuko yanabishyize mu bikorwa muri factures zibanza, kuko kuri factures z'ukwezi kwa gatanu n'ukwa gatandatu, Hestia Ltd yayishyuye ku itariki ya 22/07/2014, na sheki ya Fina Bank.

[19] Ku byerekeye factures y'ukwezi kwa karindwi n'ukwa munani, Me Bahati Vedaste avuga ko na bwo Hestia Ltd yemeye kwishyura ubwo yahaga Umoja House Ltd Ordre de Paiement yo ku wa 29/09/2014, ariko itariki yo kujya kureba amafaranga kuri banki, Hestia Ltd ikabwira Umoja House Ltd ko nta mafaranga aragera kuri konti zayo ko bityo ikwiriye gutegereza.

[20] Ku byerekeye ibaruwa Hestia Ltd yise "mise en garde", Me Bahati Vedaste avuga ko aho Hestia Ltd yishyurijwe ukwezi kwa cyenda n'ukwa cumi, yatinze kwishyura, biba ngombwa ko yandikirwa ibaruwa ya "mise en garde" yo ku wa 07/10/2014, kuko uretse n'ubwishyu bw'ayo mezi abiri yari atarishyurwa, na facture y'ukwezi kwa karindwi n'ukwa munani yatangiye ordre de paiement ariko ntiyishyurwe. Uko kubura ubwishyu bw'amezi 4 (Nyakanga, Kanama, Nzeri n'Ukwakira), ngo byatumye Hestia Ltd iva mu nzu yakodeshaga idasezeye ku wa 28/11/2014, idatanze n'integuza.

UKO URUKIKO RUBIBONA

[21] Urukiko rusanga impande zombi zitana bamwana ku bijyanye n'amakosa yakozwe mu buryo bwo kwishyura amafaranga y'ubukode ari nabyo byaje kuviramo Hestia Ltd kugenda itishyuye itanatanze integuza nk'uko byari biteganyijwe mu masezerano, rukaba rugomba kubanza gusuzuma ayo makosa yakozwe n'ingaruka zayo mu masezerano y'ubukode mbere yo kumenya uwo byaryozwa.

[22] Muri rusange, Hestia Ltd ivuga ko Umoja House Ltd ariyo yishe amasezerano ubwo yishyuzaga amezi abiri (ukwezi kwa Nyakanga na Kanama /2014), nyamara nayo ikaba idahahakana ko yarinze isubiza imfunguzo ku wa 28/11/2015 itarishyura ukwezi na kumwe kuva mu kwezi kwa Nyakanga 2014. Ibyo mu buryo bw'amategeko bibyutsa ibibazo bibiri:

- Ese byari ngombwa ko Hestia Ltd yishyuzwa kugira ngo ibone kwishyura?
- Ese kwishyuzwa muri ubwo buryo ni impamvu ituma itarangiza inshingano zayo (exception d'inexécution)?

[23] Ku byerekeye ikibazo cya mbere, Urukiko rusanga hari ihame rimenyerewe mu mategeko, ko umwenda wishyuzwa, bikaba bidategetswe ko umuntu yibwiriza ngo yishyure (la dette est querrable et non portable). icyakora mu bijyanye n'ubwishyu bw'ubukode bw'inzu, abahanga mu mategeko bemeranya ko ukodesha atakwitwaza ko nta wamwishyuje ngo yibere mu nzu y'abandi atishyura². Ibyo Urukiko Rusesa imanza rw'Ubufaransa rwarabishimangiye, rubishingiye ahanini ku nshingano nyamukuru ukodesha inzu y'undi aba afite yo kwibwiriza akishyura ubukode³

hakurikijwe ihame risanzwe ry'uko abagiranye amasezerano bagomba kuyubahiriza nta buryarya ndetse rinagaragara mu ngingo ya 70 y' Itegeko n° 45/2011 ryo kuwa 25/11/2011 rigenga amasezerano⁴.

[24] Ku byerekeye ikibazo cya kabiri naho, Urukiko rusanga hari ihame rimenyereye ko igihe umwe mu bagiranye amasezerano adakoze ibyo asabwa gukora cyangwa akabikora uko bidateganyijwe, ashobora na we kwiha uburenganzira bwo kudakora ibyo yari ategetswe (exception non adumpleti contractus). Aha ariko naho, ku bireba amasezerano y'ubukode bw'inzu, abahanga mu mategeko bemeranya ko nta kigomba kubuza ukodesha inzu y'undi kwishyura ubukode uretse igihe hari impamvu ikomeye yaba yaramubujije kuba muri iyo nzu cyangwa kuyikoresha yakodesheje nk'uko byemeranyijwe mu masezerano⁵.

Iyo myitwarire mu ishyirwa mu bikorwa ry'amasezerano ibujijwe n'ingingo ya 70 y' Itegeko n° 45/2011 ryo kuwa 25/11/2011 rigenga amasezerano ivuga ko buri ruhande rufite inshingano yo kurangiza amasezerano nta buriganya kandi rukarangwa n'imikorere myiza yemerwa ku bagiranye amasezerano. Iyo myitwarire mibi inagaragarira mu kuba aho yibukirijwe kwishyura ukwezi kwa Nzeri n'uk'Ukwakira 2014, aho kugira ngo yishyure yahisemo kwigendera nta n'integuza itanze, nyamara ingingo ya munani y'ayo masezerano yarateganyaga ko mbere yo gusesa amasezerano, uruhande bireba ruzabanza guha urundi integuza y'amezi atandatu.

[27] Kubera izo mpamvu rero, Urukiko rusanga Hestia Ltd ariyo yishe amasezerano kubera ko itishyuye ubukode hakurikije amasezerano yagiranye na Umoja House Ltd nk'uko byasobanuwe haruguru.

- Aho Hestia Ltd iviriye mu mazu ya Umoja House Ltd yari yarakodesheje hahise hajyamo abandi, bityo akaba asanga kwishyura Umoja House Ltd amafaranga y'amezi atandatu byaba ari ukwikungahaza nta mpamvu (enrichissement sans cause).

[29] Me Bahati Vedaste avuga ko basanga Hestia Ltd igomba kwishyura amafaranga y'integuza yose kuko yavuye mu nzu idatanze integuza nk'uko byari byemeranyijwe mu masezerano. [30] Nk'uko byasobanuwe mu ngingo ya mbere yasuzumwe muri uru rubanza, Hestia Ltd niyo yishe amasezerano ku mpamvu zirimo no kugenda idatanze integuza, bityo akaba ari nayo igomba kuryozwa igihombo Umoja House Ltd yagize giturutse ku kutubahiriza ingingo yayisabaga kubanza gutanga integuza mbere yo gusesa amasezerano.

[31] Naho ku byerekeye umubare w'amafaranga ikwiye kuryozwa, Urukiko rurasanga mbere yo kuwemeza hagomba kubanza gusobanuka icyo indishyi zirebana no kutubahiriza itangwa ry'integuza (préavis) mu masezerano y'ubukode ziba zishingiweho.

[32] Urukiko rusanga igihe cy'integuza (préavis) mu masezerano y'ubukode kiba kigamije gufasha nyir'inzu gutangira gushaka uzajya mu nzu ye igihe uwari uyirimo azaba ayivuyemo kandi atabihombeyemo. Ku ruhande rw'ukodesha igihe cy'integuza kimufasha kubona umwanya wo gushaka aho azimukira, kugira ngo igihe asohotse mu nzu yakodeshaga atabura aho yerekeza. Mu gihe cy'integuza kandi impande zombi zikomeza kubahiriza amasezerano zagiranye ku byerekeranye n'ubwishyu bw'ubukode. Iyo hagize uwica amasezerano ku ngingo zirebana n'integuza, habaho uburyo igihombo kiryoziwa uwagiteye mu ngeri ebyiri.

[33] Ingeri ya mbere ni irebana n'iryo zabwishyu ry'ubukode bwari butegerejwe (buteganyijwe) mu gihe cy'integuza. Ubwo bwishyu bubarwa hakurikijwe amafaranga y'ubukode uwakodeshaga yari asanzwe atanga buri kwezi n'umubare w'iminsi uwakodeshaga yagiye atarangije cyangwa yateshejwe ku gihe cy'integuza cyari giteganyijwe. icyakora, kubera ko impamvu y'ayo mafaranga ari ukuriha igihombo cyatewe n'uko kuva mu nzu mu buryo butiteguwe, iyo iyo nzu ibonye abayijyamo muri icyo gihe cy'integuza, icyo gihombo kiba kivuyeho bityo n'amafaranga yagombaga gutanga akaba atakiri ngombwa kuko nta shingiro aba agifite. [35] Muri uru rubanza, Urukiko rurasanga ibyerekeranye n'indishyi nyir'izina (indemnités de rupture) abaturanyi ntacyo bazivuzeho; ahubwo ikigibwaho impaka ari iryozabwishyu ry'ubukode bwari butegerejwe (buteganyijwe) mu gihe cy'integuza; Hestia Ltd ikaba ivuga ko itemera umubare w'amafaranga yaciwe kuko ikimara kuva mu mazu yari isanzwe ikodesha na UmojaHouse Ltd, yahise agibwamo n'abandi. Urukiko rurasanga kandi hashingiwe ku bisobanuro byatanzwe mu bika bibanziriza iki, Hestia Ltd igomba kwishyura amafaranga y'ubukode bwari buteganyijwe mu gihe cy'integuza hakuwemo ayo yagombaga gutanga mu gihe ayo mazu yari yabonye abandi bayajyamo.
