

## KAYOMBYA v I&M BANK RWANDA PLC N'UNDI

*Amategeko agenga imanza z'ubucuruzi – Ingwate – Kwandikwaho ingwate – Umutungo uri mu ngwate ushobora kwandikwa ku bifitemo inyungu mu gihe byagaragara ko umwenda wari watumye ingwate itangwa warangiye kwishyurwa wose – Uwatanze ingwate kandi afite uburenganzira bwo gusubizwa ingwate ye igihe cyose amaze kwishyura umwenda we wose hakurikijwe ibyumvikanyweho mu masezerano y'ubugwate – Itegeko N° 10/2009 ryo ku wa 14/05/2009 ryerekeye ubugwate ku mutungo utimukanwa nk'uko ryahinduwe kugeza ubu, ingingo ya 11.*

**Incamake y'ikibazo:** Kayombya yareze I & M Bank Rwanda PLC (I&M Bank) na IMEX Sarl (IMEX) ariko IMEX ntiyitaba bituma Urukiko rumuhamagaza ahatazwi, urubanza ruburanishwa idahari. icyatumye Kayombya yareze asaba ko amasezerano y'ubugwate bw'inzu iri mu kibanza N° 1874 yaguzwe na IMEX yaseswa kugira ngo abashe kubona uko imwandikaho kuko yagaragaza ko umwenda IMEX yahawe na I&M Bank wishyurwe.

I&M Bank yagaragaje ko inzu iburanwa ari ingwate yayo kubera umwenda yahaye IMEX itabashije kuwishyura wose. Nyuma yo gutsindwa mu bujirire bwa mbere, Kayombya yajuririye bwa kabiri Urukiko rw'Ikirenga, hasuzumwa niba inzu yatanzweho ingwate mu masezerano atagizemo uruhare yavanwa muri ubwo bugwate, akayigiraho uburenganzira busesuye.

Urukiko rwasanze ibyo byashoboka ari uko bigaragaye ko umwenda wari watumye ingwate itangwa warangiye kwishyurwa wose ariko habanje gushyirwaho umuhanga mu ibaruramali kugira ngo agaragaze ko uburyo umwenda I&M Bank PLC yahaye IMEX Sarl wagiye wishyurwa.

Mu miburanire ya Kayombya yagiye agaragaza yaguzwe inzu iri mu bugwate amaze kubyemeranywaho na IMEX ndetse na I&M Bank. Akavuga ko ibyo bitari kubaho mu gihe I&M Bank yari igifitiwe umwenda; bityo agasaba ko inzu yaguzwe yamwandikwaho kuko I&M Bank yanze kumuha icyangombwa cy'ubutaka kugira ngo akorerwe iherekanyamutungo.

I&M Bank yakomeje yireguye ivuga ko inzu iburanwa ari iyayo kuko ikiri mu ngwate kuko umwenda yahaye IMEX itabashije kuwishyura wose. Ku kijyanye n'uko Kayombya asaba kwandikwaho inzu yaguzwe na IMEX, I&M Bank yireguye ivuga ko bitashoboka kuko hari urubanza yatsinzwe kandi rwabaye itegeko kandi ko n'umwenda IMEX ikiyibereyemo ukaba utarishyurwa wose.

Urukiko rwashyizeho umuhanga mu ibaruramali kugira ngo agaragaze imyenda yahawe IMEX n'uko yagiye yishyurwa ndetse niba hari umwenda igisigayemo I&M Bank.

Impande zombi zatanze ibitekerezo kuri raporo y'umuhanga aho ku ruhande rwa Kayombya rwagaragaza ko kabone n'ubwo raporo y'umuhanga igaragaza ko hari umwenda IMEX akibereyemo I&M Bank ariko mu gihe yaguraga inzu, IMEX yari yararangije kwishyura imyenda yari yarafashe mbere yo gufata indi mishya.

Ku ruhande rwa I&M Bank yavuze ko kuba raporo igaragaza ko IMEX hari umwenda ikiyisigayemo, inzu Kayombya yaguzwe itakurwa mu bugwate kuko imyenda yose yagiye iyitanga ishingiyeye ku ngwate zabaga zatanzwe hari n'inzu yaguzwe na Kayombya.

## **Urubanza**

### **I. IMITERERE Y'URUBANZA**

[1] Ku wa 20/06/1991, Kayombya Robert yaguze na IMEX Sarl inzu iri mu kibanza N<sup>0</sup> 1874 gihereye mu Rugunga, ku gaciro ka 15.000.000 Frw. Yasabye ko haba *mutation* inzu ikamwandikwaho, ariko ntibyakunda kuko BCR SA (yabaye I&M Bank Rwanda PLC) yari ifite ibyangobwa byayo nk'ingwate ku myenda yahaye IMEX Sarl.

[2] Kayombya Robert yareze I&M Bank Rwanda PLC na IMEX Sarl mu Rukiko rw'Ubucuruzi rwa Nyarugenge asaba ko amasezerano y'ubugwate bw'inzu ifite N<sup>0</sup> 1874 iri mu Rugunga, BCR SA yagiranye na IMEX Sarl, aseswa ku mpamvu y'uko ari iye yaguze; akavuga ko mbere y'uko ayigura, IMEX Sarl yari yararangiye kwishyura imyenda yose yari ibereyemo BCR SA, harimo n'inyungu.

[3] I&M Bank Rwanda PLC yireguye ivuga ko Kayombya Robert nta burenganzira afite bwo gusaba ko ayo masezerano aseswa, kuko ntaho ahuriye nayo, kandi ko iby'ubwo bugwate KAYOMBYA Robert yagiye abiregera mu nkiko agatsindwa, akaba adakwiye kubigarura ubwa kabiri. I&M Bank Rwanda PLC ivuga ko iyo nzu yayihawe ingwate mbere y'uko KAYOMBYA Robert ayigura, bityo Banki ikaba ikiyifiteho ububasha.

[4] Urubanza rwaburanishijwe IMEX Sarl idahari kuko itari yitabye kandi yarahamagajwe mu buryo bukurikije amategeko. Urukiko rwaciye urubanza N<sup>o</sup> RCOM 1234/13/TC/NYGE, rwemeza ko ikirego cya Kayombya Robert gifite ishingiro kuko inzu ivugwa yagurishijwe igihe cy'ubugwate

cyarangiye. Ruvuga ko amasezerano y'ubugwate yakozwe nyuma y'ubugure nta gaciro afite, rutegeka I & M Bank Rwanda PLC na IMEX Sarl gufatanya guha Kayombya Robert indishyi zingana na 1.000.000 Frw y'ikurikiranarubanza n'igihembo cy 'Avoka.

[5] I&M Bank Rwanda PLC yajuririye Urukiko Rukuru rw'Ubucuruzi, ruca urubanza (RCOMA 0486/15/HCC) ku wa 29/03/2016, rwemeza ko ubujurire bwa I&M Bank Rwanda PLC bwakiriwe kandi bufite ishingiro; ruvuga ko IMEX Sarl yagurishije Kayombya Robert iriya nzu ikiri mu bugwate, bityo ubwo bugure bukaba nta gaciro bufite, n' indishyi Kayombya Robert yari yagenewe ku rwego rwa mbere zikaba zivanyweho.

- Naho ku bijyanye no kumenya niba inzu iburanwa yaragurishijwe umwenda yatangiweho ingwate utarishyurwa, Urukiko rwagaragaje ko inzu iri mu kibanza No 1874 mu Rugunga yari yaratanzweho ingwate na IMEX Sarl ku nguzanyo ingana na 8.000.000 Frw yahawe na BCR SA ku wa 08/06/1988. Rwagaragaje kandi ko BCR SA yongeye kugirana na IMEX Sarl amasezerano y'inguzanyo ingana na 110.000.000 Frw ku wa 03/05/1989, mu ngwate zumvikanyweho hakaba harimo n'ikibanza No 1874 cyari gisanzwe ari ingwate ya BCR SA. Urukiko ruvuga kandi ko hatigeze hagaragazwa ko IMEX Sarl yishyuye iyi nguzanyo yose, kuko historique ya compte yabarirwagaho uwo mwenda yatanzwe na Banki ku wa 12/02/2016, igaragaza ko kugeza ku wa 01/07/1991 inzu igurishwa, IMEX Sarl yari igifitiye BCR SA umwenda ungana na 58.491.184 Frw.

[7] Kayombya Robert yajuririye Urukiko rw'Ikirenga atanga impamvu eshatu z'ubujurire zikurikira:

Urukiko rwasubitse iburanisha, rwemeza ko rizakomeza nyuma yo gufata icyemezo ku bwihane. icyemezo ku bwihane cyasomwe ku wa 15/02/2019, Urukiko rwemeza ko inzitizi igamije kwihana umucamanza yatanzwe na Kayombya Robert nta shingiro ifite. Urubanza rwongeye gushyirwa kuri gahunda ku wa 04/06/2019, rugenda rwimurwa kubera impamvu zitandukanye.

[12] Urubanza rwongeye kuburanishwa mu ruhamwe ku wa 13/09/2019, Kayombya Robert yitabye, yunganiwe na Me Niyibizi Diogene, Mukangabo Aurea, na Me Nsabiyumva Cyubahiro Jean Damascene; naho I&M Bank Rwanda PLC ihagarariwe na Me Nkurunziza Francois Xavier. IMEX Sarl ntiyitabye Urukiko, ariko yari yahamagajwe ahatazwi. Umuhanga washyizweho n'Urukiko Ayinkamiye Speqose nawe yitabye Urukiko kugira ngo asobanure raporo ye. Mu bisobanuro yatanze, abarega bagaragaje impungenge z'uko hari ibiburamo, cyane cyane ibijyanye no kumenya ingwate zose zagurishijwe, n'uburyo amafaranga yazivuyemo yafashije kugabanya umwenda. Basobanura ko Kayombya Robert yaguze inzu mu buryo bukurikije amategeko kandi bikorerwa imbere ya *notaire*, akaba ari yo mpamvu batanze ikirego basaba guteshwa agaciro amasezerano y'ubugwate kuri iyo nzu; kuyivana mu bugwate bikaba ari ingaruka yumvikana y'uko guteshwa agaciro amasezerano.

[25] Me Nkurunziza Francois Xavier uburanira I&M Bank Rwanda PLC avuga ko hari urundi rubanza Kayombya Robert yaburanye na BCR SA asaba ko inzu imwandikwaho (*mutation*) akabitsindirwa, kandi urwo rubanza rukaba rwarabaye itegeko, akaba yaratsinzwe n'uko Urukiko rwasanze iyo nzu ikiri mu bugwate. Umuhanga avuga ko ayo



mafaranga yishyuye ku wa 25/10/2005 anyujijwe kuri konti ya IMEX Sarl yari muri BCR SA nk'uko bigaragara haruguru, bituma inzu iri mu kibanza No 320 ikurwa mu bugwate.

[50] Ibisobanuro bimaze gutangwa, bigaragaza ko amafaranga 12.061.500 yinjiye kuri konti ya IMEX Sarl ku wa 23/08/2005, ntaho ahuriye n'amafaranga 15.832.000 yavuye mu cyamunara cy'inzu iri mu kibanza N° 3270. Urukiko rukaba rusanga rero, amafaranga 15.832.000 nayo yagombye kuvanwa mu mwenda ungana na 82.352.527 Frw wagaragajwe n'umuhanga, IMEX Sarl yari ifitiye BCR SA ku wa 25/10/2005; bivuga ko umwenda usigaye waba ungana na (82.352.527 Frw - 12.041.000 Frw = 70.311.527 Frw ) - 15.832.000 Frw = 54.479.527 Frw.

[51] Ku bijyanye n'inzu iri mu kibanza N° 3271 kiri i Remera, Kayombya Robert n'abamwunganira bavuga ko yagurishijwe bahereye ku nyandiko yitwa *Exploit de notification et commandement prealable a la saisie immobilize* yakozwe n'Umuhesha w'Inkiko wa BCR SA Sebantu Isaac, yamenyeshaga IMEX Sarl ko nitishyura mu gihe yahawe, iyo nzu( bigaragara ko yanditse kuri Uwishema Alfred) kimwe n'izindi zivugwa muri iyo nyandiko, zizagurishwa mu rwego rwo kurangiza urubanza N° RC 31.459/99 rwavuzwe haruguru. Urukiko rusanga, uretse kuba iyo nzu ivugwa mu nyandiko y'Umuhesha w'Inkiko, nta handi bigaragara ko yaba yaratanzweho ingwate na IMEX Sarl cyangwa abishingizi bayo. Urukiko rusanga ariko, mu cyemezo N° 380/M.F/2001 cyatanzwe n'Urukiko rwa Mbere rw'Iremezo rwa Kigali ku wa 23/10/2001, Perezida w'urwo Rukiko yarategetse ko cyamunara kuri iyo nzu ihagarara biturutse ku busabe bw'uwitwa Munyawera Charles, wanditse avuga ko ikibanza N° 3271 ari icye akabitangira n'ibimenyetso, kandi ko ntaho gihuriye n'urubanza N° RC 31.459/99. Urukiko rukaba rusanga rero ntaho rwahera rwemeza ko inzu iri mu kibanza N° 3271 yaratanzweho ingwate na IMEX Sarl, kandi ko yagurishijwe mu rwego rwo kwishyura umwenda iyo Sosiyete ibereyemo I&M Bank Rwanda PLC.

[53] Hashingiwe ku bisobanuro byose byatanzwe, Urukiko rurasanga nta bimenyetso bigaragaza ko umwenda IMEX Sarl yari ibereyemo I&M Bank Rwanda PLC warangiye kwishyurwa, ku buryo inzu iri mu kibanza N° 1874 yavanwa mu bugwate; ikirego cyatanzwe na Kayombya Robert kikaba rero nta shingiro gifite.

[54] Abunganira Kayombya Robert bavuga ko I&M Bank Rwanda PLC igomba gutegekwa kwishyura 10.000.000 Frw, akubiyemo 7.000.000 Frw y'igihembo cy'Avoka, 2.500.000 Frw yo gushorwa mu manza, na 500.000 Frw yo gukurikirana urubanza, akanasubizwa 3.000.000 Frw yishyuye umuhanga washyizweho n'Urukiko.

[55] Ababuranira I&M Bank Rwanda PLC, mu bujirire bwuririye ku bwa Kayombya Robert, bavuga ko basaba Urukiko kuyigenera amafaranga y'ikurikiranarubanza n'igihembo cy'Avoka muri uru rwego kingana na 3.000.000 Frw.
