[18] Urukiko rusanga kubura ubushobozi bwo kwiregera bivugwa mu ngingo ya 171, igika cya 2, y'Itegeko N° 22/2018 ryo ku wa 29/04/2018, ari ibiba byaje nyuma y'uko umuntu aburana urubanza asaba ko rusubirishwamo ingingo nshya, kuko iyo bibaho mbere, atari kubasha kwiburanira adafite umuhagarariye (*tuteur*), uyu akaba ari nawe wakomeza urubanza kugeza igihe inzira zose z'ubujurire zirangiriye.

[19] Urukiko rusanga kandi ingingo ya 171, igika cya kabiri, irebana by'umwihariko no gusubirishamo urubanza ingingo nshya, n'ingingo ya 278 irebana n'inzira z'ubujurire muri rusange, zuzuzanya, kuko kutagira ubushobozi bwo kwiregera bishobora kuba imwe mu mpamvu zikomeye zitunguranye kandi zidaturutse ku bushake bw'umuntu.

[20] Nta ngingo y'Itegeko ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsu itanga igisobanuro (*definition*) cy'abantu badafite ubushobozi bwo kwiregera, ariko hari ingingo zitandukanye mu Itegeko N° 32/2016 ryo ku wa 28/08/2016 rigenga abantu n'umuryango, zisobanura abantu badafite ubushobozi bwo gukoresha uburenganzira mbonezamubano (*capacity to exercise civil rights*), harimo n'ubushobozi bwo gutanga ikirego. Ingingo ya 113³ y' Itegeko rimaze kuvugwa, iteganya ko imyaka y'ubukure ari 18, kandi ko kuri iyo myaka aribwo umuntu agira ubushobozi bwo gukora ibintu byose bimuhuza n'abandi; bivuga ko muni y'iyi myaka nta bushobozi umuntu aba afite, uretse igihe yemerewe ubukure (*émancipation*) hakurikijwe ibiteganywa mu ngingo ya 116⁴ y'iryo Tegeko.

[21] Muri urwo rwego kandi, ingingo ya 150 y'Itegeko N° 32/2016 ryo ku wa 28/08/2016 iteganya ko umuntu mukuru ufite ubumuga bwo mu mutwe n'aho bwaba bujya bumuha agahenge rimwe na rimwe yamburwa ubushobozi n'urukiko rubifitiye ububasha, rukamushyiraho umwishingizi. Ubwishingire busobanurwa mu ngingo ya 119 y'iryo Tegeko nk'uburyo bukoreshwa bwo gufasha umwana cyangwa umuntu mukuru ufite ubumuga bwo mu mutwe gukoresha uburenganzira bwemererwa buri wese muri rusange no kumufasha gucunga umutungo we igihe awufite.
