WAPSCOS Ltd yatakambiye icyo cyemezo muri RPPA ntibyagira icyo bitanga, bituma iregera Urukiko rw'Ubucuruzi isaba gutesha agaciro no gukuraho icyemezo n° 384/2018/BD/D cyafashwe na RPPA, ivuga ko cyayirenganyije kandi ko kitakurikije amategeko.

[2] Muri urwo Rukiko, RPPA yatanze inzitizi yo kutakira ikirego cya WAPCOS Ltd ivuga ko itabanje kuyitakambira mu minsi iteganyijwe n'amategeko, byongeye kandi n'aho ibikoreye bikaba byarakozwe n'umuntu utabifitiye ububasha. WAPCOS Ltd yo yavugaga ko RPPA itari ifite ububasha bwo kuyifatira icyemezo kuko isoko rya WASAC Ltd atari isoko rya Leta kubera ko WASAC Ltd ari sosiyete y'ubucuruzi.

[13] Me NTARUGERA Nicolas uburanira RPPA avuga ko basaba Urukiko rw'Ikirenga gusesengura amategeko n'amabwiriza ariho hagamijwe kureba niba isosiyeti y'ubucuruzi WASAC Ltd itarebwa n'amategeko agenga amasoko ya Leta ku buryo RPPA nta bubasha bwo kuyakurikirana ifite. Avuga ko RPPA ibizi neza ko WASAC Ltd ari isosiyeti y'ubucuruzi Leta ifitemo imigabane yose 100%, ndetse ikaba izi ko amasosiyeti y'ubucuruzi na WASAC Ltd irimo, agengwa n'amategeko agenga amasosiyeti y'ubucuruzi (*company Law*), ko ariko ibyo bidakuraho ko hari igihe WASAC Ltd iba igomba gukurikiza amategeko agenga amasoko ya Leta. Avuga ko RPPA ibyo yabisobanuriye Urukiko Rukuru rw'Ubucuruzi, irugaragariza amategeko n'ibimenyetso bishyigikira ibyo yavugaga ariko ruranga rubirengaho rwemeza ko nta bubasha ifite ku masoko ya WASAC Ltd.

Avuga ko mu guhuza ibyo n'isoko WAPCOS Ltd yari yaratsindiye, RPPA yagaragarije Urukiko ko mu masezerano yasinnye hagati ya WASAC Ltd na WAPCOS Ltd bigaragaramo ko WASAC Ltd yari kwishyura hakoreshejwe amafaranga aturutse

mu ngengo y'imari isanzwe ya Leta (*ordinary budget*), ibyo akaba aribyo byahaga RPPA ububasha bwo guheza WAPCOS Ltd mu masoko ya Leta mu gihe itari yubahirije amasezerano yagiranye na WASAC Ltd.

[17] Mu kwanzura, Me NTARUGERA Nicolas avuga ko ingingo ya 4 y'Itegeko Ngenga n° 001/2016 ryo ku wa 20/04/2016 rishyiraho ibigo bya Leta, ivuga ko ibigo bya Leta biri mu byiciro bibiri, ibikora ubucuruzi n'ibidakora ubucuruzi, WASAC Ltd ikaba iri mu bikora ubucuruzi. Avuga ko na WAPCOS Ltd ijya gutakambira RPPA, ari uko yari izi ko ifite ububasha bwo gufata icyemezo ku isoko yari yaratsindiye muri WASAC Ltd, bityo bakaba basanga amategeko bagaragaje yarirengagijwe n'inkiko zabanje.

[18] Me SANGANO Yves uburanira WAPCOS Ltd, avuga ko umwanzuro wo gusubirishamo urubanza ku mpamvu z'akarengane wa RPPA umeze nk'uw'ubujurire busanzwe, kuko utagaragaza impamvu z'akarengane RPPA ishingiraho. Avuga ko mu guca urubanza, Urukiko Rukuru rw'Ubucuruzi rwasesenguye amategeko impande zombi zashingiyeho ziburana nk'uko bigaragara mu bika kuva ku cya 15 kugeza ku cya 18 by'urubanza rusabirwa gusubirwamo ku mpamvu z'akarengane. Avuga ko akarengane kagombye gushingira ku nenge y'icyemezo cy'urukiko aho gushingira ku byo umuburanyi yakoresheje yiregura ntibihabwe agaciro, bitabaye ibyo iki kirego kikaba ntaho cyaba gitaniye n'icy'ubujurire busanzwe.

[19] Avuga ko kuba RPPA yemera neza ko WASAC Ltd ari isosiyete y'ubucuruzi, byumvikana neza ko nayo yemera ibivugwa mu gika cya 15 n'icya 18 by'urubanza rusabirwa gusubirishwamo ku mpamvu z'akarengane, ku bw'ibyo hakaba nta nenge n'imwe urwo rubanza rufite hakurikijwe amategeko u Rwanda rwagenderagaho mu gihe urwo rubanza rwacibwaga, kandi yose Urukiko rwarayasuzumye.

[20] Akomeza avuga ko mu gusuzuma iki kibazo, basanga Urukiko rugomba kureba mbere na mbere niba hari itegeko riha ububasha RPPA, kuko ububasha bwayo budashingiye ku kuba hakoreshwa amafaranga atangwa na Leta nk'uko uyihagarariye ashaka kubyumvikanisha, ko ahubwo bushingiye ahanini ku rwego rutanga amasoko ya Leta nk'uko itegeko rigenga amasoko ya Leta ribiteganywa mu ngingo yaryo ya 8 n'ya 9. [25] Ku birebana n'ububasha bwa RPPA, Me SANGANO Yves avuga ko ingingo ya 3, agace ka 11°, y'Itegeko rishyiraho iteganya ko RPPA ishobora kuzuza izindi nshingano yahabwa n'Itegeko zitanyuranyije n'inshingano zayo z'ibanze, ko aha ariho RPPA yagombye kuba igaragaza aho ikura inshingano ku masosiyete y'ubucuruzi kuko nayo yemera ko WASAC Ltd ari isosiyete y'ubucuruzi.
