Nyuma y'izo manza, Urubanza rw'iremezo rwarakomeje, Urukiko rw'Ubucuruzi rwa Huye rwaciye urubanza rw'iremezo rwemeza ko Ruvugabigwi Jean Paul yishyura BPR Ltd umwenda remezo, inyungu zawo, indishyi n'igihembo cy'Avoka.

Ruvugabigwi Jean Paul ntiyishimye imikirize maze ajuririra urwo rubanza mu Rukiko Rukuru rw'Ubucuruzi, avuga ko amasezerano yagiranye na BPR Ltd itubahirijwe ngo kuko yateganyaga ko mu gihe ananiwe kwishyura hazagurishwa ingwate yahaye BPR Ltd, akaba ari yo ivamo ubwishyu bitarinze kujya mu nkiko. Urukiko Rukuru rw'Ubucuruzi rwaciye urubanza rwemeza ko nta gihindutse ku mikirize y'urubanza rwaciwe n'Urukiko rw'Ubucuruzi rwa Huye aha rwavuze ko ntaho mu masezerano y'umwenda avuga ko byanga bikunze ko ingwate igurishwa hatabanje kwitabazwa inkiko.

Ruvugabigwi Jean Paul yajuririye Urukiko rw'Ikirenga, ariko mu gihe uru rubanza rwari rutaracibwa, BPR Ltd nayo, yahise itanga ikirego mu Rukiko rw'Ibanze rwa Nyarugenge, isaba icyemezo gitegeka ifatira ry'agateganyo ku bikoresho bya Ruvugabigwi Jean Paul byari mu bubiko bwe kugira ngo bizaherweho hishyurwa umwenda afitiye BPR Ltd, Urukiko runafata icyemezo gitaga uburenganzira bwo gufatira ibyo bikoresho.

Urukiko rw'Ikirenga mu guca urubanza ku kirego rwashyikirijwe na Ruvugabigwi Jean Paul rwemeje ko ubujurire bwe bufite ishingiro, ko ndetse urubanza RCOMA 0125/13/HCC rwaciwe n'Urukiko Rukuru rw'Ubucuruzi n'urubanza RCOM 0260/12/TC/HYE rwaciwe n'Urukiko rw'Ubucuruzi rwa Huye ku wa zivanyweho,rutegeka ko ahubwo hakubahirizwa ibikubiye mu rwandiko rwo ku wa 17/12/2012 BPR Ltd yamwandikiwe imumenyeshya umwenda ayibereyemo, inamwibutsa ko agomba kuwishyura mu gihe kitarenze iminsi 30, yaba atawishyuye ingwate yatanze zigategzwa cyamunara.

Nyuma y'izo manza, Ruvugabigwi Jean Paul nawe yareze BPR Ltd mu Rukiko rw'Ubucuruzi ibirego birimo indishyi zo kuba yarafatiriye ibikoresho bye, bimwe bikagurishwa cyamunara, ibindi bikangirika. Urwo rubanza rwakomeje kujya rujuririrwa ariko hose ariko Ruvugabigwi agenda atsindwa ruza kurangiririra mu Rukiko rw'Ubujurire ariko naho aratsindwa.

Nyuma yo gutsindwa hose ariko ntanyurwe, Ruvugabigwi Jean Paul yandikiye Perezida w'Urukiko rw'Ikirenga asaba ko urubanza RCOMAA 00075/2018/CA rwaciwe n'Urukiko rw'Ubujurire rwasubirishwamo ku mpamvu z'akarengane, Perezida w'Urukiko rw'Ikirenga amaze gusuzuma ubusabe bwe, yemeza ko rusubirishwamo ku mpamvu z'akarengane.

Mu gusobanura ibyo ashingiraho avuga ko yarenganye, Ruvugabigwi Jean Paul yavuze ko koko adahakana ko umwenda yahawe na BPR Ltd atananiwe kuwishyura ko ariko mu gihe yarananiwe kuwishyura BPR Ltd yagombaga kugurisha ingwate yari yarayihaye nk'uko amasezerano yabiteganyaga, ntiyihutiye kujya kumurega

mu Nkiko. Yongeraho ko kandi BPR Ltd yatanze ibirego bitandukanye byabaga bigamije gufatira ibikoresho byanditse koko bikanafatirwa bimwe ikaba ikinabifite hakiyongeraho n'ibyafatiriwe muri Magerwa hanyuma BPR Ltd ikananirwa kubikuramo bikarinda bigera ubwo RRA ibiteza cyamunara, bityo icyo gihombo akaba ariyo igomba kukiryoza kuko we, kuva hafatwa icyemezo kibifatira atari akibifiteho uburenganzira. Akaba kandi asaba ko Urukiko rwategeka BPR Ltd kumuha inyungu yavukijwe yashoboraga kubona iyo Hoteli ye iza gukora kuko ibikoresho byose byafatiriwe byari bigeye gukora muri Hotel.

Kuruhande rwa BPR Ltd n'abayunganira bo bavuga ko batabona igihombo bamuteje ngo kuko ibyo bikoresho byafatiriwe ngo hishyurwe umwenda ayibereyemo, bakaba rero babona nta karengane Ruvugabigwi yagiriye ngo kuko iyo aza kwishyura umwenda ku gihe nkuko bari barabyumvikanye, izi manza zose nditse n'amafatira tandukanye yakozwe atagombaga gukorwa.

Ruvugabigwi Jean Paul yananiwe kwishyura iyo nguzanyo, maze BPR Ltd imurega mu Rukiko rw'Ubucuruzi, irusaba kwemeza ko yananiwe kwishyura umwenda remezo wa 271,161,419 Frw.

Ku kirebana n'igihombo avuga ko yatejwe na BPR Ltd kubera ifatira ry'ibikoresho bye, urukiko rwasanze nta sano iri hagati y'ibyatejwe cyamunara n'ifatira ryasabwe na BPR Ltd, kuko umuhesha w'inkiko wagiye guteza cyamunara nk'uko bigaragazwa na PV de constat yo ku wa 03/02/2013, yasanze ibicuruzwa byaramaze gusohorwa muri MAGERWA na Ruvugabigwi Jean Paul, bituma icyemezo cyo guteza cyamunara kidashyirwa mu bikorwa. Kubera izo mpamvu, Urukiko rw'Ubucuruzi rwa Nyarugenge rwemeje ko nta hwanya ry'imyenda ryashoboka mu gihe nta mwenda BPR Ltd ibereyemo urega.

Ku wa 03/05/2019 urwo urubanza rwaraciye, Urukiko rwemeza ko ubujurire bwa Ruvugabigwi Jean Paul nta shingiro bufite, kuko kuba ibikoresho bye byaratejwe cyamunara na RRA nta ruhare BPR Ltd yabigizemo, ikaba rero itaryozwa agaciro kabyo n'inyungu avuga ko yari kubukuramo; rumutegeka kwishyura BPR Ltd umwenda ayibereyemo ungana na 118,678,770 Frw na 1,000,000 Frw y'igihembo cy'Avoka n'ikurikiranarubanza.

yari yarayihaye nk'uko amasezerano yabiteganyaga, yihutiye kujya kumurega mu nkiko, ndetse inatanga ibirego byihutirwa isaba urukiko ko rwafatira ibikoresho bya Hoteli yari yaratumije bifite agaciro ka 284 880 USD ahwanye na 176,750,000 Frw, maze Urukiko rw'Ubucuruzi rwa Huye rutegeka ko bifatirwa. Ruvugabigwi Jean Paul asobanura ko BPR Ltd yananiwe kubikura mu bubiko bwa Magerwa bikarinda bigera ubwo RRA ibiteza cyamunara, bityo icyo gihombo akaba ariyo igomba kukiryoza kuko we, kuva hafatwa icyemezo kibifatira atari akibifiteho uburenganzira.

[14] Ruvugabigwi Jean Paul n'umwunganira bavuga ko ndetse n'ibikoresho bike yari yaravanye muri Magerwa mbere y'uko Urukiko rw'Ubucuruzi rwa Huye rutegeka ko bifatirwa, na byo byaje gufatirwa na BPR Ltd hashingiwe ku cyemezo No 0001/2013 cyafashwe n'Urukiko rw'Ibanze rwa Nyarugenge ku wa 22/07/2013, ubu akaba ariyo ibifite. Ruvugabigwi Jean Paul, ahera kuri icyo gihombo yatewe n'ifatira ry'ibikoresho bye, asaba agaciro kabyo kangana na 284,880USD ahwanye na 176,750,000 Frw n'inyungu zayo zihwanye na 307,370.4 USD; inyungu yavukijwe yashoboraga kubona iyo Hoteli ye iza gukora, indishyi zinyuranye, amafaranga y'ikurikiranarubanza n'igihembo cy'Avoka.

[15] Me Mubangizi Frank avuga ko BPR Ltd yasabye koko ko ibyo bikoresho byari muri Magerwa bifatirwa ikabyemererwa, ariko ko Umuhesha w'inkiko ubwo yageraga kuri Magerwa kubifatira yasanze Ruvugabigwi Jean Paul yarabisohoye, bigatuma batanga ikindi kirego cyo kubifatira mu Rukiko rw'Ibanze rwa Nyarugenge. Avuga ko n'ubwo Ruvugabigwi Jean Paul yagiye abangamira ishyirwa mu bikorwa ry'ibyemezo by'inkiko, Umuhesha w'inkiko yaje kubifatira abisanze ahitwa GOODYEAR, bityo ko BPR Ltd nta gihombo yamuteje kuko ibyo bikoresho byafatiriwe ngo hishyurwe umwenda ayibereyemo. Me Mubangizi Frank asoza asaba amafaranga y'ikurikiranarubanza n'igihembo cy' Avoka.

- Lot ya 4 yagurishijwe amafaranga angana na 1,400,000 Frw;
- Lot ya 53 yagurishijwe 1,180,000 Frw;

bityo igiteranyo cyayo akaba ari 2,580,000 Frw.

[18] RRA ivuga ko muri ayo mafaranga hakuwemo umusoro ungana na 1,011,143 Frw, hakurwaho n'aya Magerwa angana na 208,954 Frw, hagasigara 1,359,903 Frw agashyirwa mu isanduku ya Leta nk'uko biteganywa n'ingingo ya 57 (4) y' Itegeko rigenga za Gasutamo z'Ibihugu bigize Umuryango wa Afurika y'Iburasirazuba ryo muri 2005. RRA ivuga kandi ko ibikoresho byasigaye byagurishijwe ku wa 29/01/2017 kuri Lot ya 45 yagurishijwe 1,000,000 Frw; 219,360 Frw akishyurwa umusoro, 289,500 Frw akishyurwa Magerwa, ayasigaye 491,140 Frw agashyirwa mu isanduku ya Leta.

[21] Ruvugabigwi Jean Paul asobanura ko ibikoresho byatejwe cyamunara na RRA bifite agaciro kangana n'amadorali ibihumbi mirongo itanu n'umunani magana atanu na mirongo itandatu (58 560 \$); akanavuga kandi ko hari n'ibindi bikoresho BPR Ltd yafatiriye kuri *GOODYEAR* na byo byari bifite agaciro ka 213365 \$, akaba agomba kuyishyurwa hiyongereyeho n'ikiguzi cya *transport* cyishyurwa *company* yitwa JACAJO kingana n'amadorali ibihumbi cumi na mirongo irindwi (10 070 \$). Basaba kandi n'amafaranga y'ikurikirana rubanza kuko yatakaje umwanya munini yiruka ku bintu bye mu nzego zitandukanye, mu nkiko zitandukanye kuva mu birego byihutirwa, kugeza ubu mu Rukiko rw'Ikirenga mu rubanza rw'akarengane na byo akaba abisabira indishyi zingana na 20,000,000 Frw, yose hamwe akaba angana na 40,000,000Frw.
