Yasabye kandi Urukiko gutegeka Leta n'inzego zifite aho zihuriye n'iperereza guhagarika kwereka itangazamakuru abakekwaho ibyaha no kubahatira kuvugana naryo ndetse rugategeka abayobozi b'ibitangazamakuru, imbuga nkoranyambaga harimo na *youtube* n'umuntu uwo ariwe wese, guhanagura burundu mu bubiko bwabo amafoto n'amashusho y'abakekwaho ibyaha bafashe.

Mbere yo gusuzuma ubu busabe bwa Murangwa, habanje gusuzumwa ikibazo cyo kumenya niba afite inyungu muri uru rubanza kuko avuga ko afite uburenganzira bwo gusaba ko ingingo z'itegeko zinyuranyije n'Itegeko Nshinga zivanwaho atabanje gutegereza ko zimugiraho ingaruka.

Avuga ko kuregera ingingo ko inyuranyije n'Itegeko Nshinga mbere y'uko ikugiraho ingaruka ari nko kwikingiza mbere y'uko urwara, ko mu gihe rero abona ingingo aregera zibangamiye uburenganzira bwe bw'ibanze buteganywa n'Itegeko Nshinga, nta kibuzo ko aziregera kandi ko bidakwiye ko Urukiko rufata icyo kibazo nk'ikitariko nyamara itegeko ryarasohotse mu Igazeti ya Leta ndetse akaba asabwa gukora icyo ritegeka cyangwa kudakora icyo ribuzo.

Abahagarariye Leta y'u Rwanda bavuga ko inyungu zo kurega ari impamvu y'ingenzi kugira ngo ikirego cyakirwe, ko bidakwiye ko uwo ari we wese yemererwa kurega no mu gihe yaba adafite inyungu kuko bishobora gutera akajagari ndetse bikaba byaburizamo ibirego by'abari babifitemo inyungu.

II. IKIBAZO KIGIZE URUBANZA N’ISESENGURWA RYACYO.

1. Kumenya niba Murangwa Edward afite inyungu muri uru rubanza

[5] Murangwa Edward n’abamwunganira bavuga ko, nk’umuntu urebwa n’itegeko ryose risohotse mu Igazeti ya Leta, akaba asabwa gukora icyo ritegeka cyangwa kudakora icyo ribuza, ingingo aregera zibangamiye inyungu ze kuko zigena imihango ikurikizwa mu gihe cy’isaka kandi zigashyiraho urwego rufite ububasha bwo gutanga uruhushya rw’isaka. Basobanura ko izo ngingo zijyanye n’ikurikiranacyaha zireba buri wese uri mu Rwanda, harimo na we ubwe n’umuryango we, bakaba basanga uburyo izo ngingo zabiteganyije binyuranyije n’ibiteganywa n’Itegeko Nshinga cyane cyane mu ngingo yaryo ya 43, ariyo mpamvu afite uburenganzira bwo gusaba ko ingingo z’Itegeko zinyuranyije n’Itegeko Nshinga zivanwaho atabanje gutegereza ko zimugiraho ingaruka.

[6] Bavuga ko kuregera ingingo ko inyuranyije n’Itegeko Nshinga mbere y’uko ikugiraho ingaruka ari nko kwikingiza mbere y’uko urwara, ko mu gihe rero abona ingingo aregera zibangamiye uburenganzira bwe bw’ibanze buteganywa n’Itegeko Nshinga, nta kibuzo ko aziregera, kandi ko bidakwiye ko Urukiko rufata icyo kibazo nk’ikitaraho nyamara Itegeko ryarasohotse mu Igazeti ya Leta. Avuga ko ibisobanuro by’inyungu afite muri uru rubanza abishingira ku biteganywa n’ingingo ya 72, igika cya mbere, y’Itegeko N° 30/2018 ryo ku wa 02/06/2018 rigena ububasha bw’Inkiko.¹ Avuga ko mu gusesengura iyo ngingo, uru Rukiko rwatanze umurongo mu rubanza rwa Me Mugisha Richard², aho rwavuze ko mu birego bijyanye no kwemeza ko hari ingingo z’Itegeko zinyuranye n’Itegeko Nshinga, umuburanyi ashobora gusaba ko itegeko rivaho agamije kurengera inyungu rusange za rubanda bitabaye ngombwa ko agaragaza inyungu bwite abifitemo.

[7] Bavuga ko kuba umuntu ashobora gusaba ko itegeko rivaho bitabaye ngombwa kugaragaza ko ryakoreshejwe kuri we, byemejwe n’izindi nkiko harimo n’Urukiko rw’Uburayi rushinzwe iyubahirizwa ry’uburenganzira bwa muntu mu rubanza Klass n’abandi baburanagamo n’Ubudage,³ ndetse n’Inkiko zishinzwe kurinda Itegeko Nshinga nk’uko bigaragazwa n’urubanza Ferreira yaburanaga na Allan Levin na bagenzi be rwaciwe n’Urukiko rwa Afurika y’Epfo rushinzwe kurinda iremezo ry’Itegeko Nshinga,⁴ urubanza *Rev. Christopher Mtikila* yaburanaga na *The Attorney General* rwaciwe n’Urukiko Rukuru rwa Tanzaniya,⁵ urubanza *IRC* yaburanaga na *National Federation of Self-Employed and Small Businesses Ltd* rwo mu Bwongereza,⁶ urubanza *Thorson* yaburanaga na *Attorney General of Canada*,⁷ urubanza *Adesanya* yaburanaga na *President of Nigeria & Another*⁸ n’urubanza *A.G. of Dendel State* yaburanaga na *A.G. of Nigeria*.⁹

ndetse bikaba byaburizamo ibirego by'abari babifitemo inyungu. Bavuga ko umuhanga *Blandine Rolland* mu gitabo cye cya *Procédure civile*, avuga ko urega agomba kuba afite inyungu bwite kandi itagenekereje mu gihe cyo gutanga ikirego,¹⁰ naho *Cédric Tahri*, nawe mu gitabo cyitwa *Procédure civile* akongeraho ko iyo nta nyungu ihari nta n'ikirego cyakagombye kubaho, ndetse ko iyo nyungu igomba kuba igaragara aho gushingira ku byifuzo by'utanga ikirego.¹¹

[9] Bavuga ko ibijyanye n'inyungu bwite byasobanuwe neza n'uru Rukiko mu rubanza rwa Byansi Samuel Baker,¹² uru Rukiko rutanga umurongo w'uko inyungu z'urega zivugwa mu ngingo ya 72 y'Itegeko N° 30/2018 ryo ku wa 02/06/2018 rigena ububasha bw'inkiko, ari impamvu y'ingenzi kugira ngo ikirego cyemeza ko itegeko rinyuranyije n'Itegeko Nshinga cyakirwe, kandi ko izo nyungu zigomba kumvikana nk'inyungu bwite kandi zitaziguye zerekana ko urega abangamiwe n'ingingo z'amategeko asaba ko zivanwaho. Ku bireba Murangwa Edward, bavuga ko agaragaza inyungu rusange gusa aho kugaragaza inyungu bwite, ko ikirego cye kiramutse cyakiriwe cyaba cyitiranyijwe n'icyatanzwe mu nyungu za rubanda (*public interest litigation*). Bavuga ko nubwo bikwiye ko Urukiko rwagura ububasha bw'abatanga bene ibi birego mu rwego rwo kurengera inyungu rusange, umurongo rwatanze uzitira ababitanga ku bw'impamvu zitazwi cyangwa izo kwimenyekanisha kandi ko ibyo bifasha mu gukumira ibirego bitari ngombwa bishobora kugira ingaruka ku itangwa ry'ubutabera bunoze.

kubera ko bari bafite ibirego bitegereje kuburanishwa mu nkiko zisanzwe. Inyungu z'urega muri izi manza zari zishingiye ku kuba hari urubanza rusanze uwatanze ikirego afite, agasaba Urukiko rumuburanisha kuba rutegereje guca urubanza kugira ngo abanze agaragaze ko ingingo y'Itegeko urwo Rukiko ruzashingiraho acirwa urubanza inyuranyije n'Itegeko Nshinga.

[12] Naho ikibazo cy'inyungu z'umuburanyi udafite urundi rubanza mu Rukiko rusanze cyangwa utaratangira kugirwaho ingaruka n'ingingo z'Itegeko aregera ko zinyuranyije n'Itegeko Nshinga cyasuzumwe mu buryo bwimbitse mu rubanza rwa Me Mugisha Richard.¹⁸ Guhera ku gika cya 20 kugeza ku cya 32 by'urwo rubanza, uru Rukiko rwasobanuye ko kuregera itegeko ko rinyuranyije n'Itegeko Nshinga bikwiye gufatwa nk'ikibazo gikomeye kandi kigomba gukemurwa aho gufatwa nk'ikibazo kitariho, inyungu z'uwatanze ikirego zikaba zishingiye ku kuba asaba Urukiko kwemeza ko hari ingingo z'itegeko zibangamiye uburenganzira buteganywa n'Itegeko Nshinga cyangwa zituma intego igamijwe n'Itegeko Nshinga itagerwaho nyamara igomba kurengerwa. Kuba ingingo z'Itegeko rirerwa ziriho ubwabyo biheshaurega inyungu zo gutanga ikirego asaba ko zivanwaho bitabaye ngombwa gutegereza ko zimugiraho ingaruka. Mu yandi magambo, muri bene ibi birego, inyungu zishobora kuba ari iziriho cyangwa izishobora kubaho.

[13] Uru Rukiko rwasanze kandi inyungu zigomba kumvikana mu buryo bwagutse bitewe n'uko akamaro k'urubanza ruciye kuri bene ibi birego karenga inyungu bwite z'uwatanze ikirego nk'uko bizwi mu manza zisanze kakagera no kuri rubanda, hakaba nta wundi wakongera kuregera iza ngingo zari zararegewe ko zinyuranyije n'Itegeko Nshinga. Iki ni nacyo cyatumye Umushingamategeko ateganya ko imanza zivanyeho ingingo z'Itegeko kubera ko zinyuranyije n'Itegeko Nshinga zitangazwa mu Igazeti ya Leta kugira ngo abaturage bese babimenyeshwe.

[14] Urukiko rurasanga iby'uko inyungu iregerwa mu manza zisaba kwemeza ko itegeko rinyunyije n'Itegeko Nshinga igomba kurebwa mu buryo bwagutse byaragarutseweho na none mu rubanza rwa Me Kabuye Ngendahayo.¹⁹ Muri urwo rubanza, uru Rukiko rwasanze ingingo z'Itegeko ryerekeye imicungire y'umutungo w'abashyingiranywe, impano n'izungura zaregewe ko zinyuranyije n'Itegeko Nshinga zireba umuntu wese uri muri sosiyete nyarwanda kubera ko ishyingiranwa, izungura ndetse n'uburenganzira ku mutungo ntawe bikumira, bivuze ko buri munyarwanda wese harimo na Kabuye Ngendahayo, ashobora kurikoresha cyangwa rikamugiraho ingaruka. Kuba rero ari mubo itegeko rireba kandi nawe akaba ashobora kuryifashisha kabone nubwo yaba atarahura n'ikibazo ngo ingingo zaryo zimugireho ingaruka akaba aribyo bimuhesha inyungu zo kuba yaregera ko hari ingingo zaryo zinyuranyije n'uburenganzira bwe buteganywa n'Itegeko Nshinga.

[15] Mu rubanza rubanziriza urundi rwa Byansi Samuel Baker rwaciye ku wa 10/12/2021²⁰ ndetse n'urwaciye ku wa 24/12/2021,²¹ uru Rukiko nyuma yo kwibutsa umurongo watanze mu rubanza rwa Me Mugisha Richard, rwasobanuye ko mu rwego rwo kwirinda ibirego bitari ngombwa bishobora kubangamira imikorere y'inkiko, uwatanze ikirego afite inshingano zo kugaragaza umwihariko w'inyungu we ku giti cye aharanira mu rubanza. Rwasanze Byansi Samuel Baker yari afite umwihariko w'uko yari umunyamakuru uregera ivanwaho ry'ingingo z'amategeko yavugaga ko zibangamiye ubwisanzure bw'itangazamakuru, ubwo kugaragaza ibitekerezo n'ubwo guhabwa amakuru. Mu rubanza rwaciye ku wa 24/12/2021, Urukiko rwasanze Itegeko riteganywa ibyaha n'ibihano muri rusange rireba buri wese uri ku butaka bw'u Rwanda harimo n'abanyamakuru, bityo

ingingo zaryo avuga ko zikwiye kuvaho kuko zinyuranye n'Itegeko Nshinga zikaba zishobora kumubangamira ubu cyangwa mu bihe bizaza.

[16] Urukiko rwasanze kandi, Byansi Samuel Baker, nk'umunyamakuru w'umwuga, yari akomatanyirije hamwe inyungu rusange n'inyungu bwite zo gutanga ikirego nk'uko byasobanuwe haruguru. Ku bireba inyungu rusange, yarebwe mu kuba ingingo z'Itegeko riteganywa ibyaha n'ibihano muri rusange, zireba abaturage muri rusange nawe arimo, zikaba zishobora kumubangamira mu burenganzira bwe. Naho inyungu bwite ireberwa mu kuba ari umunyamakuru w'umwuga uharanira iterambere ry'ubwisanzure bw'itangazamakuru n'amategeko arigenga aho kureberwa mu ngaruka ingingo z'amategeko yaregeraga zamugizeho. Kuba yari umunyamakuru byamuhaga umwihariko watumye muri izo manza Urukiko rubona ko amategeko aregera ko anyuranyije n'Itegeko Nshinga ari amwe mu mategeko amugenga mu mwuga we, bityo bikaba bitari ngombwa gutegereza ko abanza kumugiraho ingaruka kugira ngo yemererwe kugaragaza ko anyuranyije n'Itegeko Nshinga.

[17] Hashingiwe ku bimaze gusobanurwa haruguru, Urukiko rurasanga mu gusuzuma inyungu z'urega hagomba kurebwa ibintu bikurikira, kuba hariho kimwe muri byo bikaba byihagije kugira ngo Urukiko rwemeze ko urega afite inyungu:

- Niba hari itegeko rirerwa ko rinyuranyije n'Itegeko Nshinga rireba urega cyangwa icyiciro abarizwamo by'umwihariko ku buryo afite inyungu ku giti cye zo gutanga ikirego. Urugero ni nk'Itegeko rireba abanyamakuru, abaganga, abarimu, n'abandi;
- Niba itegeko rirerwa ko rinyuranyije n'Itegeko Nshinga rireba abaturage muri rusange ku buryo rishobora kugira ingaruka ku burenganzira bwabo, ibyo bikaba aribyo bihesha umuntu uwo ari we wese rishobora kuzagiraho ingaruka inyungu zo kuriregera ko rinyuranyije n'Itegeko Nshinga;
- Niba uwatanze ikirego ari umwavoka, uyu akaba mu nyungu z'ubutabera, yemerewe gutanga ikirego mu rwego rwo guteza imbere amategeko cyangwa uburenganzira bw'abarebwa n'iryo tegeko kabone nubwo nta nyungu we ku giti cye yaba afite muri icyo kirego.

[18] Ku bireba uru rubanza, Urukiko rurasanga Murangwa Edward avuga ko ingingo z'amategeko aregera ziyanye n'ibikorwa bimwe by'iperereza, isaka, itambamira ry'ibintu cyangwa igenzura ry'itumanaho, uburyo bikorwamo bikaba bibangamiye uburenganzira bw'ibanze buteganywa n'Itegeko Nshinga harimo n'ubwo kubahiriza icyubahiro n'agaciro ka muntu no kutavogera imibereho bwite, iy'umuryango, iy'urugo rwe cyangwa ubutumwa yohererezanya n'abandi. Avuga na none ko izo ngingo ziha ububasha bw'umurenge Ubugenzacyaha n'Ubushinjacyaha kuko hari aho ziteganywa ko isaka rishobora gukorwa hatabanje gutangwa urupapuro rw'isaka, ariko ko no kuba rushobora gutangwa n'Ubushinjacyaha asanga bivogera inshingano z'Ubucamanza zo kurinda uburenganzira n'ubwisanzure bwa muntu ziteganywa n'ingingo ya 43 y'Itegeko Nshinga.

[20] Urukiko rurasanga rero Murangwa Edward, nk'umwe mu barebwa n'ingingo z'Itegeko rishyiraho Urwego rw'Igihugu rushinzwe Ubugenzacyaha rikanagena inshingano, ububasha, imitunganyirize n'imikorere byarwo ndetse n'iz'Itegeko ryerekeye imiburanishirize y'imanza z'inshinjabyaha, afite inyungu zo gusaba kwemeza ko zimwe mu ngingo z'ayo mategeko zinyuranyije n'Itegeko Nshinga.
