Amategeko agenga imiburanishirize y'imanza z'ubucuruzi – Irangizwa ry'urubanza ry'agateganyo – Amasezerano agomba kuba mpamo mu gihe yakorwaga – Iyo impande zombi zagiranye amasezerano zibisabye, amasezerano ashobora kwemezwa ko ari mpamo n'umunoteri kabone n'iyotegeko ritabiteganyo kandi akaba yarangizwa by'agateganyo.

Incamake y'ikibazo: Marie Merci Modern Market Ltd yareze I&M Bank Ltd mu Rukiko rw'Ubucuruzi isaba kwemeza ko mu masezerano y'inguzanyo bagiranye harimo inshingano zidashobora kubahirizwa ku mpamvu zitayiturutseho, guhagarika ibarwa ry'inyungu zisanzwe n'iz'ubukererwe kugeza urubanza ruciwe burundu. I&M Bank Ltd nayo yatanze ikirego irega Marie Merci Modern Market Ltd n'abishingizi bayo isaba kwishyurwa umwenda remezo, inyungu n'indishyi zinyuranye. Yasabye kandi ko urubanza rurangizwa by'agateganyo. Urukiko rw'Ubucuruzi rwa Nyarugenge nyuma yo kuzihuza zikaburanishizwa hamwe rwemeje ko Marie Merci Modern Market Ltd yishyura umwenda yahawe habariwemo n'inyungu n'indishyi zinyuranye. Nyuma yo gutanga icyo kirego I&M Bank Ltd nayo yatanze ikirego muri urwo rukiko irega Marie Merci Modern Market Ltd n'abishingizi bayo aribo Aboyezantije Louis na Uwimana Vestine, isaba kwishyurwa umwenda yabaguriye, inyungu zawo n'indishyi zinyuranye. Izo manza zaje guhuzwa ziburanishirizwa hamwe. Urukiko rwaciye urwo urubanza kuwa 24/03/2015 rwemeza ko Marie Merci Modern Market Ltd n'abayishingiye, bishyura I&M Bank Ltd amafaranga 1.899.804.432 Frw y'umwenda remezo, inyungu n'indishyi zinyuranye. Muri uru rubanza I&M Bank yari yasabye irangizarubanza ry'agateganyo, Urukiko rwemeza ko nubwo amasezerano umwenda ushingiyeho ari inyandiko mvaho, iranginarubanza ry'agateganyo risabwa ritakwemerwa kuko umwenda wose wari utarageza igihe cyasezeranywe cyo kwishyurwa, kandi ko nta nubwihutirwe bw'ibyakwangirika bidasubirwaho riramutse ritemejwe

[2] Marie Merci Modern Market Ltd ntiyishimiye imikirize y'urwo rubanza, irujuririra mu Rukiko Rukuru rw'Ubucuruzi, narwo rucya urubanza kuwa 12/06/2015, rwemeza ko imikirize y'urubanza rujuririrwa idahindutse uretse ibiyongereyeho mu bujuriye bigizwe n'ingano y'umwenda wiyongereye no kurangiza urubanza by'agateganyo kuko Urukiko rwasanze amasezerano y'inguzanyo ari inyandikomvaho kubera ko yakorewe imbere ya Noteri w'Akarere ka Kicukiro ndetse rusanga amasezerano atagomba gusubirwamo, umwenda ukishyurwa wose.

[3] Marie Merci Modern Market Ltd ntiyishimiye uko urwo rubanza rwakijijwe, irujuririra mu Rukiko rw'Ikirenga, itanga n'ikirego cyihutirwa kigamije guhagarika irangizarubanza ry'agateganyo ryategetswe mu rubanza RCOMA0190/15/HCC.

[4] Iburanisha kuri icyo kirego cyihutirwa ryabaye kuwa 26/08/2015 hitabye Aboyezantije Louis, Umuyobozi wa Marie Merci Modern Market Ltd kandi Marie Merci Modern Market iburanirwa na Me Nzirabatinyi Fidèle na Me Kananga Protogène naho I&M Bank Ltd iburanirwa na Me Rusanganwa Jean Bosco. Nyuma yo gupfundikira iburanisha ry'urubanza, Urukiko rwatangaje ko icyemezo kizasomwa kuwa 28/08/2015.

II. IKIBAZO KIRI MU RUBANZA N'ISESENGURA RYACYO.

a. Kumenya niba amasezerano y'umwenda hagati ya Marie Merci Modern Market na I&M Bank atari inyandiko mvaho ku buryo irangizwa ry'agateganyo ry'urubanza rwajuririwe ryahagarara.

[5] Me Nzirabatinyi avuga ko imvano y'impaka ziri hagati ya Marie Merci Modern Market Ltd aburanira na I&M Bank Ltd, ari uko mu mikoranire yabo habayemo amasezerano abiri avuga ibintu bitandukanye, akaba yarakozwe ku itariki imwe, amwe yandikwa mu rurimi rw'igifaransa ndetse aba ariyo ajalanwa imbere ya Noteri kuwa 18/06/2012, andi masezerano yandikwa mu rurimi rw'icyongereza asinywa hagati ya Aboyezantije wenyine na I&M Bank Ltd ariko ntiyajyanwa imbere ya notaire.

[6] Me Nzirabatinyi avuga ko mu masezerano y'igifaransa mu ngingo yayo ya 2, hateganyijwe ko igihe cyo kwishyura cyari imyaka 15 naho ay'icyongereza akavugaga ko igihe cyo kwishyura gishyizwe ku myaka 7, ariko bikaba bitumvikana ukuntu mu gufata icyemezo Urukiko Rukuru rw'Ubucuruzi rwashingiye ku masezerano y'imyaka 15 yagiye kwa Noteri hatangwa irangizarubanza ry'agateganyo ariko mu gusuzuma urubanza muri rusange, ku birebana n'ubukerererwe n'uburyo bwo kwishyura, rukoresha amasezerano y'imyaka 7, bityo rero irangizarubanza ry'agateganyo rikaba ryaratanze mu karengane kuko Urukiko rwagendeye ku masezerano atari ay'inyandikomvaho.

[7] Avugaga ko inkiko zabanje zagiye zikoresha amasezerano yombi kandi atavugaga ibintu bimwe bituma Umucamanza mu Rukiko Rukuru rw'Ubucuruzi akoresha ingingo ya 212 y'Itegeko N° 21/2012 ryo kuwa 14/06/2012 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsu mu buyo butaribwo.

[8] Avugaga kandi ko bitari ngombwa kuregera inkiko hashingiye ku biteganywa n'amasezerano yagiye kwa notaire, bityo hakaba harirengagijwe ibikubiye mu ngingo ya 16 n'iz'ikurikira z'Itegeko ry'ingwate ku bitimukanwa kuko bagombaga kwandikira Umwanditsi Mukuru, basaba uburenganzira bwo kugurisha ingwate.

[9] Akomeza avugaga ko hatigeze haba ibirarane by'imyaka 3, ko ahubwo Aboyezantije yagiye yishyura make, igihe atishyuye akaba ari igihe hari hatangiye imanza nawe ategereza ko zirangira kugira ngo amenye umubare wayo azishyura ndetse akaba yarahagaritse kwishyura amaze gushyura agera kuri 700.000.000 Frw, bivuze ko igihe cy'ubukerererwe kingana n'amezi 4 gusa.

[10] Asoza avugaga ko irangizarubanza ry'agateganyo ryagenywe ritari ngombwa mu gihe hakiri urubanza mu ^[L]hataramenyekana umubare nyakuri w'amafaranga agomba kwishyurwa n'igihe agomba kwishyurirwa.

[11] Me Kananga avugaga ko irangizarubanza ryatanze riramutse ridakuweho hazabaho «préjudice irréparable» kuko ibintu byagurishijwe byaba bitakigarutse, bityo asaba ko ryahagarikwa kugeza urubanza ruciye burundu mu mizi kugira ngo hamenyekane amasezerano agomba gukurikizwa, ibi kandi ngo bikaba aribyo byemejwe mu rubanza RCOM0007/14/CS haburana Mushimiyimana Thaciana na Ecobank rwaciye n'Urukiko rw'Ikirenga kuwa

Urukiko Rukuru rw'Ubucuruzi rwahereye kuri iyi ngingo rutegeka ko urubanza rwajuririwe rurangizwa by'agateganyo.

Iyi baruwa ubwayo siyo masezerano y'umwenda asabwa gushyirwa mu bikorwa nkuko ababuranira Marie Merci Modern Market Ltd babivuga. Urukiko rufata "Loan offer" yahawe Marie Merci Modern Market Ltd nk'icyemezo ku busabe bwayo kiyemerera umwenda, naho amasezerano y'umwenda akaza akurikira iyo loan offer mu gihe Marie Merci Modern Market yahawe iyo offer yemeye ibiyikibiyemo. Bikaba bivuga ko izo nyandiko zombi zuzunya.

[21] Inyandiko zikubiye muri dosiye zigaragaza ko ku itariki ya 18/06/2012 hasinywe amasezerano hagati ya I&M Bank na Marie Merci Modern Market yitwa "ouverture de crédit avec constitution d'hypothèque". Iby'ingenzi bikubiye muri ayo masezerano, birebana n'umwenda ungana na 1.800.000.000 Frw wahawe Marie Merci Modern Market Ltd, wishingiwe n'ingwate iri mu mu kibanza n° 202/LC gihereye mu Kagari ka Kabeza, Umurenge wa Kanombe, Akarere ka Kicukiro. Iyo ngwate ifite agaciro kangana na 1.600.000.000 Frw. Nkuko biri mu ngingo ya mbere yayo masezerano, ibirebana nuko inyungu zibarwa bigomba kuba biri mu masezerano yihariye. Ibi bigaragaza ko amasezero y'umwenda hagati ya I&M Bank na Marie Merci Modern Market ari amwe atari amasezerano abiri atandukanye nubwo bwose loan offer nayo masezerano byasinyiwe ku itariki imwe ya 18/06/2012.

[22] Ayo masezerano kandi agaragaza ko yakorewe imbere ya Ruzindana Landrine, Noteri w'Akarere ka Kicukiro, ndetse akurikirwa no kwandikisha ingwate muri RDB ku itariki ya 30/10/2012. Ingingo ya 27 y'Itegeko N°13bis/2014 ryo kuwa 21/05/2014 rigenga umurimo w'Ubunoteri igira iti "Umunoteri yemeza ukurimpamo kw'amasezerano itegeko risaba ko agomba kuba mpamo mu gihe yakorwaga. Iyo impande zagiranye amasezerano zibisabye, amasezerano ashobora kwemezwa ko ari mpamo n'umunoteri kabone n'iyi itegeko ritabiteganywa".
