BK Ltd yireguye ivuga ko nta kosa yakoze, isaba ko ikirego cya Mugwaneza Carine Sandrine kitahabwa ishingiro kuko uyu yari afite inshingano zo kubika neza *carnet d'ordre de paiement* yahawe na banki abajura bifashishije babikuzaho ayo mafaranga n'ayo madolari kandi ko banki yagenzuye igasanga impapuro zakoreshejwe mu bujura zaratanzwe na nyiri konti ubwe.

Urukiko rw'Ubucuruzi rwa Nyarugenge rwasanze, hari urubanza rwaciwe n'Urukiko Rwisumbuye rwa Nyarugenge ku wa 18/03/2016, rwahamije Sinayobye Siméon icyaha cyo gukoresha inyandiko mpimbano, igihe yabikuzaga 11.500 USD kuri konti N° 00040-0294342-77 ya Mugwaneza Carine Sandrine, nkuko nawe abiyemerera; Inyandiko mvugo z'iperereza zakorewe mu rubanza nshinjabyaha zigaragaza ko umukono (*signature*) wari uri kuri *ordre de paiement* yakoreshejwe habikuzwa ayo madolari ari umuhimbano ndetse ko kugira ngo yibwe byagizwemo uruhare n'umukozi wa banki wafashije Sinayobye Siméon; Banki nk'umunyamwuga itarubahirije inshingano zayo zo kurinda amafaranga yari yabikijwe; ariko ko kubirebana na nta bimenyetso bigaragaza ko 310.000 Frw yabikujwe hakoreshejwe sheki y'impimbano, bityo ko ikirego cya Mugwaneza Carine Sandrine gifite ishingiro kuri bimwe, maze rwemeza ko BK Ltd igomba kumusubiza 11.500 USD, hiyongereyeho 2.012 USD, y'indishyi z'igihombo yatejwe na banki (*manque à gagner*) abariye ku gipimo cya 15%.

BK Ltd yajuririye Urukiko Rukuru rw'Ubucuruzi ivuga ko itagombaga gutegekwa gusubiza Mugwaneza Carine Sandrine 11.500 USD yabikujwe kuri konti ye, ndetse ko idakwiye no gutegekwa kwishyura inyungu ya 15%, isaba indishyi zo gushorwa mu manza nta mpamvu. Mugwaneza Carine Sandrine yireguye avuga ko ubujurire bwa BK Ltd nta shingiro bugomba guhabwa kuko mu rubanza RCOM 00860/2016/TC/NYGE rwaciwe ku wa 21/10/2016, Urukiko rw'Ubucuruzi rwa Nyarugenge rwasobanuye ko Banki nk'umunyamwuga itubahirije inshingano zayo zo kurinda konti ze bituma ikura 11.500 USD kuri konti ye.

uburangare nk'umunyamwuga, kuko itubahirije inshingano zayo zo kurinda umutekano wa konti y'umukiriya.

Mugwaneza avuga kandi ko ku bijyanye na 11.500 USD, mu rubanza RCOM 00860/2016/TC/NYGE, yagenewe inyungu za 15% nyamara amabanki y'ubucuruzi asanzwe abarira inyungu kuri 18%, akaba asaba uru Rukiko gukosora ayo makosa, agabahwa inyungu zibariye ku rugero banki zisanzwe zitangiraho inyungu kuwa ku wa 12/08/2015. Avuga ko mu gihe cy'imyaka irindwi n'amezi ane n'igice ishize, inyungu agomba kwishyurwa zingana na 15.266,25 USD ariko ko asaba uru Rukiko kuzazibara kugeza urubanza ruciwe ; asaba kandi gusubizwa 310.000 frw yakuwe kuri konti ye hiyongereyeho inyungu zayo zibariye kuri 18%.

BK Plc yiregura ivuga ko mu masezerano Mugwaneza Carine Sandrine yakoranye na banki buri ruhande rwari rufite inshingano rugomba kwubahiriza, bityo akaba asanga banki idakwiye kuryozwa ayo mafaranga kuko Mugwaneza Carine Sandrine ari we wateshutswe ku nshingano ze zo kwita ku gatabo yahawe na banki, ariyo mpamvu agomba kwirengera ibyabaye kuri konti ye.

BK ivuga kandi ko yakoze ubugenzuzi isanga *ordre de paiement* yakoreshejwe habikuzwa 11.500 USD yaracishijwe mu mashini yabugenewe, hemezwa ko ari iya Mugwaneza Carine Sandrine kandi ko ari we wayisinye, kandi ko mbere y'uko ayo madolari abikuzwa, banki yahamagaye Mugwaneza Carine Sandrine, uyu atanga uruhushya rw'uko uwahawe *ordre de paiement* yishyurwa.

[11] Ababuranyi bagiye impaka ku bibazo byo kumenya niba Urukiko rwategeka BK Plc gusubiza 11.500 USD na 310.000 Frw yabikujwe kuri konti za Mugwaneza Carine Sandrine, kumuha inyungu ziyakomokaho zibariwe ku gipimo cya 18% ku mwaka banki z’ubucuruzi zisanzwe zitangiraho inguzanyo no kumenya niba hari indishyi zatangwa muri uru rubanza.

## **II. IBIBAZO BIGIZE URUBANZA N’ISESENGURWA RYABYO.**

### **II.1. Kumenya niba BK Plc igomba gusubiza Mugwaneza Carine Sandrine 11.500 USD yabikujwe kuri konti ye n° 00040-0294342-77.**

[12] Mugwaneza Carine Sandrine na Me Bizumuremyi Isaac umwunganira, bavuga ko Sinayobye Siméon yifashishije *carte d’ordre de paiement* ifite n° AA21910409 abikuzwa 11.500 USD kuri konti n° 00040-0294342-77 atabihereye uburenganzira na nyirayo. Bavuga ko BK Plc, nk’umunyamwuga, itubahirije inshingano zayo zo kurinda umutekano wa konti y’umukiriya, kuko iyo igenzura neza yari kubona ko *ordre de paiement* yifashishijwe yasinywe na Twajeneza Olivier aho gusinywa na Mugwaneza Carine Sandrine. Bavuga ko ayo madolari atari kubikuzwa bitagizwemo uruhare n’umukozi wa banki ukorera ku Gisimenti, ari nabyo bigaragaza ko mu guca urubanza, Urukiko Rukuru rw’Ubucuruzi rwirengagije inyandiko-mvugo zashingiweho mu rubanza n° RP 0762/15/TGI/NYGE n’amategeko yariho icyo gihe, cyane cyane ingingo ya 482<sup>1</sup> n’iya 493<sup>2</sup> z’Igitabo cya gatatu cy’urwunge rw’amategeko mbonezamubano, bituma rutemeza ko banki yagize uburangare bukabije.

[13] Bavuga ko umunsi *ordre de paiement* yatanze muri BK Plc, Mugwaneza Carine Sandrine yari mu mahanga, ko ibyo binashimangirwa n’ibyo banki yivugira ko yagerageje guhamagara nimeru ye ya telefoni ya 0788308017 yatanze muri BK Plc isanga koko itariho. Basobanura ko nyuma y’uko banki isanze telefoni ye itariho byayiteye amakenga, ariko nyuma y’iminsi ibiri, bigizwemo uruhare n’umukozi wa banki, ngo ihamagara indi nimeru ya 0785978930 bahawe na Sinayobye Siméon, ndetse batazi nyirayo kuko basanze ibaruye k’uwitwa Akayezu Delphine, uyu ngo atanga uruhushya rw’uko amadolari yishyurwa. Basanga banki itagaragaza icyayimaze amakenga nyuma yuko isanze telefoni 0788308017 itariho kuko itabasha no kwerekana ko telefoni 0785978930 yayihamagaye koko kandi ko ibaruye kuri Mugwaneza Carine Sandrine. Naho ku bijyanye na telefoni ya 0788867979, bavuga ko yigeze kuba iya Mugwaneza Carine Sandrine ariko amaze kubona 0788308017 arekeraho kuyikoresha.

[14] Bavuga ko umukozi wa banki ukorera ku Gisimenti ari we wabwiye Sinayobye Siméon ko hari amadolari ari kuri konti ya Mugwaneza Carine Sandrine, ari nacyo cyatumye aba ariho aya kuyafatira aho kujya kuyabikuriza kuri BK Plc Ishami rya Nyamirambo aho yafungurije konti. Basobanura ko ibyo BK Plc ivuga ko yamaze iminsi icyenda ishakisha Mugwaneza Carine

Basaba uru Rukiko kubona ko BK Plc itabashije gucunga ibyo yabikijwe, bityo ikaba ifite inshingano zo gusubiza Mugwaneza Carine Sandrine ibyo yibwe.

[15] Me Rutagengwa Jean-Damascène uburanira BK Plc avuga ko nyuma yo gufunguza konti no guhabwa agatabo (*carnet d’ordres de paiement*), Mugwaneza Carine Sandrine yahise agira inshingano zo kukarinda neza nk’uko arinda amafaranga abitse iwe. Asobanura ko ikibazo kimaze kumenyekana, banki yakoze ubugenzuzi isanga *ordre de paiement* yakoreshejwe habikuzwa 11.500 USD yaracishijwe mu mashini yabugenewe, hemezwa ko ari iya Mugwaneza Carine Sandrine kandi ko ari we wayisinye. Avuga ko mbere y’uko ayo madolari abikuzwa, banki yategereje iminsi icyenda, hanyuma iza guhamagara Mugwaneza Carine Sandrine kuri nimeron<sup>o</sup> 0785978930, uyu atanga uruhushya rw’uko uwahawe *ordre de paiement* yishyurwa.

[16] Avuga ko ayo madolari yageze kuri konti ya Sinayobye Siméon ku wa 26/08/2016, ayabikuza ku wa 27/08/2016, uwo muni, nyuma y’amasaha abiri amadolari abikujwe, Mugwaneza Carine Sandrine atanga ikibazo muri BK Plc avuga ko hari amadolari yavanwe kuri konti ye, kuba yarahise abimenya kandi adafite uburyo bwa *SMS banking* bikaba bigaragaza ko yari aziranye na Sinayobye Siméon. Yongeraho ko ibi bishimangirwa kandi n’invugo za Niyoyita Cyprien wemeza ko yahamagaye Mugwaneza Carine Sandrine kuri n<sup>o</sup> 0788308017, amumenyesha ko agiye kwibwa kuri konti ye, ariko Mugwaneza Carine Sandrine aho kubimenyesha banki cyangwa Polisi akuraho telefoni yari yarabaruje muri banki. Yongeraho ko amadolari yabikujwe Mugwaneza Carine Sandrine ari mu Rwanda kuko Sinayobye Siméon yavuze ko *ordre de paiement* yayihawe na nyirayo.

[17] Me Rutagengwa Jean Damascène akomeza avuga ko nta nshingano banki ifite zo guhamagara nyiri konti mbere y’uko yishyura ibyo yategetse, ko kuba yarahamagaye kuri 0785978930 ari uko yari yagize amakenga gusa, kandi ko iyi nimeron<sup>o</sup> yahoze ari iya Mugwaneza Carine Sandrine hanyuma iza gukorerwa *sims wap*. Asobanura ko kuba amadolari yarabikujwe ku Ishami rya Gisimenti aho kubikurizwa i Nyamirambo, ubwabyo atari ikibazo kuko umukiliya yemerewe kubikuriza ku ishami rimwegereye kandi ko umukozi wa banki witirirwa kuba yarafashije Sinayobye Siméon kwiba ayo madolari atagaragajwe ngo abiryoze.

[18] Asoza avuga ko mu rubanza rw’inshinjabyaha Mugwaneza Carine Sandrine aburanisha, Urukiko rwagaragaje ko umujura ari Sinayobye Siméon, ko ntaho rwagaragaje uruhare urwo arirwo rwose rwa banki mu ibura ry’amadolari aburanwa, ariyo mpamvu asaba uru Rukiko kwemeza ko banki itaryozwa uburangare bwa Mugwaneza Carine Sandrine wateshutse ku nshingano ze zo kurinda neza *carnet d’ordres de paiement* yahawe.

[19] Ingingo ya 2 y’Amabwiriza Rusange N<sup>o</sup>07/2010 yo ku wa 27/12/2010 ya Banki Nkuru y’u Rwanda yerekeye iyoherezanya Koranabuhanga ry’amafaranga n’ihererekanya koranabuhanga ry’amafaranga yakoreshwaga muri 2015 ubwo amadolari n’amafaranga aburanwa



yawanwaga kuri konti ya Mugwaneza Carine Sandrine,<sup>3</sup> ivuga ko inyandiko isaba kwishyura (*ordre de paiement*) ari amabwiriza yo kwishyura akozwe n'uyohereje ku kigo kiyakira, byohereje mu mvugo, mu buryo bw'ikoranabuhanga cyangwa mu nyandiko, hagamijwe kwishyura cyangwa gutuma indi banki cyangwa ikigo gitanga serivisi zo kwishyurana ku bishyura uberewemo umwenda, amafaranga azwi cyangwa yagenwa.

[20] Iyi ngingo ivuga kandi ko uburyo bwo kwirinda (*procédure de sécurité*) ari ubushyirwaho mu bwumvikane hagati y'umukiriya n'ikigo cyakira hagamijwe :

- (a) *Kugenzura ko uburyo busaba kwishyura cyangwa ubutumwa buhindura cyangwa bukuraho inyandiko isaba kwishyura ari iby'umukiriya cyangwa ;*
- (b) *Gushakisha amakosa aba mu kohereza cyangwa mu bigize inyandiko isaba kwishyura cyangwa ubutumwa.*

*Uburyo bwo kwirinda bushobora gusaba ikorehwa ry'imibare cyangwa indi mibare y'ibanga, hagaragazwa amagambo cyangwa imibare, irindanyandiko, uburyo bwo kwibutsa cyangwa ibikoresho by'ubwirinzi bisa n'ibi..."*

[21] Amabwiriza Rusange ya Bank of Kigali Ltd agenga inyandiko isaba kwishyura (*ordre de paiement*) yo mu mwaka wa 2005 ateganya ko umukiriya agomba kwita ku gatabo k'inyandiko isaba kwishyura yahawe kandi ko banki itaryozwa ingaruka zo kuba hari urupapuro rwatakayemo cyangwa rwawanwemo, ko biramutse bibaye, nyiri agatabo asabwa kwihutira kubimenyesha banki kugira ngo hirindwe ikorehwa ritemewe ry'urwo rupapuro rwibwe cyangwa rwatakaye (*He (the customer) is also required to take great care of payment order booklet. The bank declines any liability for any damage arising from loss or removal of a form. Should this happen, the holder must urgently inform the bank in order to avoid any malpractice through the abusive use of a stolen or lost form.*)

Iyo O.P. yakiriwe na banki ku wa 17/08/2015 nk'uko bigaragazwa na *bordereau* yo ku wa 17/08/2015, umukozi wayakiriye yabanje gusaba umuyobozi we uruhushya rwo kwishyura ayo madolari (*dérogation demandée*), umuyobozi asanga nimeru ya telefoni ya Mugwaneza Carine Sandrine ari 0788308017, ategeka umukozi wa banki kutishyura ayo madolari mu gihe cyose nyiri konti atabanje kubyemeza (0788308017, *do not force if the owner is not confirming*). Kuri iyo *bordereau* hariho kandi ubundi butumwa bugira buti "*We spoke to her on 0785978930. She confirmed the ID and OP*". Muri dosiye harimo kandi indi *bordereau* yo ku wa 26 Aout 2015 igaragaza ko Sinayobye Siméon yishyuye 11.500 USD.

[23] Dosiye y'urubanza irimo na none ibaruwa Banki of Kigali Ltd yandikiye Mugwaneza Carine Sandrine ku wa 08/09/2015, ibanza kugaragaza ko nimeru ye ya telefoni ari 0788308017, kandi ko amadolari yishyuye Sinayobye Siméon mu buryo bukurikije amategeko kuko banki yasanze *ordre de paiement* yakoreshejwe ari iyahawe Mugwaneza Carine Sandrine, umukono

Banki na none ibanza kwibutsa kuri *en-tête* y’urwandiko ko nimero ya telefoni ya Mugwaneza Carine Sandrine ari 0788308017, igakomeza ivuga ko ikimenyetso yasabye cy’uko yahamagawe kuri telefoni 0785978930 mbere y’uko amadolari yishyurwa kitasabwa banki ahubwo cyatangwa gusa n’ikigo cya MTN (*the proof you requested the bank to provide indicating that you were called on Mobile N° 0785978930 : before paying the amount above can only be given by the telecommunication company MTN not the bank*).

[25] Urukiko rurasanga ikibazo kigibwaho impaka muri uru rubanza ari ukumenya niba banki yarateshutswe ku nshingano zayo z’ubushishozi bigatuma itarindira umutekano konti n’amafaranga by’umukiliya nk’uko ibisabwa nk’umunyamwuga ku buryo igomba gusubiza Mugwaneza Carine Sandrine 11.500 USD yabikujwe kuri konti ye n° 00040-0294342-77.

[26] Ikibazo cy’umutekano w’amakonti n’amafaranga y’abakiliya cyagarutsweho n’uru Rukiko mu manza zitandukanye. Mu rubanza *I & M Bank Rwanda Plc yaburanaga na Coffee Business Center (CBC) Ltd*, uru Rukiko rwibukije ko mbere yo kwishyura, banki igomba kubanza gusuzuma niba inyandiko ishyikirijwe ngo zishyurwe zujuje ibyangombwa. Mu byo isuzuma harimo imiterere y’iyo nyandiko, umukono uyiriho, uburyo yahererekanyijwe no kumenya niba itaratambamiwe. Muri urwo rubanza Urukiko rwasanze ibyo banki yavugaga ko yasuzumye inyandiko yashyikirijwe mbere yo kwishyura ataribyo kuko iyo iba yarabikoze yari kubona ko umukono uzirihho atari uwa nyiri konti.<sup>4</sup>

[27] Naho mu rubanza Sebahizi Jules yaburanaga na Equity Bank Rwanda Ltd, Urukiko rwasanze iyo banki yarabikuje 30.000 USD kuri konti y’umukiliya, iyohereza muri Singapore ishingiye kuri *e-mail indemnity* na *Diaspora Application for Funds Transfers* yuzurishijwe imashini ndetse banki itabanje kumuhamagara ngo abyemeze nyamara amasezerano ateganya ko *Diaspora Application for Funds Transfers* izajya yuzurishwa intoki kandi ko nta madolari azavanwa kuri konti ye banki itabanje kumuhamagara kuri telefoni yayihaye ngo abyemeze. Urukiko rwasanze kuba Equity Bank Rwanda Ltd yemera ko itabanje guhamagara Sebahizi Jules mbere yo kohereza ayo madolari binyuranyije n’amabwiriza yayo ndetse “*n’imikorere y’ama banki (pratique) yo mu Rwanda ayategeka kubanza guhamagara abakiliya bayo batanze amasheki mbere yo kwishyura.*”<sup>5</sup>

[28] Ibijyanye n’inshingano za banki zo kurinda konti z’abakiliya bazo byagarutsweho na none mu rubanza II ZR 185/85 rwaciwe n’Urukiko rw’Ikirenga rw’Ubudage (*Bundesgerichtshof*) ubwo rwasuzumaga ikirego cy’umuturage wibwe agapapuro ka sheki, hanyuma umujura akiganana

ubuhanga umukono wa nyiri sheki akajya kuyibikuzwa kuri banki. Umukozi wa banki amaze kubona ko amafaranga asabwa kubikuzwa ari menshi ugereranyije n'ayo nyiri konti asanzwe abikuzwa kandi uyu akaba atarahamagaye banki kuri telefoni ngo yemeze ko iyo sheki yishyurwa nk'uko yari asanzwe abigenza, yasabye umuyobozi w'Ishami rya banki kwemeza ko iyo sheki yishyurwa, nawe arabyemera.<sup>6</sup>

[29] Mu gusuzuma niba kuba banki yaremeye ko iyo sheki yishyurwa bigomba gufatwa nk'uburangare, Urukiko rwasanze :

- i. Banki iba yishe inshingano zayo z'ubushishozi ziri mu masezerano yakoranye n'umukiliya wayo iyo yeretswe sheki isaba kwishyura amafaranga arenze cyane ingano y'ay'umukiliya asanzwe yishyura akoresheje sheki, ikabikora itabanje kubaza niba koko iyo sheki ari umwimerere ;
- ii. Banki iba yishe inshingano zayo z'ubushishozi iyo yishyuye sheki itabanje kubaza umukiliya wayo kandi kuri sheki zabanje umukiliya yarabanzaga guhamagara banki kugira ngo ayihe uburenganzira bwo kubikuzwa amafaranga kuri konti ye ;
- iii. Nubwo atari ingano y'amafaranga yanditse kuri sheki igomba gutuma buri gihe iyo sheki ikemangwa, iyo sheki yanditseho amafaranga menshi ugereranyije n'ayo umukiliya asanzwe yishyura ni ikintu cy'ingenzi kigomba guherwaho hasuzumwa niba harabayeho uburangare bwa banki, kandi icyo gihe gukeka ko banki itakoze inshingano zayo yishyura iyo sheki birusha uburemere iby'uko sheki yari yanditsweho amafaranga menshi.<sup>7</sup>

[30] Muri urwo rubanza, Urukiko rw'Ikirenga rw'Ubudage rwasanze mu gihe banki ibonye ko sheki yanditsweho amafaranga arenze ayo umukiliya asanzwe abikuzwa cyangwa yishyura, igomba guhita itekereza ko bishoboka ko iyo sheki irimo gukoreshwa mu buryo bunyuranyije n'amategeko, icyo gihe igahita isaba ko hatangwa umucyo kuri iyo sheki. Urukiko rwasanze bidakozwe bityo bishobora gushyira abakiliya benshi mu kaga, bityo ko Urukiko rw'Ubujurire rwari rufite ukuri mu kwemeza ko banki yari ifite inshingano zo gutelefona nyiri konti mbere yo kwishyura sheki kugira ngo imenye neza niba koko ari we wayitanze.<sup>8</sup>

Nubwo iri tegeko ridakwiye gushingirwaho mu gufata icyemezo muri uru rubanza kuko ritari ririho ubwo konti ya Mugwaneza Carine Sandrine yavogerwaga, ritanga icyereko cy'uko *utanga serivisi y'imari agomba ... gukorana ubwitonzi, ubuhanga n'ubushishozi mu bijyanye n'igicuruzwa cy'imari cyangwa serivisi y'imari atanga.*

- i. Umukiliya wa banki afite inshingano zo kwita ku gatabo k'inyandiko isaba kwishyura cyangwa ubundi buryo ahabwa na banki bwatuma yishyura, ariko ibyo ntibivanaho inshingano y'ubushishozi kuri banki mbere y'uko yemeza ko ubwishyu bukorwa ;
- ii. Banki ifite inshingano zo kugenzura ko uburyo busaba kwishyura bwatanzwe n'umukiliya wayo koko ndetse no gusuzuma ko nta makosa yabaye mu gutanga ubutumwa busaba banki kwishyura ;

[35] Ku bijyanye n'uru rubanza, Urukiko rurasanga banki yarabanje kugira amakenga kuri *ordre de paiement* yagaragarijwe na Sinayobye Siméon ku wa 17/08/2015 bituma ndetse umukozi wayakiriye ajya gusaba uruhushya rwo kuyishyura, ntiyuruhabwa kuko nimeru ya telefoni Mugwaneza Carine Sandrine yari yarahaye banki itari iriho. Kuba banki yarabanje guhamagara nyiri konti kuri nimeru ye yari yarahaye banki bigaragaza ko nayo yemera inshingano yayo yo gushaka amakuru (*vigilance-information*) mu gihe ibonye hari igikorwa kitamenyerewe kigiye gukorerwa kuri konti y'umukiliya. Kuba kandi umuyobozi wa banki yarategetse ko kwishyura bihagarara kugeza igihe nyiri konti yemereje ko ari we watanze ubutumwa, ni ikindi kimenyetso gihamya ko banki yemera inshingano zayo zo gushishoza mbere yo kwishyura. Iyi myitwarire ya banki inyomoza kandi ibyo iburanisha by'uko itari itegetswe guhamagara Mugwaneza Carine Sandrine mbere yo kwishyura, kuko iyo iba itabitegetswe itari kumuhamagara cyangwa se ngo nyuma yo kumumahagara ntimubone isabe ko kwishyura bitegereza akabanza kuboneka.

[36] Urukiko rurasanga mu iburanisha imbere y'uru Rukiko, BK Plc yaremeje ko nimeru ya telefoni Mugwaneza Carine Sandrine yayihaye ari 0788308017, kandi koko niyo yabanje guhamagarwaho na banki, imubuze itegeka ko *ordre de paiement* itegereza uwayitanze akabanza kuyemeza. Byongeye kandi inyandiko zose BK Plc yandikiye Mugwaneza Carine Sandrine, yashyizeho ko abarizwa kuri telefoni 0788308017. Banki ntisobanura aho yakuye nimeru 0788867979 yanditse kuri *ordre de paiement*, ndetse no mu mikorere ya kinyamwuga ntibyari bikwiye ko banki ihabwa nimeru 0785978939 na Sinayobye Siméon wari uje kubikuzwa *ordre de paiement*, noneho ngo iyo nimeru banki ifate ko ari iya Mugwaneza Carine Sandrine nta handi ibishingiye nyamara uyu hari indi nimeru yayihaye ngo ijye imushakiraho mu gihe imukeneye.

[37] Urukiko rurasanga BK Plc itabasha kugaragaza ko telefoni 0785978939 ivuga ko yahamagaye bwa nyuma mbere yo gufata umwanzuro wo kwishyura ibaruye kuri Mugwaneza Carine Sandrine, nta nubwo igaragaza ko uyu yaba yarayitanze nk'iyo bamushakiraho mu gihe yaba abuze kuri 0788308017 (*alternative telephone*). Kuba rero harahamagawe umuntu utazwi akemeza ko ayo madolari abikuzwa, bikwiye gufatwa nko kuba banki yaremeye ko ayo madolari abikuzwa nyirayo atabyemeje, nyamara banki yari imaze kwivugira ko atazabikuzwa uwatanze *ordre de paiement* ataraboneka kuri telefoni yahaye banki ngo abyemeze.

[38] Urukiko rurasanga *bank statement* ya Mugwaneza Carine Sandrine kuri konti y'amadolari n° 00040-0294342-77 igaragaza ko kugeza ku wa 17/08/2015 ubwo *ordre de paiement* iburanwa yagezwaga muri BK Plc, amadolari menshi yari yarabikuje ari 1.629 USD yavanywe kuri konti ku wa 28/01/2015, avanyweho na Mugwaneza Carine Sandrine. Kuba rero kuri konti hari hariyeye kuvanwaho 11.500 USD hashingiwe kuri *ordre de paiement* yahawe umuntu ku giti cye cyari igikorwa kitamenyerewe kuri iyo konti cyategeka banki gushishoza kurushaho mbere yo kwishyura.

[39] Urukiko rurasanga nk'uko Urukiko Rukuru rw'Ubucuruzi rwabisanze mu gika cya 26 cy'urubanza rusubirishwamo, Mugwaneza Carine Sandrine yari afite koko inshingano zo kurinda neza *carnet d'ordres de paiement* ndetse no kumenyeshya banki cyangwa izindi nzego ko *ordre de payment* yibwe. Ibyo ariko sibyo byatuma banki ikurwaho inshingano isanganywe nk'umunyamwuga zo gushishoza buri gihe mbere yo kwishyura, cyane cyane ko nayo ubwayo

yivugira ko yabanje kugira amakenga mbere yo kwishyura. Nk’uko byibukijwe haruguru, banki ntigaragaza icyaje kuyimara ayo makenga.

[40] Urukiko rurasanga inshingano y’umukiliya yo kurinda *carnet d’ordre de paiement* ndetse n’iyo kwihutira kumenyesha banki n’izindi nze ko yibwe zitaburizamo burundu ibyago byo kwibwa kuko hari igihe yamenya ko yibwe ari uko abonye amakuru ko amafaranga ye yabikujwe. Kumenya amakuru ya konti bishobora gutinzwa n’impamvu zitandukanye harimo no kuba umukiliya adakoresha ikoranabuhanga, agatinda kubona amakuru cyangwa akayabona ari uko agiye aho banki ikorera. N’abakoresha ikoranabuhanga bashobora kugira imbogamizi cyangwa rikabatenguha ntibabone amakuru cyangwa bagatinda kuyabona.

[41] Urukiko rurasanga gushaka kukumira ikoresha rya konti y’umukiliya mu buryo budakwiye ari byo mu ntangiriro biha umukiliya inshingano zo gucunga neza inyandiko cyangwa andi makuru yahawe na banki ariko bigaha na banki inshingano z’ubushishozi nk’urwego ruri aho amafaranga y’umukiliya asohokera. Ibi bituma ibitabashije kukumirirwa hamwe bikumirirwa ahandi. Byumvikanisha ko banki iramutse ivaniweho inshingano y’ubushishozi bishobora gushyira konti z’abakiliya benshi mu kaga. Inkiko zasanze iyi nshingano y’ubushishozi ariyo ituma mu mikorere ya za banki zigomba guteganyiriza abakiliya bazo icyitwa *affidavit form of forgery* kugira ngo mu gihe amafaranga y’umukiliya yaba yibwe hakoreshejwe inyandiko mpimbano, banki izabashe kuyakurikirana no kuyagaruza.<sup>10</sup>

[42] Ku bijyanye n’ingaruka zo kutubahiriza inshingano y’ubushishozi ku ruhande rwa banki, mu rubanza I & M Bank Rwanda Ltd yaburanaga na Coffee Business Center (CBC) Ltd, uru Rukiko rwasanze “banki isubiza amafaranga nyirayo, iyo yayahaye umuntu yibeshye, cyane cyane umutekamutwe, kubera ko ubwishyu buba iyo amafaranga yafashwe n’ubifitiye uburenganzira. Keretse banki ishoboye kubona ibimenyetso ku makosa y’umukiliya ... cyangwa se ko yabitewe n’impamvu zidasanzwe.”<sup>11</sup> Naho mu rubanza Sebahizi Jules yaburanaga na Equity Bank Rwanda Ltd rwavuzwe haruguru, uru Rukiko rwasanze “kuba nta ruhare Sebahizi Jules yagize mu ibikuzwa rya 30.000 USD kuri konti ye ...n’iyoherezwa ryayo mu gihugu cya Singapore, bigaragaza ko Equity Bank Rwanda Ltd yabikoze kubera uburangare bwayo, (ikaba) ikwiye kuyamusubiza uko yakabaye...”<sup>12</sup>

[43] Uruhare rwa banki rumaze igihe rugarukwaho n’inkiko z’ibindi bihugu, nkaho mu rubanza *Central Nat. Bank of Richmond yaburanaga na First & Merchants Nat. Bank*, Urukiko rw’Ikirenga rwa Leta ya Virginia muri Leta Zunze Ubumwe za Amerika rwavuze ko ihame rusange ari uko amafaranga y’umuntu Banki ibitse atagomba gukorwaho nyirayo atabitangiye uruhushya, ko banki iramutse iyahaye umuntu utabifitiye uburenganzira, ibyo bitareba nyiri amafaranga ndetse ko bifatwa nk’aho ayo mafaranga atigeze ava kuri konti ye, icyo gihe banki ikaba ariyo ibyirengera.<sup>13</sup>

Uyu murongo ni nawo wemejwe mu rubanza *Cairo Banking Co. yaburanaga na West et al.*, aho Urukiko rw’Ikirenga rwa Georgia rwasanze iyo umukiliya abikije amafaranga muri banki, bifatwa ko banki iba imugiyemo umwenda, kugira ngo rero banki yigobotore izo nshingano igomba kwishyura uwayibikije amafaranga kandi ko inshingano za banki zitavanwaho n’uko yemeye kwishyura sheki y’impimbano.<sup>14</sup>

- ii. Banki yishyuye sheki y’impimbano igomba gufatwa nk’iyishyuye ku mafaranga yayo, ikazikurikiranira uwo yishyuye.<sup>17</sup>

## **II.2. Kumenya niba Mugwaneza Carine Sandrine yahabwa inyungu zikomoka ku 11.500 USD zibariwe kuri 18% ku mwaka.**

[48] Mugwaneza Carine Sandrine na Me Bizumuremyi Isaac umwunganira bavuga ko ku bijyanye na 11.500 USD, mu rubanza RCOM 00860/2016/TC/NYGE, Mugwaneza Carine Sandrine yagenewe inyungu za 15% nyamara amabanki y'ubucuruzi asanzwe abarira inyungu kuri 18%, akaba asaba uru Rukiko gukosora ayo makosa, agabahwa inyungu zibariye ku rugero banki zisanzwe zitangiraho inyungu kuva ku wa 12/08/2015. Avuga ko mu gihe cy'imyaka irindwi n'amezi ane n'igice ishize, inyungu agomba kwishyurwa zingana na 15.266,25 USD ariko ko asaba uru Rukiko kuzazibara kugeza urubanza ruciwe.

[49] Me Rutagengwa Jean-Damascène, uburanira BK Plc avuga ko Mugwaneza Carine Sandrine atahabwa izo nyungu kuko ari we wateshutse ku nshingano ze zo kurinda agatabo ke, ko iyo aza kuba yarabitse neza agatabo ke n'umukono we, ayo madolari atari kubikuzwa, bityo akaba adakwiye kungukira mu makosa ye.

## **UKO URUKIKO RUBIBONA**

[50] Ingingo ya 137 y'Itegeko n° 45/2011 ryo ku wa 25/11/2011 rigenga amasezerano iteganya ko “uruhande rwarenganyijwe rufite uburenganzira bwo kubona indishyi zitanzwe n'urundi ruhande rutubahirije ibisabwa mu masezerano, keretse iyo ikirego kigamije kubona indishyi cyahagaritswe cyangwa cyaravuyeho.”

[51] Ingingo ya 94, igika cya kabiri n'icya kane, y'Amabwiriza Rusange n° 55/2022 yo ku wa 27/10/2022 yerekeye kurengera umuguzi wa serivisi z'imari ivuga ku Indishyi ihabwa umuguzi wa serivisi y'imari, igira iti: “*Iyo uburangere bw'utanga serivisi y'imari buteje umuguzi wa serivisi y'imari igihombo cy'amafaranga, umuguzi wa serivisi y'imari aba afite uburenganzira bwo gusaba indishyi y'igihombo. Kubara indishyi bishingira kuri ibi bikurikira :*

*1° umubare w'amafaranga y'igihombo cyatewe n'uburangare ;*

*2° ikiguzi cy'amahirwe yabuze kubera uburangare ;*

*3° indishyi zishyurwe n'umuguzi wa serivisi y'imari niba zihari.*

*Ibyo ari byo byose, igipimo cy'indishyi ntigishobora kujya munsu y'ikigereranyo cy'inyungu k'unguzanyo (taux moyen de prêt/ average lending rate) nk'uko cyatangajwe n'urwego rw'ubugenzuzi.”*



[52] Mu rubanza *Sebahizi Jules yaburanaga na Equity Bank Rwanda Ltd*,<sup>19</sup> uru Rukiko rwasanze kuba banki yaravanye amafaranga kuri konti ya Sebahizi Jules nta burenganzira abitangiye byaramuteye igihombo kuko atashoboye kuyakoresha mu buryo ubwo aribwo bwose, haba kuyatungisha umuryango cyangwa kuyarekera muri banki ngo abyare inyungu, uku kandi ni nako bimeze muri uru rubanza kuko banki yishyuye Sinayobye Siméon 11.500 USD kandi Mugwaneza Carine Sandrine, nyiri konti yavanweho ayo madolari, atabitangiye uburenganzira, igihe cyose Mugwaneza Carine Sandrine amaze adafite ayo madolari bikaba byaramuvukije inyungu yari kuyavanamo iyo aba yarayakoresheje cyangwa yarayabikije agamije kuyungukiramo.

[53] Muri urwo rubanza rwa *Sebahizi Jules*,<sup>20</sup> uru Rukiko rwagennye indishyi rushingiye ku gipimo cy'inyungu z'amafaranga abakiliya babitsa mu mabanki kugira ngo abungukire (*taux moyen créditeur*). Uyu murongo ni nawo uherutse kwemezwa mu rubanza *Nsengiyumva Théoneste yaburanaga na Ntagungira Jérôme na bagenzi be*, aho uru Rukiko rwasanze Nsengiyumva Théoneste agomba gusubizwa amafaranga yari yaraguze isambu yatsindiwe hiyongereyeho inyungu zibariwe ku gipimo cy'inyungu kingana na 8% amabanki aheraho abakiriya bayo babikije amafaranga kugira ngo abungukire.<sup>21</sup>

[54] Urukiko rurasanga icyakora uburyo bwo kubara inyungu bwavuzwe haruguru aribwo Banki Nkuru y'u Rwanda yasubiyeho mu mabwiriza yavuzwe haruguru ateganya ko igipimo cy'indishyi zihabwa umuguzi wa serivisi z'imari kidashobora kujya muni y'ikigereranyo cy'inyungu ku nguzanyo (*taux moyen de prêt/ average lending rate*) nk'uko cyatangajwe n'urwego rw'ubugenzuzi." Inyandiko yitwa *Interest Rate Structure* yatangajwe na Banki Nkuru y'u Rwanda ku rubuga rwayo [www.bnr.rw/browse-in/financial-market/money-marketinterest-rates/monthly-interest-rates](http://www.bnr.rw/browse-in/financial-market/money-marketinterest-rates/monthly-interest-rates) ndetse inagarukwaho n'urubuga rwa [www.tradingeconomics.com/rwanda/interest-rate](http://www.tradingeconomics.com/rwanda/interest-rate) igaragaza ko icyo gipimo mu Rwanda kigeze kuri 15.81%,<sup>22</sup> bityo akaba ari cyo kigomba kubarirwaho inyungu Mugwaneza Carine Sandrine agomba guhabwa na BK Plc.

[55] Urukiko rurasanga rero BK Plc igomba guha Mugwaneza Carine Sandrine inyungu zingana na 11.500 USD x 15.81 % guhera ku wa 27/08/2015, ni ukuvuga umunsi ukurikira uwo amadolari yavanwe kuri konti, kugeza ku wa 31/03/2023, ni ukuvuga igihe kingana n'imyaka irindwi, amezi arindwi n'iminsi ine, bihwaye n'iminsi 2.734, bityo akangana na:

[56] Urukiko rurasanga nubwo inyungu BK Plc yakagombye kwishyura Mugwaneza Carine Sandrine zingana na **13.807,8 USD**, izi nyungu zirenze kure 11.500 USD BK Plc yahaye Sinayobye Siméon kubera uburangare. Mu rubanza *Banque Populaire du Rwanda Plc yaburanaga n'Akarere ka Nyamasheke*,<sup>23</sup> uru Rukiko rwasanze inyungu zo gutinda kwishyura umwenda zitagomba kuba umurengera. Rwasobanuye ko igipimo cyo kugena inyungu z'ubukererwe ari ukwirinda ko zihinduka inzira yo kwikungahaza nta mpamvu k'uzihawe, ariyo mpamvu ari inshingano y'Urukiko kugarura ku gipimo gikwiye inyungu z'umurengera.

[57] Muri urwo rubanza, uru Rukiko rwasanze igipimo gikwiye cy'inyungu z'ubukererwe kigenwa n'Urukiko mu bushishozi bwarwo. Inyungu ariko ntizigomba kurenga izikenewe mu gukosora ibyangijwe ariko kandi zigomba kuba zihagije ku buryo zitanga isomo kugira ngo ibyatumye zitangwa bitazasubira, rwemeza ko inyungu z'ubukererwe zitagomba kurenga ingano y'umwenda wishyuzwa.

[58] Urukiko rurasanga iki cyerekezo cy'uko inyungu ku mwenda remezo zihagarara kubarwa iyo zimaze kungana n'umwenda remezo wari usigaye kwishyurwa aricyo kigaragara mu yandi mategeko yihariye nk'aho ingingo ya 72, agace ka 4, y'Itegeko n° 031/2022 ryo ku wa 21/11/2022 rigenga Amasoko ya Leta,<sup>24</sup> iya 112, agace ka 2, y'Itegeko n° 47/2017 ryo ku wa 23/09/2017 rigena imitunganyirize y'imirimo y'amabanki<sup>25</sup> n'ya 59 y'Itegeko n° 25/2005 ryo ku wa 04/12/2005 rigena imitunganyirize y'isoresha nk'uko ryahinduwe kandi ryujujwe kugeza ubu,<sup>26</sup> buri tegeko kubyo rireba, inyungu zikaba zidashobora kurenga ingano y'ingwate yatanzwe ku bijyanye n'amasoko ya Leta cyangwa kurenga ingano y'umwenda wishyuzwa ku bijyanye n'imyenda yatanzwe na banki cyangwa kurenga ingano y'umusoro wishyuzwa ku bireba imisoro yatinze kwishyurwa.

[61] Me Rutagengwa Jean-Damascène, uburanira BK Plc, avuga ko mu masezerano Mugwaneza Carine Sandrine yakoranye na banki buri ruhande rwari rufite inshingano rugomba kwubahiriza, ko banki yubahirije izayo zo kugenzura ubuziranenge bw'inyandiko za *ordre de paiement* zakoreshejwe ndetse n'umukono wa Mugwaneza Carine Sandrine, bityo akaba asanga banki idakwiye kuryozwa ayo mafaranga kuko Mugwaneza Carine Sandrine ari we wateshutswe ku nshingano ze zo kwita ku gatabo yahawe na banki, ariyo mpamvu agomba kwirengera ibyabaye kuri konti ye.
