Amategeko agenga ubugwate ku mutungo utimukanwa – Ingwate – Abatanze umutungo watanzweho ingwate nta burenganzira bari bafite bwo kwivanaho umutungo wari ubanditseho ubwo amasezerano y'ingwate yakorwaga batabiherewe uburenganzira mu nyandiko ndetse bakabyemererwa– Itegeko N° 10/2009 ryo ku wa 14/05/2009 ryerekeye ubugwate ku mutungo utimukanwa, ingingo ya 4.

Incamake y ikibazo: Sosiyete Advance Material Trading Pte Ltd hamwe na sosiyete Gisande Trading Ltd yari ihagarariwe n'umuyobozi wayo Niyigaba Ignace n'umugore we akaba n'umwishingizi wayo Akingeneye Dally ivuga ko mu bihe bitandukanye bagiye bakorana ibikorwa by'ubucuruzi bw'amabuye y'agaciro, Advance Material Trading Pte Ltd ikajya iha Gisande Trading Ltd amafaranga ikagura ndetse ikanayohereza amabuye y'agaciro mu gihugu cya Singapore, ariko nyuma biza kugaragara ko Gisande itagiye yubahiriza amasezerano, umuyobozi hamwe n'umwishingizi wayo batanga ingwate zigizwe n'imitungo itimukanwa zizavamo ubwishyu kuko bari bamaze kugeramo sosiyete Advance umwenda munini cyane.

Mu gihe sosiyete Advance yari irimo gushaka uburyo yakwandikisha ingwate yahawe, yaje gutungurwa n'uko zimwe muri zo zatambamiwe na Rwanda Revenue Authority kubera imisoro, bituma Advance irega Gisande n'umwishingizi wayo mu rukiko rw'ubucuruzi, isaba Urukiko gutegeka abaregwa kuyisubiza ingwate bari bayihaye kugira ngo zivanwemo ubwishyu, kwishyura umwenda wasigara mu gihe ingwate zaba zigurishijwe ntihavemo ubwishyu bw'umwenda wose, no kuyiha indishyi zitandukanye.

Gisande Trading Ltd hamwe n'umuyobozi wayo Niyigaba Ignace na Akingeneye Dally batanze inzitizi yo kutakira icyo kirego, bashingiyeye ku mpamvu y'uko mu masezerano impande zombi zagiranye zemeranyije ko nihavuka amakimbirane cyangwa imanza bizakemurwa n'ubukemurampaka bw'i London mu Bwongereza (*arbitration clause*), mu mizi y'urubanza biregura bavuga ko ikirego kidafite ishingiro, kubera ko Advance Material Trading Pte Ltd itagaragaza ibimenyetso by'ibyo iregera.

Urukiko rw'Ubucuruzi rwaciye urubanza, rusanga inzitizi yatanzwe na Gisande nta shingiro ifite, mu mizi y'urubanza rusanga ikirego cyatanzwe na Advance kidafite ishingiro.

Advance yajuririye mu Rukiko Rukuru rw'Ubucuruzi, rwemeza ko ubujurire bufite ishingiro, ko imikirize y'urubanza rwajuririwe ihindutse, rutegeka ko Gisande, Niyigaba Ignace na Akingeneye Dally bagomba guhita bafatanya kwandikisha ingwate bahaye Advance mu masezerano y'inguzanyo n'ingwate bagiranye.

Gisande, Niyigaba Ignace na Akingeneye Dally bajuririye Urukiko rw'Ubujurire, bavuga ko Urukiko Rukuru rw'Ubucuruzi rwirengagije ibivugwa mu amasezerano y'ubugwate bakoranye

kandi ko urwo Rukiko rwabaciye indishyi kandi nta masezerano bishe, uru Rukiko gukosora ayo makosa, bagahabwa indishyi zo gushorwa mu manza.

Mu rubanza rubanziriza urundi, Urukiko rwasanze hari ibisobanuro ababuranyi bakwiye kuruha, bagasobanura icyakorwa kugira ngo izo ngwate zandikwe mu buryo bukurikije amategeko, no kurushyikiriza ibyangombwa by'imitungo batanzeho ingwate mu masezerano kandi ko Niyigaba Ignace agomba kurwitaba ubwe kugira ngo ibisobanuro rwifuzza bibashe kumvikana kurushaho.

Gisande yisobanuye ivuga ko imitungo Niyigaba Ignace na Akingeneye Dally batanzeho ingwate igaragara muri *exhibit A* igihari, iri mu maboko ya Advance kandi ko yabahaye uburenganzira busesuye bwo kuzandikisha (*power of attorney*) igihe abazitanze badashoboye kuboneka, ivuga kandi ko mu masezerano, Advance Material Trading Pte Ltd yemeye gukomeza kuyifasha iyiha amafaranga, we n'umugore we bemera gutanga ingwate ku mutungo wabo amaze guhabwa amafaranga bumvikanye, ariko ko iyo nguzanyo itatanzwe, bituma ingwate zitandikishwa, imikoranyire irahagarara.

Advance nayo yisobanura ivuga ko Akingeneye Dally na Niyigaba Ignace aribo batayubahirije, kuko bafashe umutungo batanzeho ingwate bawukura ku mazina yabo bawandika ku wundi muntu, bikaba bitari gushoboka kwandikisha ingwate itacyanditse ku bayitanze.

Gisande Trading Ltd n'abishingizi bayo bavuga ko basabye Urukiko Rukuru rw'Ubucuruzi kudasuzuma ubujurire bwatanzwe na Advance bwerekeranye no kwishyura umwenda wasigara mu gihe ingwate zaba zigurishijwe, kubera ko itari yaregeye kwishyurwa umwenda.

Bavuga na none ko nta mwenda wemejwe mu cyemezo cy'Urukiko Rukuru rw'Ubucuruzi mu rubanza rujuririrwa, ko icyo Advance Material Trading Pte Ltd yasabaga kwari uko ingwate zajya mu mazina y'abazitanze zikandikishwa kugira ngo zizavemo ubwishyu.

AMT Ltd yandikiye Perezida w'Urukiko rw'Ikirenga, isaba ko urubanza RCOMAA 00091/2020/CA rwaciwe n'Urukiko rw'Ubujurire rusubirishwamo ku mpamvu z'akarengane kuko rwirengagije ko kuva ku rwego rwa mbere Gisande Trading Ltd n'abishingizi bayo ntacyo bayinengaga ku bijyanye n'ishyirwa mu bikorwa ry'amasezerano y'inguzanyo bagiranye, isaba uru rukiko gutegeka ko ingwate zatanzwe ubwo amasezerano y'inguzanyo yakorwaga zandukurwa zigasubizwa ku mazina yabazitanze.

-Mu bihe bitandukanye yagiye ikorana na Gisande Trading Ltd, ihagarariwe na Niyigaba Ignace ibikorwa by'ubucuruzi bw'amabuye y'agaciro yo mu bwoko bwa *Tin and Tantalium* nkuko bigaragazwa n'amasezerano yo ku wa 25/05/2018, AMT Ltd ikaba yarahaga amafaranga Gisande Trading Ltd hanyuma nayo ikagura ndetse ikanayohereza amabuye y'agaciro muri Singapore;

-Yageze aho isanga Gisande Trading Ltd iyizezemo umwenda munini, igira impungenge ku myishyurirwe yayo, nyuma yo kurebera hamwe uko ikibazo cyakemuka, yumvikana n'umuyobozi wayo Niyigaba Ignace ko bakorana andi masezerano y'inguzanyo n'ingwate, isaba amakuru ku mitungo yagombaga guhabwaho ingwate, mu ibaruwa yo ku wa 7/11/2018, Ikigo gishinzwe imicungire n'imikoreshereze y'ubutaka mu Rwanda kiyigaragariza ko iyo mitungo yanditse ku mazina ya Niyigaba Ignace n'umugore we Akingeneye Dally. Ku wa 24/12/2018 basinye amasezerano y'inguzanyo n'ingwate, aho bemeranyije ko umwenda Gisande Trading Ltd iyibereyemo ungana na 5,380,456 USD, akubiyemo 4,680,456 USD yari isanzwe iyibereyemo na 700,000 USD y'inguzanyo y'inyongera. Muri ayo masezerano Niyigaba Ignace na Akingeneye Dally nabo biyemeje kwishingira umwenda Gisande Trading Ltd ibereyemo AMT Ltd batanga ingwate ku mitungo yabo bwite igizwe n'amazu atatu n'ikigo cy'ishuri biherereye mu Karere ka Kayanza;

-Imikoranire hagati y'impande zombi yarakomeje ariko Gisande Trading Ltd ntiyuzuzwa inshingano zayo zo kohereza amabuye y'agaciro ahwanye n'amafaranga yumvikanyweho kuko yohereje amabuye afite agaciro ka 700,000 USD gusa nkuko bigaragazwa na Invoices (*shipment remittances*) zo ku wa 11/12/2018 no ku wa 20/12/2018, yishyura na 680,456 USD, hasigara umwenda ugera kuri miliyoni 4,7 z'amadolari y'Amerika (USD), kuva muri 2019 ikaba nta mabuye yongeye koherereza AMT Ltd;

-Mu gihe AMT Ltd yari irimo gushaka uburyo yakwandikisha ingwate, yatunguwe no gusanga zimwe muri zo zitambamiwe n'Ikigo cy'imisoro n'Amahoro kubera imisoro, naho ikigo cy'ishuri cyari cyanditse kuri Niyigaba Ignace n'umugore we Akingeneye Dally nk'umutungo wabo bwite ubwo basinyaga amasezerano, baracyandikishije ku mazina ya sosiyete yitwa International Technical School of Kigali Ltd (ITS of Kigali Ltd) babereye abanyamigabane 100%, ibyo byose rero bikaba byaratumye AMT Ltd ibura uko yandikisha ingwate zumvikanyweho mu masezerano;

-Nyuma yo kubona ko Gisande Trading Ltd itubahirije amasezerano bagiranye yohereza amabuye y'agaciro ahwanye n'agaciro k'umwenda yahawe cyangwa iwishyura, n' abishingizi bayo bakaba batarubahirije amasezerano y'ingwate, ku wa 15/05/2019 AMT Ltd yabandikiye ibaruwa y'integuza ibihanangiriza, ariko ntibagira icyo babikoraho, nibwo ku itariki ya 09/08/2019 yiyambaje Urukiko kugira ngo amasezerano yubahirizwe, isaba ko abaregwa bategekwa kugarura ku mazina yabo ishuri ribaruye kuri UPI: 1/02/11/02/229, rikandikishwa muri RDB nk'ingwate yayo, kugira ngo uwo mutungo uzabashye kuvanwamo ubwishyu bw'umwenda Gisande Trading Ltd iyibereyemo, ndetse bakanategekwa kwishyura umwenda wasigara mu gihe ingwate zaba zigurishijwe ntihavemo ubwishyu bw'umwenda wose.

[2] Gisande Trading Ltd n' abishingizi bayo batanze inzitizi yo kutakira icyo kirego bavuga ko mu masezerano yo ku wa 25/05/2018, impande zombi zemeranyije ko nihavuka amakimbirane cyangwa imanza bizakemurwa n'ubukemurampaka bw'i London mu Bwongereza. Ku bijyanye n'imizi y'urubanza bireguye bavuga ko ikirego kidafite ishingiro kubera ko AMT Ltd itagaragaza ikosa bakoze kuko yasinye amasezerano y'ingwate ku wa 24/12/2018 ifite amakuru ku mitungo yahaweho ingwate, bakaba ntacyo bahinduye kuri icyo mitungo.

[3] Urukiko rw'Ubucuruzi rwaciye urubanza N° RCOM 01669/2019/TC ku wa 31/10/2019. Ku bijyanye n'inzitizi, rwemeje ko itakiriwe kuko amasezerano ababuranyi bagiranye ku wa 25/05/2018 atariyo aregerwa mu rubanza, ahubwo ari ayo bakoranye ku wa 24/12/2018 ateganya ko mu gihe havuka ibibazo bitashobora gukemurwa mu bwumvikane, byaregerwa inkiko zo mu Rwanda. Ku bijyanye n'imizi y'urubanza, rwemeje ko ikirego cya AMT Ltd nta shingiro gifite, ruyitegeka kwishyura Gisande Trading Ltd amafaranga y'igihembo cya Avoka n'ikurikiranarubanza ahwanye na 600,000 Frw.

[4] Mu gufata icyo cyemezo, Urukiko rwasobanuye ko rutategeka ko umutungo ugarurwa ku mazina y'abayihaye ingwate kuko AMT Ltd yagize uburangare bwo kudahita iyandikisha mu rwego rubishinzwe, ikaba itagaragaza ko nyuma yo guhabwa amakuru ku banditseho imitungo n'Ikigo gishinzwe imicungire n'imikoreshereze y'ubutaka mu Rwanda mu kwezi kwa 11/2018 no kugirana amasezerano n'abaregwa mu kwezi kwa 12/2018 yatambamiye ihinduzamutungo ngo habe harabayeho amakosa yakozwe n'urwego rwakoze iryo hinduzamutungo kandi waratambamiwe.

[5] AMT Ltd yajuririye Urukiko Rukuru rw'Ubucuruzi, ivuga ko kuba Urukiko rw'Ubucuruzi rutaremeje ko umutungo ubaruye kuri UPI: 1/02/11/02/229 wandukuzwa kuri ITS of Kigali Ltd ukagarurwa mu mazina ya Niyigaba Ignace n'umugore we Akingeneye Dally kugira ngo uzandikishwe muri RDB nk'ingwate yahawe, binyuranyije n'amasezerano bagiranye ku wa 24/12/2018, inenga kandi urwo rukiko kuba ntacyo rwavuze ku byo rwasabwe gutegeka ko mu gihe ingwate zitakwishyura umwenda wose, abaregwa bategekwa kwishyura amafaranga azaba asigaye.

[6] Urukiko Rukuru rw'Ubucuruzi rwaciye urubanza N° RCOMA 00946/2019/HCC ku wa 08/10/2020, rwemeza ko ubujurire bwa AMT Ltd bufite ishingiro, ko imikirize y'urubanza rwajuririwe ihindutse, rutegeka Gisande Trading Ltd, Niyigaba Ignace na Akingeneye Dally gufatanya kwandikisha ingwate bahaye AMT Ltd mu masezerano y'inguzanyo n'ingwate

bagiranye ku wa 24/12/2018, byaba ngombwa hagahinduzwa amazina ya ba nyir'imitungo kugira ngo ubwo bugwate bushobore kwandikwa, mu gihe izo ngwate zaba zitabashije kwishyura umwenda wose AMT Ltd iberewemo, umwenda usigaye ukishyurwa na Gisande Trading Ltd na Niyigaba Ignace. Rwategetse kandi Gisande Trading Ltd, Niyigaba Ignace na Akingeneye Dally gufatanya guha AMT Ltd amafaranga y'igihembo cya Avoka n'ikurikiranarubanza angana na 3,500,000 Frw ku rwego rwa mbere, 1,500,000 Frw mu bujirire, yose hamwe akaba 5,000,000 Frw.

[7] Urwo rukiko rwasobanuye ko ibimenyetso bigizwe n'amabaruwa Umubitsi Mukuru w'impapurompamo z'ubutaka yandikiye Me Rwigamba Molly (Avoka wa AMT Ltd) ku wa 07/11/2018 no ku wa 10/06/2019, agaragaza ko amakuru AMT Ltd yahawe ku mutungo ubaruwe kuri UPI: 1/02/11/02/229 yahinduwe nyuma yo ku wa 24/12/2018, ubwo ababuranyi basinyaga amasezerano, kuko ibaruwa ya mbere yagaragazaga ko umutungo wanditse kuri Niyigaba Ignace, naho iya kabiri ikaba igaragaza ko wanditse kuri ITS of Kigali Ltd, bikaba bigaragaza neza ko Gisande Trading Ltd, Niyigaba Ignace na Akingeneye Dally batubahirije amasezerano y'ingwate bagiranye na AMT Ltd. -Kuba Gisande Trading Ltd yaragaragaje ko itahagaze kwishyura nk'uko bigaragazwa n'ibaruwa AMT Ltd yayandikiye ku wa 18/02/2020, aho yagaragazaga ko umwenda iberewemo kuri iyo tariki ungana na 3,772,064.15 USD, ibyo bikaba bivuguruza ibikubiye mu kirego cyatanzwe na AMT Ltd, aho ivuga ko Gisande Trading Ltd iyifitiye umwenda ungana na miliyoni 4,7 z'amadolari y'Amerika.

[9] Izo ngingo z'ubujurire nizo zaburanyweho mu iburanisha ryo ku wa 28/06/2021, ariko ubwo urubanza rwapfundurwaga ku wa 11/10/2021, Niyigaba Ignace yitabye ubwe nk'uko byari byategetswe n'Urukiko, yavuze ko ingwate itandikishijwe kuko AMT Ltd itubahirije amasezerano bagiranye. Yasobanuye ko Gisande Trading Ltd yagize igihombo bitewe n'uko ibiciro by'amabuye y'agaciro byaguye n'ikibazo cy'amabuye yibwe, ko ku wa 24/12/2018 yagiranye na AMT Ltd andi masezerano, aho buri ruhande rwari rufite ibyo rwiyejeje. Ku ruhande rwa AMT Ltd yagombaga gukomeza gufasha Gisande Trading Ltd iyihira amafaranga, naho we n'umugore we bagatanga ingwate ku mutungo wabo Gisande Trading Ltd imaze guhabwa amafaranga bumvikanye, ariko ko iyo nguzanyo itatanzwe, bituma ingwate zitandikishwa imikoranire irahagarara. Yavuze kandi ko kugira ngo umutungo wandikweho ubugwate, babanza kumvikana na AMT Ltd, ikamuha amafaranga yemeye mu masezerano.

[10] Mu rubanza N° RCOMA 00091/2020/CA rwaciye ku wa 05/11/2021, Urukiko rw'Ubujujire rwemeje ko ubujurire bwa Gisande Trading Ltd, Niyigaba Ignace na Akingeneye Dally bufite ishingiro, rutegeka AMT Ltd guha abajuriye 1,500,000 Frw y'igihembo cya Avoka ku nzego zose baburanyeho na 50.000 Frw y'amagarama y'urubanza.

Ntaho rwahera rutegeka ko wandukurwa kuri iryo shuri ngo wandikwe kubo wari wanditsweho mbere kandi iryo shuri ritararezwe mu rubanza;

Ku birebana n'umwenda, kugeza ubu AMT Ltd nta ngwate ifite kuko itazandikishije, bityo ikaba itanatekereza kugurisha ingwate idafite. Mu gihe kandi nta kirego kirebana n'ingano y'umwenda cyatanzwe, ndetse ngo ube warafashweho icyemezo, ntaho rwahera rutegeka Gisande Trading Ltd, Niyigaba Ignace na Akingeneye Dally kwishyura umwenda utaramenyekana.

Amaze gusuzuma ubwo busabe, mu cyemezo N° 034/CJ/2022 cyo ku wa 25/02/2022, Perezida w'Urukiko rw'Ikirenga yemeje ko urubanza rwoherezwa mu Bwanditsi bw'Urukiko rw'Ikirenga kugira ngo rwandikwe mu bitabo ruzaburanishwe, ruhabwa N° RS/INJUST/RCOM 00004/2022/SC.
