*Itegeko Nshinga – Ihame ryo kureshya imbere y'amategeko no kutavangura – Ntawavuga ko yavanguwe mu gihe ibikorwa na kamere y'ibyo aregwa gukora n'ingaruka zabyo kuri sosiyete bitandukanye n'ibikorwa na kamere y'ibyo uwo yigereranya nawe yakoze, kuko bitahanwa kimwe.*

Avuga ko binyuranyije n'amahame ateganyijwe mu ngingo ya 15, iya 16 n'iya 29 y'Itegeko Nshinga, kuko ibihano byateganyijwe ari umurenge ugereranyije n'ibihano biteganywa mu ngingo zindi z'amategeko zihana ibyaha by'ubugome bifite uburemere buze ubw'icyaha cyo gusambanya umwana.

Akomeza avuga ko ibihano biteganyijwe muri iyo ngingo ya 4 binyuranyije n'amahame n'uburenganzira bwa muntu biteganywa n'ingingo ya 15, iya 16 n'iya 29 y'Itegeko Nshinga. Asoza avuga ko yatanze iki kirego mu nyungu ze bwite ndetse no mu nyungu rusange nk'umunyarwanda uharanira ubutabera bwuzuye n'iterambere ry'amategeko.

Uhagarariye Leta y'u Rwanda asobanura ko iyo urebye uburyo icyaha cyo gusambanya umwana gihanwa mu bihugu byinshi, usanga ibihano biteganywa mu gika cya 2, icya 3 n'icya 4 by'ingingo ya 4 y'Itegeko N° 69/2019 yavuzwe haruguru, atari umurenge, akaba asanga uretse kuvuga gusa ko ibi bika binyuranye n'ingingo ya 15, iya 16 n'iya 29 z'Itegeko Nshinga ngo kubera ko biteganywa ibihano biremereye, urega atagaragaza uburenganzira buba butubahirijwe.

Mu kibazo byasuzumwe muri uru rubanza, harimo ikibazo cyo Kumenya niba igika cya 2, icya 3 n'icya 4 by'ingingo ya 14 y'Itegeko N° 059/2023 ryo ku wa 04/12/2023 rihindura Itegeko N° 68/2018 ryo ku wa 30/08/2018 riteganya ibyaha n'ibihano muri rusange, binyuranyije n'ingingo ya 15 n'iya 16 z'Itegeko Nshinga rya Repubulika y'u Rwanda. Aha Urega avuga ko iyo ngingo inyuranyije n'amahame ateganyijwe muri izo ngingo z'Itegeko Nshinga kubera ko iyo ngingo y'itegeko asabira gukurwaho iteganya ibihano bikakaye ku basambanya abana kurusha ibiteganyirizwa abantu bakora ibindi byaha bikomeye kurusha icyo gusambanya umwana. Ikindi ni uko guhanisha umuntu igifungo cya burundu kubera gukoza igitsina cye ku cy'umwana ntibyubahiriza ihame ry'uko uburemere bw'igihano bugomba gushingira ku buremere bw'icyaha.

Uhagarariye Leta y'u Rwanda avuga ko icyaha cyo gusambanya umwana kigira ingaruka zikomeye zitandukanye haba ku mitekerezwe, imibanire, imyigire ndetse n'imikurire y'ubwonko bw'umwana kandi izo ngaruka zikanamukurikirana n'iyoyakuze. Ni icyaha kandi kigira ingaruka ku muryango

muri rusange, bityo ni icyaha kidakwiye gukinishwa cyangwa gupfobywa nk'uko Munyemana ashaka kubikora, kuko mu bihugu byinshi byo ku isi, iki cyaha gihanishwa ibihano bikomeye harimo igifungo cya burundu ndetse n'igihano cy'urupfu.

Certa Foundation nk'Inshuti y'Urukiko muri uru rubanza ihagarariwe na Me Kabasinga, ivuga ko gusambanya umwana ari icyaha gikomeye kivogera uburenganzira bwa muntu ku bagikorewe. Ibi ibivuga ishingiyeye ku masezerano mpuzamahanga arengera uburenganzira bwa muntu, arengera uburenganzira bw'umwana cyangwa aca burundu iavangura iryo ari ryo ryose rikorerwa abagore, ishingiyeye ku mategeko y'u Rwanda, ku manza zo hanze n'izo mu Rwanda ndetse ishingiyeye no ku bushakashatsi butandukanye bukorwa ku bijyanye n'uburenganzira bw'umwana. Ikomeza ivuga ko ibihano ku byaha byo gusambanya abana byarashimangiwe byimazeyo kubera ingaruka bisigira umwana wahohotewe, ndetse n'umuryango muri rusange. Isaba ko uru Rukiko rugomba gusesengura niba kuba itegeko ryarashyizeho ibihano bikomeye ku bakora icyaha cyo gusambanya abana, bivuguruzwa ihame ryo kungana imbere y'amategeko. Isoza ivuga ko Itegeko Nshinga mu ngingo yaryo ya 19 itegenyeye ko umwana wese afite uburenganzira bwo kurengerwa ku buryo bwihariye n'umuryango we, abandi banyarwanda na Leta, bitewe n'ikigero n'imibereho arimo nk'uko biteganywa n'amategeko. Kuba bakeneye kurengerwa byihariye kugirango ihohoterwa bakorerwa ricike ndetse bahabwe n'ubutabera mu buryo bwo guhana byimazeyo uwabahohoteye, ntawavuga ko itegeko rivangurwa ugereranyije n'ibindi byaha bishobora kubakorerwa nk'icyaha cyo gukomeretsa bikabije.

Ku kibazo kijyanye no kuba ingingo ya 14 y'Itegeko N° 059/2023 ryo ku wa 04/12/2023 rihindura Itegeko N° 68/2018 ryo ku wa 30/08/2018 ritangaza ibyaha n'ibihano muri rusange unyuranyije n'ihame ry'ubutabera buboneye, Urega avuga ko nta butabera buboneye aba ahawe iyo uwakojeje igitsina cye ku gitsina cy'umwana, ahanishijwe igifungo cy'imyaka 20 cyangwa cya burundu, mu gihe uwamutemye amaguru n'amaboko ahanishwa igihano kitarenze imyaka 15. Ibi bivuze ko aba yahawe igihano gifite ubukana budahuye n'uburemere bw'icyaha yakoze.

Kuri iki kibazo, Uhagarariye Leta y'u Rwanda avuga ko kuba ibihano biremereye ntibivuga ko uwahanwe yimwe uburenganzira ku butabera buboneye cyangwa ngo yimwe uburenganzira ateganyirizwa n'Itegeko Nshinga. Ikindi ni uko Urega atagaragaza ko ibihano biteganyijwe muri iyo ngingo asaba ko yakurwaho bidashyira mu gaciro cyangwa ngo bibe bibangamiye uburenganzira bw'abatubera, akaba agaragaza gusa ko biremereye.

Inshuti y'Urukiko ivuga ko izi mpaka ziriho zishobora kugabanya ubukana bw'ihohoterwa rishingiyeye ku gitsina, ugereranyije n'ubundi buryo bwo kugira nabi. Isobanura ko mu gihe cyo guhangana n'icyaha cyo gukoresha imibonano mpuzabitsina ku gahato, bikwiye kutibanda gusa ku karengane gashobora kuba ku bakoze icyaha, bavuga ko igihano kidahuye n'uburemere bw'icyaha, kuko kwibanda ku bitekerezo by'uwakoze icyaha utitaye bihagije ku ngaruka zabaye ku wahohotewe, bishobora gutuma mu buryo butagambiriwe habaho imyumvire mu bantu yo gushyira imbere uburenganzira n'ibitekerezo by'abaregwa ibyaha bishingiyeye ku mibonano mpuzabitsina kuruta kwita ku mibereho y'abahohotewe.

## **II. ISESENGURA RY'IBIBAZO BIGIZE URUBANZA**

### **1. Kumenya niba igika cya 2, icya 3 n'icya 4 by'ingingo ya 14 y'Itegeko N° 059/2023 ryo ku wa 04/12/2023 rihindura Itegeko N° 68/2018 ryo ku wa 30/08/2018 riteganywa ibyaha n'ibihano muri rusange, binyuranyije n'ingingo ya 15 n'ya 16 z'Itegeko Nshinga rya Repubulika y'u Rwanda**

[6] Me Kayitana Evode uhagarariye Munyemana Dionize avuga ko ingingo ya 15 y'Itegeko Nshinga iteganywa ko abantu bose bareshya imbere y'amategeko, itegeko ribarengera ku buryo bumwe. Iyi ngingo kandi ishimangirwa n'Amasezerano Mpuzamahanga yerekeye uburenganzira mu by'imbenezamubano no mu bya Politiki u Rwanda rwashyizeho umukono ateganywa ko abantu bose bareshya imbere y'amategeko kandi bafite uburenganzira bwo kurengeka n'amategeko ku buryo bungana nta kuvangura. Akaba asanga ibiteganywa mu gika cya 2, icya 3 n'icya 4 by'ingingo ya 14 y'Itegeko N° 059/2023 ryo ku wa 04/12/2023 ryavuzwe haruguru binyuranyije n'ingingo ya 15 n'ya 16 z'Itegeko Nshinga, kubera impamvu zikurikira:

a) Riteganywa ibihano bikakaye ku basambanya abana kurusha ibiteganyirizwa abantu bakora ibindi byaha bikomeye kurusha icyo gusambanya umwana. Urugero, iyo Munyemana Dionize aza gutema umwana aregwa gusambanya, akamuca amaboko cyangwa amaguru yombi, yari

guhanishwa igifungo cy'imyaka itarenze 15 hashingiwe ku ngingo ya 121 (3) y'Itegeko riteganywa ibyaha n'ibihano muri rusange ryavuzwe haruguru.

b) Guhanisha umuntu igifungo cya burundu kubera gukoza igitsina cye ku cy'umwana ntibyubahiriza ihame ry'uko uburemere bw'igihano bugomba gushingira ku buremere bw'icyaha. Iryo hame kandi rishimangirwa n'umuhanga Gregory S. Schneider mu nyandiko yise “*Sentencing Proportionality in the States*”, rikanagarukwaho n'ikigo cyitwa Sentencing Advisory Council cyo mu gihugu cya Australia.

c) Mu bihugu by'amahanga hari aho usanga iki cyaha gihanishwa ibihano bito cyane ugereranyije n'ibiteganywa muri iyi ngingo. Urugero, muri Leta ya California yo muri Leta Zunze Ubumwe z'Amerika ntibirenga imyaka ine (4) ku cyaha cyo gusambanya umwana, mu gihe icyaha cyo kumuca amaboko cyangwa amaguru byo bihanishwa igifungo cya burundu.

[7] Me Karemera Georges uhagarariye Leta y'u Rwanda asobanura ko ingingo ya 15 y'Itegeko Nshinga ivuga ko abantu bose bareshya imbere y'amategeko, ko kandi itegeko ribarengera ku buryo bumwe; naho ingingo ya 16 yo ikavuga ku bijyanye no kurindwa ivangura ndetse no kuba abanyarwanda bafite uburenganzira n'ubwisanzure bingana, ko ivangura iryo ariryo ryose ribujijwe kandi rihanwa n'amategeko. Avuga ko igika cya 2, icya 3 n'icya 4 by'ingingo ya 14 y'Itegeko N° 059/2023 ryo ku wa 04/12/2023 ryavuzwe haruguru, bitanyuranyije n'ingingo ya 15 n'ya 16 z'Itegeko Nshinga, kubera impamvu zikurikira:

a) Buri gihugu kigira amategeko ahana agaragaza ibyaha n'ibihano, kandi mu kubigena harebwa ububi bw'icyaha n'ingaruka zacyo haba ku wagikorewe (*victim*) ndetse no kuri sosiyete muri rusange; hagamijwe guhana uwakoze icyaha, gukumira ibyaha (*deterrence*) no kugorora (*rehabilitation*).

b) Binyuze mu nzego zibifitiye ububasha cyane cyane Inteko Ishinga Amategeko, buri gihugu kigena uburemere bw'icyaha ndetse n'igihano gikwiriye icyo cyaha hagamijwe kugera ku ntego zo guhana, gukumira no kugorora.

d) Icyaha cyo gusambanya umwana kigira ingaruka zikomeye zitandukanye haba ku mitekerereze, imibanire, imyigire ndetse n'imikurire y'ubwonko bw'umwana kandi izo ngaruka zikanamukurikirana n'iyi yakuze. Icyo cyaha cyonona kandi kikamunga ubuzima bw'umwana ndetse kigira ingaruka ku muryango muri rusange, bityo icyaha nk'icyo kikaba gikwiye guhanishwa igihano kiremereye, mu rwego rwo guhana abagikoze no gukumira kugira ngo n'abashaka kugikora babe batinya igihano bashobora guhabwa.

e) Iyo urebye uburyo icyaha cyo gusambanya umwana gihanwa mu bihugu byinshi, usanga ibihano biteganywa atari umurengera. Urugero n'urwo mu bihugu 3 bigize Umuryango w'Ibihugu by'Iburasirazuba bw'Afurika (East African Community) Kenya, Uganda na Tanzania no mu bindi bihugu byinshi, aho usanga iki cyaha gihanishwa ibihano biri hejuru cyane:

i) Mu Gihugu cya Kenya, umuntu usambanyije umwana ufite imyaka 11 no muni yaho ahanishwa igifungo cya burundu, naho iyo umwana afite hagati y'imyaka 12 na 15, ahanishwa igifungo kidashobora kujya muni y'imyaka 20.

ii) Mu Gihugu cya Uganda, umuntu usambanyije umwana uri muni y'imyaka 18 ahanishwa igifungo cya burundu, naho usambanyije umwana uri muni y'imyaka 14, ahanishwa igihano cy'urupfu.

iii) Mu Gihugu cya Tanzania, umuntu usambanyije umwana uri muni y'imyaka 14 ahanishwa igifungo cya burundu.

iv) Muri Leta ya California, imwe muri Leta zigize Leta Zunze Ubumwe z’Amerika, umuntu ufite nibura imyaka 18 usambanyije umwana ufite imyaka 10 no muni yayoy ahanishwa igifungo kiri hagati y’imyaka 25 n’igifungo cya burundu.

v) Mu gihugu cya Nigeria, Umuntu usambanyije umwana uri muni y’imyaka 13 ahanishwa igifungo cya burundu.

f) Ukurikije izo ngero zitandukanye, bigaragara ko icyaha cyo gusambanya umwana ari icyaha kidakwiye gukinishwa cyangwa gupfobywa nk’uko Munyemana Dionize ashaka kubikora, kuko mu bihugu byinshi byo ku isi, iki cyaha gihanishwa ibihano bikomeye harimo igifungo cya burundu ndetse n’igihano cy’urupfu.

g) Mu rubanza RS/INCONST/SPEC 00001/2019/SC, Urukiko rw’Ikirenga rwatanze igisobanuro cy’ingingo ya 15 n’iya 16 z’Itegeko Nshinga, ushingiye kuri urwo rubanza usanga igika cya 2, icya 3 n’icya 4 by’ingingo ya 14 y’Itegeko N° 059/2023 ryo ku wa 04/12/2023 ryavuzwe haruguru, ntaho binyuranya n’amahame akubiye mu ngingo ya 15 n’iya 16 y’Itegeko Nshinga, kandi haba mu Rwanda cyangwa mu bindi bihugu, hateganyijwe ko icyaha cyo gusambanya umwana muto gifite uburemere bukomeye kurusha icyaha cyo gukubita no gukomeretsa urega yagarutseho abigereranya.

h) Kuba igihano cyaremerera uwakoze icyaha ntibikwiye gufatwa ko icyo gihano ari umurenge, cyangwa ko ingingo igiteganyije inyuranye n’Itegeko Nshinga, kuko uburemere bw’igihano budashobora gupimwa cyangwa kugenwa n’umuntu ku giti cye, cyane cyane uwakoze icyaha, nk’uko Munyemana Dionize ashaka kubikora.

[8] Mu izina ry’Inshuti y’Urukiko (*amicus curiae*), Me Kabasinga Florida, uhagarariye Certa Foundation, ashingiye ku Masezerano mpuzamahanga y’Uburenganzira bw’Umwana (*Convention on the Rights of the Child*), Amasezerano nyafurika yerekeye uburenganzira n’imibereho myiza y’umwana, Amasezerano Nyafurika y’uburenganzira bwa muntu n’abaturage ya Banjul, Amasezerano nyafurika y’uburenganzira bwa muntu n’abaturage ku burenganzira bw’umugore muri Afurika (Maputo Protocol), Amasezerano mpuzamahanga y’uburenganzira mbonezamubano n’ubwa politiki (ICCPR), n’Amasezerano yerekeye guca burundu ivangura iryo ari ryo ryose rikorerwa abagore (CEDAW), amategeko atandukanye y’u Rwanda, imanza zo hanze ndetse n’izo mu Rwanda, ubushakashatsi butandukanye ndetse n’ibisobanuro bitangwa na UNICEF ku burenganzira bw’abana n’ingimbi, avuga ko:

a) Gusambanya umwana ari icyaha gikomereye kivogera uburenganzira bwa muntu ku bagikorewe (victims). Bivogera amahame shingiro y’uburenganzira bwa muntu (fundamental human rights) ku mwana wakorewe iryo hohoterwa, ku mibereho (*safety*) ku buzima bwe, nko kuba yakwandura ubwandu bw’agakoko gatera SIDA, cyangwa izindi ndwara zandurira mu mibonano mpuzabitsina, ndetse ko ashobora no guhura n’ingorane mu gihe cyo gutwita no kubyara.

b) Raporo yakozwe n’Urwego rw’Ubugenzacyaha mu Rwanda (RIB), igaragaza ubwiyongere bwa 27.9 % bw’imanza zakozweho iperereza ugereranyije imibare yo mu mwaka w’ingingo y’imari wa 2018/2019 (3.215) na 2019/2020 (4.013). Raporo imwe ivuga ko umubare w’abana wiyongereyeho gato bava ku 3.215 muri 2019 ukagera kuri 4.265 muri 2020. Imibare igaragaza ko 1.239 (29.1%) y’abahohotewe bari muni y’imyaka 10 muri 2020, ko kandi 98 % by’izo manza, abahohotewe ari abakobwa.

c) Raporo yakozwe n’Ubushinjacyaha Bukuru yagaragaje ko ibyaha byo gusambanya abana byiyongereye kuva ku 1.819 mu mwaka wa 2013 bigera ku 3.793 mu mwaka wa 2020. Iyo raporo igaragaza neza ko icyo cyaha ari ikibazo gikomereye Leta y’u Rwanda gikeneye

gufatirwa ingamba zitajenjetse. Niyo mpamvu icyaha cyo gusambanya abana ndetse n'ibindi bikorwa by'ihohoterwa rishingiye ku gitsina, bigomba gufatwa nk'ihohoterwa ry'uburenganzira bwa muntu.

d) Abana b'abakobwa aribo bibasirwa cyane n'ibyo bikorwa bibi, kandi bakaba bakomeje gucecekesha, badashobora kubona uburenganzira bwabo no kurindwa nyuma y'ibi bintu bibi bakorerwa.

e) Gusambanya umwana ari icyaha gikomeye gitera n'ingaruka nyinshi zitandukanye nk'ihungabana (*Trauma*) n'akababaro ku basambanyijwe, ndetse ibyo bikabagiraho n'ingaruka kuri ejo habo hazaza, ku mishinga yabo, ku buzima bwabo, ku myigire yabo, ku bukungu bwabo ndetse no mu mibanire yabo n'abandi.

f) Abahuye n'ihohoterwa barahamuka bakumva ko atari abagore buzuye, kuko baba bateshejwe agaciro ku rwego rwo gutakaza icyubahiro cyabo. Niyo mpamvu Guverinoma y'u Rwanda yateye intambwe intambwe mu gukumira no guca burundu ihohoterwa rishingiye ku gitsina, ishyiraho urwego rugamije gushyira mu bikorwa amategeko na politiki yo kurwanya no gukurikirana ihohoterwa rishingiye ku gitsina.

g) Habayeho iterambere ry'amategeko na politiki byerekana intambwe igaragara iganisha ku buringanire no gushyiraho uburyo bwiza bwo gukumira no kurwanya ihohoterwa rishingiye ku gitsina, aho ryagizwe icyaha gihanwa n'ibihano biremereye. Ni ngombwa kwerekana ingaruka zishobora guterwa no gukoresha imyumvire ibogamye ishingiyeye ku nshingano n'imico iranga igitsina mu bucamanza. Imyumvire ishingiyeye ku gitsina iyo ikoresha mu nzego z'ubutabera ishobora kugira ingaruka zikomeye ku burenganzira bw'ibanze bw'umugore, harimo uburinganire imbere y'amategeko, ubutabera buboneye, n'uburenganzira bwo gukemurirwa ibibazo mu buryo bunoze.

h) Ibihano ku byaha byo gusambanya abana byarashimangiwe byimazeyo kubera ingaruka bisigira umwana wahohotewe, ndetse n'umuryango muri rusange. Urukiko rukaba rugomba gusesengura niba kuba itegeko ryarashyizeho ibihano bikomeye ku bakora icyaha cyo gusambanya abana, bivuguruza ihame ryo kungana imbere y'amategeko.

i) Gukumira icyaha cyo gusambanya abana bisaba imbaraga nyinshi za Leta hagamijwe ko abakora bene ibi byaha batazongera kubikora ukundi. Bumwe mu buryo bukomeye u Rwanda rwakoresheje ni ugufata gusambanya umwana nk'icyaha gikomeye cy'indengakamere ndetse cyashyizwe mu byaha bidasaza. Umuntu wese wangiza ejo hazaza h'umwana nta mutima aba afite, bityo umuryango, sosiyete na Leta muri rusange bigomba gufatanya kurwanya iryo hohoterwa no kurinda abahohotewe.

j) Ihame ryo kungana imbere y'amategeko risobanura ko mu gukurikirana uwakoze icyaha hagomba kubahirizwa uburenganzira bw'uregwa bwo kuburanira mu ruhamu, mu rukiko rufite ububasha kandi rwigenga, kandi rwanashyizweho n'itegeko. Iri hame rikaba ryumvikanisha ko amategeko akoresha arengera abantu mu buryo bumwe nta vangura rihari, hatitawe ku byiciro babarizwamo muri sosiyete, nko kuba umuntu ari umukire, umukene, umwana, umuntu mukuru, igitsina, uruhu, umuco, idini cyangwa ikindi icyo aricyo cyose.

K) Ku birebana n'uburyo bwo kurengera abana cyane ko ari nabo bahohoterwa cyane, ingingo ya 19 y'itegeko Nshinga ivuga ko umwana wese afite uburenganzira bwo kurengerwa ku buryo bwihariye n'umuryango we, abandi banyarwanda na Leta, bitewe n'ikigero n'imibereho arimo nk'uko biteganywa n'amategeko. Abana bakeneye rero kurengerwa byihariye kugirango ihohoterwa bakorerwa ricike ndetse bahabwe n'ubutabera mu buryo bwo guhana byimazeyo uwabahohoteye, bityo akaba ari ntawavuga ko itegeko rivangura ugereranyije n'ibindi byaha bishobora gukorerwa abana nk'icyaha cyo gukomeretsa bikabije.

Naho ingingo ya 16 yo ikavuga ko (1) Abanyarwanda bose bavukana kandi bagakomeza kugira uburenganzira n'ubwisanzure bingana. (2) Ivangura iryo ari ryo ryose cyangwa kurikwirakwiza byaba bishingiye ku bwoko, ku muryango cyangwa ku gisekuru, ku nzu, ku ibara ry'umubiri, ku gitsina, ku karere, ku byiciro by'imibereho, ku idini cyangwa ukwemera, ku bitekerezo, ku mutungo, ku itandukaniro ry'umuco, ku rurimi, ku bukungu, ku bumuga bw'umubiri cyangwa ubwo mu mutwe no ku rindi vangura iryo ari ryo ryose, birabujijwe kandi bihanwa n'amategeko.

Igika cyayo cya mbere aricyo kivuga ibikorwa bihanirwa mu gika cya 2, icya 3 n'icya 4 byaregewe, kigira kiti: (1) umuntu ukorera ku mwana kimwe mu bikorwa bishingiye ku gitsina bikurikira, aba akoze icyaha: (a) gushyira igitsina cy'umuntu mu gitsina, mu kibuno cyangwa mu kanwa by'umwana; (b) gushyira urungu urwo ari rwo rwose rw'umubiri w'umuntu mu gitsina cyangwa mu kibuno cy'umwana; (c) gukora ikindi gikorwa cyose ku mubiri w'umwana hagamijwe ishimishamubiri. Naho igika cy'iyi ngingo cya 2, icya 3 n'icya 4, bigateganyaga ko (2) Umuntu uhamijwe n'urukiko gukora kimwe mu bikorwa bivugwa mu gika cya (1) cy'iyi ngingo ahanishwa igifungo kitari munsi y'imyaka 20 ariko kitarenze imyaka 25. b) Ingaruka z'icyaha cyo gusambanya abana ndetse n'abatari abana muri rusange.

c) Ihame ry'uko uburemere bw'igihano bushingira ku buremere bw'icyaha (*principle of proportionality*)

### **a. Ihame ryo kureshya n'iryo kutavangura imbere y'amategeko**

[12] Ihame ryo kureshya imbere y'amategeko n'iryo kutavangura yasesenguwe mu bihe bitandukanye n'uru Rukiko mu manza zitandukanye zaritanzeho umurongo, zirimo urubanza RS/INCONST/SPEC00004/2021/SC, rwaciwe ku wa 10/02/2023, haburana Ngendahayo Kabuye, aho rwasobanuye ko ihame ryo kureshya imbere y'amategeko rijyana n'iryo kutavangura, kandi ko afitanye isano, akaba agomba kureberwa hamwe kuko yombi ahuriza ku kintu cy'ingenzi cyo kudasambanya abantu mu buryo butemewe cyangwa bubujijwe nta mpamvu, ugamiye kugira abo uheza ku burenganzira bemerera n'amategeko. Urukiko rwavuze kandi ko kureshya imbere y'amategeko no kutavangura bitavuze ko gutandukanya abantu ubwabyo mu bihe byose ari ivangura. [16] Mu cyegeranyo cyasohowe n'Umuryango w'Abibumbye, gikubiyemo imanza zaciwe n'Inkiko Mpuzamahanga ku ihohoterwa rishingiye ku gitsina, harimo Urukiko Mpanabyaha Mpuzamahanga washyiriweho u Rwanda, urwashyiriweho Yugoslavia n'urwashyiriweho Sierra Leone, hagaragamo ko ihohoterwa rishingiye ku gitsina ritera ububabare bukabije no kubabara ku mubiri ndetse no mu ntekerezo. Kubabara mu ntekerezo ku wakorewe ihohoterwa bishobora gukongezwa na sosiyete ndetse n'ibiranga umuco kandi bikaba biremereye byihariye binamara igihe kinini cyane.<sup>3</sup> Gukoreshwa imibonano mpuzabitsina ku gahato bitera ububabare bukabije ku mubiri no mu bitekerezo. Ububabare mu bitekerezo bw'abantu bakoreshwe imibonano mpuzabitsina ku gahato bushobora kongerwa bitewe n'ibyerekeye imibereho n'umuco kandi bikagira ingaruka zikomeye kandi z'igihe kirekire.

[18] Urwo rubanza rumaze kuvugwa rukomeza rugaragaza ko inyungu shingiro umushingamategeko aba arengera mu kugena ibihano ku byaha byo gusambanya abana ari ubwigenge bwa muntu, kudahungabanywa ku mubiri, kudahungabanywa mu by'imibonano mpuzabitsina, ikuzo, no kungana kw'abana. Rwagaragaje kandi ko ihohoterwa rishingiye ku gitsina rikorewe abana rihungabanya ubwigenge bwa muntu bw'umwana mu buryo butandukanye no ku muntu mukuru kuko umwana aba adafite ububasha bwo kwemera gukora imibonano mpuzabitsina n'umuntu mukuru, bisobanuye ko aba agikeneye uburenganzira bwo gukura butarangwamo gufatiranwa akoreshwa imibonano mpuzabitsina n'abakuze.<sup>5</sup>

Iryo hohoterwa buri gihe rijyana no gukoresha imbaraga zijyanye na kamere y'imibonano mpuzabitsina ku mwana. Ikindi cyagaragajwe n'urwo rubanza ni uko impamvu zikomeza icyo cyaha zituruka ku buryo guhungabanywa ku bwigenge ku bijyanye n'imibonano mpuzabitsina ku mwana byiyongeraho guhungabanywa ku mubiri w'umwana. Amahame abiri amaze kuvugwa ntabwo avuguruzanya, ahubwo kubahiriza rimwe nibyo bituma irindi naryo ryubahirizwa. Nanone kandi, uburyo bwatuma hatangwa igihano kimwe ku bitameze kimwe nabwo buba butubahirije ihame ryo kuba igihano kigomba kuba kingana n'uburemere bw'icyaha n'ihame ryo kuba abanyabyaha bamwe, bakoze icyaha kimwe mu buryo bumwe bagomba guhabwa igihano kimwe. Iri hame rimaze kuvugwa niryongiragaza mu buryo ngiro uko uburemere bw'igihano bugomba gushingira ku buremere bw'icyaha.<sup>7</sup>

[21] Abahanga mu mategeko bavugaga kandi ko ihame ry'uburemere bw'igihano bugomba gushingira ku buremere bw'icyaha (*principle of proportionality*) ritegeka ko igihano ku cyaha kigomba gutangwa hadashingiwe gusa kuri kamere y'ibikorwa bigize icyaha byakozwe, ahubwo ko hanashingirwa ku buryozwe n'umugayo uwagikoze akwiye. Bimwe mu byitabwaho inkiko zagiye zigenderaho igihe zemeza urwego umuntu ari buryozweho ku bikorwa bigize icyaha akaba ari ububasha bwe bwo gufata icyemezo (*decision-making capacity*), uburyo icyaha cyakozwemo, ndetse n'imyitwarire imuranga.<sup>8</sup>

[22] Ukurikije ibisobanuro n'imirongo byatanze mu manza zavuzwe haruguru zaciye n'uru Rukiko kw'ihame ryo kureshya n'iryo kutavangura imbere y'amategeko, Urukiko rurasanga urega atabasha kugaragaza uburyo ibihano ku cyaha cyo gusambanya abana binyuranyije n'ingingo ya 15 n'ya 16 z'Itegeko Nshinga, usibye kugereranya ibihano bihanishwa uwahamwe n'icyo cyaha n'ibihabwa uwahamwe n'icyaha cyo gukubita no gukomeretsa byaviriyemo uwakorewe icyaha ingaruka zigaragara ku mubiri nko gucibwa ukuboko.

[23] Urukiko rushingiye ku isesengura ryakozwe haruguru, ndetse no ku manza zitandukanye zisesengura amahame ateganywa mu ngingo ya 15 na 16 z'Itegeko Nshinga, rurasanga ibyo byaha byombi bitandukanye, bityo n'ababikoze bakaba batahanwa kimwe kandi bahanirwa ibyaha bitandukanye, hakaba ntawavugaga ko yavanguwe mu gihe ibikorwa na kamere y'ibyo aregwa gukora n'ingaruka zabyo kuri sosiyete bitandukanye n'ibikorwa na kamere y'ibyo uwo yigereranya nawe yakoze.

[24] Kubera izo mpamvu zose zavuzwe haruguru, Urukiko rurasanga ingingo ya 14, mu gika cya 2, icya 3, n'icya 4, y' Itegeko N° 059/2023 ryo ku wa 04/12/2023 rihindura Itegeko N° 68/2018 ryo ku wa 30/08/2018 riteganyaga ibyaha n'ibihano muri rusange itanyuranyije n'ingingo ya 15 n'ya 16 z'Itegeko Nshinga.

Umuntu utemye umwana akamuca amaguru cyangwa amaboko we ahanishwa imyaka itarenze 15, bikaba bitumvikana ukuntu gukoza igitsina ku cy'umwana, rimwe na rimwe uwabikoze ntagere no ku gikorwa nyirizina cyo kumusambanya, nk'uko Ubushinjacyaha bubivuga mu rubanza rwa Munyemana Dionize, yahanishwa igifungo cy'imyaka 20 cyangwa icya burundu.

b. Nta butabera buboneye umuntu yavuga ko yabonye mu gihe yahawe ibihano bifite ubukana budahuye n'uburemere bw'icyaha yakoze.

c. Hari abantu benshi basambanyijwe bakiri batoya, kandi ubu bakaba bubatse, barabyaye, bakora akazi neza, nta kibazo gikomeye bafite mu buzima. [26] Me Karemera Georges uhagarariye Leta y'u Rwanda asobanura ko ingingo ya 29 y'Itegeko Nshinga irebana n'uburenganzira ku butabera buboneye (*right to due process / droit à la garantie judiciaire*). Akavuga ko igika cya 2, icya 3 n'icya 4, by'ingingo ya 14 y'Itegeko N° 059/2023 ryo ku wa 04/12/2023 rihindura Itegeko N° 68/2018 ryo ku wa 30/08/2018 ryavuzwe haruguru, bitanyuranyije n'ingingo ya 29 y'Itegeko Nshinga, kubera impamvu zikurikira:

a. Kuba ibihano biremereye ntibivuga ko uwahanwe yimwe uburenganzira ku butabera buboneye cyangwa se ko atahawe uburenganzira buteganywa n'ingingo ya 29 y'Itegeko Nshinga.

b. Ku bijyanye n'ubutabera buboneye (*substantive due process*), urega ntagaragaza ko ibihano biteganyijwe mu gika cya 2, icya 3 n'icya 4 by'ingingo ya 14 y'Itegeko N° 059/2023 ryo ku wa 04/12/2023 yavuzwe haruguru, bidashyira mu gaciro, cyangwa ngo bibe bibangamiye

uburenganzira bw'abaturage. icyo agaragaza gusa ni uko ibihano biremereye ibyo bikaba bidahura n'ibyo Urukiko rw'Ikirenga rwasobanuye mu rubanza yagaragaje mu mwanzuro we.

c. Urega yatanze urugero kuri Pastor Joyce Meyer, ashaka kugaragaza ko icyaha cyo gusambanya umwana kidafite ingaruka zikomeye, bitandukanye cyane n'ukuri, kuko ubwe yivugira ko kuba se umubyara yaramusambanyije kuva akiri muto byamugizeho ingaruka zikomeye cyane mu mikurire ye, ko ndetse bigoye kwiyumvisha ingaruka mbi gusambanya umwana bigira kuri uwo mwana.<sup>9</sup>

d. Ibihano bigenewe abakoze icyaha cyo gusambanya abana bigamije kurinda uburenganzira bw'abana ndetse na sosiyete muri rusange, bibarinda abantu nka Munyemana Dionize, kandi bikanakumira abandi bantu bashobora kugira igitekerezo cyo gukora icyo cyaha ariko ntibagikore kubera gutinya igihano bashobora guhabwa baramutse bishoye muri icyo cyaha.

a. Impaka ziriho zishobora kugabanya ubukana bw'ihohoterwa rishingiye ku gitsina, ugereranyije n'ubundi buryo bwo kugira nabi. Uku gupfobya kukaba gushobora gushimangira mu buryo butagenderewe imyumvire igabanya uburemere bw'icyaha cyo gusambanya umwana no gukinisha imyumvire y'uwahohotewe.

b. Kwibanda gusa ku bikorwa bifatika bigize icyaha bishobora kubuza kumenya neza ingaruka mbi zikomoka kw'ihohoterwa iryo ari ryo ryose rishingiye ku gitsina, cyane cyane irikorwa umwana ndetse bikanagira ingaruka zo kumvikanisha ko ko igihano cy'ibi byaha kidakwiye.

c. Birakwiye ko mu butabera hatagarukirwa gusa ku gusesengura ingaruka ku mubiri zo gukoreshwa imibonano mpuzabitsina ku gahato kuko n'ubwo zishobora kuba ziremereye ushingiyeye ku kuba bamwe mu bahohotewe byarabateye ubumuga, zimwe mu ngingo zabo zigatakaza imikorere, cyangwa bagahura n'ibibazo byo gutwita, abandi bagapfa kubera gukuramo inda, ingaruka mu mitekerereze y'uwakoreshejwe imibonano mpuzabitsina ku gahato cyangwa uwasambanyijwe ziraremereye kandi akenshi zikaba zirengagizwa.

d. Igitekerezo cy'uko abarokotse gukoreshwa imibonano mpuzabitsina ku gahato bashobora kubaho neza, gukora no kugira imiryango nk'uko byavuzwe ahanini mu nkuru ya Joyce Meyer, bishobora kuba ukuri kuri bamwe, nyamara ntibikuraho ihungabana abarokotse iryo hohotera akenshi bahangana naryo. Joyce Meyer mu magambo ye ntiyigeza avuga ko atagizweho ingaruka n'ihohoterwa yakorewe.

e. Ubushakashatsi bwakozwe hagati ya Kamena 2015 na Nyakanga 2016 mu bitaro by'igihugu bya Kenyatta n'ibitaro by'abagore bya Nairobi, bwakorewe ku bantu 40 bakoreshejwe imibonano mpuzabitsina ku gahato n'imiryango yabo, bwagaragaje ko abana bakoreshejwe imibonano mpuzabitsina ku gahato baragize ingaruka mbi mu bijyanye no kutitwara neza mu masomo, kwiyubaha guke, kwiheba, ndetse n'imibanire mibi n'abandi.

f. Mu gihe hasesengurwa ibijyanye no gukoreshwa imibonano mpuzabitsina ku gahato, hagomba kandi kurebwa ingaruka iki cyaha gishobora kugira ku bagize umuryango w'abahohotewe, kuko bitewe no guhohoterwa na se, murumuna wa Joyce Meyer yabaswe n'ibiyobyabwenge ndetse birangira yiyahuye. Ibi bigaragaza ko gukoreshwa imibonano mpuzabitsina ku gahato bigera ku yindi ntera yo kurimbura abagize umuryango ukikije abahohotewe.

h. Mu rubanza rwaciwe n'Urukiko rw'Amerika rw'Uburenganzira bwa Muntu haburana Linda Loaiza v. Venezuwela, Urukiko rwemeje ko gukoresha Linda Loaiza imibonano mpuzabitsina ku gahato byagize uruhare mu kuvogera ubuzima bwe ku bijyanye n'imibonano mpuzabitsina, kandi bikuraho uburenganzira bwe bwo guhitamo mu bwisanzure uwo bazakorana imibonano mpuzabitsina, bigatuma atakaza uburenganzira bwe bwo gufata ibyemezo bikwiye ku mikorere y'ibanze y'umubiri.

i. Ni ngombwa gukorana ubwitonzi ibiganiro bishingiye ku ngingo zikomeye nko gusambanya umwana, hirindwa imvugo ishobora kwimakaza imyumvire mibi cyangwa ibangamira ubuzima bw'abahohotewe.

j. Iteganya ko umucamanza atanga igihano akurikije uburemere bw'icyaha, ingaruka icyaha cyateye, impamvu zatumye agikora, uko uwagikoze yari asanzwe yitwara, imibereho ye bwite n'uburyo icyaha cyakozwemo. [...].

[30] Mu rubanza RS/INCONST/SPEC00003/2019/SC, ku wa 04/12/2019, haburana Kabasinga Florida, uru Rukiko rwasobanuye ko ubutabera buboneye busobanurwa mu buryo butandukanye; hari ubutabera buboneye bushingiye ku migendekere (*procedural due process: a course of formal proceedings (such as legal proceedings) carried out regularly and in accordance with established rules and principles*). Ni ukuvuga uruhererekane rw'ibigomba kubahirizwa mu migendekere y'urubanza hashingiye ku mahame ateganywa n'amategeko. Hari n'Ubutabera buboneye bushingiye

ku biteganywa n'itegeko “*substantive due process*”: *protection against enactment of arbitrary and unreasonable legislation or other measures that would violate peoples' rights.*” Ubu buryo bwo bubuza ishyirwaho ry'amategeko cyangwa izindi ngamba zidashyira mu gaciro zibangamira uburenganzira bw'abaturage.

[31] Mu rubanza RS/INCONST/SPEC00005/2020/CS - RS/INCONST/SPEC00006/2020/CS rwaciwe ku wa 12/02/2021, uru Rukiko rwemeje ko ingingo iteganya igifungo cya burundu ku muntu wakoze icyaha cyo gusambanya umwana kidashobora kugabanywa kubera impamvu nyoroshyacyaha, nta gaciro ifite kubera ko inyuranye n'Itegeko Nshinga. Ibi bivuze ko igihe bigaragara ko hari impamvu nyoroshyacyaha, igifungo cya burundu kivugwa muri iyo ngingo gishobora kugabanywa, ndetse mu rubanza RS/INJUST/RP 00003/2019/SC rwaciwe n'uru Rukiko ku wa 28/01/2022, haburana Niyonsaba Eric n'Ubushinjacyaha, rwagabanyije igihano cy'igifungo cya burundu cyari cyahawe Niyonsaba Eric ku cyaha cyo gusambanya umwana yahamijwe n'Urukiko rw'Ubujurire, maze rushingiye ku mpamvu nyoroshyacyaha rumuhanisha igifungo cy'imyaka cumi n'itanu (15).

[32] Urukiko rurasanga ibimaze kuvugwa haruguru bigaragaza ko mu gihe umucamanza asanze hari impamvu nyoroshyacyaha, atabujijwe kugabanyiriza igihano uhamwe n'icyaha cyo gusambanya umwana, bitandukanye n'ibyo Me Kayitana Evode avuga.

[33] Ku birebana n'uburemere bw'icyaha cyo gusambanya umwana nk'imwe mu mpamvu zishingirwaho mu igenwa ry'igihano uregwa agomba guhanishwa, mu rubanza Botha v The State (546/2021) [2022] ZASCA 87 (08 June 2022),<sup>10</sup> rwaciwe n'Urukiko rw'Ikirenga rw'Ubujurire mu gihugu cy'Afurika y'Epfo, aho icyasuzumwaga kwari ukumenya icyakorwa ku gihano cy'igifungo cy'imyaka 36 gishingiye ku giteranyo cy'ibihano cyatanzwe n'Urukiko Rukuru, urugereko rwa Gauteng, Pretoria, kubera impurirane y'ibyaha by'ihohotera rishingiye ku gitsina, rwasuzumye niba harabaye kurengera cyangwa se harimo gukabya mu buryo budakwiye, runasuzuma niba ari ngombwa ko Urukiko rw'Ikirenga rw'Ubujurire ruhagarika icyo gihano binyuze mu zindi nzira ziteganywa n'amategeko. Mu isesengura ryakozwe rikubiye mu gika cya 18, rwasobanuye ko impamvu nkomezacyaha zarutaga impamvu nyoroshyacyaha, uburemere bw'icyaha n'icyasha cyo gusambanywa ku bana badafite kirengera kitafatwa nk'ikintu cyoroshye, kuko ingaruka bigira ku miterere y'umuryango na sosiyete muri rusange, igikomere cyo mu ntekerezo n'amarangamutima mabi ku mwana, bizwi neza. [...]. Urukiko rwemeye ko igihano cy'igifungo cy'imyaka 36 gikomeye koko, ariko ko kidakomeye kurusha uburemere bw'ibyaha cyatanzweho. Urwo Rukiko rwasanze Urukiko Rukuru rutarakoresheje ububasha ku mahitamo yarwo mu buryo budashyize mu gaciro.

[34] Urukiko rurasanga nk'uko byagaragajwe haruguru, mu isesengura ryakozwe ku kibazo cya mbere cyasuzumwe haruguru, ndetse n'iryakozwe ku kibazo gisuzumwa muri iki gice, uburemere icyaha cyo gusambanya umwana gifite n'ingaruka kimugiraho, ndetse n'izo kigira kuri sosiyete, n'ubwo koko ibihano bitangwa kuri icyo cyaha biremereye ntibiruta ingaruka zacyo n'uburemere bwacyo. Rusanga kandi uburemere bw'icyo cyaha bwaragaragajwe muri raporo zakozwe n'Urwego
