Yasobanuye ko kuba igika kimaze kuvugwa giteganywa ko abakatiwe n'Inkiko Gacaca bemererwa gusubirishamo imanza zabo ingingo nshya iyo berekanye ko abo bashinjwaga kwica bakiriho gusa, ari ivangura ribakorerwa kandi itegeko ritabareshyeshya n'abandi kubera ko abakatiwe n'inkiko zisanzwe bo hari izindi mpamvu zateganyijwe n'itegeko bashobora gushingiraho basaba gusubirishamo imanza zabo ingingo nshya. Yavugaga kandi kuba yarabonye ibimenyetso byatuma asubirishamo ingingo nshya urubanza yaciriwe n'Urukiko Gacaca ariko itegeko rikamuzitira, ibyo bibangamira ubutabera buboneye yemererwa n'Itegeko Nshinga kuko adashobora kugaragaza akarengane ke.

Uhagarariye Leta y'u Rwanda muri uru rubanza avuga ko ikirego cya Kamanzi cy'uko ibiteganyijwe mu gika cya 4 cy'ingingo ya 197 y'Itegeko N° 027/2019 ryo ku wa 19/09/2019 ryavuzwe haruguru binyuranyije n'ingingo ya 15 n'iya 16 z'Itegeko Nshinga basanga nta shingiro gifite, kuko ibiteganyijwe muri izo ngingo bigomba gusuzumwa hagereranywa umuntu n'abo bahuje icyiciro. Asobanura ko kuba iyi ngingo iteganywa impamvu zo gusubirishamo imanza ingingo nshya ishingiyeye ku nkiko zaziciye nta vangura ririmo dore ko gushyirwa abantu mu byiciro atari ukubavangura, cyane cyane iyo ibyo byiciro byashyizweho hagamijwe kugera ku ntego yumvikana, igaragarira buri wese, ishingiyeye ku mategeko, kandi ibyashingiweho bikaba bifite ireme mu nyungu rusange.

cya 4 cy'ingingo ya 197 y'Itegeko ryavuzwe haruguru, cyaje kigamije kuziba icyuho, aho abakatiwe n'Inkiko Gacaca wasangaga bitabaza inkiko zisanzwe kugira ngo basubirishemo imanza zabo ingingo nshya bagamije kuzitesha agaciro batitaye ku mwihariko w'uburyo icyaha cya Jenocide cyakozwemo.

Ku bijyanye n'ihame ryo kudakorerwa ivangura no kureshya imbere y'amategeko ryasuzumwe muri uru rubanza hagaragajwe ko gufata abantu mu buryo butandukanye bikozwe hari impamvu igaragara kandi yumvikana binagamije intego yemewe, bigakorwa mu buryo bufitanye isano n'ikigamijwe kugerwaho, byemewe.

Urukiko rwasanze abakurikiranyweho icyaha cya Jenocide n'ibindi byaha byibasiye inyokomuntu barashyizwe mu cyiciro cyihariye bashyirirwaho n'Inkiko zihariye zababuranishije mu buryo bwihariye hakurikijwe intego yari igamijwe kugerwaho. Kuba rero mu miburanire yabo itandukanye n'iy'abakurikiranwaho ibyaha bisanzwe hari ibyo batemerewe byemererwa abandi bitewe n'uburyo icyaha cya Jenocide bakurikiranyweho cyakozwemo, Urukiko rwasanze atari ivangura ribakorerwa cyangwa kutareshya n'abandi imbere y'amategeko kubera ko bagize icyiciro cyihariye, rwanzura ko igika cya 4 cy'ingingo ya 197 y'Itegeko N° 027/2019 ryavuzwe haruguru kitanyuranyije n'ingingo ya 15 n'iya 16 z'Itegeko Nshinga.

Asobanura ko uru rubanza rwari rushingiye ku cyemezo cya ICTR (*International Criminal Tribunal for Rwanda*) cyo kohereza Uwinkindi Jean ngo akurikiranwe n'inkiko zo mu Rwanda, aho yagombaga kuburanishwa n'Urukiko Rukuru ku rwego rwa mbere hashingiwe ku ngingo ya mbere y'Itegeko N° 11/2007 ryo ku wa 16/03/2007 rigena kwimurira muri Repubulika y'u Rwanda imanza zivuye mu Rukiko Mpanabyaha Mpuzamahanga rwashyirwaho u Rwanda. Uwinkindi Jean yahise aregera Urukiko rw'Ikirenga arusaba gukuraho iyo ngingo kuko inyuranyije n'Itegeko Nshinga, aho yavugaga ko ituma habaho ivangura igatuma aburanishwa n'Urukiko Rukuru ku rwego rwa mbere, bityo ntagire uburenganzira abandi bafite bwo kujurira.

Urukiko rwabivuze muri aya magambo: gushyira abantu mu byiciro ntabwo ari ukubavangura cyane cyane iyo ibyo byiciro byashyizweho hagamiywe kugera ku ntego yumvikana, igaragarira buri wese, ishingiyeye ku mategeko kandi ibyashyirwaho bikaba bifite ireme mu nyungu rusange.

[18] Asobanura ko iby'uko itegeko rishobora kuvangura abantu kandi byanavuzweho n'Akanama k'Umuryango w'Abibumbye Gashinzwe iyubahirizwa ry'Uburenganzira bwa Muntu (*United Nations Human Rights Committee*) mu mwanzuro kafashe mu nama yako ya 37, nako kavuze ku by'uko itegeko rishobora kuvangura abantu, aho kagize kati “...*the committee observes that not every differentiation of treatment will constitute discrimination, if the criteria for such differentiation are reasonable and objective and if the aim is to achieve a purpose which is legitimate under the covenant*”.

[19] Avuga ko asanga ariko ibiteganywa mu gika cya 4 cy'ingingo ya 197 y'Itegeko N° 027/2019 ryo ku wa 19/09/2019 ryavuzwe haruguru bidashobora kubonerwa ibisobanuro (*justification*) kuko nta mpamvu n'imwe yatuma akarengane ka bamwe gasuzumwa n'inkiko hanyuma ak'abandi ntigasuzumwe.

[20] Akomeza asobanura kandi ko ku byerekeranye n’uburenganzira bwo kureshya imbere y’amategeko no kurengerwa kimwe na yo, n’ibihugu by’amahanga bifite icyo bibuvugaho. Urugero atanga ni muri Canada, aho itegeko ryerekeye uburenganzira bwa muntu (*Canadian Charter of Rights and Freedoms*) riteganywa mu cyiciro (*Section*) cya 15(1) ko abantu bose bareshya imbere y’amategeko kandi itegeko ribarengera kimwe nta vangura. Avuga ko mu gusobanura icyo uku kureshya imbere y’amategeko no kurengerwa kimwe bivugwa, Urukiko rw’Ikirenga rwa Canada mu rubanza “*Andrews v. Law Society of British Columbia*”, rwashimangiye ko nk’ihame, imvugo kurengerwa kimwe yumvikanisha ko abari mu mimerere imwe bagomba gufatwa kimwe.

Avuga ko rwabivuze muri aya magambo: “*Discrimination is a distinction which, whether intentional or not but based on grounds relating to personal characteristics of the individual or group, has an effect which withholds or limits access to advantages available to other members of society.*”

[28] Yongeraho ko byari ngombwa ko icyo gika kibaho, kubera ko gusubirishamo ingingo nshya imanza zaciwe n'Inkiko Gacaca ku mpamvu ibonetse yose byaba ari ugutesha agaciro umurimo wakozwe n'izo nkiko, bikaba byahembera umwiryane mu banyarwanda, kubera ko hari ahagiye hagaragara akagambane mu manza zaciwe n'izo nkiko kugira ngo zisubirishwemo ingingo nshya mu nkiko zisanzwe hagamijwe gusa kurekura abo zakatiye.

[29] Akomeza asobanura ko impamvu y'igika cya 4 cy'ingingo ya 197 y'Itegeko N° 027/2019 ryavuzwe haruguru urega asaba ko cyakurwaho, ari uko mu gihe cy'Inkiko Gacaca, hagiye hagaragara ubwumvikane hagati y'abahamwe n'icyaha cya jenocide, umuntu ubona ko ashinjwa kwica abantu benshi akishyiraho n'undi atishe agamije kugira uwo ahishira. Avuga ko iyo usesenguye uburyo icyaha cya jenocide cyakorwagamo, usanga urupfu rw'umuntu umwe rwaragizwemo uruhare n'abantu benshi, nk'aho nk'umuntu wagaragayeho igikorwa cyo kujya kuri bariyeri, bigoye kumenya umubare w'abantu bayiciweho, cyangwa mu gihe ahamwe n'icyaha cyo gushishikariza abantu kwica, kugambanira abishwe cyangwa kujya mu gitero, usanga urupfu rw'uwishwe muri icyo gihe rufitwemo uruhare n'abantu benshi kuko bose ibyo bakoraga byabaga bigambiriye ko yicwa. [33] Ingingo ya 15 y'Itegeko Nshinga rya Repulika y'u Rwanda iteganya ko abantu bose bareshya imbere y'amategeko, ko itegeko ribarengera ku buryo bumwe, naho iya 16 yaryo igateganya ko ivangura iryo ariryo ryose cyangwa kurikwirakwiza byaba bishingiye ku bwoko, ku muryango cyangwa ku gisekuru, ku nzu, ku ibara ry'umubiri, ku gitsina, ku karere, ku byiciro by'ubukungu, ku idini cyangwa ukwemera, ku bitekerezo, ku mutungo, ku itandukaniro ry'umuco, ku rurimi, ku

bukungu, ku bumuga bw'umubiri cyangwa ubwo mu mutwe no ku rindi vangura iryo ari ryo ryose, bibujijwe kandi bihanwa n'amategeko.

[34] Ingingo ya 197 y'Itegeko N° 027/2019 ryo ku wa 19/09/2019 ryerekeye imiburanishirize y'imanza z'inshinjabyaha, igika cyayo cya 4, ari nacyo urega asaba ko cyakurwaho avuga ko kinyuranye n'ingingo ya 15 n'ya 16 z'Itegeko Nshinga, iteganya ko ku bijyanye n'imanza zaciwe n'Inkiko Gacaca, gusubirishamo urubanza ingingo nshya byemerwa gusa iyo uwakatiwe urubanza yerekanye ko uwo yashinjwaga kwica akiriho. Ibi bikaba bisobanuye ko izindi mpamvu zose ziteganywa n'iyi ngingo² zitemewe mu gusubirishamo ingingo nshya ku wakatiwe n'Inkiko Gacaca.

[35] Ihame ryo kureshya imbere y'amategeko no kudakorerwa ivangura, si mu Itegeko Nshinga ry'u Rwanda turisanga gusa, rigaragara no mu Masezerano Mpuzamahanga u Rwanda rwashyizeho umukono. Twavugaga nk'ingingo ya 7 y'Itangazo ry'Umuryango w'Abibumbye ku burenganzira bwa muntu (*Universal Declaration of Human Rights*), ryo mu mwaka wa 1948, igira iti: *"All are equal before the law and are entitled without any discrimination to equal protection of the law. All are entitled to equal protection against discrimination in violation of this Declaration and against any incitement to such discrimination"*. Hari kandi n'ingingo ya 26 y'Amasezerano Mpuzamahanga arebana n'uburenganzira mu by'imbonezamubano no mu bya Politiki (*International Covenant on Civil and Political Rights, 1966*) igira iti: *"All persons are equal before the law and are entitled without any discrimination to equal protection of the law. In this respect, the law shall prohibit any discrimination and guarantee to all persons equal and effective protection against discrimination on any ground such as race, colour, language, religion, political or other opinion, national or social origin, property, birth or other status"*.

[36] Ibirebana n'uburyo ingingo ya 15 n'ya 16 z'Itegeko Nshinga zigomba kumvikana, uru Rukiko rwabisobanuye mu rubanza RS/SPEC/0001/16/CS rwaciwe ku itariki ya 23/09/2016³. Urukiko rwavuze ko ingingo ya 15 n'ya 16 z'Itegeko Nshinga zifitanye isano ku buryo utasobanura icyo zishatse kuvuga uzitandukanyije. Rwasobanuye ko ingingo ya 15 ivuga ko abantu bose bareshya imbere y'amategeko kandi bakarengerwa n'amategeko mu buryo bumwe, bisobanuye ko hatagomba kubaho ivangura rituma abantu batarengerwa mu buryo bumwe cyangwa kutagira uburenganzira aho bakabugize, ingingo ya 16 igakomerezaho ivuga uburyo gutandukanya abantu bifatwa nk'ivangura kandi ko bitemewe n'Itegeko Nshinga. Izi ngingo zombi zafatwa nk'izikubiyemo ihame rimwe ryo kudasumbanya abantu mu byo bemerewe cyangwa babujijwe ugamije kugira abo uheza ku burenganzira bemererwa n'amategeko. Ibi kandi uru Rukiko rwongeye kubishimangira mu rubanza RS/INCONST/SPEC 00004/2021/SC⁴.

[37] Nk'uko bimaze kugaragazwa haruguru, ihame ry'uko abantu bareshya imbere y'amategeko rivuze ko abantu bafatwa kimwe imbere y'itegeko, nta busumbane cyangwa ivangura, ndetse

n'itegeko rigiyeho rikaba rigomba gufata kimwe abo rireba. Iryo hame ariko rishobora kugira irengayobora (*exception*) igihe hari impamvu zumvikana zishingiye ku ntego ifite ireme (*legitimate or rational purpose*) nk'uko n'uwatanze ikirego abyemera, ibi bikaba byarashimangiwe n'uru Rukiko mu rubanza RS/INCONST/SPEC 00001/ 2019/SC rwaciye ku itariki ya 29/11/2019⁵. Muri urwo rubanza, Urukiko rushingiye ku byavuzwe n'umuhanga mu mategeko Erwin Hemerinsky, rwasobanuye ko ibigomba gufatwa kimwe ari ibimeze kimwe, naho ibintu bitandukanye bigafatwa ku buryo butandukanye hakurikijwe itandukaniro ryabyo (*Things that are alike should be treated alike, and things that are unlike should be treated unlike in proportion to their unalikehood*). Mu yandi magambo, abantu bagomba gufatwa kimwe, ariko hitawe ku byiciro byabo, ku buryo abantu bari mu byiciro bitandukanye batafatwa kimwe.

[38] Iri hame ry'uko kugira ngo byitwe ko hari ivangura cyangwa ukutashyeshya abantu ari uko abantu bari mu cyiciro kimwe baba bafashwe mu buryo butandukanye kandi nta mpamvu yumvikana, ryanagarutsweho mu rubanza rwa Thlimmenos v. Greece rwaciye n'Urukiko rw'Ibihugu by'Iburayi rushinzwe kurengera Uburenganzira bwa Muntu (*European Court of Human Rights*), aho rwavuze ko kugira ngo bifatwe ko igihugu cyarenze ku ngingo ya 14 y'Amasezerano ibuzwa ivangura⁶, ari uko kiba cyafashe mu buryo butandukanye abantu bari mu byiciro bimwe kandi nta mpamvu yumvikana gitanga. Rwabivuze muri aya magambo mu rurimi rw'icyongereza: "*The Court has so far considered that the right under Article 14 not to be discriminated against in the enjoyment of the rights guaranteed under the Convention is violated when States treat differently persons in analogous situations without providing an objective and reasonable justification*".⁷

[39] Mu rubanza rwa Carson and Others v. The United Kingdom, Urukiko rw'Ibihugu by'Iburayi rushinzwe kurengera Uburenganzira bwa Muntu, rushingiye ku zindi manza rwaciye, rwemeje ko gutandukanya abantu bihura n'igisobanuro cy'ingingo ya 14, ari mu gihe uko kutabafata kimwe biba bishingiye ku bintu runaka bibaranga. Byongeye kandi, kugira ngo bifatwe nk'ivangura, ni uko abo bantu badafashwe kimwe baba bari mu cyiciro kimwe, kandi bigakorwa nta ntego yumvikana ihari cyangwa nta sano iri hagati y'uko gutandukanya abantu n'ikigamijwe. Rwabivuze muri aya magambo mu rurimi rw'icyongereza: "*The Court has established in its case-law that only differences in treatment based on an identifiable characteristic, or "status", are capable of amounting to discrimination within the meaning of Article 14. Moreover, in order for an issue to arise under Article 14 there must be a difference in the treatment of persons in analogous, or relevantly similar, situations. Such a difference in treatment is discriminatory if it has no objective and reasonable justification; in other words, if it does not pursue a legitimate aim or if there is not a reasonable relationship of proportionality between the means employed and the aim sought to be realised. [...]*"⁸

[40] Nanone mu rubanza rwa Inze vs Austria, urwo Rukiko rwemeje ko ku birebana n'ingingo ya 14, byitwa ivangura, iyo gufata abantu mu buryo butandukanye bikozwe nta mpamvu ihari igaragara kandi yumvikana nta n'itegeko yemewe igamijwe cyangwa bigakorwa mu buryo budafitanye isano n'ikigamijwe kugerwaho. Rwavuze ko ibihugu bifite uburenganzira bwo gusesengura igihe ari ngombwa kudafata abantu kimwe mu itegeko, ibyo bigakorwa hitawe ku mateka yabyo. Rwabivuze muri aya magambo mu rurimi rw'icyongereza: "*For the purposes of Article 14, a difference of treatment is discriminatory if it "has no objective and reasonable justification", that is, if it does not pursue a "legitimate aim" or if there is not a "reasonable relationship of proportionality between the means employed and the aim sought to be realised". The Contracting States enjoy a certain margin of appreciation in assessing whether and to what extent differences in otherwise similar situations justify a*

A differentiation based on reasonable and objective criteria does not amount to prohibited discrimination within the meaning of article 26).*”¹⁰

Nk’uko byasobanuwe haruguru, iyo ngingo isobanura ko ku bakatiwe n’Inkiko Gacaca, gusubirishamo urubanza ingingo nshya byemerwa gusa iyo uwakatiwe urubanza yerekanye ko uwo yashinjwaga kwica akiriho, naho ku bakatiwe n’izindi nkiko hakaba hari izindi mpamvu ziteganyijwe muri iyo ngingo zishobora gutuma basaba gusubirishamo imanza zabo ingingo nshya.¹¹

Icyiciro uwatanze ikirego avuga ko cyakorewe ivangura ndetse akanongeraho ko hatabayeho gufatwa kimwe imbere y’amategeko, ni icy’abantu baburanishijwe bagakatiwe n’Inkiko Gacaca ukigereranyije n’icy’abakatiwe n’inkiko zisanzwe. itandukanye n'iy'inkiko zisanzwe. Nyuma yo guhagarika Jenoside yakorwe Abatutsi mu mwaka wa 1994 igahitana abarenga miliyoni, kimwe mu bibazo byagombaga gushakirwa ibisubizo kandi mu buryo bwihutirwa, cyari icyo guca imanza z'abakekwagaho kuyigiramo uruhare kugira ngo abayirokotse babone ubutabera. [45] Nubwo Guverinoma y'u Rwanda yari yarakoze umurimo ukomeye kugira ngo imanza zirebana na Jenoside yakorewe Abatutsi zicibwe, byagaragaye ko ku muvuduko imanza zacibwagaho icyo gihe, byari kuzatwara imyaka myinshi kugira ngo nibura haburanishwe gusa abari bakurikiranywe bafunze, hatirengagijwe ko hari n'abandi bari batarafatwa¹³. Ni muri rwo rwego byabaye ngombwa gushaka bundi buryo budasanzwe hagamijwe gukemura icyo kibazo, Inkiko Gacaca zivuka ubwo zifite imikorere yihariye itandukanye n'iy'inkiko zisanzwe kubera ko nazo zari zije zigamije gukemura ikibazo kidasanzwe¹⁴.

[46] Harebwe irangashingiro ry'Itegeko Ngenga n° 16/2004 ryo ku wa 19/06/2004 ryagenaga imiterere, ububasha n'imikorere by'Inkiko Gacaca zari zishinzwe gukurikirana no gucirwa imanza abakoze ibyaha bya Jenoside n'ibindi byaha byibasiye inyoko muntu byakozwe hagati y'itariki ya mbere Ukwakira 1990 n'ya 31 Ukuboza 1994¹⁵, izo nkiko zari zifite intego zikurikirana:

- Kugaragaza ukuri kuri Jenoside;
- Kwihutisha imanza za Jenoside;
- Guca umuco wo kudahana;
- Gushimangira ubumwe n'ubwiyunge bw'abanyawanda;
- Kugaragaza ubushobozi bw'umuryango nyarwanda mu kwikemurira ibibazo.

Kubera izo ntego umushingamategeko yari afite, byatumye abari bakurikiranyweho icyaha cya Jenoside n'ibindi byaha byibasiye inyokomuntu, abaremera icyiciro cyihariye, abashyiriraho n'uburyo bw'imiburanishirize bwihariye ugereranyije n'icyiciro cy'abakurikiranyweho ibyaha bisanzwe.

[47] Umwihariko w'Itegeko Ngenga ryashyiragaho Inkiko Gacaca ryavuzwe haruguru nk'uko ryagiye rihindurwa kandi rikuzuzwa urigereranyije n'andi mategeko ahana ibyaha ndetse n'ayerekeye imiburanishirize y'imanza z'inshinjabyaha, ni uko ryo ryasobanuraga ubwaryo imiterere (*organisation*), imikorere (*fonctionnement*) n'ububasha (*compétence*) by'Inkiko Gacaca, ibyaha n'ababakurikiranyweho ndetse n'ibihano biteganyijwe. Mu yandi magambo, mu guca imanza zari mu bubasha bwazo, Inkiko Gacaca zakurikije imiburanishirize (*procédure*) yihariye iteganywa n'Itegeko Ngenga ryazishyiragaho itandukanye n'imiburanishirize y'imanza zisanzwe.

[57] Me Batsinda Aline uhagarariye Leta y'u Rwanda, avuga ko uburenganzira ku butabera buboneye buteganywa n'ingingo ya 29 y'Itegeko Nshinga ntaho buhuriye n'ubwo Kamanzi Anaclet avuga ko yabujijwe, ari bwo burenganzira bwo kujurira n'ubwo gusubirishamo urubanza ingingo nshya. Avuga ko uburenganzira bwo kujurira n'ubwo gusubirishamo urubanza ingingo nshya yari abufite igihe yaburanaga mu Nkiko Gacaca nk'uko biteganyijwe mu Itegeko Ngenga N° 16/2004 ryo ku wa 19/06/2004 rigena imiterere, ububasha n'imikorere by'Inkiko Gacaca nk'uko ryagiye rivugururwa rikanuzuzwa n'Amategeko Ngenga atandukanye, ko kandi yabukoresheje igihe yaburanaga mu Nkiko Gacaca.

UKO URUKIKO RUBIBONA

[59] Ingingo ya 29 y'Itegeko Nshinga rya Repubulika y'u Rwanda igaragaza bimwe mu bigize ubutabera buboneye buri muntu wese afiteho uburenganzira. Ibyo ni ibi bikurikira:

- Uburenganzira bwo kumenyeshwa imiterere n'impamvu z'icyaha umuntu akurikiranyeho, kwiregura no kunganirwa;
- Gufatwa nk'umwere kugeza igihe urukiko rubifitiye ububasha rumuhamirije icyaha;
- Kuburanira imbere y'urukiko rubifitiye ububasha;

- Kudakurikiranwa, kudafatwa, kudafungwa cyangwa kudahanirwa ibyo yakoze cyangwa atakoze iyo amategeko y'Igihugu cyangwa amategeko mpuzamahanga atabifataga nk'icyaha igihe byakorwaga. Ibyaha n'ibihano bijyanye nabyo biteganywa n'amategeko;
- Kutaryozwa icyaha atakoze; uburyozwacyaha ni gatozi ku wakoze icyaha;
- Kudahanishwa igihano kiruta icyari giteganyijwe n'amategeko mu gihe yakoraga icyaha;
- Kudafungwa bitewe gusa no kutagira ubushobozi bwo kubahiriza inshingano ituruka ku masezerano;
- Kudakurikiranwa cyangwa kudahanirwa icyaha cyashaje. Icyakora icyaha cya jenocide, ibyaha byibasiye inyokomuntu n'ibyaha by'intambara ntibisaza. [...].

[60] Ku birebana n'ibigomba kubahirizwa mu rwego rwo gutanga ubutabera buboneye, uretse no mu Itegeko Nshinga, tubisanga no muri amwe mu masezerano mpuzamahanga akurikira:

- Amasezerano mpuzamahanga mu by'imbonezamubano na politiki (*Pacte international relatif aux droits civils et politiques*) aho ingingo ya 14 yayo irondera uburenganzira umuntu ukurikiranyweho icyaha agomba kuba afite;¹⁸
- Itangazo Mpuzamahanga rirebana n'uburenganzira bw'Ikiremnamuntu (*Universal Declaration of Human Rights*), aho ingingo ya 10 n'ya 11 zivuga ku burenganzira bw'ukekwa icyaha;¹⁹
- Amasezerano nyafurika ku burenganzira bwa Muntu n'ubw'Abaturage (*African Charter on Human and Peoples' Rights*) aho ingingo ya 7 yayo ivuga uburyo ukekwa icyaha agomba gufatwa;²⁰

[61] Mu gutanga igisobanuro cy'uburenganzira ku butabera buboneye, mu rubanza RS/INCONST/SPEC 00003/2019/SC²², Urukiko rw'Ikirenga rwabusobanuye mu buryo bubiri: ubutabera buboneye bushingiye ku biteganywa n'itegeko (*substantive due process*), n'ubutabera buboneye bushingiye ku migendekere y'urubanza (*procedural due process*). Ubutabera buboneye bushingiye ku biteganywa n'itegeko bubuza ishyirwaho ry'amategeko cyangwa izindi ngamba zidashyira mu gaciro zikanabangamira uburenganzira bw'abaturage nta mpamvu ihari igaragara, mu gihe ubutabera buboneye bushingiye ku migendekere y'urubanza bwo ari uruhererekane rw'ibigomba kubahirizwa mu migendekere yarwo hashingiwe ku mahame ateganywa n'amategeko cyangwa amasezerano mpuzamahanga. Ibi nibyo kandi byasobanuwe n'umuhanga mu mategeko Professor Erwin Chemerinsky muri aya magambo mu rurimi rw'icyongereza yifashishije urugero: "*Substantive due process asks the question of whether the government's deprivation of a person's life, liberty or property is justified by a sufficient purpose. Procedural due process, by contrast, asks whether the government has followed the proper procedures when it takes away life, liberty or property. Substantive due process looks to whether there is a sufficient substantive justification, a good enough reason for such a deprivation*".²³

[62] Harebwe uburyo uwatanze ikirego agisobanura, Urukiko rurasanga ikibazo kiri muri uru rubanza ari ukumenya niba igika cya 4 cy'ingingo ya 197 y'Itegeko N° 027/2019 ryo ku wa 19/09/2019 ryavuzwe haruguru, kibuzababari mu cyiciro cy'abakatiwe n'Inkiko Gacaca kubona ubutabera buboneye (*Substantive due process*) nk'uko uwagitanze abivuga. Mu yandi magambo, ni ukureba niba iki gika hari uburenganzira kibuzababari abakatiwe n'Inkiko Gacaca mu migendekere y'imanza zabo mu rwego rwo kubona ubutabera buboneye.

[63] Hakurikijwe kandi uburyo uwatanze ikirego agisobanura, Urukiko rurasanga ikindi kibazo afite gifitanye isano n'uburenganzira bwo kureshya cyangwa gufatwa kimwe imbere y'inkiko, kubera ko avuga ko igika anenga kibuzababari ubutabera buboneye ku bakatiwe n'Inkiko Gacaca ngo kuko abari muri icyo cyiciro bemererwa gusubirishamo imanza zabo ingingo nshya iyo berekanye gusa ko abo bashinjwaga kwica bakiriho, mu gihe abari mu cyiciro cy'abakatiwe n'inkiko zisanzwe bo hari izindi mpamvu ziteganyijwe muri icyo gicingiro zituma bashobora kubyemererwa.

[64] Kugira ngo itegeko cyangwa ingingo yaryo ibangamire ubutabera buboneye, harebwe igisobanuro cyatanzwe n'umuhanga mu mategeko Erwin Chemerinsky cyagarutsewe haruguru, Urukiko rurasanga riba rigomba gukuraho uburenganzira umuntu yari afite nk'uko bwatanzwe

(a) the right to an appeal to competent national organs against acts of violating his Fundamental rights as recognised and guaranteed by conventions, laws, regulations and customs in Force; (b) the right to be presumed innocent until proved guilty by a competent court or tribunal; (c) the right to defence, including the right to be defended by counsel of his choice; (d) the right to be tried within a reasonable time by an impartial court or tribunal. 2. No one may be condemned for an act or omission which did not constitute a legally punishable offence at the time it was committed. No penalty may be inflicted for an offence for which no provision was made at the time it was committed. Punishment is personal and can be imposed only on the offender."

[65] Ku birebana n'igika cya 4 cy'ingingo 197 y'Itegeko N° 027/2019 ryo ku wa 19/09/2019 uwatanze ikirego anenga avuga ko hari abo kibuzwa ubutabera buboneye, harebwe ibigomba kubahirizwa ku muntu ukekwa icyaha mu rwego rw'imigendekere y'urubanza rwe, Urukiko rurasanga nta hantu na hamwe igika anenga kivuga ko hari ibyo abakatiwe n'Inkiko Gacaca batari bemerewe mu migendekere y'imanza zabo kugira ngo bahabwe ubutabera buboneye, cyangwa ko hari ibyo babujijwe nko gufatwa nk'umwere cyangwa se kutaryozwa icyaha batakoze nk'uko uwatanze ikirego abivuga.

[66] Ku birebana no gufatwa kimwe imbere y'inkiko, Urukiko rurasanga iki kibazo gisa n'icyasobanuwe haruguru ku birebana n'uburenganzira bwo kureshya imbere y'amategeko no kurindwa ivangura. Kureshya imbere y'inkiko bivuze ko abantu bari imbere y'inkiko zimwe bagomba kugira uburenganzira bumwe. Ibi bisobanuye ko abantu baburanira imbere y'inkiko zitandukanye, bitewe n'ubwoko bw'ibyaha bakurikiranyweho, atari ngombwa buri gihe ko bafatwa kimwe. Ibi ni nako byemejwe n'Akanama k'Umuryango w'Abibumbye gashinzwe iyubahirizwa ry'uburenganzira bwa muntu, ubwo kasobanuraga ingingo ya 14,1° y'Amasezerano mpuzamahanga mu by'imbonezamubano na politiki (*International covenant on civil and political rights*) kayihuza n'ubutabera buboneye. Kavuze ko kureshya imbere y'inkiko bigomba kumvikana ko ubwo burenganzira bureba abantu baburanira mu nkiko zimwe. Katanze urugero rw'uko hari ibyaha bidasanze biburanishwa mu buryo budasanze cyangwa bigashyirirwaho inkiko zidasanze, ariko ibyo bigakorwa kubera impamvu yumvikana. Kabivuze muri aya magambo mu rurimi rw'icyongereza: *"Equality before courts and tribunals also requires that similar cases are dealt with in similar proceedings. If, for example, exceptional criminal procedures or specially constituted courts or tribunals apply in the determination of certain categories of cases, objective and reasonable grounds must be provided to justify the distinction."*²⁴

[67] Nk'uko byasobanuwe haruguru mu ngingo irebana no kureshya imbere y'amategeko, Urukiko rurasanga kuba harashyirahwe Inkiko Gacaca zikaburanisha abakekwagaho kugira uruhare muri Jenocide n'ibindi byaha byibasiye inyokomuntu, icyo kikaba ari icyiciro cyihariye gitandukanye n'icy'abakurikiranyweho ibindi byaha baburanishwa n'inkiko zisanze, ibyo biremewe. Kuba hari ibyemerewe abari mu cyiciro kimwe ntibyemererwe abari mu kindi, ibyo ntibivuze ko nta butabera buboneye buba bwatanze, kubera ko buri cyiciro kigomba kurebwa ukwacyo bitewe n'urukiko rwakiburanishije hashingiwe no ku bwoko bw'ibyaha gikurikiranyweho.

[68] Nk'uko byasobanuwe haruguru, kuba umushingamategeko yarashyirahwe ibyiciro bibiri, icy'abakurikiranyweho ibyaha bya Jenocide n'ibindi byaha byibasiye inyokomuntu n'icy'abakurikiranyweho ibyaha bisanze, biremewe. Icyangombwa ni uko mu kubishyiraho hari hagamiywe intego yumvikana, kandi mu migendekere y'imanza zabo, uburenganzira bwose buteganywa n'amategeko bukaba bwarubahirijwe. Ibimaze kuvugwa bihura n'ibyemejwe n'Urukiko rw'Ibihugu by'Iburayi rushinzwe kurengera uburenganzira bwa muntu mu rubanza rwa Taxquet C. Belgique, aho rwasanze ibihugu bifite uburenganzira busesuye bwo guhitamo uburyo inkiko zabyo zubahiriza ibiteganywa n'ingingo ya 6²⁵. Rwasanze inshingano yarwo ari ukureba niba inzira igihugu cyafashe iganisha ku ntego itanyuranye n'amasezero ku burenganzira bwa muntu mu icibwa ry'urubanza runaka bitewe n'umwihariko warwo. Muri make, Urukiko rureba niba mu kuburanisha urubanza harubahirijwe ihame ry'ubutabera buboneye. Rwabivuze muri aya magambo mu rurimi rw'igifaransa: *"En effet, les Etats contractants jouissent d'une grande liberté dans le choix des moyens*

propres à permettre à leur système judiciaire de respecter les impératifs de l'article 6. La tâche de la Cour consiste à rechercher si la voie suivie a conduit, dans un litige déterminé, à des résultats compatibles avec la Convention, eu égard également aux circonstances spécifiques de l'affaire, à sa nature et à sa complexité. Bref, elle doit examiner si la procédure a revêtu, dans son ensemble, un caractère équitable.”²⁶
