

# MONGOLIA CLEARING AGENCY LTD v. SONARWA GENERAL INSURANCE COMPANY LTD

*Amategeko agenga imiburanishirize y'imanza z'ubucuruzi – Umusoro – Umusoro wa Gasutamu – Kumenyekanisha umusoro – Iyo ibicuruzwa bitageze aho byari byerekeje – Uwamenyekanishije umusoro afatwa nka nyir'ibicuruzwa akaryozwa imisoro n'amahoro nkaho ari we nyirabyo – East African Community Customs Management Act, 2004, Ingingo ya 147.*

**Incamake y'ikibazo:** Mongolia Clearing Agency Ltd yafashe ubwishingizi muri SONARWA ku makosa yakora mu kazi kayo ko gukora imenyekanisha ry'ibicuruzwa muri gasutamo. Nyuma iza kumenyekanisha ibicuruzwa by'uwitwa Rutanga Nasar bivugwa ko bigiye i Burundi, ariko biza kuburirwa irengero mu Rwanda. RRA ishingiye ku masezerano y'ubwishingizi ya Mongolia Clearing Agency Ltd, yasabye SONARWA kwishyura umusoro ungana na 63.937.780 Frw irawishyura, nyuma SONARWA isaba Mongolia Clearing Agency Ltd kuyiyasubiza irabyanga bituma iregera Urukiko rw'Ubucuruzi isaba gusubizwa amafaranga y'imisoro yishyuriye iyo sosiyete ku bw'amakosa yayo, inyungu zayo zibariye kuri 18% n'indishyi zitandukanye.

Urukiko rw'Ubucuruzi rwaciye urubanza rwemeza ko Mongolia Clearing Agency Ltd igomba kwishyura SONARWA 69.495.569Frw akubiyemo 63.934.780Frw y'umusoro wishyuwe, 4.710.789Frw y'inyungu, 500.000Frw y'igihembo cya Avoka, 300.000Frw y'ikurikiranarubanza na 50.000Frw y'ingwate y'amagarama y'urubanza.

Mongolia Clearing Agency Ltd yajuririye urwo rubanza mu Rukiko Rukuru rw'Ubucuruzi ivugako ikirego kitagombaga kwakirwa kuko SONARWA yareze uwo itagombaga kurega, kuko yagombaga kurega umushoferi wari utwaye ibicuruzwa byaburiwe irengero n'umukozi wa RRA kandi ko yihutiye kwishyura RRA kandi haragombaga kugeragezwa inzira y'ubwumvikane.

Urukiko Rukuru rw'Ubucuruzi rwaciye urubanza rwemeza ko ubujurire bwa Mongolia Clearing Agency Ltd nta shingiro bufite, rwemeza ko nta gihindutse ku mikirize y'urubanza rwajuririwe.

## **Urubanza**

### **I. IMITERERE Y'URUBANZA.**

[1] Mongolia Clearing Agency Ltd yafashe ubwishingizi muri SONARWA ku makosa yakora mu kazi kayo ko gukora imenyekanisha ry'ibicuruzwa muri gasutamo. Nyuma yaje kumenyekanisha ibicuruzwa by'uwitwa Rutanga Nasar bivugwa ko bigiye i Burundi, ariko biza kuburirwa irengero mu Rwanda. Ikigo cy'Igihugu gishinzwe imisoro n'amahoro, RRA muri uru rubanza, gishingiye ku masezerano y'ubwishingizi ya Mongolia Clearing Agency Ltd, cyasabye SONARWA kwishyura umusoro ungana na 63.937.780 Frw irawishyura, nyuma isaba Mongolia Clearing Agency Ltd kuyiyasubiza irabyanga bituma iregera Urukiko rw'Ubucuruzi isaba gusubizwa amafaranga y'imisoro yishyuriye iyo sosiyete ku bw'amakosa yayo, inyungu zayo zibariye kuri 18% n'indishyi zitandukanye.

[2] Mongolia Clearing Agency Ltd yatanze inzitizi ivuga ko Urukiko rw'Ubucuruzi rwaregewe nta bubasha rufite, ko hari kuregerwa Urukiko Rwisumbuye kubera ko ikiburanwa kidafite kamere y'ubucuruzi. Yasabye kandi ko Rutanga Nasar ndetse na Karuranga Marcel, umukozi wa RRA, bagobokeshwa mu rubanza kuko aribo bazi irengero ry'umuzigo. SONARWA yavuze ko Urukiko yaregeye rufite ububasha, kandi ko nta n'impamvu yo kugobokeshwa Rutanga Nasar na Karuranga Marcel kuko nta masezerano bafitanye.

[3] Ku itariki ya 21/12/2017, Urukiko rw'Ubucuruzi rwaciye urubanza rubanziriza urundi RCOM 01625/2017/TC/NYGE rwemeza ko inzitizi yatanzwe na Mongolia Clearing Agency Ltd nta shingiro ifite, ndetse ko nta n'impamvu zo kugobokeshwa Rutanga Nasar na Karuranga Marcel, rwemeza ko urubanza rukomeza mu mizi.

[4] Ku itariki ya 26/07/2018, Urukiko rwaciye urubanza mu mizi, rwemeza ko Mongolia Clearing Agency Ltd igomba kwishyura SONARWA 69.495.569 Frw akubiyemo 63.934.780 Frw y'umusoro wishyuwe, 4.710.789 Frw y'inyungu, 500.000 Frw y'igihembo cya Avoka, 300.000 Frw y'ikurikiranarubanza na 50.000 Frw y'ingwate y'amagarama y'urubanza.

[5] Mongolia Clearing Agency Ltd yajuririye Urukiko Rukuru rw'Ubucuruzi ivuga ko SONARWA yareze uwo itagombaga kurega, ko yagombaga kurega umushoferi wari utwaye ibicuruzwa byaburiwe irengero n'umukozi wa RRA, bityo ko n'ikirego kitagombaga kwakirwa, ko kandi yihutiye kwishyura RRA, nyamara ingingo ya 220 ya *EAC Customs Management Act, 2004*, iteganya ko hagombaga kubanza kugeragezwa inzira y'ubwumvikane, ndetse ko Urukiko rwitiranyije amasezerano yakoranye na SONARWA n'ubwishingizi busanzwe (*caution*), bituma rwirengagiza *EAC Customs Management Act*.

[7] Ku itariki ya 11/06/2019, Urukiko rwaciye urubanza rwemeza ko ubujurire bwa Mongolia Clearing Agency Ltd nta shingiro bufite, rwemeza ko nta gihindutse ku mikirize y'urubanza rwajuririwe, rutegeka Mongolia Clearing Agency Ltd guha SONARWA 1.000.000Frw akubiyemo amafaranga y'igihembo cya Avoka n'ay'ikurikiranarubanza.

[8] Mu gufata icyo cyemezo, Urukiko rwashingiye ku mpamvu y'uko amakosa yo kumenyekanisha umusoro Mongolia Clearing Agency Ltd yakoreye mu kazi ariyo yatumye RRA iyaryoza SONARWA yari yarayishingiye kugira ngo iyishyurire uwo musoro nk'uko bari barabyumvikanyeho mu masezerano yo ku itariki ya 30/12/2014, ndetse no kuba amasezerano y'ubwishingizi izo sosiyete zombi zagiranye atagengwa n'amategeko agenga za gasutamo ku buryo na SONARWA yari kubanza gusaba ubwumvikane, ko ahubwo inshingano za SONARWA zari gusa kubahiriza amasezerano nk'uko biteganywa n'ingingo ya 64 y'Itegeko N° 45/2011 ryo ku wa 25/11/2011 rigenga amasezerano.

[9] Ku itariki ya 23/07/2019, Mongolia Clearing Agency Ltd yandikiye Perezida w'Urukiko rw'Ubujurire isaba ko urubanza RCOMA 00578/2018/CHC/HCC rwaciye n'Urukiko Rukuru rw'Ubucuruzi ku itariki ya 11/06/2019, rwasubirwamo ku mpamvu z'akarengane. Perezida w'Urukiko rw'Ubujurire amaze gusuzuma ubwo busabe, yandikiye Perezida w'Urukiko rw'Ikirenga asaba ko urwo rubanza rwasubirwamo, maze mu cyemezo 056/CJ/2023 cyo ku itariki ya 04/05/2023, yemeza ko rwongera kuburanishwa ruhabwa RS/INJUST/RCOM 00002/2023/SC.

[10] Mongolia Clearing Agency Ltd yasabye ko urubanza rwasubirwamo ku mpamvu z'akarengane ivuga ko Urukiko Rukuru rw'Ubucuruzi rwemeje ko igomba kwishyura umusoro nyamara itarigeze yemera ko yawunyereje nk'uko biteganywa n'ingingo ya 219 ya *EAC Customs Management Act, 2004*, iboneraho no gusaba indishyi zinyuranye. SONARWA yiregura ivuga ko hari icyemezo cya RRA cyishyura Mongolia Clearing Agency Ltd umusoro, ko inshingano zayo kwari ukwishyura ikimara guhabwa ibaruwa ya RRA yishyura, ko kubera icyo mpamvu nta n'indishyi igomba gutanga.

[11] Urubanza rwaburanishijwe mu ruhamwe ku itariki ya 17/10/2023, Mongolia Clearing Agency Ltd ihagarariwe na Me Cyiza Clément, SONARWA ihagarariwe na Me Nkurunziza Jean Pierre afatanyije na Me Bimenyimana Eric, ababuranyi bajya impaka ku kibazo cyo kumenya niba Mongolia Clearing Agency Ltd itaragombaga kuryozwa umusoro w'ibicuruzwa bya Rutanga Nasar byaburiwe irengero no kumenya niba indishyi zisabwa mu rubanza zatangwa. Iburanisha rishojwe, ababuranyi bamenyeshejwe ko urubanza ruzasomwa ku itariki ya 24/11/2023, ariko hagati aho umwe mu bacamanza bari bagize inteko ahindurirwa imirimo biba ngombwa ko iburanisha ripfundurwa kugira ngo inteko ihinduke, rishyirwa ku itariki ya 13/02/2024.

## II. IBIBAZO BIGIZE URUBANZA N'ISESENGURWA RYABYO.

□ **Kumenya niba Mongolia Clearing Agency Ltd itaragombaga kuryozwa umusoro w'ibicuruzwa bya Rutanga Nasar byaburiwe irengero.**

[13] Me Cyiza Clément uhagarariye Mongolia Clearing Agency Ltd avuga ko akarengane kari mu rubanza basabye ko rwasubirwamo, ari uko Urukiko Rukuru rw'Ubucuruzi rutubahirije ihame ku butabera buboneye buteganywa n'ingingo ya 29 y'Itegeko Nshinga, kubera ko rwemeje ko igomba kwishyura umusoro nyamara itarigeze yemera ko yawunyereje nk'uko biteganywa n'ingingo ya 219 ya *EAC Customs Management Act, 2004*. Asobanura ko inyandiko yujuje yitwa *statement of offence* idahamya ko yemeye ko yakoze icyaha cyo kunyereza umusoro ku bicuruzwa bya Rutanga Nasar, ko ahubwo irimo gukekeranya, hakaba haragombaga kuzuzwa *form* igaragaza ko yemera ko yanyereje umusoro. Avuga ko mu gihe Mongolia Clearing Agency Ltd itiyemereye icyaha, haragombaga kuregerwa Urukiko hashingiwe ku biteganywa n'ingingo ya 220 ya *EAC Customs Management Act, 2004*, akaba arirwo rwemeza ko yanyereje umusoro.

[14] Me Cyiza Clément asobanura kandi ko hasuzumwe ibikubiye mu ngingo ya 219 n'ya 220 za *EAC Customs Management Act*, izo ngingo zateganyije uburyo ibyaha byakorewe muri Gasutamo bihanwamo mu gihe uwakoze icyaha abyemera. Avuga ko ingingo ya 220 ivuga ko iyo uwakoze icyaha atacyemera, hakurikizwa inzira isanzwe yo gukurikirana icyaha. Ku bijyanye n'uru rubanza, avuga ko umukozi wa Gasutamo yakoze inyandikomvugo igaragaza amafaranga y'umusoro Mongolia Clearing Agency Ltd igomba gutanga kubera ibicuruzwa byari byaburiwe irengero, iyo nyandiko ikaba yaragombaga kwemezwa na Komiseri w'Imisoro.

[15] Me Cyiza Clément avuga ko umurongo watanze n'Urukiko rw'Ikirenga mu gika cya 13 cy'urubanza RCOMA 0047/10/CS rwaciwe n'Urukiko rw'Ikirenga ari uko, uretse igihe ukekwa kunyereza umusoro yabyiyemereye yuzuzwa inyandiko yabugenewe iteganywa n'ingingo ya 219 *EAC Customs Management Act, 2004*, ibyaha bya Gasutamo bikurikiranwa n'inkiko zibifitiye ububasha hakurikijwe ibiteganywa n'ingingo ya 220 y'iryo Tegeko.

[16] Akomeza asobanura ko muri urwo rubanza, Urukiko rw'Ikirenga rwasanze umusoresha nta burenganzira afite bwo kwishyura usora utemera icyaha, bivuze ko icyemezo cy'Urukiko Rukuru rw'Ubucuruzi kinyuranyije n'uwo murongo nyamara inkiko zigomba kubahiriza imirongo yashyizweho. Asoza avuga ko Mongolia Clearing Agency Ltd yamenyesheje SONARWA ko nta makosa yakoze ndetse ko nta n'icyaha yigeze yemera cyangwa ngo icyemezwe, bityo ko itagombaga kwishyura imisoro, kuba yarabirenzeho ikayishyura ikaba igomba kwirengera ingaruka zabyo ku giti cyayo.

[17] Me Bimenyimana Eric na Me Nkurunziza Jean Pierre bahagarariye SONARWA bavuga ko hari icyemezo cya RRA cyishyura Mongolia Clearing Agency Ltd umusoro, ko inshingano za SONARWA kwari ukwishyura ikimara guhabwa ibaruwa ya RRA yishyura. Basobanura ko ntawundi wanyozwa

imisoro uretse uwo yaciwe, ko mu gihe Mongolia Clearing Agency Ltd ibona ko hari abatumye yishyuzwa amafaranga ku maherere, yazabikurikiranira kubera ko SONARWA nta masezerano ifitanye nabo.

[18] Me Bimenyimana Eric na Me Nkurunziza Jean Pierre bakomeje bavuga ko SONARWA itari kubura kwishyura kandi ku itariki ya 31/10/2016, Mongolia Clearing Agency Ltd yarayandikiye iyimenyeshya ko iri gukora ibishoboka ngo abagize uruhare mu ikorwa ry'icyaha bamenyekane, ko amasezerano bafitanye azarangira ikibazo cyaracyemutse, ariko ko hagati aho nta bushobozi ifite bwo kwishyura umusoro yaciwe.

[19] Bakomeza basobanura ko Mongolia Clearing Agency Ltd itagaragaza mu masezerano yakoranye na SONARWA cyangwa mu mategeko icyari kuyibuza kwishyura umusoro mu gihe yamenyeshejwe ko igomba kwishyura ku bw'amakosa cyangwa icyaha cyakozwe n'uwo yishingiye, ko ubusanze, iyo wishyuzwa umusoro utemera, hari inzira (*procedures*) zikurikizwa, SONARWA akaba atariyo yagombaga kuzitangira, ko ahubwo ari Mongolia Clearing Agency Ltd yagombaga kuzikurikiza, RRA ikabisuzuma yasanga ari ukuri, uwo musoro ugakurwaho. Bavuga ko kugeza ubu Mongolia Clearing Agency Ltd itigeze yiyambaza iyo nzira ndetse ko itigeze inaregera inkiko ngo igaragaze ko yaciwe umusoro mu buryo bunyuranyije n'amategeko.

[20] Ku bivugwa na Mongolia Clearing Agency Ltd ko SONARWA itagombaga kwishyura umusoro n'ihazabu yaciwe na RRA kandi itaremeraga icyaha, abavoka bayihagarariye bavuga ko ntacyari kuyibuza kwishyura mu gihe amakosa ya Mongolia Clearing Agency Ltd yari yamaze kwemezwa n'urwego rubifitiye ububasha, kandi ibyo akaba aribyo yari yarishingiye.

## **UKO URUKIKO RUBIBONA**

[21] Impande zombi muri uru rubanza, zemeranya ko ku itariki ya 19/02/2015, umukozi wa Mongolia Clearing Agency Ltd yamenyekanishije ibicuruzwa by'umucuruzi Rutanga Nasar byari byerekeje i Burundi, ariko imodoka yari ibitwaye ikaza kuburirwa irengero itarambuka umupaka ngo igere aho yajyaga, ibi bikaba byaratumye ku itariki ya 20/03/2015, Komiseri wa Gasutamo, ashingiye ku ngingo ya 147 ya *East African Community Customs Management Act, 2004*, aca Mongolia Clearing Agency Ltd umusoro wanyerejwe n'ibihano ungana na 63.934.780 Frw. icyo ababuranyi batumvikanaho, ni uko SONARWA yishyuye uwo musoro mu mwanya wa Mongolia Clearing Agency Ltd, ikavuga ko yabikoze ishingiyeye ku masezerano y'ubwishingizi bagiranye, ikaba isaba kuyasubizwa hashingiwe kuri ayo masezerano, Mongolia Clearing Agency Ltd ariko yo ikavuga ko ntayo igomba kuyisubiza kuko itagombaga kuyishyura kubera ko itari yemeye icyaha yashinjwaga na RRA.

[22] Ingingo ya 64 y'Itegeko N° 45/2011 ryo ku wa 25/11/2011 rigenga amasezerano, iteganya ko amasezerano akozwe ku buryo bukurikije amategeko aba itegeko ku bayagiranye. Ashobora guseswa ari uko babyumvikanyeho cyangwa ku mpamvu zemewe n'amategeko. Agomba kubahirizwa nta buriganya.

[23] Ingingo ya 147 ya *East African Community Customs Management Act, 2004*, iteganya ko iyo hakozwe amakosa atuma ibicuruzwa bitagera aho byari byerekeje, uwamenyekanishije umusoro afatwa nka nyir'ibicuruzwa akaryozwa imisoro n'amahoro nkaho ari we nyirabyo (*A duly authorised agent who performs any act on behalf of the owner of any goods shall, for the purposes of this Act, be deemed to be the owner of such goods, and shall, accordingly, be personally liable for the payment of any duties to*

*which the goods are liable and for the performance of all acts in respect of the goods which the owner is required to perform under this Act: Provided that nothing herein contained shall relieve the owner of such goods from such liability).*

[24] Ingingo ya 109, igika cya mbere, y'Itegeko rimaze kuvugwa, iteganya ko iyo ibiteganyijwe mu masezerano y'ubwishingizi bitubahirijwe, Komiseri ashobora gusaba mu nyandiko uwatanze ubwishingizi kwishyura amafaranga yishingiwe mu gihe kitarenze iminsi cumi n'ine guhera umunsi aboneyeho inyandiko imwishyura, atabikora muri icyo gihe, Komiseri akaba yakwishyura ayo mafaranga nk'umwenda utarishyurwa (*Where the conditions of any bond have not been complied with the Commissioner may by notice in writing require the person who has given security under it to pay to him or her the amount of the security within fourteen days of the notice; and on failure to comply with the notice, the Commissioner may enforce payment of the security as though it were duty due and unpaid).*

[25] Inyandiko zigize dosiye y'urubanza zigaragaza ko ku itariki ya 30/12/2014, Mongolia Clearing Agency Ltd yagiranye na SONARWA amasezerano y'ubwishingizi mu bya gasutamo (*Custom Bond Guarantee n° 13801*) yagombaga gutangira ku itariki ya 01/01/2015 akarangira ku ya 31/12/2015, bemeranya ibintu bikurikira :

- i. Mongolia Clearing Agency Ltd yemeye ko ishinganiye kuri Komiseri wa gasutamo 100.000.000 Frw ku birebana n'ibicuruzwa binyura mu Rwanda bijya hanze, na 50.000.000 Frw ku bicuruzwa bigarukira mu gihugu, ayo mafaranga akazishyurwa mu gihe yaba itujuje inshingano zayo neza nk'umuntu ushinze kumenyekanisha ibicuruzwa (*Hereby acknowledge that we are bound to the commissioner of customs the sum of 150.000.000 of which 100.000.000 for transit operations and 50.000.000 for customs operations to be paid to the commissioner upon failure to discharge our obligations as customs agents).*
- ii. Mongolia Clearing Agency Ltd yiyemeje kandi kuzarangiza neza uko bikwiye inshingano zayo mu buryo bunogeye Komiseri wa gasutamo. (*...Shall faithfully perform our duties as customs agents to the satisfaction of the commissioner of customs).*
- iii. Mongolia Clearing Agency Ltd na SONARWA biyemeje kuzubahiriza amategeko yose agenga imisoro ku birebana n'ibicuruzwa binyura muri gasutamo kuva ku itariki ya 01/01/2015 kugeza ku ya 31/12/2015. (*We, the principal and the surety understand that the condition of this obligation is that I/we shall comply with all relevant provisions of Customs law in relation to goods under customs control for the period starting from 01/01/2015 to 31/12/2015).*
- iv. SONARWA yiyemeje kwishyura ubuyobozi bwa gasutamo mu gihe kitarenze iminsi cumi n'itanu (15) yakiriye urwandiko ruyishyura amafaranga yishingiwe. (*SONARWA undertakes to pay the amount guaranteed to Customs Administration within*

*Fifteen days after reception of a letter from Customs requiring them to pay the amount guaranteed).*
