Icyakora, iyo nyandiko ishobora kuba yihagije ubwayo, mu gihe yakozwe hashingiwe ku buhamya bwatangiwe mu nteko y'abaturage y'aho aba.

Incamake y'ikibazo: Niyonsaba wari utwaye igare ava Nyabugogo yerekeza mu Gatsata yagonzwe n'imodoka ifite ubwishingizi bwa Radiant Insurance Company Ltd (Radiant) ahita apfa. Abamukomokaho barimo n'umubyeyi we witwa Mukabera begereye umwishingizi basaba indishyi ariko ntibabasha kumvikana batanga ikirego mu Rukiko Rwisumbuye rwa Gasabo basaba indishyi, Urukiko rubagenera indshyi zitandukanye zirimo n'indishyi mbangamirabukangu zahawe Mukabera.

Radiant ntiyishimiye imikirize y'urwo rubanza irujuririra mu Rukiko Rukuru ivuga ko hatanzwe indishyi mbangamirabukungu kandi nyakwigendera nta bantu yari atunze ndetse n'umubyeyi we atabashije kugaragaza ibimenyetso bifatika byerekana ko yari atunzwe na nyakwigendera. Urukiko Rukuru rwaciye urubanza rwemeje ko nta gihindutse ku rubanza rwajuririwe. Radiant yaje kujya mu nzira z'akarengane maze urwo rubanza ruhabwa Urukiko rw'Ikirenga rwongera kuruburanisha hasuzumwa ikibazo cyo kumenya niba Mukabera yagenerwa indishyi z'ibangamirabukungu.

Radiant isobanura ko inshingano y'uko abana bagomba gufasha ababyeyi babo atari itegeko ahubwo ko babafasha mu gihe batishobpye andi bamaze kugaragaza ko bakeneye ubwo bufasha. Ikomeza ivuga ko kuri Mukabera atabashije kugaragaza ko yari atunzwe na Niyonsaba kuko n'icyemezo yatanze cy'umudugudu kidafite ibindi bimenyetso bigaragaza ko yari atunzwe na nyakwigendera.

Mukabera we avuga ko nyakwigendera yari afaite umurimo uzwi wo kunyonga igare ko ibyo byamuhaga ubushobozi bwo kubasha gutanga ibitunga umubyeyi we. [1] Ku wa 15/09/2020, Niyonsaba Daniel wari utwaye igare mu muhanda Nyabugogo – Gatsata, yagonzwe n'imodoka ya Fuso Mitsubishi RAD 627S ajyanwa ku bitaro bya CHUK, ku wa 21/09/2020 arapfa; iyo modoka ikaba yari ifite ubwishingizi muri RADIANT INSURANCE COMPANY Ltd (RADIANT muri uru rubanza). Mukabera Françine nyina wa nyakwigendera n'abavandimwe be bane (4) basabye RADIANT kubaha indishyi mu bwumvikane, ntibashobora kumvikana, bituma bayirega mu Rukiko Rwisumbuye rwa Gasabo. Mukabera Françine yasabaga guhabwa indishyi z'akababaro zingana na 1.080.000 Frw, indishyi z'ibangamirabukungu zingana na 7.807.229 Frw, n'amafaranga anyuranye yakoresheje kwa muganga no mu gikorwa cyo gushyingura. Buri muvandimwe wa nyakwigendera yasabaga guhabwa 540.000 Frw.

[2] RADIANT yireguye ivuga ko indishyi z'akababaro zisabwa ari umurengera, ko nta ndishyi z'ibangamirabukungu zatangwa kuko nta bimenyetso bifatika bigaragaza ko ari nyakwigendera wari utunze umubyeyi we, kandi ko n' icyemezo kivuga ko nyakwigendera yari umunyonzi nta gaciro cyahabwa kuko kitatanzwe n'ishyirahamwe ry'abanyonzi yakoreragamo. Ku bijyanye n'amafaranga yakoreshejwe, RADIANT yavuze ko yemera kwishyura 9.200 Frw yishyuwe ibitaro, 12.000 Frw yaguze ibyangombwa, na 200.000 Frw yakoreshejwe mu gushyingura; naho andi ikaba itemera kuyatanga kuko nta bimenyetso bigaragaza ko yatanzwe.

[3] Ku wa 07/10/2021, Urukiko Rwisumbuye rwa Gasabo rwaciye urubanza N° RC 00006/2021/TGI/GSBO, rutegeka RADIANT guha Mukabera Françine 7.264.574 Frw y'indishyi z'ibangamirabukungu na 810.000 Frw y'indishyi z'akababaro; igaha na buri muvandimwe wa nyakwigendera 540.000 Frw y'indishyi z'akababaro. Rwayitegetse kandi gutanga amafaranga yakoreshejwe harimo 9.200 Frw yishyuwe ibitaro, 200.000 Frw yakoreshejwe mu ishyingura,

8.500 Frw yaguze dosiye y'impanuka (P.V.de constat) na 12.000 Frw yakoreshejwe mu gushaka ibyangombwa.

[4] RADIANT yajuririye Urukiko Rukuru, ivuga ko Urukiko rwageneye Mukabera Françine indishyi z'ibangamirabukungu kandi nyakwigendera yari ingaragu, nta n'ibimenyetso bifatika bigaragaza ko ari we wari umutunze mu buryo buhoraho. Urukiko Rukuru rwaciye urubanza No RCA 00286/2021/HC/KIG ku wa 30/09/2022, rwemeza ko nta gihindutse ku rubanza rwajuririwe.

[5] Urukiko Rukuru rwasobanuye ko inshingano yo guhana ibibatunga ku mwana n'umubyeyi, igihe umwe muri bo abikeneye, ishingiye ku mategeko bikaba bidasabirwa ikimenyetso; bikaba bitanasaba ko usabwa gutanga ibitunga undi aba afite ubushoboziburenze ubw'ugenerwa inshingano. Kuba rero nyakwigendera yari afite umurimo ushobora kumufasha kubahiriza iyo nshingano, RADIANT ntigaragaza ikimenyetso cyari cyarayimukuyeho, kandi ariwe mwana yari asigaranye mu rugo.

Perezida w'Urukiko rw'Ubujurire amaze gusuzuma ubwo busabe, yohereje Perezida w'Urukiko rw'Ikirenga raporo yarukozeho, maze nawe amaze kubisuzuma yemeza ko urwo rubanza rwongera kuburanishwa, ruhabwa N° RS/INJUST/RC 00005/2023/SC.

[7] Urubanza rwaburanishijwe mu ruhame ku wa 04/06/2024, RADIANT ihagarariwe na Me Nyirangirimana Astérie, naho abaregwa bahagarariwe na Me NSENGIMANA Emmanuel, bamenyeshwa ko ruzasomwa ku wa 12/07/2024. Hasuzumwe ikibazo cyo kumenya niba Mukabera Françine yaragombaga kugenerwa indishyi z'ibangamirabukungu kubera umwana we wishwe n'impanuka.

RADIANT ivuga ko icyumvikana ari uko umwana afasha umubyeyi igihe atishoboye cyangwa abikeneye, bitandukanye n'ibyo umucamanza yavuze ko izo nshingano ziriho ku bw'itegeko.

[9] RADIANT ivuga kandi ko mu rubanza N° RS/INJUST/ RC 00021/22/SC rwaciwe n'Urukiko rw'Ikirenga ku wa 17/03/2023 haburana Mukagatare Regine na SANLAM AG Plc, Urukiko rwemeje ko abari batunzwe n'uwhahohotewe aribo bahabwa indishyi z'ibangamirabukungu, uwo murongo ukaba uhura neza n'ibiteganywa n'ingingo ya 22, igika cya

mbere, y'Iteka rya Perezida N° 31/01 ryo ku wa 25/8/2003 rishyiraho uburyo bwo kwishyura indishyi ku bubabare bwo ku mubiri zikomoka ku mpanuka zatewe n'ibinyabiziga.

[10] RADIANT isobanura ko Urukiko rwageneye Mukabera Françine indishyi z'ibangamirabukungu rwirengagije ko hagomba kugaragazwa ko umwana wapfuye yari yishoboye kurenza umubyeyi we, runirengagiza ko Niyonsaba Daniel yapfuye ari ingaragu, nta bikorwa bifatika bigaragaza ko ari we wari utunze umubyeyi we mu buryo buhoraho, cyane cyane ko yari umuhererezi mu bana benshi, atagira akazi kazwi, atagira n'umusaruro uzwi yinjiza. RADIANT yongeraho ko hakwiye kugaragazwa ibimenyetso bifatika, nk'impapuro zigaragaza aho yoherezaga amafaranga kuri konti cyangwa kuri telefoni, cyangwa aho yamwishiuriye kwa muganga.

[11] RADIANT isoza isaba ko indishyi z'ibangamirabukungu zagenewe Mukabera Françine zakurwaho, agategekwa gusubiza 7.264.574 Frw yari yarahawe mu rwego rwo kurangiza urubanza rusabirwa gusubirwamo ku mpamvu z'akarengane, kugirango hatabaho kwikungahaza mu buryo bunyuranyije n'amategeko (enrichissement sans cause), cyangwa kwakira ubwishi atagenewe (paiement de l'indû).

[12] Mukabera Françine avuga ko urega yatsinzwe no kubura ibimenyetso by'ibyo yaregeraga, kandi Urukiko rukaba rwaragennye indishyi z'ibangamirabukungu rugendeye ku kuba Niyonsaba Daniel yaragonzwe atwaye igare, akora akazi k'ubunyonzi, akaba yari afite umurimo ushobora gutuma yuzuza inshingano zo gufasha umubyeyi we. Avuga ko kuba nyakwigendera ariwe wari umuhererezi iwabo, no kuba yari mu cyiciro cy'ubudehe kimwe n'umubyeyi we, atari ibimenyetso bihamya ko atari kubahiriza inshingano yo kumutunga. Yongeraho ko iby'umurongo watanzwe n'Urukiko rw'Ikirenga bitakurikizwa muri uru rubanza, kuko watanzwe mu 2023 mu gihe uru rubanza rwaciwe ku wa 30/09/2022. Ku bijyanye n'amafaranga 7.264.574 yahawe harangizwa urubanza rusabirwa gusubirwamo ku mpamvu z'akarengane, avuga ko atagomba gusubizwa kuko nta karengane kabayeho.

[25] Nyirangendahimana Claudine, Mukashyaka Florentine, Sekanabo François na Sibomana Jean nabo basaba ko RADIANT yabaha amafaranga 1.000.000 akubiyemo ay'iglihembo cy'Avoka angana na 500.000 Frw, n'ay'ikurikiranarubanza angana na 500.000 Frw, kubera gukomeza kubasiragiza mu manza.

[26] RADIANT ivuga ko indishyi zisabwa zitatangwa kuko ariyo yarenganyijwe mu gihe hagenwaga indishyi z'ibangamirabukungu.

UKO URUKIKO RUBIBONA

[27] Urukiko rurasanga indishyi Mukabera Françine asaba atazihabwa kuko atsinzwe urubanza. Ku bijyanye n'indishyi Nyirangendahimana Claudine, Mukashyaka Florentine, Sekanabo François na Sibomana Jean basaba RADIANT, Urukiko rurasanga batazihabwa kuko atari RADIANT yabazanye mu rubanza, ahubwo barujemo hashingiwe ku ngingo ya 63 y'Itegeko N° 30/2018 ryo ku wa 02/06/2018 rigena ububasha bw'inkiko, iteganya ko ababaye ababuranyi mu rubanza rusubirishwamo ku mpamvu z'akarengane bose bahamagazwa.

III. ICYEMEZO CY'URUKIKO
