haburana Mukarusanga Olive n’Ubushinjacyaha, aho mu gusesengura amagambo itegeko ritariho cyangwa ingingo z’amategeko zitakiriho, Urukiko rw’Ikirenga rwasanze agomba kumvikana mu buryo bw’Itegeko ritagikoreshwa (*une loi abrogée/a repealed law*), cyangwa Itegeko ritaratangira gukoreshwa (*une loi non encore en vigueur/ a law not yet in force*) cyangwa se Itegeko ritigeze ribaho (*loi qui n’a jamais existé/ a law that has never existed*). Agaragaza ko igisobanuro cya nyuma aricyo itegeko ritigeze ribaho (*une loi qui n’a jamais existé/ a law that has never existed*) ari cyo gihuje neza n’icyo umushingamategeko yashatse kuvuga ku itegeko ritariho mu gace ka 10 k’igika cya mbere, cy’ingingo ya 46 y’Itegeko N° 30/2018 ryo ku wa 02/06/2018 rigena ububasha bw’inkiko.

[11] Asoza asaba Urukiko kuzemeza ko bidashoboka ko habaho Itegeko ritigeze ribaho, bityo runemeze ko ingingo iregerwa inyuranyije n’Itegeko Nshinga kuko yemerera umuburanyi uburenganzira bwo kwiyambaza inzira y’ubujurire bwa kabiri ku mpamvu idashoboka, kuko Itegeko ryose rigomba gutangazwa mu Igazeti ya Leta, iritigeze ritangazwa rikaba riba ritariho.

[12] Me Kabibi Spéciose avuga ko ibisobanuro byatanzwe na Kamegeri Emmanuel asanga nta na hamwe bigaragaza uburyo agace ka 10, k’igika cya mbere, cy’ingingo ya 46 y’Itegeko N° 30/2018 ryo ku wa 02/06/2018 rigena ububasha bw’inkiko kabangamiye ihame rivugwa mu ngingo ya 29 y’Itegeko Nshinga ku butabera buboneye, ahubwo asa n’aho asaba ko iyo ngingo yasobanuka, kandi muri icyo gihe ikirego cye cyaba gihindutse ikirego kiregera *interprétation authentique/authentic interpretation*.

Naho ubujurire bwa kabiri kimwe n'izindi nzira z'ubujurire biteganyijwe mu mategeko y'Igihugu bikorwa hashingiye ku byo umuryango ukeneye, kandi Umushingamategeko akaba ashobora nabwo guteganya ibigomba kubahirizwa kugira ngo ubujurire bwakirwe.

[22] Mu rubanza RPAA0096/15/CS rwaciwe ku wa 18/05/2018, uru Rukiko rwasesenguye amagambo urega agarukaho ari yo itegeko ritariho, rwemeza ko agomba kumvikana mu buryo bw'itegeko ritagikoreshwa (*loi abrogée, repealed law*), cyangwa itegeko ritaratangira gukoreshwa

(*loi non encore en vigueur, a law not yet in force*), cyangwa se itegeko ritigeze ribaho (*qui n'a jamais existé, a law that never existed*). Rusanga bivuze ko ishingiro ry'ububasha hakurikijwe ingingo ivuga kuba Urukiko rwashingiye ku itegeko ritariho, ryareberwa mu ikoresha mu rubanza rujuririrwa ry'Itegeko ryavanyweho, ritaratangira gukoresha cyangwa ritarabaho.³
