

## NIYIGENA v. ECOBANK RWANDA PLC N'UNDI

[Rwanda URUKIKO RW'IKIRENGA – RS/INJUST/RCOM 00005/2023/SC (Mukamurisa, P.J., Hitiyaremye na Kazungu, J.) 28 Kamena 2024]

*Amategeko mbonezamubano – Amasezerano – Amasezerano y'ubwishingire – Itangwa ry'ingwate – Ingwate itangwa hishingirwa umwenda uraho, ishobora no kwishingira umwenda cyangwa imyenda izafatwa nyuma, ariko mu masezerano y'ubugwate bikwandikwamo neza ko iyo ngwate izishingira n'umwenda cyangwa imyenda runaka, hakagaragazwa ingano yayo, icyo izaba igamije, n'ibindi.*

**Incamake y'ikibazo:** Kantarama Felicie yareze Niyigena Eraste mu Rukiko rw'Ubucuruzi ku kuba yaranze kwishyura umwenda yahawe na Ecobank Rwanda Plc akamwishingira ariko bikaza kurangira ingwate yamutije igurishijwe mu cyamunara. Ecobank igobokeshwa muri urwo rubanza.

Urwo Rukiko rwaciye urubanza rwemeza ko ikirego cya Kantarama gifite ishingiro, rutegeka Niyigena kumwishyura 261.173.067 Frw y'agaciro k'umutungo we ufite UPI: 5/04/03/01/2936 yari yaramutije, runamutegeka kumwishyura indishyi.

Niyigena atishimiye icyo cyemezo yajuririye mu Rukiko Rukuru rw'Ubucuruzi avuga ko umwenda yahawe wishyuwe bityo atarakwiye gutegekwa kwishyura Kantarama Félicie 261.173.067 Frw y'ingwate yagurishijwe na Ecobank ndetse n'indishyi.

Urukiko Rukuru rw'Ubucuruzi rwaciye urubanza rwemeza ko imikirize y'urubanza rwaciwe n'Urukiko rw'ubucuruzi idahindutse.

Niyigena yandikiye Perezida w'Urukiko rw'Ubujurire asaba ko urwo rubanza rwasubirishwamo ku mpamvu z'akarengane, nawe amaze gusuma impamvu z'ubwo busabe agasanga zifite ishingiro, yandikira Perezida w'Urukiko rw'Ikirenga asaba ko rwasubirwamo, yemeza ko rusubirwamo ruburanishwa n'Urukiko rw'Ikirenga.

Mu miburanire ye mu rubanza rusubirwamo ku mpamvu z'akarengane, Niyigena avuga ko Urukiko Rukuru rw'Ubucuruzi rwafashe ibintu uko bitari rwemeza ko amazerano hagati ye na Kantarama yo gutiza ingwate atubahirijwe kuko umutungo yamutije wagurishijwe mu cyamunara RDB imaze kubitangira icyemezo. Akavuga ko icyo uwo mutungo wagurishirijwe bitari ukutubahiriza amasezerano y'umwenda yahawe na Ecobank wiswe *avance de démarrage*, wishingiwe na Kantarama kuko wishyuwe kandi uburenganzira kuri iyo ngwate bukaba bwari burangiriye aho, ahubwo ari uburangare bwa Ecobank bwo kuba nyuma yo kumuha indi myenda itandikishije ingwate aho byasabaga ko Kantarama abanza kwemera ko ingwate ye ikomereza no ku zindi nguzanyo, hakabaho kongera kwandikisha ingwate, ko kuba ibyo bitarabaye, uburenganzira bwa Ecobank ku ngwate Niyigena Eraste yari yaratijwe na Kantarama Félicie bwagarukiraga gusa ku mwenda wa 284.747.744 Frw.

Ecobank Rwanda Plc yiregura ivuga ko ibivugwa na Niyigena ko Kantarama Félicie yishingiye gusa umwenda wa *advance payment guarantee* nta shingiro bifite, ndetse Kantarama akaba yeremereye Ecobank ko iyo ngwate yakomeza kwishingira imyenda yose Niyigena azahabwa niyo Banki. Ikavugako kuba yaraniwe kwishyura imyenda yahawe aribyo byabaye intandaro yo kugurisha iyo ngwate mu cyamunara.

Kantarama ku ruhande rwe avuga ko kuba Ecobank yiyyemerera ko umwenda yishingiye wamaze kwishyurwa ariko ikabirengaho ikamugurishiriza ingwate, ikwiye kwirengera izo ngaruka, agahakana ko atemereye Ecobank ko ingwate ye izishingira iyindi myenda Niyigena azafata ndetse kuba yarandikishijwe inshuro imwe, nta wundi mwenda yagombaga kwishingira, ndetse nta kigaragaza ko hari undi mwenda yandikishijweho. Agasaba ko Ecobank yirengera amakosa yose yakoze.

## **Urubanza**

### **I. IMITERERE Y'URUBANZA**

[1] Uru rubanza rwatangiriye mu Rukiko rw'Ubucuruzi Kantarama Félicie arega Niyigena Eraste kuba yaranze kwishyura umwenda yari afitiye Ecobank bigatuma ingwate yari yaramutije ngo yishingire uwo mwenda igurishwa mu cyamunara, hamwe n'indishyi zinyuranye zikomoka ku kwica amasezerano, Ecobank igobokeshwa mu rubanza.

[2] Ku itariki ya 08/02/2022, Urukiko rw'Ubucuruzi rwaciye urubanza RCOM 01291/2021/TC, rwemeza ko ikirego cya Kantarama Félicie gifite ishingiro kuri bimwe, ruvuga ko Ecobank itari ikwiye kugobokeshwa ku gahato mu rubanza, rutegeka Niyigena Eraste kwishyura Kantarama Félicie 261.173.067 Frw y'agaciro k'umutungo we ufite UPI:

5/04/03/01/2936 yari yaramutije, runamutegeka kumwishiura 600.000 Frw akubiyemo indishyi z'ikurikiranarubanza n'igihembo cya Avoka hamwe n'igarama, rumutegeka kandi kwishyura Ecobank 500.000 Frw y'igihembo cya Avoka.

[3] Niyigena Eraste yajuririye urwo rubanza mu Rukiko Rukuru rw'Ubucuruzi avuga ko atagobokesheje Ecobank mu rwego rwa mbere, ko ahubwo yifuzaga ko izanwa mu rubanza kugira ngo iryoze amakosa yakoze igurisha ingwate yahawe ubwo yatangaga ubwishingizi ku mafaranga Niyigena Eraste yahawe na WDA akishyurwa nta ruhare ibigizemo. Yavugaga kandi ko umwenda ungana na 284.747.744 Frw utatanzwe na Ecobank, ko kandi uwo mwenda wishyuwe, ko rero atari akwiye gutegekwa kwishyura Kantarama Félicie 261.173.067 Frw y'ingwate yagurishijwe na Ecobank ndetse n'indishyi.

[5] Ku itariki ya 25/11/2022, Urukiko Rukuru rw'Ubucuruzi rwaciye urubanza RCOMA 00190/2022/HCC rwemeza ko imikirize y'urubanza rwajuririwe idahindutse, ko ubujurire bwa Niyigena Eraste bufite ishingiro gusa ku bijyanye nuko mu rwego rwa mbere atagobokesheje Ecobank, ko ahubwo yasabye ko ihamagarwa nk'umwishingizi waryozwa ibyo yaregwaga, rumutegeka kwishyura Ecobank na Kantarama Félicie, buri wese indishyi zingana na 300.000 Frw y'igihembo cya Avoka mu bujurire.

Perezida w'Urukiko rw'Ubujurire amaze gusuzuma ubwo busabe, yoherereje Perezida w'Urukiko rw'Ikirenga raporo yarukozeho asaba ko rwasubirwamo, na we yemeza ko rwongera kuburanishwa ruhabwa RS/INJUST/RCOM 00005/2023/SC.

[8] Mu nama ntegurarubanza, ababuranyi bemeranyijwe ko icyo Ecobank yishingiye ari *avance de démarrage* yatanzwe na WDA, ko kandi yishyuwe nta ruhare Ecobank ibigizemo, bityo ko itari mu myenda Niyigena Eraste ayifitiye. Ikibazo cyabaye icy'uko Niyigena Eraste yafatiye indi myenda muri Ecobank ku ngwate yari yaratijwe na Kantarama Félicie ubwo Ecobank yishingiraga *avance de démarrage* imaze kuvugwa. Hakaba hibazwa niba Ecobank yarashoboraga

kwimurira iyo ngwate ku yindi myenda Kantarama Félicie atabimeneshejwe ngo abyemere nk'uko byagenze kuri *avance de démarrage*.

[9] Urubanza rwaburanishijwe mu ruhame ku itariki 15/05/2024, Niyigena Eraste yunganiwe na Me Bayingana Janvier, Ecobank ihagarariwe na Me Bimenyimana Eric, naho Kantarama Félicie ahagarariwe na Me Ngendakuriyo Célestin. Muri uru rubanza hasuzumwe ikibazo cyo kumenya niba Ecobank yari ifite uburenganzira bwo kwimurira ku yindi myenda ingwate Kantarama Félicie yatije Niyigena Eraste hishingirwa *avance de démarrage* itabimumenyesheje, n'ikibazo kijyanye no kumenya ingano y'indishyi zigomba kwishyurwa Kantarama Félicie, hamwe n'ikibazo kijyanye n'izindi ndishyi zisabwa muri uru rubanza.

## II. IBIBAZO BIGIZE URUBANZA N'ISESENGURA RYABYO

[10] Me Bayingana Janvier wunganira Niyigena Eraste avuga ko akarengane kabaye mu rubanza basabye ko rwasubirwamo, ari uko Urukiko Rukuru rw'Ubucuruzi rwafashe ibintu uko bitari bigatuma rwibeshya rugafata icyemezo ku kibazo kitariho, kuko rwafashe ko umwenda wari wishingiwe n'ingwate ya Kantarama Félicie utishyuwe bigatuma rwemeza ko amasezerano yo gutiza ingwate yagiranye na Niyigena Eraste yishwe. Avuga ko Ecobank yitwikiriye imyenda yindi Niyigena Eraste yari ayibereyemo, ariko itandukanye cyane n'umwenda Kantarama Félicie yari yaratangije ingwate ye, bituma isaba RDB kugurisha ingwate ya Kantarama Félicie ku mwenda nyamara itari yarandikishirije ingwate. Avuga ko hanarebwe uburenganzira bwo kugurisha bwatanzwe na RDB (*permit to sale*), usanga umwenda watangiwe ingwate yagurishijwe ari *avance de démarrage* yonyine.

[11] Akomeza asobanura ko ingwate imaze kuvugwa ijya gutangwa, ku itariki ya 13/01/2014, hagati ya ECOTRAP/Niyigena Eraste, Kantarama Félicie na Ecobank, habaye amasezerano arebana n'umwenda ungana na 284.747.744 Frw, nyuma iyo ngwate irandikishwa. Avuga ko mu gihe iyo nguzanyo yari imaze kwishyurwa, inshingano za Kantarama Félicie zari zirangiye, ko ku yindi myenda itarishyuwe Ecobank ivuga yahaye Niyigena Eraste ku ngwate ya Kantarama Félicie, byari ngombwa ko abanza kwemera ko ingwate ye ikomereza no ku zindi nguzanyo, hakabaho kongera kwandikisha ingwate, ko kuba ibyo bitarabaye, uburenganzira bwa Ecobank ku ngwate Niyigena Eraste yari yaratijwe na Kantarama Félicie bwagarukiraga gusa ku mwenda wa 284.747.744 Frw.

[12] Ku bijyanye n'ibivugwa na Ecobank ko mu masezerano y'itizwa ry'ingwate (*procuration*) yo ku itariki ya 07/01/2014, Kantarama Félicie yemereye Niyigena Eraste gukomeza gukoresha ingwate ye mu gihe cy'imyaka icumi, Me Bayingana Janvier asobanura ko iyo myumvire atari yo kuko iyo *procuration* yarebanaga n'amasezerano yandi Niyigena Eraste yashoboraga kuzakorana n'ibindi bigo byose by'imari, ko atari *spécifique* ku myenda ya Ecobank.

[13] Arangiza avuga ko Urukiko rwaciye urubanza rwasabiwe gusubirwamo ku mpamvu z'akarengane rwahaniye Niyigena Eraste amakosa yakozwe na Ecobank, bityo agasaba uru Rukiko kubikosora, Ecobank akaba ari yo yirengera ingaruka z'amakosa yayo, rugategeka ko amafaranga

yaciwe muri urwo rubanza yacibwa Ecobank kuko ari yo yakoze amakosa yo kugurisha ingwate ya Kantarama Félicie kandi umwenda yari yishingiye warishyuwe.

[14] Me Bimenyimana Eric uhagarariye Ecobank avuga ko ibivugwa na Niyigena Eraste ko Kantarama Félicie yishingiye gusa umwenda wa *advance payment guarantee* nta shingiro bifite, kubera ko mu masezerano yo ku itariki ya 13/01/2014, Kantarama Félicie yashyizeho umukono, mu ngingo yayo ya 3, igika cya 3, ubwe yemereye Ecobank ko ingwate ye ishobora no kuba yakomeza gukoreshwa no ku yindi myenda (yemeye guhindura *mode d'utilisation*), ko ari muri urwo rwego umutungo we wakomeje gufatwa nk'ingwate ku myenda yose yahabwaga Niyigena Eraste. Avuga ko uretse n'ibyo, amasezerano yo ku itariki ya 07/01/2014 yakorewe imbere ya Noteri w'ubutaka mu Karere ka Kayonza aho umutungo watijwe uherereye, yari ayo guha Niyigena Eraste uburenganzira bwo gutangaho ingwate umutungo wa Kantarama Félicie mu gihe cy'imyaka icumi (10), akaba atarigeze amukumira ku myenda azafata.

[15] Akomeza asobanura ko, ashingiye ku bimaze kuvugwa, ari muri urwo rwego guhera ku itariki ya 14/01/2015, Niyigena Eraste yagiye afata imyenda itandukanye yumvikana na Banki ko umutungo yatijwe na Kantarama Félicie uzaba ingwate, mu byo yategetswe hakaba harimo kuwufatira ubwishingizi bw'inkongi y'umuriro, kandi akaba yaragiye abikora igihe cyose uwo mutungo wari ukiri mu bugwate. Avuga ko umwenda yahawe ku itariki ya 20/05/2015 ungana na 250.000.000 Frw yananiwe kuwisyura, habaho kuvugurura amasezerano yawo (*restructuration*), umwenda urazamuka ugera kuri 308.909.333 Frw, ari byo byaje kuba intandaro yo kugurisha mu cyamunara ingwate yari yaratanzé.

[16] Me Bimenyimana Eric yabajije icyatumye habaho kugurisha ingwate ya Kantarama Félicie mu gihe yemera ko umwenda ungana na 284.747.744 Frw wishyuwe, nta n'indi *permit to sale* ku yindi myenda avuga yatanzwe, asubiza ko ingwate igurishwa hashingiwe kuri *invoice discounting* yo ku itariki ya 28/07/2016, yahinduraga umwenda wishingiwe. Asobanura ko mbere y'uko Banki ijya kugurisha ingwate hari imihango (*procedures*) ibanza irimo nko kwibutsa uyibereyemo umwenda inshingano zo kwisyura, no kuri Niyigena Eraste akaba ari ko byagenze.

[17] Ku kibazo cyo kumenya umwenda uvugwa niba ari umwe ku baburanyi bose kuko basa nk'abavuga imyenda itandukanye, asobanura ko hari imyenda itandukanye Ecobank yahaye Niyigena Eraste, bakumvikana ko mu bigomba kwishingira iyo myenda harimo n'inzu ya Kantarama Félicie, ko kandi yari isanzwe yanditse, ari yo mpamu batongeye kongera kuyandikisha. Yongeraho ko ibimaze kuvugwabihura n'ibyo Kantarama Félicie yumvikanyeho na Ecobank na Niyigena Eraste mu ngingo ya 3 y'amasezerano bagiranye, aho bemereye Banki kuba yakwimirira iyandikisha ry'ingwate ku wundi mwenda, ibyo akaba aribyo Ecobank yashingiye iteza cyamunara ingwate yahawe nyuma yo kubona ko hari umwenda wishingiwe n'ijo ngwate Niyigena Eraste atishyuye.

[18] Me Ngendakuriyo Célestin uhagarariye Kantarama Félicie avuga ko kuba umwenda ungana na 284.747.744 Frw Kantarama Félicie yari yaratangiye ingwate Ecobank yi yemerera ko wishyuwe wose, ariko ikaba yarabirenzeho ikamugurishiriza ingwate, ariyo ikwiriye kwirengera ingaruka zabyo. Avuga ko ibyo uhagarariye Ecobank avuga ko Kantarama Félicie yari yaremeye kwishingira imyenda yose Niyigena Eraste yari kuzahabwa atari ukuri, kuko ingingo ya 2, igika cya 2, y'amasezerano y'ubugwate impande zose zagiranye ku itariki ya 13/01/2014, igaragaza uburyo ingwate ye yagombaga gukoreshwa. Kuba rero Kantarama Félicie atarigeze yishingira

izindi nguzanyo zahawe Niyigena Eraste, asanga Ecobank ikwiriye kwirengera ingaruka zose zatewe no kugurishirizwa ingwate.

[19] Me Ngendakuriyo Célestin akomeza asobanura ko hashingiwe ku ngingo ya 4 y'Itegeko ryerekeye ubugwate ku mutungo utimukanwa, ingwate yandikwa inshuro imwe gusa ku mwenda umwe, ko kuba rero ingwate ya Kantarama Félicie yari yaratangiwe umwenda umwe wa 284.747.744 Frw ikanandikishwa inshuro imwe kuri uwo mwenda, nta wundi mwenda yagombaga kwishingira, cyane cyane ko nta kigaragaza ko hari undi mwenda yandikishijweho.

## UKO URUKIKO RUBIBONA

[20] Ingingo ya 555 y'Itegeko ryo ku wa 30/07/1888 ry'urwuge rw'amategeko y'imbonezamubano ryakurikizwaga ubwo amasezerano avugwa muri uru rubanza yasinywaga, yateganyaga ko ubwishingire budakekwa, ko bugomba kwemerwa ku buryo bweruye, ko kandi budashobora kwagurwa ngo burenge inshingano uwishingiye undi yi yemeje. Ingingo ya 576 y'iryo Tegeko yo igateganya ko uwishingiye undi ntacyo ashobora kwishyuzwa, iyo uburenganzira bwe bwo gusimbura ugomba kwishyurwa mu burenganzira bwe, mu ngwate ze z'ibintu bitimukanwa no mu bwizimbe bwe, atagishoboye kubukoresha kubera ikosa ry'ugomba kwishyurwa.

[21] Ingingo ya 4 y'Itegeko N° 10/2009 ryo ku wa 14/05/2009 ryerekeye ubugwate ku mutungo utimukanwa nk'uko ryahinduwe kandi ryujuwe kugeza ubu, iteganya ko byitwa ko ubugwate bufite agaciro iyo bwanditswe mu gitabo cyandikwamo ingwate ku mutungo utimukanwa mu biro by'Umwanditsi Mukuru.

[22] Ingingo ya 11 y'Itegeko rimaze kuvugwa, iteganya ko uwatanze ingwate afite uburenganzira bwo gusubizwa ingwate ye igihe cyose amaze kwishyura umwenda we wose hakurikijwe ibyumvikanyweho mu masezerano y'ubugwate.

[23] Ibiteganywa n'ingingo imaze kuvugwa, byasobanuwe n'Urukiko rw'Ikirenga mu rubanza rwaciye ku itariki ya 19/06/2020 haburana Kayombya Robert, I&M Bank Rwanda Plc na IMEX Sarl, aho rwifashishiye ibisobanuro bitangwa n'abahanga mu mategeko, rwasobanuye ko ingwate ari uburenganzira bushingiye ku bundi, ni ukuvuga ku mwenda wishingiwe; imwe mu ngaruka z'ibyo ikaba ari uko ingwate izimana n'umwenda wari wishingiwe, ko mu gihe umwenda wari wishingiwe urangije kwishyurwa wose, ingwate yawishingiraga ihita irekurwa, uretse mu gihe byaba byarateganyijwe ukundi mu masezerano.<sup>1</sup>

[24] Ababuranyi muri uru rubanza bemeranya ku kuba umwenda wari wishingiwe n'umutungo wa Kantarama Félicie ufile UPI : 5/04/03/01/2936 mu masezerano y'ubugwate yo ku itariki ya 13/01/2014 (*convention d'ouverture de crédit avec constitution d'hypothèque*) warishyuwe kandi nta ruhare Ecobank ibigizemo. Bemeranya kandi ko nyuma y'aho uwo mwenda wishyuriwe, Niyigena Eraste wari waratijwe ingwate yayifatiyeho indi myenda, umwe muri yo ntiwishyurwa, bituma ingwate igurishwa mu cyamunara. Icyo batemeranyaho nuko Niyigena Eraste na Kantarama Félicie bavuga ko iyo ngwate itagombaga kugurishwa kuko umwenda yishingiye

wishyuwe, Ecobank yo ariko ikavuga ko kuba Niyigena Eraste yarakomeje gufatira kuri iyo ngwate indi myenda, umwe muri yo ntiwishyurwe, ntacyari gutuma ingwate itagurishwa.
