

HORIZON SOPYRWA Ltd vs YANKUNDIYE

Amategeko agenga imanza z'imbonezamubano – Imanza ku mitungo itimukanwa – Ubutaka – icyemezo gihamya nyiri ubutaka - Acte de notoriété yatanzwe kandi yashyizweho umukono n'Umunyamabanga Nshingwabikorwa w'Umurenge, ntiyafatwa nk'icyemezo cy'umutungo gihamya nyir'ubutaka kubera ko atari we amategeko aha ububasha bwo gusinya bene ibyo byemezo.

Incamake y'ikibazo: Ikigo cya Leta cy'iterambere ry'ibireti cyaje kwegurirwa abashoramri batanu (5) barimo uwitwaga Gatemberezi bahita bashingira sosiyete y'ubucuruzi bise SOPYRWA Sarl. Gatemberezi mu izina rya SOPYRWA Sarl yaje gukora inyandiko yo guha Yankundiye igice cy'ubutaka bwa SOPYRWA avuga ko yagaragaje imikoranyirye myiza n'uruganda rwayo akaba ariyo mpamvu ahawe ubwo butaka. Abanyamigabane bageze igihe bagabana amasambu ya Sosiyete hanyuma Gatemberezi ahabwa isambu iri Karandaryi n'iri ku Ikora ari n'aho yari yarahaye Yankundiye.

HORIZON Ltd yaguzwe imigabane yose yo muri SOPYRWA Sarl, bumvikana n'uburyo izajya yishyura ariko igeze aho ihagarika kwishyura ivuga ko yasanze hari ubutaka bumwe bwagurishijwe indi ikaba yaribarujweho n'abahoze ari abanyamigabane bayo. Ibi byatumye hatangwa ikirego mu Ubukemurampaka hanyuma hemezwa ko abari abanyamigabane ba SOPYRWA Sarl bagomba gusubiza imitungo yose, yaba yatanzwe cyangwa yaragurishijwe, ikagarurwa mu mutungo wa HORIZON SOPYRWA Ltd, uretse abafite ibyangombwa byayo bahawe n'ubuyobozi bubifitiye ububasha. HORIZON yaje kwibaruzaho uwo mutungo wose harimo n'ubutaka Gatemberezi yari yarahaye Yankundiye.

Yankundiye yatanze ikirego mu Rukiko Rwisumbuye rwa Rubavu arega HORIZON SOPYRWA Ltd ko yamuhagaritse kubaka mu butaka bwe no kuba yarabwibarujeho kandi nawe abufitiye acte de notoriété yatanzwe ku wa 25/06/2008. Urukiko rwemeje ko inyubako iri mu butaka buburanwa bugizwe n'ikibanza N° 1200 igomba kuvanwaho kuko ubutaka ari ubwa HORIZON. Yankundiye yajuririye urwo rubanza mu Rukiko Rukuru urugereko rwa Musanze hanyuma rwemeza ko ikibanza N° 1200 ari icye. Nyuma habayeho imanza zitandukanye ariko hemezwa ko imikirize y'urubanza 0009/013/TGI/RBV rwaciwe n'Urukiko Rwisumbuye rwa Rubavu ihindutse, ko ikibanza N° 1200 kibarurwa kuri Yankundiye.

Uru rubanza rwaje gusabirwa gusubirwamo ku mpamvu z'akarengane hanyuma ruhabwa Urukiko rw'Ikirenga rurusubiramo harebwa ikibazo kirebana no kumenya nyir'ikibanza N° 1200, hagati ya Yankundiye na HORIZON SOPYRWA Ltd. HORIZON ivuga ko Gatemberezi yatanze ubutaka butari ubwe kuko bwari ubwa SOPYRWA kandi abutanga itamuhaye ubwo bubabasha dore ko yabutanze ku wa 22/01/2007 mbere y'uko abuhabwa n'inama rusange kuko yabuhawe ku wa 15/07/2007. Ikomeza isobanura ko SOPYRWA yari ifite icyangombwa cy'inkondabutaka bityo kikaba cyaragombaga gusimburwa n'ikindi cyangombwa cy'inkondabukata kandi siko byagenze. Yankundiye avuga ko afite icyangombwa cy'ubutaka acte de notoriété" yahawe ku itariki ya 25/06/2008 ishyizweho umukono n'Umunyamabanga Nshingwabikorwa w'Umurenge wa Jenda bityo ubwo butaka akaba asanga abutunze mu buryo bwemewe n'amategeko.

Bamaze kucyegukana, bahise bashinga Sosiyete y'Ubucuruzi bayita SOPYRWA Sarl ifite icyicaro mu Ruhengeri (ubu ni Musanze).

[2] Ku itariki ya 22/01/2007, Gatemberezi Aloys yakoze inyandiko avuga ko, mu izina rya SOPYRWA Sarl, ahaye Yankundiye Epimaque ubutaka bufite N° 1200 bwari ubwa SOPYRWA Sarl kubera ko afitanye imikoranire myiza n'urwo ruganda. Ku itariki ya 15/07/2007, Inama Rusange y'Abanyamigabane ba SOPYRWA Sarl, yarateranye igabana amasambu yayo, Gatemberezi Aloys ahabwa isambu iri Karandaryi n'iri ku i Kora mu Murenge wa Jenda, ari naho harimo ikibanza yari yarahaye Yankundiye Epimaque waje kucyubakamo inzu anacyibaruzaho igihe cy'ibarura ry'ubutaka mu mwaka wa 2012.

[3] Ku itariki ya 20/06/2008, HORIZON Ltd yaguze imigabane ingana na 70% muri SOPYRWA Sarl, ku itariki ya 30/11/2009 yongera kugura imigabane 30% yari isigaye ihita yegukana SOPYRWA Sarl yose ihindura n'izina yitwa HORIZON SOPYRWA Ltd. Nyuma yo kwemeranya ko iguze imigabane yose no guhindura izina, bumvikanye uburyo imigabane yose izishyurwa ariko ntibyubahirizwa. Mu mpamvu HORIZON SOPYRWA Ltd yatanze zatumye idakomeza kwishyura, harimo ko yasanze hari imitungo yari iya SOPYRWA Sarl yibarujweho n'abahoze ari abanyamigabane bayo kandi nayo yakagombye kuba iri mu mutungo wayo. Uko kutumvikana byatumye abari abanyamigabane ba SOPYRWA Sarl batanga ikirego mu Bukemurampaka basaba kwishyurwa imigabane yose.

[4] Ku itariki ya 14/09/2011, Abakemurampaka bemeje ko abari abanyamigabane ba SOPYRWA Sarl bagomba gusubiza imitungo yose, yaba yaratanzwe cyangwa yaragurishijwe, ikagarurwa mu mutungo wa HORIZON SOPYRWA Ltd, uretse abafite ibyangombwa byayo bahawe n'ubuyobozi bubifitiye ububasha. Nyuma y'icyo cyemezo, HORIZON SOPYRWA Ltd yibarujeho umutungo wose harimo n'ubutaka Gatemberezi Aloys yari yarahaye Yankundiye Epimaque, inamuhagarika gukomeza kubaka kuri ubwo butaka.

[5] Yankundiye Epimaque yatanze ikirego mu Rukiko Rwisumbuye rwa Rubavu irega HORIZON SOPYRWA Ltd ko yamuhagaritse kubaka mu butaka bwe no kuba yarabwibarujeho kandi nawe abufitiye ibyangombwa bigizwe na acte de notoriété yahawe ku itariki ya 25/06/2008, asaba n'indishyi zingana na 34.000.000 Frw, Gatemberezi Aloys agobokeshwa mu rubanza.

[9] HORIZON SOPYRWA Ltd yatanze ikirego cyo gusubirishamo ingingo nshya urubanza N° RCA 0172/13/HC/MUS, ivuga ko Urukiko rwakoze amakosa yo kwitiranya ibintu uko bitari rukemeza ko Gatemberezi Aloys yatanze ikibanza yahawe nk'umunyamigabane wa SOPYRWA Sarl, kandi yaragitanze ku itariki ya 22/01/2007, Inama Rusange yamuhaye isambu irimo icyo kibanza igaterana ku ya 15/07/2007, yaramaze kugitanga.

Muri icyo cyemezo, Abakemurampaka basanze ubutaka bwose bwari bufitwe na SOPYRWA Sarl, hashingiwe ku masezerano yo mu mwaka wa 2001 iyo sosiyete yagiranye na Leta y'u Rwanda ubwo yayeguriraga Ikigo gishinzwe guteza imbere ibireti mu Rwanda (OPYRWA), bugomba gusubizwa uregwa (uwaregwaga icyo gihe yari HORIZON SOPYRWA Ltd), uretse ubwari butunzwe n'ababufitiye ibyangombwa bitangwa n'urwego rubifitiye ububasha.
